ENTITLED

THE EAST AFRICAN COMMUNITY SUPPLEMENTARY APPROPRIATION (No. 2) ACT, 2020

An Act of the Community to appropriate a supplementary sum of United States Dollars eight hundred and fifteen thousand, five hundred and eighty-two out of the Community Budget to meet additional expenditure for the Inter-University Council for East Africa for the financial year ending 30th June, 2020.

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Supplementary Appropriation (No. 2) Act, 2020 and shall be deemed to have come into force on the 1st day of July, 2019.
