A Bill for an Act

ENTITLED

THE EAST AFRICAN COMMUNITY SUPPLEMENTARY APPROPRIATION (No. 2) ACT, 2022

An Act of the Community to appropriate a supplementary sum of United States Dollars two million, seven hundred and thirty-one thousand, six hundred and twenty-six out of the budget of the Community to meet additional expenditure for specified organs and institutions of the Community for the financial year ending 30th June, 2022.

ENACTED by the East African Community and assented to by the Heads of State.

- 1. This Act may be cited as the East African Community Supplementary Appropriation (No. 2) Act, 2022 and shall be deemed to have come into force on the 1st day of July, 2021.
- 2. Supplementary appropriation of the sum of United States Dollars two million, seven hundred and thirty-one thousand, six hundred and twenty-six is allowed out of the budget of the Community to meet additional expenditure for the organs and institutions of the Community specified in the Schedule, for the financial year ending 30th June, 2022.
