2.0 BACKGROUND

The Bill to which the Presidential memorandum relates was dated 11th August, 2015 and was sponsored by the House Majority leader, Hon. Aden Duale, M.P.

The Bill sought to establish Small Claims Court to provide for the jurisdiction and procedures of the Courts and for connected purposes.

The Bill was passed by the House on 18th November, 2015 and forwarded to H.E. the President for assent on 14th December, 2015. In exercise of powers conferred by Article 115 of the Constitution, H.E. the President refused to assent to the Bill. He expressed reservations on amendments made by the House on Clause 37 of the Bill and proposed amendments to the said clause. The Bill was referred back to the House for reconsideration.

It should be noted that the Bill was amended by deletion of clause 37 (2). Clause 37 of the Bill provides for the enforcement of orders made by a small courts requiring a party to pay money and sets out the procedure applicable thereto. In this regard, sub clause (2) of the initial Bill provided as follows:

"(2) Where an application is made to the Court for the issue of any Process to enforce an order requiring a party to pay money to another as an alternative to compliance with a work order, that Court shall give notice of the application to the party against whom enforcement is sought."

The amended subclause marked the commencement of the enforcement proceedings and triggered the actions anticipated under the rest of the clause i.e sub clauses (3) - (6).

2.1 The Small Claims Court Bill, 2015

The Bill was sponsored by Hon. Aden Duale and was passed by the House on 18th November, 2015. Thereafter, it was committed to H.E. the President for assent in line with provisions of the constitution of Kenya and the National Assembly Standing Orders.

3.0 THE PRESIDENTS MEMORANDUM ON THE BILL

Referral of the Bill to the House by H.E the President

H.E. the President by way of memorandum dated 23rd December, 2015 referred the Bill back to the House with reservations. This was pursuant to provisions of Article 115 of the constitution and was communicated to the House by the Speaker on Tuesday February 9th, 2016 and committed the memorandum to the Departmental Committee on Justice and Legal Affairs for consideration and report to the House.

While committing the memorandum to the Committee, the Speaker was categorical that the Committee considers it and reports back to the House on or before 23rd February, 2016 as required by Standing Order 154. A copy of the Presidential memorandum is annexed hereto as appendix 3.

3.1 Consideration of the President's Memorandum on Bills

The Committee was guided by the Hon. Speaker's Communication of 28th July, 2015 which gave Committees the liberty to amend recommendations from the President as long as the amendments account for the President's reservations in line with Article 115 of the Constitution. Amendments approved by the Speaker as taking into account the President's reservations would only require a simple majority to pass in the House.

4.0 COMMITTEE'S OBSERVATIONS

The Committee considered the President's Memorandum dated 16th February, 2016 and Observed as follows;

- i. The President's recommendation to the House to amend clause 37 is meant to ensure enforceability of the Act and related events designed to realize its objectives.
- ii. The deletion of subclause (2) by the House renders the rest of the clause unenforceable as it curtails the logical sequence of events initially designed for its enforcement.

5.0 COMMITTEE'S RECOMMENDATIONS

THAT pursuant to Standing Orders 154 and 199 and in view of the foregoing, the Committee recommends that Clause 37 of the Bill be amended by inserting the following new clause after sub clause (1)-

"(2) Where an application is made to the Court for the issue of any Process to enforce an order requiring a party to pay money to another, as an alternative to compliance with a work order, that Court shall give notice of the application to the party against whom enforcement is sought."

AND WHEREAS the Small Claims Court Bill, 2015, was presented to me for assent, in accordance with the provisions of the Constitution, on the 14th December, 2015;

RECOMMENDATION:

REFERRAL BY H.E. THE PRESIDENT OF THE NATIONAL EMPLOYMENT AUTHORITY BILL, 2015 AND THE SMALL CLAIMS COURT BILL, 2015

Honourable Members,

I wish to welcome you back to the House for the Fourth Session of this Eleventh Parliament after the well deserved long recess. It is my hope that all Members have rested and are now rejuvenated for what promises to be another busy Session. As an overview, we have a number of Bills with constitutional deadlines that require to be passed by August 27th 2016, some of which need to also be considered by the Senate. We are also at the beginning of the Budget Cycle and have various other important matters before us, including the various Bills proposing to amend the Constitution.

Having said that Honourable Members, I now wish to convey two messages from His Excellency the President which were received in my office during the recess period. In the two Messages, the President is requesting the National Assembly to consider his reservations on-

- (i) The National Employment Authority Bill, 2015; and,
- (ii) The Small Claims Court Bill, 2015.

Honourable Members,

The First Message relates to the National Employment Authority Bill, 2015. You will recall that on 8th October, 2015, the National Assembly passed the National Employment Authority Bill, 2015 which was sponsored by the Hon. Johnson Sakaja,

MP. Subsequently, the Bill was presented for Assent to H.E. the President in accordance with the provisions of the Constitution and our Standing Orders. However, H.E. the President, by way of Memorandum has referred this Bill back to the National Assembly for reconsideration pursuant to the provisions of Article 115(1)(b) of the Constitution. In his reservations to the National Assembly, the President observes that the National Employment Authority Bill as passed did not incorporate transitional provisions which would facilitate the perpetual and legal transformation of the existing National Employment Bureau, which is a department in the Ministry of Labour and East African Affairs, into the new body being created in the Bill.

In the second Message, His Excellency the President has also referred the Small Claims Court Bill, 2015 back to the National Assembly for reconsideration. The said Bill, being amongst the statutes with a constitutional deadline, was passed by the House on 18th November, 2015, and subsequently presented for Assent. His reservations on the Bill relate to Clause 37 which provides for the enforcement of orders made by the Small Claims Court. In passing that particular Clause, the House deleted crucial text of sub-clause (2) which consequently rendered the entire Clause unenforceable. I want to admit that, indeed my office noticed the omission during the preparation of the Vellums prior to presentation to the President for Assent. Having consulted with the office of the Attorney General on the most suitable corrective measure, it was felt that, since correcting the deletion was beyond the powers of the Speaker as contemplated under Standing Order 152(3), the only option was for the President to return the Bill to the House for reconsideration of the specific sub-clause. It is on this basis that this particular Bill has been referred back to the House by the President for reconsideration.

Honourable Members,

In conclusion, Standing Order 154 requires the National Assembly to consider the President's reservations within 21 days. In this regard, the National Employment Authority Bill, 2015 stands committed to the Departmental Committee on Labour and Social Welfare, while the Small Claims Court Bill, 2015 is committed to the Departmental Committee on Justice and Legal Affairs for further consideration. The Committees should table their reports by February 22, 2016. In considering the Memoranda, regard will be given to the guidance given by the Speaker in a Communication delivered on July 28, 2015 concerning consideration of Presidential Memorandum and amendments thereto, particularly my guidance, that amendments by a Committee or an individual Member that have the effect of fully accommodating the Presidential reservations will not attract two thirds requirement for passage.

Honourable Members,

I wish to remind the House and the Committees that only clauses of the Bills for which the President has made reservations will be reconsidered by the House.
