INTRODUCTION

The NG-CDF (Amendment) Act, 2016 section 50 establishes the National Assembly Select Committee (NASC) on the NG-CDF whose main functions include but not limited to;

- (a) Oversee the implementation of the Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary propose any amendments to this Act, in particular, with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
- (b) Oversee the policy framework and legislative matters that may arise in relation to the Fund;
- (c) Continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
- (d) Consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act;

Section 51(1) of the Act further stipulates that the Board shall, on a quarterly basis, submit a report to the National Assembly Select Committee detailing the following;

- a) A summary of the project proposals received from the constituencies in the preceding month and indicating the approval status of such projects;
- (b) A summary of the status of disbursements of funds to the constituencies for that preceding month;
- (c) A summary of the status of disbursements from the Treasury to the National Account;
- (d) Any restriction imposed on a constituency account in accordance with the Act.

Based on the foregoing, the NG-CDF Board is submitting its report for the second quarter of 2016/17 Financial Year.

A. SUMMARY OF PROJECT PROPOSALS FOR 2016/17 FINANCIAL YEAR RECEIVED FROM THE CONSTITUENCIES

The NG-CDF Board received and deliberated on two hundred and eighty eight (288) Project Proposals for 2016/17 Financial Year. Two Constituencies namely; Kajiado West and Dagoretti South are yet to submit their Project Proposals.
