# COMMUNICATION FROM THE CHAIR

CONVENING OF SPECIAL SITTING OF THE SENATE

**The Speaker** (Hon. Ethuro): Hon. Members, I have a Communication to make on the convening of this particular Special Sitting.

Hon. Senators, I wish to welcome you back to the Senate for the Special Sittings today. The Special Sittings come very early in the year and only days after the New Year festivities.

Hon. Senators, let me take this opportunity to wish all of you a Happy New Year 2017.

Hon. Senators, these sittings also come against the backdrop of another Special Sitting that we had on 28<sup>th</sup> December, 2016. As you will recall, during the said sitting, I deferred further consideration of the Election Laws (Amendment) (No.3) Bill (National Assembly Bill No.63 of 2015) to allow scrutiny by the Committee and public participation by the Standing Committee on Legal Affairs and Human Rights together with the Standing Committee on Information and Technology. Most of the Joint Committee deliberations were streamed live by media, and most Kenyans followed the debate very keenly.

Hon. Senators, I wish to take this opportunity to commend the two Committees led by the Chairpersons, Sen. Wako and Sen. Kagwe, respectively, for working tirelessly, and in the midst of New Year festivities, to complete the assigned task on time and I hope they are now ready to table their Report today.

I also wish to extend the same appreciation to the Members of the Committee and the members of the public who undertook their civic duty and presented their views on the Bill to the Committees.

Hon. Senators, by a letter dated 28<sup>th</sup> December, 2016, and pursuant to Standing Order No. 29 (1), the Senate Majority Leader and Senate Minority Leader, supported by

the requisite number of Senators, requested me to convene Special Sittings of the Senate to conclude consideration of the Election Laws (Amendment) (No. 3) Bill (National Assembly Bill No. 63 of 2015).

Following this request and further considerations, I was satisfied that it met the requirements of Standing Order No. 29 (2). It is in this respect that I convened these Special Sittings of the Senate via Gazette Notice No.10691 dated 30<sup>th</sup> December, 2016. The Gazette Notice specified the business to be transacted at these sittings. The first Special Sitting will last until 12.30 p.m. while the Special Sitting for this afternoon will commence at 2.30 p.m. and run until conclusion of business or at midnight, whichever comes first.

Hon. Members, you may also wish to recall that by the time we ended the Special Sitting of the 28<sup>th</sup> December, 2016, we had agreed to convene on 4<sup>th</sup> January, 2017. However, when the Joint Committee looked at the work programme, they made a presentation to me and in consultation with the political leadership, we agreed and that is what necessitated that these Special Sittings take place today, 5<sup>th</sup> January, 2017.

Hon. Senators, please, note that pursuant to Standing Order No. 29 (5), the business specified in the Gazette Notice shall be the only business before the Senate during these Special Sittings, following which the Senate shall stand adjourned until Tuesday, 14<sup>th</sup> February, 2017 at 2.30 p.m. in accordance with the Senate Calendar.

I, therefore, wish to appeal to you, Hon. Senators; you have distinguished yourself before and this is another time that will call for that sobriety so that you may debate the matter before us with the seriousness it deserves and display the same level of sobriety as you have always done.

### GUIDELINES ON PROCESSING OF THE ELECTION LAWS (AMENDMENT) (NO.3) BILL (NATIONAL ASSEMBLY BILL NO.63 OF 2015

**The Speaker** (Hon. Ethuro): Hon. Members, you will recall that at the end of the morning sitting today, I directed, with the leave of the House, that we will continue with the debate on the Second Reading of the Election Laws (Amendment) (No.3) Bill (National Assembly Bill No.63 of 2015) this afternoon. It is just as well that the Report has been tabled and during this Second Reading, we will be able to use that opportunity to allow the Chairperson, during his contribution on the Second Reading, to shed light on what the Report contains.

The Report is now available to every Member. So, we will have plenty of time before the time for the Third Reading where the input will impact on the Bill. This is a matter that we discussed quite at length in the morning and the position still remains the same. What you need is time. The Report is now available and as Members continue to contribute, you will be able to look at the Report yourself.

Hon. Senators, you also recall that part of the reason why we referred this matter to the Committees of the House was to allow for public participation as well as inform the debate through the Report of the said Committees. I, therefore, thank the two Committees that facilitated the public participation on behalf of the Senate - the Committee on Legal Affairs and Human Rights and the Committee on Information and Technology - for the long sittings that they held since this matter was referred to them. In fact, I know for a fact, a number of Members, as Sen. Mutula Kilonzo Jnr. said in the morning, part of the reason one Motion was being brought could be because Members served very well and maybe they lacked sleep.

Allow me to also thank Members of the House for the sobriety on the matters before the House. I wish to encourage you to pursue that path. As Wole Soyinka says, a tiger does not proclaim its tigritude; it pounces. In other words, a tiger does not stand in the forest and say: "I am a tiger." Kenya already knows the Senators. When you pass where the tiger has walked before, you see the skeleton and then you know that some tigritude has been emanated there.

Finally, as we embark on the Report before us, I want us to bear in mind our role as representatives of the people, adhere to the rules of debate that bind all of us; that this is going to the defining moment of this debate this afternoon and we conclude this Bill.

In the words of Edmund Burke in his *Speech to the electors of Bristol*, he said: "Parliament is not a congress of ambassadors from different and hostile interests, which interest each must maintain as an agent and an advocate against other agents and other agents and other advocates. Parliament is a deliberative assembly of one nation with one interest; that of the whole where not local purposes or local prejudices ought to guide but the general good resulting from the general reason of the whole".

#### DEMISE OF SEN. BOY JUMA BOY, SENATOR FOR KWALE COUNTY

**The Deputy Speaker** (Sen. Kembi-Gitura): Hon. Senators, it was with profound shock and sadness that I learnt of the untimely death of our friend, colleague and brother, the distinguished Senator for Kwale County, Sen. Boy Juma Boy, on Sunday, 12<sup>th</sup> February, 2017.

In line with the Islamic faith funeral rites, his remains were laid to rest yesterday, 13<sup>th</sup> February, 2017, at this home in Vanga, Kwale County. I note with appreciation that some of you, Hon. Colleagues, I note with appreciation that some of you made time and travelled to Vanga to give our colleague a befitting send off. I had the honour and privilege to represent the Senate at the funeral. I would also like to thank all Senators for standing with the Late Sen. Boy Juma Boy's family in various forms including prayers.

Hon. Senators, Sen. Boy Juma Boy was first elected as a Member of Parliament (MP) in 1983 at the age of 24 and served as the MP for Matuga Constituency for three uninterrupted terms from 1983 to 1997. Having joined politics as a successor to his late father, who was the then MP for Matuga, he became the youngest MP at the time. He

rose through the party ranks to become Chief Whip in Parliament in recognition of his distinguished service and loyalty to the ruling party, KANU.

The Late Sen. Boy Juma Boy was elected as the Senator for Kwale County during the General Elections held on 4<sup>th</sup> March, 2013 following the reintroduction of a bicameral parliament in our country. While serving as Senator for Kwale County, he actively represented and accomplished great milestones through articulating and fighting for the rights of his constituents and the entire Kenyan citizenry.

The Late Sen. Boy Juma Boy was passionate about his county. This is evident in the way he championed the spirit of devolution while ensuring that funds allocated to the county were used to deliver services to the people. He was an articulate Member of our Senate Committees, namely; the Standing Committee on Information and Technology, Committee on Lands and Natural Resources, Joint Committee on Broadcasting and Library and the County Monitoring and Evaluation Committee.

His dedication to his roles as a Committee Member and Senator enabled him to make significant contributions to the working and operations of these committees. On the Floor of the Senate, the Late Sen. Boy Juma Boy made passionate and witty contributions on debates in and out of the House that were usually filled with humuor but geared towards achieving improved service and wellbeing of his electorate. This won him profound admiration and respect by all the people across the political divide, old and young, educated and uneducated as well as his fellow leaders.

Hon. Senators, you may recall the Senate deliberations on the Mining Bill 2015, just recently during which the Late Senator offered invaluable contribution and great insight to ensure that Kwale residents would also benefit from the value of huge deposits of rare earth minerals in the county. The Late Sen. Boy Juma Boy will no doubt be remembered and missed by all of us for his Kiswahili Sanifu on the Floor of the Senate. I am certain that we can all attest to the fact that he had immense oratory skills and mastery of the Kiswahili language.

Hon. Senators, the Late Sen. Boy Juma Boy was always ready and willing to work in a bipartisan manner with his colleagues on matters of public good and national interest while remaining loyal to his party and coalition. We all thank God for the gift of Sen. Boy Juma Boy's life and pray that He will grant the family and friends of the late Senator and the great people of Kwale County comfort during this very difficult time.

May the soul of our late colleague, Sen. Boy Juma Boy, rest in eternal peace. I thank you and request that we all rise for a minute of silence in honor of our departed colleague.

### DISPOSAL OF THE CONSTITUTION OF KENYA (AMENDMENT) BILL, SENATE BILL NO.16 OF 2015

**The Deputy Speaker** (Sen. Kembi-Gitura): Hon. Senators, I have a short communication to give on the disposal of the Constitution of Kenya (Amendment) Bill, Senate Bill No.16 of 2015. I believe that is the Bill by Sen. Sijeny. I hope she is listening because I do not want to come back to it.

Hon. Senators, you will recall that on 28<sup>th</sup> December, 2016, during the Special Sitting of the Senate, this House voted on the Constitution of Kenya (Amendment) Bill, Senate Bill No.16 of 2015 by Sen. Sijeny, popularly known as the two-thirds gender Bill.

Article 256(1)(d) provides that a Bill to amend the Constitution shall be passed by Parliament when each House of Parliament has passed the Bill in both its second and third readings by not less than two-thirds of all Members of that House. This then means that for the Bill by Sen. Sijeny to pass at Second Reading, it must be supported by at least 45 Senators.

As you recall, the result of the division held on 28<sup>th</sup> December, 2016 was as follows: Ayes - 37, Noes - 6 and Abstentions - 3. From the result of the division, it was clear that the Bill did not attain the required threshold for it to pass Second Reading.

Hon. Senators, Standing Order No.63 provides as follows and I quote:-

"(1) In every instance where the Constitution lays down that a fixed number of Senators is necessary to support the moving of, or to decide any question on a Motion, any amendment Motion to such Motion shall not be passed unless supported by the fixed number of Senators required to pass the original Motion.

(2) Notwithstanding paragraph (1), whenever a Bill or a Special Motion that requires a special majority in the Senate fails to obtain the required majority when the question on the Bill or the Motion is put and the vote results in a majority of "Ayes" but the "Noes" have not numbered at least one third of all the Senators, the Speaker may direct that a further vote be taken on the particular question and the further vote shall be taken within five sitting days from the day the first vote was taken.

(3) If the Speaker does not direct a further vote under paragraph (2) or if on such further vote the fixed majority is not obtained, the Speaker shall declare that the Motion is negatived."

Hon. Senators, you further recall that the Speaker, while communicating the results of the division on the Bill, directed that pursuant to Standing Order No.63, a second opportunity will be afforded to this House to vote again on the Bill.

As indicated in the timelines, we have sitting days to vote again on this matter. For avoidance of doubt, today is the third day. The fifth day shall be on Wednesday, 22<sup>nd</sup> February, 2017. If the Bill will not have been voted on by then, I will declare the Motion on Second Reading of the Bill negatived. I hope that this House is now guided accordingly.

SENSITIZATION RETREAT ON THE KENYA DEVOLUTION SUPPORT PROGRAMME (KDSP)

Hon. Senators, I wish to inform you that the National Treasury has organized and invites all Senators to a sensitization retreat on proposals to have conditional allocations in the County Allocation of Revenue Bill. (2) Consider the proposed amendments to the County Allocation of Revenue Act 2016 and agree on a way forward so as to facilitate the flow of fund s and implementation of the proposed programme as contemplated.

(3) The retreat will discuss and agree on the way forward on the proposed allocations for the Kenya Devolution Support Programme for results for the financial year 2017/2018.

The retreat is scheduled to take place from 24<sup>th</sup> to 25<sup>th</sup> February 2017 this weekend at Simba Lodge Naivasha. Senators are expected to depart for Naivasha tomorrow evening Thursday 23<sup>rd</sup>, 2017.

#### THE SECOND ANNUAL LEGISLATIVE SUMMIT 2017

**The Speaker** (Hon. Ethuro): Hon. Senators, the second communication is on the Second Annual Legislative Summit 2017.

I am pleased to invite you to the Second Annual Legislative Summit 2017 which is scheduled to take place from 20<sup>th</sup> to 24<sup>th</sup> March, 2017, at Pride Inn Paradise Beach Resort Convention Centre and Spa in Shanzu, Mombasa County. The 19<sup>th</sup> and 24<sup>th</sup> March will be the travel dates. The theme of this year's Summit is 'Effective Legislatures for Sustainable Grassroots Development'. The event is jointly organised by the Senate and the County Assemblies Forum (CAF), in line with our shared constitutional mandate and obligation to conduct mutual relations on the basis of consultation and co-operation as required by Article 6(2) of the Constitution of Kenya (2010)

Hon. Senators, you will recall that the Inaugural Legislative Summit whose theme was 'Celebrating and Entrenching Devolution through Representation' was held at Flamingo Beach Resort, Mombasa County, in May 2016. This year's summit is primarily informed by the fact that the inaugural legislative bodies established by the Constitution of Kenya (2010) as part of the devolved system of government are now at the penultimate stages of their five year term. As such, the Senate, in collaboration with the CAF, need to meet in order to take stock of the gains made and to plan ahead of the next legislatures.

Hon. Senators, the objectives of this year's Legislative Summit are:-

(a) Take stock of the complementary law making, oversight and budgetary functions of the Senate and the county assemblies;

(b) To reflect on the period since the inception of the devolved system and to determine how stronger the institutions can be established, going forward;

(c) Interrogate the effectiveness of oversight tools in enhancing prudent use of national resources;

(d) Interrogate the measures that need to be taken during the transition period to receive the next legislatures;

(e) Enhance citizen participation and mainstream the needs of marginalized groups such as persons with disabilities, youth and women in devolved system of governance;

ADJOURNMENT OF THE SENATE SINE DIE

**The Speaker** (Hon. Ethuro): Hon. Senators, before I invite the Senate Majority Leader to move the Motion of Adjournment, allow me to make this Communication.

Hon. Senators, today marks the last day of the ordinary sittings of the Senate, and indeed Parliament, during the current eleventh term. As the Waswahili say, "*Kilicho na mwanzo, hakikosi mwisho*".

As we assemble here this afternoon, it is important to visualize where we have come from, on the role and mandate of the Senate, our experience over the last four and a half years, our achievements and challenges, as well as what we envision the next and indeed future Senate to be. Indeed, it has been encouraging; even those of you who have decided not to come back to the House should be our ambassadors out there.

Hon. Senators, you will recall that the first Senate existed in the immediate post-Independence period from 1963 until 1966, when the Provincial Assemblies were scrapped and the Senate itself got dissolved or rather merged with the House of Representatives to form one Kenya National Assembly. The Members of the Senate then were combined with those of the other House to form a unicameral legislature.

In the long journey that followed towards constitutional reforms, devolution of power and resources became a critical component as a means to address marginalization and promote equitable growth and development in all parts and regions of the Republic. This was realized with the enactment of the new Constitution of Kenya in 2010, which established the 47 counties that you represent in this august House.

The new Constitution reinstated the Senate as the primary institution charged with protecting and advancing the interests of counties and their governments, and, indeed, ensuring that the devolution experiment succeeds. Indeed, I could not be any happier than this week when the Senate stood ground for the umpteenth time on the quantum for the Division of Revenue Bill.

### (Applause)

This is a mandate I can affirm with confidence that the Senate has discharged to the best of its ability, and to the extent allowed under the Constitution. In the last four and a half years, the Senate has considered many Bills on various aspects affecting counties and devolution, in addition to Motions, Petitions, Statements, Reports and other Business transacted by the House over this period. There are also a number of key Bills listed for consideration by the Senate this afternoon that will need to be ably taken forward into the future.

Hon. Senators, it is sad that as this term comes to a close, only a few Bills originating from the Senate have been successfully passed by both Houses and assented to. This is a matter we have had extensive discussions about, going right to the architecture of the Constitution, and which I am sure will continue after this. But I can assure you the self-fulfilling prophesy of doom cannot cloud our resolve. It is my firm conviction, however, that the current situation is not what the framers of the Constitution and, indeed, Kenyans had, when re-establishing the Senate under the 2010 Constitution.

As Senators will recall, I have previously observed that the Senate was deliberately created by the people of Kenya as an organ of the national Government to perform specific functions, and especially to be a guardian angel of devolution, which goes to the heart of the constitutional order. I may add, if there is no Senate, there is no devolution and there is no need for a new Constitution.

It is, therefore, important that, as the Senate comes to the end of its first term, we re-look at the architecture of the Constitution, particularly as far as processing legislation between the two Houses is concerned, with a view to ensuring that the Senate effectively discharges its mandate under the Constitution and that a clear-cut distinction in mandate and operations be made between the lower and the upper Houses.

In addition to its representative, legislative and oversight roles, the Senate has achieved various milestones over the last four and a half years. Notable among them are relocation from the temporary Chamber to the permanent Chamber that we have now.

The same Senate also has in the last two years, successfully organized the Annual Legislative Summits bringing together the Senate, County Assemblies and key players in the devolution sector. During these summits, we have identified and soberly deliberated on the critical aspects of devolution, the gains and successes accomplished, difficulties encountered, and come up with resolutions and plans of specific action on the way forward, including ensuring devolution of all the functions that are supposed to be devolved under the Constitution. We have also taken our responsibility seriously to ensure that there is more cohesion amongst the players of devolution; a role that may not be appreciated by many, but extremely critical in laying the foundation of the new architecture.

The Senate has also participated in the capacity building of county assemblies, through bench-marking visits by Committees and Members of County Assemblies at the Senate, as well as through legislative attachments at the Senate for county assembly staff. In fact, our Committee on Information Technology developed what we call the model ECD classroom which a number of counties have been be able to adopt and actually build to specification.

Hon. Senators, in addition, the Senate has hosted dignitaries who have addressed the House, among them, the Speaker of the Senate of Rwanda, Hon. (Dr.) Jean Damascene Ntawukuliryayo, and the then Chief Justice and President of the Supreme Court of Kenya, Hon. Dr. Willy Mutunga.

The Senate has also been called upon to intervene in a number of critical events, at times to mediate conflicts and ensure the very survival of some county governments.

Examples include the Isiolo County Government and Makueni County Government, where the Senate adjourned business to attend to and help resolve the conflicts in these counties. Indeed, in the matter of Kericho Governor Impeachment, the Senate realised that this was more of a political issue and we invited our Senator to intervene and that matter was resolved amicably.

Senators will also recall that during debate on the Security Amendment Laws as well as the Electoral Amendment Laws, when the country appeared to be in crisis, it is the sobriety and bipartisan manner in which this Senate considered these matters that helped to lower tensions in the country and win the confidence and admiration of our people. Needless to say, you did not see any water being poured, any Order Paper being scattered and no stones thrown around.

#### (Applause)

Hon. Senators, I must admit you made me your proud Speaker. This year this country has not witnessed any demonstration along those lines.

The Senate has also faced its fair share of challenges, primarily with regard to fighting for the space to exercise its legislative and oversight mandates under Article 96 of the Constitution. As Senators will recall, this necessitated the Senate going all the way to the Supreme Court for an advisory opinion on the Senate's role in consideration of the annual Division of Revenue Bill and other Bills affecting counties. I must also confirm that we have always had our way in most of these judicial actions, for various good reasons, the least of which being that we have men and women of substance.

There have also been differences, at times, between the Senate and Governors, on the one hand, and between the Senate and County Assemblies, on the other. This is true for any human enterprise, especially of such complicated nature.

It is my hope that as we progress with entrenchment of the devolved system of governance in Kenya; as system that through hard labour, loss of limbs and lives some times, and the bicameral legislature established under the Constitution, we will find better ways of addressing and resolving these conflicts.

As the House proceeds to adjourn *Sine die* later this afternoon - I heard the Professor say that you pronounce it as it written, and you write it as pronounced. I was just assessing whether you have been good students.

Let me give some guidance with respect to a number of matters.

Firstly, regarding the question of what emoluments and benefits Senators will be entitled to on completion of this term, and when and how these are to be paid, the Clerk of the Senate is preparing a detailed circular that will be shared shortly with Senators on these issues as we agreed in the *Kamukunji* this week. The circular will also address matters of office space, handover of assets, as well as the expected transitions of staff serving at the Parliament and county offices of Senators.

Secondly, is the question of what business may be transacted by the Senate and its Committees once the Senate adjourns *Sine die*. The position, hon. Senators, is that both the House and its Committees will cease transacting Business, save for consideration of very urgent and important national issues, during which a Special Sitting of the Senate may be called. Accordingly, the sittings of all Committees stand suspended effective today.

One of the aspirations I expressed when addressing the first sitting of this Senate in March 2013, was that the Senate would become "a model legislative House for the country" and "offer the requisite inspiration, guidance and confidence" to the country and the region. I, therefore, urged Members of this House to conduct ourselves with decorum, consistently observe the due process and to uphold the rule of law, legality and the culture of constitutionalism.

I am proud to observe today that this aspiration has been realized, despite the many obstacles and challenges where the Senate mandate was challenged at every turn and twist. This House has continued to win the respect, admiration and confidence of Kenyans by the manner in which we have conducted ourselves and transacted business at a time when public confidence in Parliament and many other institutions is at their lowest.

On my part I undertook to be a faithful servant and diligently discharged my duties to this Senate and to the Republic. I further pledged to respect and uphold the rule of law and nurture the culture of constitutionalism, protect and defend our Constitution and always safeguard the role of the Senate. It is my sincere hope that as this term comes to an end, I will be judged to have firmly stood by these values and kept my promise to the Senate and Kenyans.

Let me, therefore, take this opportunity to convey my best wishes to all of you, Senators, many of you who have become friends and are contesting also for elections to various offices during the upcoming general elections. For those taking a break from Parliament, it is my hope that you will continue serving Kenyans faithfully and diligently in your many other capacities, for I know you are not limited in what you can do, either in private or public service elsewhere. I want to particularly appeal to those who will be joining the 'lower House' to remain our ambassadors.

Hon. Senators, as I conclude, let me express what a great honour and privilege it has been to serve this House and Kenyans as the first Speaker of the first modern Senate. I remain humbled by the immense confidence and trust you bestowed upon me, in entrusting me to serve us your Speaker of the inaugural Senate under the new Constitution and the support you have extended to my office throughout this term. For those of you who will be coming back, we will be counting on you and your votes. For those who will be helping our country elsewhere, know that you will remain Senator Soand-So, and that reputation will precede you in your future undertakings.

God bless you all; God bless Kenya. I thank you.
