PROPOSED AMENDMENTS BY THE COMMITTEE

Title of Bill

The Minister to insert the commencement date.

Clause 2.

- (1) Adopted with further amendments by inserting a definition of corrupt conduct before the definition of the word "investigator".

"Corrupt conduct" means:-

Conduct constituting corruption or economic crimes that takes place after this Act comes into operation.

- (2) The Minister should clarify the minister referred to in page 314 of the Bill. Currently the Permanent Secretary incharge of good governance is in the Office of the President.
- (3) Definition of "Unexplained assets" was adopted provided that the burden of proof must remain with the Commission and not the accused person.

- (1) Adopted with amendments. Insert the word "Deputy Director" after the word "Director" whenever the word "Director" appears in all clauses of the Bill.
- (2) Insert clause 5A before clause 6(1) and lift the contents of section 5 of the first schedule.
