BACKGROUND

Mr. Speaker Sir,

The Environment and Land Court Bill, 2011 was read a First Time on 23rd August 2011 and subsequently committed to the Departmental Committee on Lands and Natural Resources. The committee held its first sitting on this matter on 24th of August 2011 at Ten O'clock to deliberate on the bill and also received memorandum and oral submissions from the Law Society of Kenya, Kenya Land Alliance, Kenya Private Sector Alliance, Fida, the Kenya Chamber of Commerce and Industry, and Kenya Miners' Cooperative Society, and made some amendments. The Committee held its second sitting on the matter on 24th August, 2011 at Five O'clock and deliberated on the amendments and, adopted amendments.

This Report contains the deliberations of the Committee on the proposed amendments to the Bill.


