#### **EXECUTIVE SUMMARY**

Pursuant to Section 50 (5) of the National Government Constituencies Development Fund (NG-CDF) Act of 2015, the Select Committee on NG-CDF of the National Assembly is mandated to consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under the Act amongst others.

Section 43(1) and (2) of the National Government Constituencies Development Fund (NG-CDF) Act 2015 provides that:

- "(1) There is established a National Government Constituency Development Fund Committee for every constituency.
- (2) Each Constituency Committee shall comprise of—
- (a.) the national government official responsible for coordination of national government functions;
- (b.) two men each nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;
- (c.) two women nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;
- (d.) one person with disability nominated by a registered group representing persons with disabilities in the constituency in accordance with subsection (3); and
- (e.) two persons nominated by the constituency office established under Regulations made pursuant to the Parliamentary Service Act";

Further, Section 43 (3) and (4) provides that: -

- "(3) The seven persons referred to in subsection (2) (b), (c), (d) and (e) shall be selected in such manner and shall have such qualifications as the Board may, by regulations, prescribe.
- (4) The names of the persons selected under subsection (3) shall be submitted by the Board to the National Assembly for approval before appointment and gazettement by the Board."

In accordance to section 43(4) of the NG-CDF Act of 2015 which provides for submission of names by the Board to the National Assembly for approval before appointment and gazettement by the board and regulation 5(2a) which provides for appointment of members of constituency committees upon commencement of a new parliamentary term, the National Government Constituencies Development Fund Board forwarded names of eighty one constituencies and resubmitted nominees from 12 constituencies out of the 124 Constituencies that the house had approved that had inadvertent errors to the Select Committee on NGCDF for consideration and recommendation for approval by the National Assembly. The Committee considered the names and made a report on the same.

The Committee is grateful to the offices of the Speaker and Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. Finally, I wish to express my appreciation to the Honorable members of the Committee and the Committee secretariat who made useful contributions towards the preparations and production of this report.

On behalf of the Select Committee on National Government Constituencies Development Fund and pursuant to provisions of Standing Order 199(6), it is my pleasant privilege and honor to present to this House the report of the Committee on its consideration of the list of nominees of the National Government Constituencies Development Fund Committees for eighty one (81) Constituencies and resubmitted nominees from 12 Constituencies for approval by the House before appointment and gazettement by the Board.

#### 1.0 PREFACE

#### 1.1 ESTABLISHMENT OF THE COMMITTEE

- 01. The Select Committee on National Government Constituency Development Fund is established in accordance with the provisions of section 50 of the National Government Constituency Development Fund Act, 2015 and its functions include:
  - a) To oversee the implementation of this Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act;
  - b) To oversee the policy framework and legislative matters that may arise in relation to the Fund;
  - c) To continually review the framework set out for the efficient delivery of development programmes financed through the Fund;
  - d) To consider and report to the National Assembly, with recommendations, names of persons required to be approved by the National Assembly under this Act; and
  - e) To carry out any other functions relevant to the work of the Fund.

# MIN NO. NA/DAAOSC/NG-CDF/19/2022: CONSIDERATION OF THE BUDGET CEILING FOR CONSTITUENCIES FOR THE FINANCIAL YEAR 2022/2023

The committee considered the budget ceiling for the financial year 2022/2023(attached) as submitted by the NGCDF Board by scrutinizing on compliance requirements to confirm that the 2022/2023 financial year allocation to the fund was in conformity with the law, as follows: -

#### 1. Compliance with Section 4(1) Of The NG-CDF Act

The total allocation to the NG-CDF for the year2022/2023 financial year is forty-four billion, two hundred eighty -nine million, nine hundred thousand shillings (Ksh.44,289,900,000.00)

Based on the Division of Revenue Act 2022, the National Government 's share of Revenue for 2022-2023 financial year is one trillion, seven hundred sixty-four billion, ninety-nine million, seven hundred sixty thousand four hundred sixty-six shillings (Ksh1,764,099,760,466.00). This means that the total allocation to the NG-CDF for the financial year 2022/2023 financial year of Kshs.44,289,900,000.00 is 2.51 per cent of the National Government's share of the Revenue.

Therefore, the Ksh.44,289,900,000.00 allocated to NG-CDF in the year 2022/2023 financial year meets the legal threshold of a minimum of 2.5% of the National Government's share of revenue as determined by the Annual Division of Revenue Act.

#### 2. Compliance with section 4(3) of the NG-CDF Act

The allocation of the fund for the year 2021/2022 financial year was Ksh.41,714,800,000.00. The amount of Ksh.44,289,900,000.00 allocated to the fund in 2022/2023 financial year ,is more than amount allocated in the preceding year, and therefore meets the threshold as provided by section 4(3) of the Act.

# Proposed Budget Ceilings for each Constituency for the 2022/2023 financial year

The determination of the budget ceilings for each constituency is based on the following facts:

a) The total allocation to NG-CDF: Ksh.44,289,900,000.00

b) Allocation to NG-CDF Board: Ksh.2,214,495,000

c) Emergency Reserve: Ksh.2,214,495,000

d) Constituencies' shareable amount: Ksh.39,860,910,000

e) A.I.A declared by 34 constituencies: ksh.16,305,580.00

The shareable amount is subjected to the criteria stipulated in section 34 of the ND-CDF Act as follows:

75% to be shared in equal proportion: (75% of ksh.39,860,910,000) = Ksh.29,895,682,500/=

25% of the constituencies sharable amount equivalent to Ksh.9,965,227,500 to be allocated based on the number of wards in each constituency.
