Re: SUBMISSION OF TWELFTH BATCH OF NOMINEES TO THE NATIONAL GOVERNMENT CONSTITUENCIES DEVELOPMENT FUND COMMITTEES FOR NATIONAL ASSEMBLY APPROVAL & RESUBMISSION OF NDHIWA CONSTITUENCY NOMINEES

I. TWELFTH BATCH

Reference is made to the above matter and our letter Ref: **NG-CDFB-CEO-KNA/VOL VI (03)** dated 24th November 2022 submitting the eleventh batch of nominees to NG-CDF Committees for various constituencies.

As noted in our letter Ref: **NG-CDFB/CEO-KNA/VOL V (62)** dated **November 03, 2022**, Section 43(1) and (2) of the National Government Constituencies Development Fund (NG-CDF) Act 2015 states that:

“(1) There is established a National Government Constituency Development Fund Committee for every constituency.

(2) Each Constituency Committee shall comprise of —

- (a.) the national government official responsible for coordination of national government functions;*
- (b.) two men each nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;*
- (c.) two women nominated in accordance with subsection (3), one of whom shall be a youth at the date of appointment;*
- (d.) one person with disability nominated by a registered group representing persons with disabilities in the constituency in accordance with subsection (3); and*
- (e.) two persons nominated by the constituency office established under Regulations made pursuant to the Parliamentary Service Act”;*

Vision: Equitable socio-economic development countrywide



Further, Section 43 (3) and (4) provides that: -

“(3) The seven persons referred to in subsection (2) (b), (c), (d) and (e) shall be selected in such manner and shall have such qualifications as the Board may, by regulations, prescribe.

(4) The names of the persons selected under subsection (3) shall be submitted by the Board to the National Assembly for approval before appointment and gazettelement by the Board.”

And as further noted and pursuant to the provision of Regulation 5(2)(a) of the National Government Constituencies Development Fund Act Regulations, 2016, the Board issued circular Ref: NG-CDFB/ CEO/CIRCULARS / Vol. II (033) dated September 15, 2022, setting in motion the constitution of constituencies’ committees. In light hereof, the Board has received and processed additional submissions from Seven (7) constituencies.

Based on the foregoing and in compliance with section 43(4) of the National Government Constituencies Development Funds Act, we herewith forward names of the under listed Seven (7) constituencies for consideration and approval by the National Assembly before gazettelement by the Board.


