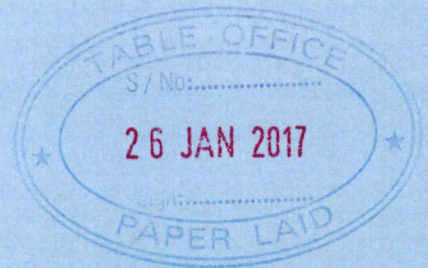

## II. FORWARD BY THE CHAIRMAN CONSTITUENCY DEVELOPMENT FUND COMMITTEE (CDFC)

It is my pleasure to present to you Kisumu Central CDF's annual report and financial statement for the financial year 2014/2015. In the year under review, we are pleased with our overall performance which aligns very well with our vision and also our proven track record of constituent delivery and value for money.

The actual amounts utilized by the constituency in its various expense items were more than 50% of its budget performance; however the target should be 100% if funds are availed in time during the financial year.

### Key achievements for the CDF

- By providing funds directly to each constituency for fighting poverty, CDF assists in ironing out regional imbalances due to patronage.
- CDF has been able to open rural access roads (feeder roads) thus contributing to economic growth
- Through the Health Sector CDF has it possible for the public to easily access health facilities
- Water projects have been implemented to enhance access to clean and reliable water.
- In the education sector, CDF funding of schools has assisted in increasing students enrolment, the CDF bursary has helped retain in schools students from low income families.

### Emerging issues related to the CDF

Entrenching CDF Act in the new constitutional dispensation, since it is facing a lot of legal challenges, hence Members of Parliament should enact legislations which do not contravene the constitution in order to protect the CDF.

### Implementation challenges and recommended way forward

- Late disbursement of funds, lead to rise in project costs due to factors like inflation due to time value of money and also public do not get the value of the funds in time, a good case is in late bursary awards, to remedy this, funds should be released by CDF Board in time.
- Frequent development forums and awareness forums should be held to intuit the public with information concerning the development initiatives, from various funding agencies and stakeholders and CDF, County Government and other development stakeholders plan together to avoid duplication of projects.
- Lack of a simple but standardized practical curriculum for training PMC's in order to enhance their capacity to implement the projects, hence a PMC training manual should be operationalized.

**III. STATEMENT OF CONSTITUENCY MANAGEMENT RESPONSIBILITIES**

Section 81(1) of the Public Finance Management Act, 2012 requires that, at the end of each financial year, the accounting officer for a national government entity shall prepare financial statements in respect of that entity. Section 81(3) requires the financial statements so prepared to be in a form that complies with relevant accounting standards as prescribed by the Public Sector Accounting Standards Board of Kenya from time to time.

The Fund Account Manager in charge of the Kisumu Central *CDF* is responsible for the preparation and presentation of the Constituency's financial statements, which give a true and fair view of the state of affairs of the Constituency as at the end of the financial year ended on June 30, 2014. This responsibility includes: (i) maintaining adequate financial management arrangements and ensuring that these continue to be effective throughout the reporting period; (ii) maintaining proper accounting records, which disclose with reasonable accuracy at any time the financial position of the constituency; (iii) designing, implementing and maintaining internal controls relevant to the preparation and fair presentation of the financial statements, and ensuring that they are free from material misstatements, whether due to error or fraud; (iv) safeguarding the assets of the constituency; (v) selecting and applying appropriate accounting policies; and (vi) making accounting estimates that are reasonable in the circumstances.

The Fund Account Manager in charge of the Kisumu Central *CDF* accepts responsibility for the Constituency's financial statements, which have been prepared on the Cash Basis Method of Financial Reporting, using appropriate accounting policies in accordance with International Public Sector Accounting Standards (IPSAS) and relevant legal framework of the Government of Kenya. The Fund Account Manager is of the opinion that the Kisumu Central *CDF* financial statements give a true and fair view of the state of Constituency's transactions during the financial year ended June 30, 2014, and of the Constituency's financial position as at that date. The Fund Account Manager in charge of the Kisumu Central *CDF* further confirms the completeness of the accounting records maintained for the Constituency, which have been relied upon in the preparation of the Constituency financial statements as well as the adequacy of the systems of internal financial control.

The Fund Account Manager in charge of the Kisumu Central *CDF* confirms that the entity has complied fully with applicable Government Regulations and that the Constituency's funds received during the year under audit were used for the eligible purposes for which they were intended and were properly accounted for. Further the Fund Account Manager confirms that the Constituency's financial statements have been prepared in a form that complies with relevant accounting standards prescribed by the Public Sector Accounting Standards Board of Kenya.

### REPORT OF THE AUDITOR-GENERAL ON CONSTITUENCIES DEVELOPMENT FUND-KISUMU CENTRAL CONSTITUENCY FOR THE YEAR ENDED 30 JUNE 2015

#### REPORT ON THE FINANCIAL STATEMENTS

I have audited the accompanying financial statements of Constituencies Development Fund-Kisumu Central Constituency set out on pages 5 to 17, which comprise the statement of assets as at 30 June 2015, and the statement of receipts and payments, statement of cash flows and summary statement of appropriation recurrent and development for the year then ended, and a summary of significant accounting policies and other explanatory information, in accordance with the provisions of Article 229 of the Constitution of Kenya and Section 8 of the Public Audit Act 2003. I have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of the audit.

#### **Management's Responsibility for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with International Public Sector Accounting Standards (Cash Basis) and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

The management is also responsible for the submission of the financial statements to the Auditor-General in accordance with the provisions of Section 7 of the Public Audit Act, 2003.

#### **Auditor-General's Responsibility**

My responsibility is to express an opinion on these financial statements based on the audit and report in accordance with the provisions of Section 9 of the Public Audit Act, 2003 and submit the audit report in compliance with Article 229 (7) of the Constitution. The audit was conducted in accordance with International Standards of Supreme Audit Institutions (ISSAIs). Those standards require compliance with ethical requirements and that the audit be planned and performed to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation

and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

## **Basis for Qualified Opinion**

### **1.0 Cash and Cash Equivalent**

A review of the bank reconciliations indicated that there were un-cleared deposits credits totaling Kshs.206,000 thus understating the revenue reported. In the circumstances, the accuracy of the cash and cash equivalent balance of Kshs.17,961,287 reflected in the statement of financial for the year ended 30 June 2015 could not be confirmed.

### **2.0 Disiltation and Drainage of Alwera Swamp**

Included in Other Grants and Transfers figure of Kshs.54,240,332 is Kshs.1,100,459.74 paid to supplier for distillation of Alwera Swamp Project. The following were noted,

- i. The management did not avail documentary evidence as to how a sum of Kshs.200,000 included in the bill of quantities as contract supervision under the payment to Democo Supplies was utilized.
- ii. No certificates from line ministry were made available for our audit.
- iii. During physical verification of the project on 22/12/2015, the management of Kisumu Central Constituency did not disclose as to what extent the services were carried out and it therefore appeared doubtful as to whether any work was actually carried out.

In the absence of the supporting documents, it was not possible to confirm the propriety of expenditure.

### **3.0 Construction of Police Posts**

#### **3.1 Migosi Police Post**

Included in Other Grants and Transfers figure of Kshs.54,240,332 is Kshs.2,700,000 paid to a contractor for construction of Migosi Police Post. The Project Management



Committee was paid a total of Kshs.2,700,000 while the contractor had accepted to carry out the work at a sum of Kshs.2, 099, 975. Leading to overpayments of Kshs.600,025. Works totalling Kshs.71,536 as included in the bill of quantities were not carried out.

The propriety of Kshs.71,536 paid to the contractor for work not done and overpayments of Kshs 600,025 could not be confirmed.

### **3.2 Nyalenda B Police Post**

Included in other grants and transfers figure of Kshs.54, 240,332 is Kshs.2,700,000 paid to a contractor for construction of Nyalenda Police Post. The following were noted:

- i. The Project Management Committee was paid a total of Kshs.2,700,000 while the contractor had accepted to carry out the works at a sum of Kshs.2,100,792.
- ii. Physical verification revealed that the floor had huge gaping cracks and only one coat of paint to walls internally an indication of poor workmanship.
- iii. Works as detailed in the bill of quantities totalling Kshs.83,090 was not carried out and provisional sums of Kshs.116,000 which was not accounted with documentary evidence.

It was not possible to confirm the propriety of the expenditure.

### **Qualified of Opinion**

In my opinion, except for the effect of the matters described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of Constituencies Development Fund-Kisumu Central Constituency as at 30 June 2015, and of its financial performance and its cash flows for the year then ended, in accordance with International Public Sector Accounting Standards (Cash Basis) and comply with the Constituencies Development Fund Act, 2013

### **Other Matter**

#### **1. Budget implementation analysis**

A total of Kshs.87,199,706 was allocated to the Constituency Development Fund during the year to finance several projects in the 2014-2015 budget period which the CDF were required to implement within the financial year. However, only Kshs.54,797,764 had been spent on 12 projects, which represent only 63% of the funds allocated as follows:

The following were noted:

- i. The actual expenditure was Kshs.87,199,706 against a budget of Kshs.54,797,764 achieving 63% absorption
- ii. The constituency under spent on eight (8) items with a total expenditure of Kshs.37,597,940 and overspent on three (3) items with a total of Kshs.8,695,993.
- iii. The expenditure shows that other bursary and environment had the highest over expenditure and no explanation was provided for the material variations, and neither were reallocations regularized through supplementary budget before the end of the financial year
- iv. The Included in the total payments of Kshs.88,501,201 in the statements of receipts and payments is expenditure of Kshs.33,703,437 which relates to 2013-2014 which were rolled over to the financial year 2014-2015.
- v. As at 30th June 2015, the reconciled bank balance was Kshs.16,201,287, however some of the projects were not undertaken.

The public did not received the services as provided for in the approved budget.


## 2. Construction of Flood Lights

Included in other grants and transfers figure of Kshs.54,240,332 is Kshs.6,068,129 paid to a contractor for construction of ten (10) flood lights in Migosi ward. The following were noted.

- i. Quotation was used as opposed to open tender which contravened section 29 (1) of the Public Procurement and Disposal Act 2005
- ii. Payments were paid without the inspection and acceptance team contrary to section 17 of the Public procurement and Disposal Regulations 2006.

It was not possible to confirm the propriety of the expenditure.

My opinion is not qualified in respect of these matters.

## **VIII. SIGNIFICANT ACCOUNTING POLICIES FOR THE YEAR ENDED 30 JUNE 2015**

The principle accounting policies adopted in the preparation of these financial statements are set out below:

### **a) Statement of compliance and basis of preparation**

The financial statements have been prepared in accordance with and comply with International Public Sector Accounting Standards (IPSAS) with particular emphasis on Cash Basis Financial Reporting under the Cash Basis of Accounting and relevant legal framework of the Government of Kenya. The financial statements comply with and conform to the form of presentation prescribed by the Public Sector Accounting Standards Board of Kenya.

The financial statements are presented in Kenya Shillings, which is the functional and reporting currency of the Constituency and all values are rounded to the nearest thousand (Kshs'000). The accounting policies adopted have been consistently applied to all the years presented.

The financial statements have been prepared on the cash basis following the Government's standard chart of accounts. The cash basis of accounting recognises transactions and events only when cash is received or paid by the Constituency.

### **b) Recognition of revenue and expenses**

The Constituency recognises all revenues from the various sources when the event occurs and the related cash has actually been received by the Constituency. In addition, the Constituency recognises all expenses when the event occurs and the related cash has actually been paid out by the Constituency.

### **c) In-kind contributions**

In-kind contributions are donations that are made to the Constituency in the form of actual goods and/or services rather than in money or cash terms. These donations may include vehicles, equipment or personnel services. Where the financial value received for in-kind contributions can be reliably determined, the Constituency includes such value in the statement of receipts and payments both as revenue and as an expense in equal and opposite amounts; otherwise, the contribution is not recorded.

**d) Cash and cash equivalents**

Cash and cash equivalents comprise cash on hand and cash at bank, short-term deposits on call and highly liquid investments with an original maturity of three months or less, which are readily convertible to known amounts of cash and are subject to insignificant risk of changes in value. Bank account balances include amounts held at various commercial banks at the end of the financial year. For the purposes of these financial statements, cash and cash equivalents also include short term cash imprests and advances to authorised public officers and/or institutions which were not surrendered or accounted for at the end of the financial year.

*SIGNIFICANT ACCOUNTING POLICIES (Continued)*

**e) Receivables and payables**

Receivables are funds due to the Constituency at the end of the financial year from the CDF Board and other sources but not yet received while payables are funds due to other parties at the end of the financial year but not yet paid. As receivables and payables do not involve the receipt or payment of cash in the reporting period, they are recorded as 'memorandum' or 'off-balance' items to provide a sense of the overall net cash position of the Constituency at the end of the year. When the receivables or payables are finally settled, such payments are included in the statement of receipts and payments in the year in which the payments are made.

**f) Budget**

The budget is developed on the same accounting basis (cash basis), the same accounts classification basis, and for the same period as the financial statements. The Constituency's budget was approved as required by Law and as detailed in the Government of Kenya Budget Printed Estimates. A high-level assessment of the Constituency's actual performance against the comparable budget for the financial year under review has been included in an annex to these financial statements.

**g) Comparative figures**

This is the first year the Constituency is preparing financial statements and hence we do not have comparative figures.

**h) Subsequent events**

There have been no events subsequent to the financial year end with a significant impact on the financial statements for the year ended June 30, 2015.
