A Bill for an Act

ENTITLED

**THE EAST AFRICAN COMMUNITY
APPROPRIATION ACT, 2023**

An Act of the Community to appropriate a sum of United States Dollars one hundred and three million, eight hundred and forty-two thousand, eight hundred and eighty out of the budget of the Community to meet expenditure for the organs and institutions of the Community for the financial year ending 30th June, 2024.

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Appropriation Act, 2023 and shall be deemed to have come into force on the 1st day of July, 2023. Short title and Commencement.
2. Appropriation of the sum of United States Dollars one hundred and three million, eight hundred and forty-two thousand, eight hundred and eighty is allowed out of the budget of the Community to meet expenditure of the organs and institutions of the Community, as specified in the Schedule, for the financial year ending 30th June, 2024. Appropriation for financial year ending 30th June, 2024.
