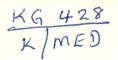

ANNUAL REPORT OF THE ASIAN AND ARAB HOSPITAL FUND AUTHORITY

In accordance with the provisions of section 18 (1) (a) of the Hospital Treatment Relief (Asian and Arab) Ordinance No. 57 of 1959, the Asian and Arab Hospital Fund Authority established under the Ordinance is required to furnish within a period of seven months after the end of each financial year, a report of its operation during that year together with a balance sheet and receipts and payments account audited by the Controller and Auditor-General, or such other auditor as may be appointed.

The Authority now has pleasure in submitting its Report for the year ended 31st December, 1962—the third year of operation supported by Audited Accounts.

BENEFITS

- 3. The Authority is required to pay out of the Fund a daily allowance of such amount and in respect of such period as may be prescribed towards the cost of fees necessarily incurred for hospital treatment received by a Contributor.
 - 4. Benefits payable as at 31st December, 1962 were as follows:-
 - (i) Hospital Treatment Allowance Sh. 30 per day.

(ii) Maternity Cases Sh. 30 per day, inclusive of mother and child or children.

- (iii) Domiciliary Midwifery Allowance of Sh. 125 in respect of the day upon which a child is born.
