In Act of Parliament to provide for the review by the Electoral Commission of the number and the boundaries of the parliamentary constituencies into which Kenya is divided, preparatory to the creation of a larger number of constituencies for the reform of the National Assembly, and for matters incidental thereto and connected therewith

ENACTED by the Parliament of Kenya, as follows:----

der. 1. This Act may be cited as the Parliamentary Constiody uencies (Preparatory Review) (No. 2) Act 1966.

2. (1) In this Act, "the Constitution" means the Constition of the Republic of Kenya contained in Schedule 2 of he Kenya Independence Order in Council 1963, as amended y the Constitution of Kenya (Amendment) Act 1964, the onstitution of Kenya (Amendment) (No. 2) Act 1964, the onstitution of Kenya (Amendment) Act 1965, the Constiution of Kenya (Amendment) Act 1966, the Constiution of Kenya (Amendment) Act 1966, and the Constitution of Kenya (Amendment) (No. 3) Act 1966.

(2) Save where the context otherwise requires, expressions sed in this Act have the same meaning as in the Constiution, and section 247 of the Constitution shall apply for the purposes of interpreting this Act as it applies for the purposes of interpreting the Constitution.

3. (1) In anticipation of the amendment of the Constiution for the reform of the National Assembly, the Electoral commission shall, as soon as practicable and in accordance with the provisions of this section, review the number and boundaries of the constituencies into which Kenya is wided, and shall, by order, prescribe the number and the coundaries of the constituencies in accordance with the revisions of this section and make such alterations of existing coundaries as it considers desirable in the light of that review.

## Parliamentary Constituencies (Preparatory Review) (No. 2)

## (2) The number of constituencies into which Kenya shall be divided by the order made under this section shall be 158

(3) The order made under this section shall create in each District and in the Nairobi Area one constituency in addition to the number of constituencies into which that District or Area is divided at the time of the passing of this Act.

(4) For the purposes of subsection (3) of this section a An Act constituency shall be treated as being in a District or in the Nairobi Area if, in the estimation of the Commission, not less than 80 per cent of the inhabitants of that constituency are inhabitants of that District or of the Nairobi Area, as the Amendr case may be.

(5) In the exercise of its functions under this section day as th the Electoral Commission shall apply the provisions of sub-2. sections (3) and (6) of section 49 of the Constitution, as if the princ the review made under this section were a review made under that section of the Constitution, but the Commission shall (a) i not be required to have regard to the provisions of subsection (2) of that section.

(6) The order made by the Commission under this section shall be published in the Kenya Gazette, but shall not come into effect until it is brought into effect by an Act of Parliament which amends the Constitution for the reform of the National Assembly.

4. Nothing in this Act shall affect subsections (6) and (7) of section 10 of the Constitution of Kenya (Amendment) Act 1965.
