The functions of this Departmental Committee as established under Standing Order No. 198 are:-

(i) To investigate, inquire into, and report on all matters relating to the mandate, management, activities,

- administration, operations and estimates of the assigned Ministries and Departments;
- (ii) To study the programme and policy objectives of the Ministries and Departments and the effectiveness for the implementation;
- (iii) To study and review all legislation referred to it;

- (ii) Ministry of Planning, National Development & Vision 2030
- (iii) Ministry of Industrialization
- (iv) Ministry of Tourism
- (v) Ministry of Trade

Public Procurement Oversight Authority (PPOA) is one of the State Corporations under the Committee's line ministry of the Office of the Deputy Prime and Ministry of Finance. The Public Procurement Oversight Authority Board through a competitive process recommended the appointment of Mr. Maurice Juma Jone Oduor as the Director General of the Authority.

Consequently the Board wrote to the Deputy Prime Minister and Minister for Finance to facilitate parliamentary approval of the appointment pursuant to section 10(2) of the Public Procurement & Disposal Act of 2005. The Minister communicated the same to Parliament and the matter was referred to the Departmental Committee on Finance, Planning & Trade.

The Committee held a meeting with the Public Procurement Oversight Authority Board on 7th October, 2010 during which the Committee was appraised on the recruitment process. The Committee supported and approved the Advisory Board's recommendation and resolution to appoint Mr. Maurice Juma Jone Oduor to the position of the Director General.

## 2.0 INTRODUCTION

The Public Procurement Oversight Authority and Public Procurement Oversight Advisory Board are established by the Public Procurement & Disposal Act of 2005. The Act creates the position of Director General who is the Chief Executive Officer of the Authority.

The appointment of the Director General is governed by section 10 of the Public Procurement & Disposal Act which provides that:-

- (i) The Authority shall have a Director General who shall be the Chief Executive Officer of the Authority and who shall be responsible for its direction and management.
- (ii) The Director General shall be appointed by the Authority with the approval of Parliament.
- (iii) To be appointed as the Director General, a person must:-
  - (a) Have a university degree in commerce, business administration, economics, engineering or a related field of study from a recognized university;
  - (b) Have a professional qualification in supply management from a reputable organization;

- (c) Have experience in management; and
- (d) Be of outstanding honesty and integrity.

The requirements for the position were formulated by the Public Procurement Oversight Advisory Board with the following, though not limited, considerations:-

- ♦ Compliance with the Act which is mandatory.
- Benchmarking, regionally, internationally with similar organizations.
- ◆ Professional experience, management, competence, technical knowledge with advanced academic qualifications as an advantage.
- ♦ Understanding of issues related to the PPOA, good governance, reform especially procurement.
- Experience and leadership in a similar position.
- Communication skills and ability to respond to stakeholders.
- ♦ Job evaluation and organization structure report.
- ◆ Integrity and membership of good standing to a professional body where applicable.

# 3.0 RECRUITMENT PROCESS

In accordance with the mandate conferred on the Public Procurement Oversight Advisory Board by the Act, the Board engaged the services of a Human Resource consultancy firm to initiate the recruitment process and conduct the short-listing of prospective candidates in a transparent and fair manner.

- (i) The advertisements were placed in the following local dailies:- the Nation; the Standard and the East African on 23<sup>rd</sup> October and 26<sup>th</sup> October, 2009. This was a re-advertisement after the first recruitment process was completed in May, 2009 with unsatisfactory results.
- (ii) Registration of applicants was done online and out of 88 applicants received by the consultants, only 54 were duly completed. Applications were received both from Kenya and Uganda. Only 17 candidates were short-listed out of which twelve (12) were male and five (5) were female.
- (iii) First interviews were conducted by the consultants on 25<sup>th</sup> –27<sup>th</sup> November, 2009 attended by 16 candidates. The Consultant firm presented its report to the Advisory Board on 27<sup>th</sup> November, 2009 in which ten (10) candidates (7 male & 3 female) were selected and invited for the final interviews.
- (iv) The final interviews were conducted by the Members of the Advisory Board on 14th and 15th December,

2009 attended by only 8 candidates. The candidates were scored individually by each Board Member and the top five (5) then proceeded to the next stage of due diligence by the National Security Intelligence Service, Kenya Revenue Authority and Kenya Anti-Corruption Authority.

# 3.3 ADVISORY BOARD RESOLUTION AND RECOMMENDATION

Further to the results of the due diligence report received, the Advisory Board in its meeting held on 17th March, 2010 recommended by unanimous resolution, subject to parliamentary approval, the appointment of Mr. Juma, Maurice Jone Oduor to the position of Director General on the following grounds:-

- ◆ Technical knowledge with advanced academic qualifications.
- Professional and management experience since he has been acting for two years since September 2008 todate and therefore has leadership experience in the position.
- ♦ Has been dealing with high-level government officers and has received favourable responses from the ministries.
- ♦ Has international exposure.

The Advisory Board's recommendations were presented to the Deputy Prime Minister and Minister for Finance on 19<sup>th</sup> March 2010, for onward submission to Parliament for approval.

# 4.0 **COMMITTEE'S RECOMMENDATION**

The Committee held a meeting with the Public Procurement Oversight Advisory Board on Thursday 7<sup>th</sup> October, 2010 during which the Board appraised the Committee on the recruitment process.

The Committee unanimously supported the Advisory Board's resolution and recommended that Mr. Juma, Maurice Jone Oduor should be appointed to the position of Director General.

# APPOINTMENT OF THE DIRECTOR GENERAL OF PUBLIC PROCUREMENT OVERSIGHT AUTHORITY (PPOA)

The Chairperson, Public Procurement Oversight Advisory Board informed the Committee that:-

- (i) PPOA has no substantive Director General and Mr. Maurice J. O. Juma has been serving in as an Acting Interim Director General since September 2008 to-date.
- (ii) The appointment of the Director General of PPOA is governed by section 10 (2) of PPOA Act, 2005 which provides that the Director General shall be appointed by the Authority Board with the approval of Parliament.
- (iii) The Advisory Board engaged the services of a Human Resource firm in October 2009 to undertake the recruitment process and conduct the short-listing of prospective candidates for the position of the Director General.
- (iv) The advertisements were placed in the local dailies and registration of applicants was online. Out of 88 applications received only 54 were duly completed.
- (v) First interviews were conducted by the Consultants in November, 2009 while the final interviews for 8 candidates was done by the Advisory Board in December, 2009.
- (vi) The top five (5) candidates were then subjected to the next stage of due diligence

by the National Security Intelligence Service, Kenya Revenue Authority, and Kenya Anti Corruption Commission.

# EVIDENCE BY HON. AMOS KIMUNYA, MP ON CHARTERHOUSE BANK

Hon. Amos Kimunya, MP informed the Committee that the decision to place Charterhouse Bank under statutory management during his tenure as the Minister for Finance was informed by the following:-

- (i) The adverse publicity on Charterhouse Bank in the media and the matter having been officially brought in Parliament thereby causing jittery among international corresponding banks.
- (ii) The perceived risk on the stressed Charterhouse Bank that would trigger off

effects on other commercial banks hence the need to avert a run on other banks and restore confidence in the banking industry.

(iii) Recommendations by CBK as the regulator to safeguard the depositors, shareholders and the banking industry following its inspections audit reports on Charterhouse Bank.

## MINUTE NO. 133/2010 COMMITTEE'S OBSERVATIONS

- (i) The Statutory Manager did not perform her duties and the intention appears to have Charterhouse Bank closed as the Manager proceeded to close the Bank immediately, wrote to CBK to suspend the Bank from Clearing House and commissioned a forensic audit on the Bank.
- (ii) There is no evidence on the perceived fear or a run on Charterhouse Bank due to the adverse publicity to justify its closure.
- (iii) The Minister for Finance exempted other commercial banks from the provisions of sections 13(1) (d) of the Banking Act which Charterhouse Bank was being accused of violating.
- (iv) There is apparent act of omission by the government on the outcome of the allegations on the Bank to assure the public and restore the confidence in the banking industry. Therefore, it is apparent that the government is not interested in protecting the interest of the depositors.
