## FOREWORD

This report is a summary of proceedings and resolutions of the 5th Conference of the Association of Parliamentary Librarians of Eastern and Southern Africa (APLESA) held in Windhoek, Namibia from 18th to 23rd July, 1999.

Sir, the Association of Parliamentary Librarians of Eastern and Southern Africa (APLESA) is a Professional Association which was formed in 1994 in Harare, Zimbabwe. The objectives of the Association are summarised as follows:

### (i) to establish an information exchange;

### (ii) to create a forum for networking and resource-sharing in the sub-region.

APLESA is also committed to identifying training needs (formal and informal) of its member libraries and the means which such needs may be addressed. This is necessary to ensure that Parliamentary libraries in the sub-region are managed and administered professionally for the effective delivery of information to Parliamentarians and their support staff. Since its inception in 1994, APLESA has held five meetings:

## SUMMARY OF CONFERENCE PROCEEDINGS

The conference was inaugurated at a ceremony held on the 18th July at C1 Parliament Conference Room by His Excellency the Ambassador of Finland to Namibia, Mr Kari Karanko. Among other notable personalities who addressed the conference included:-

Sir, the 5th APLESA conference began its work at the Hotel Safari Conference Room in Windhoek on the 18th of July, with the Chair-person reading a letter of encouragement and well-wishing from the Chair-person of the IFLA Parliamentary Library Section, Jennifer Tanfield; self introduction by participants and presentation of country reports.

Delegations from 12 countries took part in the work of the conference. There was a total of 26 delegates including two resource persons and 3 delegates attending as observers and translator respectively.

During the general debate of the conference, we discussed problems related to the implementation of the resolutions taken in Lusaka in 1998, with many participants devoting much of their statements to the situation of the dwindling library budgets which all participants unanimously agreed that was the cause of inefficiency in the provision of information services to Members of Parliament.

The issue of computerisation of Parliamentary libraries in order to facilitate resource-sharing among member libraries was once again brought up. It was sad to note that only two member libraries, that is, the Kenya National Assembly Library and the Parliament Library of Swaziland, which were not connected to the Internet. An urgent call was therefore made to the two libraries to take urgent measures to get internet connection so as to enable fulfil their Client's information needs and also to facilitate Parliamentary resource-sharing and resource-sharing within the sub-region.

## **RESOLUTIONS**

The following resolutions on the major issues of discussion were adopted by the 5th conference of the Association of Parliamentary Librarians of Eastern and Southern Africa (APLESA):-

- 1. To rigorously market APLESA by coming up with a directory of each member library which would be placed on the APLESA website before the year 2000 conference and to promote networking within APLESA member countries;
- 2. To facilitate capacity building through attachments and study visits and to promote exchange between member countries;
- 3. To ensure that all knowledge produced in the country made accessible to Parliamentarians. Each Parliament should be given Legal Deposit Status.
