

#### 1. INTRODUCTION

#### 2. First Quarter, Third Session of the Ninth Parliament

As one of the three arms of Government, Parliament carries out the Legislative role of the Government. Since independence, Kenya has had eight Parliaments, the current one being the ninth one. The Third Session of the Ninth Parliament was inaugurated by his Excellency the President on Tuesday March 30, 2004.

As provided by the Constitution, Parliament is composed of 224 Members of whom 210 are elected 12 nominated and two *ex-officio* Members -the Speaker and the Attorney General.

During the Third Session, the ruling coalition, National Rainbow Coalition (NARC) has a majority of 132 Members, KANU 68 while Ford-People has 15 Members. FORD-A, Shirikisho Party of Kenya and Safina has two Members each while, Sisi kwa Sisi Party has one Member.

NARC has seven nominated members, KANU four and Ford People one.

The current Session has a total of 17 Lady-Members of whom 10 are nominated. This is the highest number of Lady-Members in independent Kenya.

#### 3. Legislative and Procedural Services Department

The Legislative and Procedural Department is one of the three Departments of the Clerk's Chambers. The Mission of the Department is to provide Professional Support and advice to Members in order to facilitate the discharge of their legislative duties efficiently and effectively. The Department renders procedural and operational services that includes; processing of Motions, Parliamentary Questions, and Bills; Preparation and circulation of Orders of the Day and subsequent Votes and Proceedings, and Weekly Parliamentary Programme; Custodian of Parliamentary documents and handling matters related to the Commonwealth Parliamentary Association and the Inter-Parliamentary Union.

The internship programme aims at demystifying parliament and equipping young Kenyans, who have just graduated, with the necessary information and skills to better understand their Parliament and the legislative process. The current interns, of the Third Session of the Ninth Parliament, are the third lot of interns to have joined the National Assembly with the previous interns having been with the National Assembly in 2002 and 2003.

This report is a highlight of the proceedings of the first quarter of the Third Session of the Ninth Parliament.

#### 6. BILLS

Section 30 of the constitution vests the legislative power of the Republic in the Parliament of Kenya, which consists of the President, and the National Assembly. Legislative power is exercisable by Bills enacted by the Assembly.

The procedure for the introduction and enactment of Bills is provided for in both the Constitution and the Standing Orders of the National Assembly.

In the first quarter, a total of 8 Bills were presented (7 substantive and 1 Amendments) all introduced by the Government. (Schedule annexed)

#### 7. MOTIONS

A Total of 46 Motions were introduced by Members, 37 of them from the National Rainbow Coalition Party, 7 from the Official Opposition KANU, and 1 from Ford People.

16 Motions were adopted. Only one Motion was rejected, which was from the government side, while 31 Motions are pending debate.

#### 8. QUESTIONS

In its oversight role, Parliament has provided for a period for questions through which Members can inquire into the activities and performance of the Government on issues of concern. In this session, a total of 133 questions were submitted, of which 53 were questions by Private Notice while 80 were by Ordinary notice. Of these 86 were answered, while 29 deferred and 2 dropped. The 2 dropped questions were questions by Private Notice, while of the 29 deferred, 10 were of Private Notice while 19 were Ordinary.
