### MEETING HELD ON WEDNESDAY 11TH SEPTEMBER 1907

### QUESTIONS

Questions 7, 8, 9 and 10 were asked and answers given by the Honourable mem#bers concerdned.

# OSTRICH BILL SECOND READING

The Crown Advocate moved the Second Reding of a Bill to authorise the issuing of licences to ostrich farmers for collecting of eggs of wild ostriches and for capturing the young wild ostriches.

The Senior Commissioner seconded and this was agreed to without dissent.

# COUNCIL INTO COMMITTEE

The Crown Advocate moved that the Council go into Committee to consider this Bill.

The Senior Commissioner seconded and this was agreed to without dissent.

# Section 9

Mr & Wilson moved to insert "Rs 15" instead of "Rs 300" in Section 9.

Lord Delamere seconded and this was agreed to without dissent.

#### Section 15

Lord Delamere moved to delete Section 15.

The Treasurer seconded.

On the question being put there voted for the motion the Treasurer, the General Manager Uganda Railway, Lord Delamere and Mr Wilson. The Crown Advocate, the Senior Commissioner and the Land Commissioner voted against the motion.

The motion was carried.

# Section 16

Mr Wilson moved to insert " European" before " Police" in section 16, subsection 2 and 3.

The Grown Advocate seconded and this was agreed to without dissent.

The Treasurer moved to insert " with a Magistrate's order " after " orficer" in section 16, subsection 2 and 3

Lord Delamere seconded.

On the question being put, there voted for the motion the Treasurer, Lord Delamere and Mr Wilson. The Land Commissioner, the Senior Commissioner, the Crown Advocate and the General Manager Uganda Railway voted against the motion.

The motion was lost.

The Treasurer moved to insert " of or above the rank of Inspector" after " officer" in section 16, subsection 2 and 3.

Lord Delamere seconded and this was agreed to without dissent.

# Section 22.

The Crown Advocate moved to insert " Thus of proving such possession being on the owner " after " Ordinance" in Section 22.

Lord Delamere seconded and this was agreed to without dissent.

### Section 24

The Crown Advocate moved to delete "any"
to "Protectorate" inclusive in Section 24 and to insert
the following:

"When any Magistrate European Police
officer above the rank of Inspector
Game Ranger of Assistant Game Ranger" and
to insert at the end of the section.

" Provided however that no Game Ranger

" or Assistant Game Ranger shall exercise this power except in cases of emergency in which case he shall report to a

Magistrate as soon as possible".

The Snier Commissioner seconded and this was agreed to without dissent.

#### Section 26

The Grown Advocate moved to insert the word "European" before the word "Police" in each instance in Section 26 (1) and the words "Game Ranger or Assistant Game Ranger "after the word "Officer" in each instance in Section 26 (1).

The Treasurer seconded and this was agreed to without dissent.

### Section 2

Lord Delamere moved that the word "six" shall become "three" in Section 2

The General Manager Uganda Railway seconded and this was agreed to without dissent.

The Crown Advocate then moved that the Bill be now . reported to the Council.

The Senior Commissioner seconded and this was agreed to without dissent.

After debate the Bill was reported to the Council.

The Crown Advocate in Council gave notice that he would move the Third Reading of this Bill at the next meeting of the Council.

### VOULUNTEER BIL -- COMMITTEE STAGE

The Crown Advocate moved that the Council go into Committee to consider this Bill to amend the East Africa Volunteer Reserve Bill (Ordinance) of 1905.

# Section 5

The Crown Advocate moved the insertion of the following section No 5:

"No Goanese or Parsi shall be admitted as a memeber of the corps until and unless there shall be atleast fifteen of such willing to become memebers of such coprs".

The Treasurer seconded and this was agreed to without dissent.

# Section 6\*

The Crown Advocate moved the insertion of the following section No 6:

"The Goanese and Parsi members of the corps shall be formed it no a separate company half company or section as the case may be, any officer of which above the rank of section Commander shall be a European member of the corps elected by European members of the corps."

The General Manager Uganda Railway seconded and this was agreed to without dissent.

#### Section 7

The Crown Advocate moved the insertion of the following section No 7

should the number of Goanese or Parsi
memphers of a corps fall below fifteen
the Goansese and Parsi Company half Company
or section as the case may be shall be
disbanded and the arms and ammunition
issued to the members shall be returned
to the Government."

The General Manager Uganda Railway seconded and this was agreed to without dissent.

### Section 8

The Crown Advocate moved the insertion of the following Section No 8:

"The Goansese and Parsi memebers of the corps shall not be entitled to vote on a delation of an officer above the rank Section Commander under Section 2 of the Principal Ordinance or at any general or special meeting of the memebers of the corps other than the election of the Section Commander to their own sections".

The General Manager Uganda Railway seconded and this was agreed to without dissent.

The Crown Advocate moved that the Bill be now reported to the Council.

The Senior Commissioner seconded and this was agreed to without dissent.

After debate the Bill was reported to the Council.

The Crown Advocate gave notice of the Third Reading of this Bill at the next meeting of the Council.
