



FOREWORD

The Statute Law (Miscellaneous Amendments) Bill, (National Assembly Bills, No. 60 of 2022) (hereinafter referred to as "the Bill") was read a First time on 8th December, 2022 and referred to the respective Committees for consideration and report to the House. The Bill proposes to make minor amendments to several Acts of Parliament including the Tourism Act, No. 28 of 2011.

In line with Article 118(1)(b) of the Constitution and Standing Order 127(3), the Committee sought public views and received memoranda from Office of the Director of Public Prosecutions.

On behalf of the Departmental Committee on Tourism and Wildlife and pursuant to the provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the report on the consideration of the Statute Law (Miscellaneous Amendments) Bill, (National Assembly Bills, No. 60 of 2022)

The Committee is grateful to the offices of the Rt. Hon. Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. The Committee further wishes to thank all stakeholders who submitted their comments on the Bill. Finally, I wish to express my appreciation to the Honourable Members of the Committee and the Committee Secretariat who made useful contributions towards the preparation and production of this report.

It is my pleasure to report that the Committee has considered the Statute Law (Miscellaneous Amendments) Bill, (National Assembly Bills, No. 60 of 2022), and has the honour to report back to the House with the recommendation that the Bill be proceeded with.

1. PREFACE

1.1 Mandate of the Committee

The Departmental Committee on Tourism and Wildlife is one of the twenty Departmental Committees of the National Assembly established under **Standing Order 216** whose mandate pursuant to the **Standing Order 216** (5) is as follows: -

- (a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- (b) study the programme and policy objectives of ministries and departments and the effectiveness of the implementation;
- (c) on a quarterly basis, monitor and report on the implementation of the national budget in respect of its mandate,
- (d) study and review all legislation referred to it;
- (e) study, assess and analyze the relative success of the ministries and departments as measured by the results obtained as compared with their stated objectives;
- (f) investigate and inquire into all matters relating to the assigned ministries and departments as they may deem necessary, and as may be referred to them by the House;
- (g) examine treaties, agreements and conventions;
- (h) make reports and recommendations to the House as often as possible, including recommendation of proposed legislation,
- (i) consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
- (j) examine any questions raised by Members on a matter within its mandate.

2. OVERVIEW OF THE STATUTE LAW (MISCELLANEOUS AMENDMENTS) BILL, (NATIONAL ASSEMBLY BILLS, No. 60 of 2022)

- 6. The Statute Law (Miscellaneous Amendments) Bill (National Assembly Bills, No. 60 of 2022) seeks to make minor amendments to various statutes
- 7. The Bill is in keeping with the practice of consolidating minor amendments which do not merit the publication of separate Bills into one Bill.
- 8. The Bill proposes to amend Section 116 of the Tourism Act, No. 28 of 2011 by deleting the term "Attorney-General" appearing immediately after the words "leave of the" and substituting therefor the term "Director of Public Prosecutions".
- 9. The principal object of the amendment is to harmonize Section 116 of the Tourism Act, 2011 with the provisions of Article 157 of the Constitution in relation to the exercise of prosecution powers of the State.

3. PUBLIC PARTICIPATION/STAKEHOLDER CONSULTATION

- 10. Pursuant to Article 118(1)(b) of the Constitution and Standing Oder 127(3), which mandate Parliament to facilitate public participation and involvement in its legislative and other business, the Committee placed an advert in the local dailies on 16th December, 2022 inviting the public to submit their views to the Clerk of the National Assembly on or before 6th January, 2023.
- 11. The Committee received one memorandum from Office of the Director of Public Prosecutions
- 12. In processing the Bill, the Committee took into account the memoranda received from the public and its deliberations. The stakeholders submitted as follows:-
- 13. The Office of the Director of Public Prosecutions submitted that Section 116 of the Act be amended by deleting the term "Attorney-General" and substituting therefor the term "Director of Public Prosecutions" In their justifications, they submitted that the proposal will bring the provision of the Act into conformity with Article 157 of the Constitution. That the proposal is acceptable as it aligns the Act with the Constitution.

4. COMMITTEE OBSERVATION

14. The Committee considered the amendment proposed to Section 116 of the Tourism Act, No. 28 of 2011 *vide* the Statute Law (Miscellaneous Amendments) Bill (National

15. Assembly Bills, No. 60 of 2022) and observed that Article 157 of the Constitution establishes the Office of the Director of Public Prosecutions and mandates the Director of Public Prosecutions to exercise State powers of prosecution including the power to undertake criminal proceedings against any person who is alleged to have committed an offence.

5. COMMITTEE RECOMMENDATIONS

16. The Committee considered the amendment proposed to Section 116 of the Tourism Act, No. 28 of 2011 *vide* the Statute Law (Miscellaneous Amendments) Bill (National Assembly Bills, No. 60 of 2022) and recommended that Bill be proceeded with as proposed.

MIN. NO. NA/TW/2023/53: PRESENTATION OF THE BUDGET POLICY STATEMENT BRIEF BY THE BUDGET OFFICE.

The fiscal analyst Ms. Terry Ondiko made a presentation of the brief on Budget Policy Statements for the state Department for Tourism and the State Department for Wildlife

as per the attached annexures and as indicated in the summary below.

Sectoral Policy priorities in the BPS

- 1. Tourism plays a critical role in economic growth and development. Its contribution to economic diversification and foreign exchange earnings is critical in reducing reliance on a single industry and thus making the country more resilient to economic shocks, resulting in more stable and long-term growth. In order to support the industry, the government will concentrate on a bottom-up job-creating tourism industry by:
 - i. Fostering a tourism ecosystem that supports independent travel, especially for young people, which includes quality and secure low-cost hotels and bedand-breakfast facilities, inexpensive low-cost air travel to all parts of the country, and safe road travel.
 - ii. Diversifying Kenya's tourism by promoting niche market products, particularly adventure, sport, and cultural tourism
 - iii. Diversifying source markets to include African markets.
- 2. The State Department for Tourism implements three programmes. These are: Tourism Promotion and Marketing, Tourism Product Development and Diversification and the General Administration Planning and Support Services. The total proposed ceiling for the State Department is KSh. 8,431.2 million of which the recurrent ceiling is KSh. 8,167.1 million and the development ceiling is KSh. 264.1 million.

State Department for Wildlife.

1. Even though the government is looking into using insurance, allocating money towards human-wildlife conflict compensation has been a strategic action. Furthermore, a substantial amount is spent on mitigating strategies, such as building fences and employing rangers to patrol.

3.2.2 Sectoral Expenditure Ceilings

Table 3 provides a summary of the Programme Expenditure Ceilings for the State Department for Wildlife

2. The total proposed ceiling for the State Department is KSh 10,440 million, of which KSh 8,244.6 million is allocated for recurrent expenses and KSh 7,985.8 million is allocated for development. The ceilings show an increase of 30.7% from the approved estimates for 2022/2023. The Kenya Wildlife Service set a target of 3.8 million park visits overall, an increase from the baseline of 2.7 million tourists in 2022/2023. Furthermore, the revenues generated are anticipated to rise from KSh. 2,200 million in 2022/2023 to KSh. 4,300 million in 2023/2024.

B. JUSTIFICATION

- 1. In considering the proposed amendment, the Committee is required to determine whether the amendment conforms to the Constitution.
- 2. Article 157 of the Constitution establishes the office of the Director of Public Prosecutions and mandates the Director of Public Prosecutions to institute and undertake criminal proceedings against any person in respect of any offence alleged to have been committed.
- 3. Section 116 of the Tourism Act grants prosecutorial powers to an authorized officer to prosecute an offence committed under the Act. This is in concurrence with the provisions of the Criminal Procedure Code.
- 4. The proposed amendment seeks to amend section 116 to delete the term "Office of the Attorney-General" and substitute therefor the term "Office of the Director of Public Prosecution".
- 5. The amendment is in order as it seeks to align the provisions of the Act with Article 157(6) of the Constitution.

The Committee recommended that the amendment be proceeded with as proposed.
