Mr. Speaker Sir,

The Constitutional Implementation Oversight Committee is established under Section 4 of the Sixth Schedule to the Constitution with the mandate of overseeing the implementation of the Constitution. The Constitution requires that the Committee shall:

- (a) receive regular reports from the Commission on the Implementation of the Constitution on the implementation of the Constitution including reports concerning
 - (i) the preparation of the legislation required by the Constitution and any challenges in that regard;
 - (ii) the process of establishing the new commissions;
 - (iii) the process of establishing the infrastructure necessary for proper operation of each county including progress on locating offices and assemblies and establishment and transfers of staff;
 - (iv) the devolution of powers and functions to the counties under the legislation contemplated in section 15 of the Sixth Schedule to the Constitution; and
 - (v) any other impediments to the process of implementing this Constitution;
- (b) coordinate with the Attorney General, the Commission on the Implementation of the Constitution and relevant parliamentary committees to ensure the timely introduction and passage of the legislation required by the Constitution; and
- (c) take appropriate actions on the reports including addressing any problems in the implementation of the Constitution.

Mr. Speaker Sir,

On 27th July 2011 the Speaker informed the House that pursuant to Article 171 (2) (h) of the Constitution which provides for the membership of the Judicial Service Commission (JSC) as including: - one woman and one man to represent the public, not being lawyers, appointed by the President with the approval of the National Assembly, on 21st July, 2011, the Clerk of the National Assembly received a letter from the Office of the Permanent Secretary to the Cabinet and Head of the Public Service advising the National Assembly that, following the resignation of Bishop Anthony Muheria from the JSC and after consultations between His Excellency the President and the Right Hon. Prime Minister, His Excellency the President had nominated Rev. Dr. Samuel Kobia to take up the vacant position of Commissioner in the JSC.

The Speaker then directed that the name and the Curriculum Vitae of Rev. Dr. Samuel Kobia be referred to the Constitutional Implementation Oversight Committee (CIOC) for consideration prior to approval by the House. He further directed that the Committee tables its report on the nominee on or before Tuesday, 2nd August, 2011.

As directed, the Committee held a meeting with the nominee on Tuesday 2nd August, 2011 at 10.00a.m. The Nominee made submissions on why he should be appointed to serve in the Judicial Service Commission. The Committee deliberated on the suitability of the nominee to serve in the Judicial Service Commission and found him qualified for appointment to the Judicial Service Commission.

The Committee therefore recommends that pursuant to Article 171 (2) (h) of the Constitution, the House should approve the appointment of Rev. Dr. Samuel Kobia to the Judicial Service Commission.

BACKGROUND

- 1. The Judicial Service Commission is established under Article 171 of the Constitution of Kenya
- 2. On 23rd February, 2011 Parliament passed the Judicial Service Bill, 2011. The Bill was assented to by H. E. the President on 21st March, 2011 and published on 22nd March, 2011.
- 3. Article 171 of the Constitution states that: -
- (1) There is established the Judicial Service Commission.
- (2) The Commission shall consist of:
 - (a) the Chief Justice, who shall be the chairperson of the Commission;
 - (b) one Supreme Court judge elected by the judges of the Supreme Court;
 - (c) one Court of Appeal judge elected by the judges of the Court of Appeal;
 - (d) one High Court judge and one magistrate, one a woman and one a man, elected by the members of the association of judges and magistrates;
 - (e) the Attorney-General;
 - (f) two advocates, one a woman and one a man, each of whom has at least fifteen years' experience, elected by the members of the statutory body responsible for the professional regulation of advocates;
 - (g) one person nominated by the Public Service Commission; and
 - (h) one woman and one man to represent the public, not being lawyers, appointed by the President with the approval of the National Assembly.
 - (3) The Chief Registrar of the Judiciary shall be the Secretary to the Commission.
 - (4) Members of the Commission, apart from the Chief Justice and the Attorney-General, shall hold office, provided that they remain qualified, for a term of five years and shall be eligible to be nominated for one further term of five years.
- 4. Article 172 of the Constitution provides that the Judicial Service Commission shall promote and facilitate the independence and accountability of the judiciary and the efficient, effective and transparent administration of justice and shall—
- (a) recommend to the President persons for appointment as judges;
- (b) review and make recommendations on the conditions of service of: -
 - (i) judges and judicial officers, other than their remuneration; and (ii) the staff of the Judiciary;

- (c) appoint, receive complaints against, investigate and remove from office or otherwise discipline registrars, magistrates, other judicial officers and other staff of the Judiciary, in the manner prescribed by an Act of Parliament;
- (d)prepare and implement programmes for the continuing education and training of judges and judicial officers; and
- (e) advise the national government on improving the efficiency of the administration of justice.

In the performance of its functions, the Commission shall be guided by the following: —

- (i) competitiveness and transparent processes of appointment of judicial officers and other staff of the judiciary; and (ii) the promotion of gender equality.
- 5. On 27th July, 2011, the Honourable Speaker in a communication to the House referred the name of Rev. Dr. Samwel Kobia to the Constitutional Implementation Oversight Committee for vetting and directed the Committee to submit its recommendations on the nominee to the House on Tuesday, 2nd August, 2011.

CONSIDERATION OF THE NOMINEE BY THE COMMITTEE

Rev. Dr. Samwel Kobia was nominated to serve in the Judicial Service Commission in line with Article 171 (2) (h) by H. E. the President through a letter to the Clerk of the National Assembly dated 21st July, 2011.

At a meeting held on 2nd August, 2011, the Committee examined the candidate against the criteria set out in the Second Schedule to the *Commission on the Implementation of the Constitution Act, 2010* (Criteria for vetting/approval of nominees for appointment to public office by the National Assembly). That criterion requires nominees to disclose information on their personal and professional life including their political affiliations, tax compliance and potential conflict of interests and other things.

Nomination of Rev. Dr. Samwel Kobia to the serve in the Judicial Service Commission

The Committee having considered the curriculum vitae of Rev. Dr.

Samwel Kobia, and having heard his submissions during the interview, made the following observations on his nomination to the JSC:-

- i. That Rev. Dr. Samwel Kobia is a Kenyan citizen born on 20th March, 1947 and holds a Doctorate Degree in Divinity from Christian Theological Seminary, Indianapolis, Indiana, USA, a Masters in City Planning from Massachusetts Institute of Technology, Cambridge, Mass, USA, a Diploma in Urban Ministry from the Institute on Urban and Industrial Society at MacCormick Theological Seminary, Chicago, USA and a Diploma in Theology from St. Paul's United Theological College.
- ii. He is currently an Ecumenical Special Envoy to Sudan where he provides high level diplomacy and advocacy on Sudan for the All Africa Conference of Churches and the World Council of Churches
- iii. He has served as Secretary General of the World Council of Churches and is a member of several organizations including All Africa Conference of Churches, National Council of Churches of Kenya and Africa Council of Elders, Africa Monitor, South Africa among others.
- iv. He has fully complied with his tax obligations to the State and has never been dismissed from office for contravention of provisions of Article 75 of the Constitution which deals with conduct of state officers or adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
- v. He is not a member of any political party and does not expect any conflict of interest to arise
- vi. He has never been charged in a court of law for any offence
- vii. The Committee found the nominee qualified.

RECOMMENDATIONS OF THE COMMITTEE

The Committee noted that the nominee had the experience and qualifications required for appointment to the Judicial Service Commission.

The Committee having considered the curriculum vitae of the nominee, and having met and examined the nominee during the meeting of 2nd August, 2011, unanimously recommends that: -

Pursuant to Article 171 (2) (h) of the Constitution, this House approves Rev. Dr. Samuel Kobia for appointment to the Judicial Service Commission.

The committee discussed this matter and noted there was need to fast truck the bills so as to comply with the Constitution. The Committee resolved to convene an urgent meeting on Thursday, August 4, 2011 for all stakeholders to discuss this matter and chart a way-forward. The following should be invited to the meeting:-

- (x) The Deputy Prime Minister and Minister for Finance
- (xi) The Minister for Labour
- (xii) The Head of Public Service
- (xiii) The Permanent Secretary Office of the Prime Minister

- (xv) The Chairman Commission on Revenue Allocation

It was further resolved that:

(i) The stakeholders are persuaded to surrender the bills to parliament for publishing.

- (ii) The Committee requests the House Business Committee to increase the sitting time of the House to include Tuesday and Thursday mornings.
- (iii) The committee to form at least three sub-committees to consider the bills.
- (iv) The House Business committee is requested to operationalise the Justice and Legal Affairs committee to help in the consideration of Bills.

The committee considered the conduct of the Commission for the Implementation of the Constitution and in particular pronouncements made by the Chairperson on the implementation process.

It was observed that the Chairperson was working in total disregard of other implementing organs including Parliament.

It was noted that whereas the Committee was willing to support the Commission, the CIC was overstepping its mandate by purporting to interpret the Constitution.

It was resolved that this matter be addressed during the consultative meeting on Thursday, August 4, 2011

MIN. NO. 104/2011: VETTING OF REV. DR. SAMUEL KOBIA

The Chairperson welcomed the nominee to the meeting and instructed the administration of Oath to the nominee. The nominee was informed that the Vetting Procedure was being done in accordance with the Judicial Service Act, 2011. He was informed that he had been nominated by the President on July 21st, 2011 to replace Bishop Antony Muheria who had resigned from the Commission.

Rev. Dr. Samuel Kobia informed the Committee that he was a Kenyan citizen born in Meru on March 20, 1947 and that:

- (i) He holds a Doctor of Divinity (D.D) from Christian Theological Seminary, Indianapolis (1993), a Masters in City Planning from Massachusetts Institute of Technology (1978), a Diploma in Urban Ministry from the Institute of Urban and Industrial Society at McCormick Theological Seminary and a Diploma in Theology from St.Paul's United Theological College (1971).
- (ii) He works as the Ecumenical Special Envoy to Sudan, All Africa Conference of Churches and World Council of Churches.
- (iii) He was the General Secretary World Council of Churches (WCC), 2003-2010. He was a special representative of the WCC- General Secretary For Africa, Director, Cluster on issues and Themes, WCC, 2001, Executive Director, Justice, Peace and Creation, WCC, 1998. He was the General Secretary, National Council of Churches of Kenya (NCCK) 1987-1993. He has been an Executive Director, Secretary and Industrial advisor to NCCK. He was the organizing secretary Christian Students' council of Kenya and interim secretary World Student Christian Federation, Africa Region, 1973.

- (iv) He holds many honours and awards including, Senior Fellow, Geneva school of Diplomacy and International Relations, 2010, Martin Luther King Peace Award by Polytechnic University of Nicaragua, 2008, Doctor of Divinity Honoris Causa, The Academy of Ecumenical Indian Theology and Church Administration, 2006, Ambassador for peace by Interreligious federation for peace, Geneva, 2005, Honorary professor, University of Buenos Aires, Argentina among many others.
- (v) He is a member ,Board of Directors of Tiso Foundation of South Africa, Chancellor of St. Paul's University, Kenya, Member of Globethics.net Foundation, Geneva, Member, Club of the Hague, Honorary President World Congress of Religious for peace, New York, Member, Africa Council of Elders, Africa Monitor, South Africa and Advisor, Christian/Muslim dialogue programme for Africa.
- (vi) He has published many writings including, Called to the One Hope, WCC Press (2006), The Courage of Hope, WCC Press(2003), The Quest for Democracy in Africa, NCCK Publications(1992) among many others.
- (vii)He has fully complied with his tax obligations to the State and has never been adversely mentioned in any investigatory report of Parliament or any Commission of Inquiry.
- (viii) He is not a member of any political party and has never been charged in a court of law.

Members also sought clarifications from Rev.Dr.Samuel Kobia on the following issues:-

- (i) His opinion on what ails the Judiciary and his proposals on how to deal with the problem.
- (ii) His capacity to accommodate divergent views considering that church leadership is usually not flexible and does not divergent views.
- (iii) Relevance of his International experience to his appointment to the Judicial Service Commission.
- (iv) Will he be available to serve in the JSC considering his other assignments?
- (v) His contribution to city planning

In response, Rev. Dr. Samuel Kobia informed the Committee that:-

(i) The Judiciary is the custodian of justice and is critical in ensuring implementation of the Constitution and its name has been seriously tarnished in the past. It has also not measured to people's expectations in addition to being associated with corruption and incompetence. The Judicial Service commission should therefore endeavor to restore public confidence to the Judiciary. He

- believes that the Judicial Service Commission should work towards restoring the confidence of the Judiciary. He also believes that the terms of service of all judicial staff should be improved.
- (ii) He recognizes that the Constitution does not provide for any state religion. He believes that he is impartial, believes in richness of diversity and would not champion any Christian rights and believes that all religions must be respected. He believes that he is flexible and not rigid in outlook either as a theologian or a person.
- (iii) He believes that he would be bringing in values that uphold justice, whether local or international.
- (iv) He previously served as an industrial advisor while working for the NCCK.He was also instrumental in the introduction of microfinance and has always opposed demolitions of poor people's homes.
- (v) His position as Ecumenical Envoy to Sudan will be done on advisory basis thereby creating time for his role in the Judicial Service Commission.
