2.0 Executive Summary

The Library Committee is a Parliamentary Committee established by Standing Order No. 193 and is mandated, amongst other functions to make proposals and consider suggestions for improvement of the Parliament library. During the period July to December 2009, the Committee held seven (7) meetings where it deliberated on various issues affecting the provision of effective and efficient information services to Members of Parliament and Parliamentary staff. In order to familiarize itself with the available library and research facilities in Kenya and lobby for the modernization of the Parliament library, the Committee, in its sittings, resolved to conduct study tours to both public and private libraries and research institutions within and outside the country. The committee conducted its first study tour to Maseno University Libraries, Moi University Libraries and Kenya National Library Services (KNLS) Kisumu Branch Library to inspect the available library and research facilities in the institutions for benchmarking purposes. The team met and held discussions with senior university personnel, university librarians, KNLS branch librarian and senior personnel in the KNLS Branch library on issues affecting library development in the country. The team found out that libraries in the institutions were faced with several challenges, which included lack of space, limited funding and poor infrastructure. The team recommended that the government should allocate more funds for library development as information was a critical enabler in the achievement of Vision 2030.

3.0 Committee Activities

Mr. Speaker, Sir,

According to section (2) of the Standing Order No. 193 the Deputy Speaker, by virtue of his office, is the Chairman of the Library Committee. The Committee held its first sitting on Friday July 31, 2009 where Hon. Silas Ruteere was elected as the Vice-Chairman of the Committee.

During the period July – December, 2009, the Committee held seven (7) sittings where it deliberated on various issues affecting the provision of effective and efficient information services to Members of Parliament and Parliamentary staff.

3.1 Orientation of the Parliament Library

The Committee was taken on an orientation tour of the library to familiarize itself with the available facilities and services offered by the library. Members visited the library in Main Parliament Building and the Archives in the basement of County Hall. Members noted with concern that the library lacked adequate room for expansion and that the Archives location posed a threat to the documents' safety. Members were, however, informed that the library had already started digitizing its collection as a back-up measure in case of any disaster. The Committee recommended that National Assembly should consider putting up a modern purpose-built library to cater for the growing population of Members of Parliament and Parliamentary staff.

3.2 Library Sub-Committee

During its first sitting, the Committee resolved to constitute a Sub-Committee to look into ways of strengthening the services currently offered by the departments of Library, Research and Information and Communication Technology (ICT), which fall under the mandate of the

Committee. The following members were nominated to the Sub-committee: Hon. Farah Maalim, M.P. – Chairman; Hon. Sammy Mwaita, M.P. – Vice-Chairman; Hon. Walter Nyambati, M.P. and Hon. Benson Mbai, M.P. The Sub-Committee held its first meeting with the three Heads of Department on September 01, 2009, where they discussed various issues and challenges facing the departments in the provision of efficient and effective services.

3.3 Local Study Tour of the Library Committee

Mr. Speaker, Sir,

To familiarize itself with the available library and research facilities in both public and private institutions in the country, Parliament organized the first local study tour of the Committee since its inception in 1954 to two public university libraries and Kenya National Library Services (KNLS) branch Library. The study tour took place from November 03 – 07, 2009, and members visited three public institutions, namely: Maseno University, Moi University and KNLS branch library in Kisumu.

During the study tour of the public institutions, the team had an opportunity to meet and hold discussions with senior university personnel, university librarians and branch librarians on various issues affecting library development in the country. The team also toured libraries in the institutions to see the available library and research facilities.

Mr. Speaker Sir,

In Maseno University, the team toured four libraries situated within the University as well as a branch library in City Campus, Kisumu. The five libraries visited were:

(i). College Campus Library

The library is situated at College Campus and it houses the administrative offices, technical services and the bindery unit. The collection is on Humanities.

(ii). Siriba Campus Library

The library is situated at Siriba Campus. The stock is mainly on Science and Technology, including Mathematics and Statistics. There is also an Africana Collection (Materials on Africa or by Africans).

(iii). Resource Centre Library

This library is also situated at Siriba Campus and its holdings are on Education and Social Sciences.

(iv). School of Graduate Studies Library

This library is also situated at College Campus and the collection comprises materials on Research and Development Studies. It also has a collection of Maseno University dissertations/theses and tertiary level publications on various academic fields.

(v). City Campus Library, Kisumu

The library serves students registered for courses at the City Campus, Kisumu. The materials in the library are on higher education in all fields.

Mr. Speaker, Sir,

In Moi University, the team visited two (2) of the thirteen (13) branch libraries of Moi University, namely The Margaret Thatcher Library and Chepkoilel Campus Library, respectively.

(i). The Margaret Thatcher Library (MTL)

This is the main University Library and is located at the Main Campus of Moi University. The library's overall administration operates from the MTL building which accommodates both library and School of Information Sciences. The MTL serves the Schools of Information Sciences, Engineering, Arts and Social Sciences, Education, Environmental studies, Law, Business Management and Economics, and Human Resource Management. It is also a depository for all the theses and other research findings produced in the University. It also houses a collection of artefacts from different communities in Kenya.

(ii). Chepkoilel Campus Library

Chepkoilel Campus library is located seven (7) kilometres from Eldoret town. The branch library serves the Schools of Agriculture and Biotechnology, Business and Economics, Science and Natural Resources.

Mr. Speaker, Sir,

The team also visited the KNLS branch library in Kisumu, where they were taken around the library by the branch librarian. The team also held discussions with the KNLS staff on issues affecting the management of the KNLS libraries.

Mr. Speaker, Sir,

Besides visiting the libraries, the team also visited some income generating projects in Maseno and Moi Universities. The team was informed that the Universities had come up with the projects to supplement government funding, as was the case of Moi University which receives 50% of its total funding from the government. On the other hand, Maseno University only relies on its

income generating projects to run the University as it does not receive any funding from the government.

Mr. Speaker, Sir,

In Maseno University, the team visited the Maseno University Hospital and the Kisumu Hotel. The University hospital is located at Siriba College Campus and caters for the University population and the surrounding community. Members were informed that the University had plans to start a medical school in the near future. The Kisumu hotel, which is located in Kisumu city, is managed by the staff and students of Maseno University. The staff and students also have a live band which provides entertainment to its hotel customers.

Mr. Speaker, Sir,

In Moi University, the team visited the Rift Valley Textiles (RIVATEX) East Africa Ltd. factory in Eldoret town and Dairy, Beekeeping and Fish farms in Chepkoilel Campus.

The team was taken round the RIVATEX factory which is currently operating on half capacity due lack of funds to purchase modern equipment; and the factory shop where the team had an opportunity to buy the finished products at factory price. The factory also has a tailoring wing which makes garments using the factory's products.

The team also had an opportunity to see different breeds of dairy cattle, bee hives, as well as fish ponds in Chepkoilel Campus. The visit enlightened the team on the benefits of fish farming, which is part of the Economic Stimulus Programme earmarked for implementation in one hundred and forty (140) constituencies by the Ministry of Finance.

Mr. Speaker, Sir,

During the study tour of the libraries, the team made the following observations:

(1). Apart from the Margaret Thatcher Library which is a modern purposebuilt library, the expansion of the universities had put pressure on the available library facilities, especially in Maseno and Chepkoilel Campus. Similarly, the opening of twelve (12) constituent university colleges (both public and private) and other tertiary colleges in Kisumu city had overstretched the existing library facilities in KNLS branch library;

- (ii). The development budget allocated to universities and KNLS is inadequate to put up modern libraries to cope up with the increase of the student population. Library buildings in Maseno University and Chepkoilel Campus have stalled due to lack of funds. Similarly, the KNLS Mobile library services have been grounded due to lack of funds. The libraries rely on donations from well wishers;
- (iii). The libraries are located in dilapidated buildings with run down furniture, equipment and leaking roofs;
- (iv). All the libraries visited were yet to be connected to the fibre optic; hence the internet and e-mail services offered were still very slow.

Lastly Mr. Speaker, Sir,

During the period July – December, 2009, the Committee made the following recommendations:

- (i). Parliament should put up a modern purpose-library to cater for the information needs of Members of Parliament and Parliamentary staff;
- (ii). The Parliament library should join the consortium of university libraries to access e-journals for research purposes;
- (iii). The Parliament library should consider linking up with other libraries in the country to facilitate information resource- sharing among libraries;
- (iv). The Parliament Library should organize staff attachment and exchange programmes with Universities;
- (v). The government should allocate adequate funds for library infrastructure development in the country;
- (vi). Funds allocated to parent ministries should be itemized to ensure that libraries are not left out;
- (vii). KNLS should be moved from the Ministry of State for National Heritage

- and Culture to the Ministry of Education as a department on its own;
- (viii). The current KNLS Board should be dissolved and a new Board formed comprising of information professionals to ensure that citizens have the right concepts and attitudes about information and libraries;
- (ix). The government should amend the Kenya National Library Services Board Act CAP 225 of the Laws of Kenya to update it;
- (x). The government should amend the Books and Newspapers Act, CAP 111 of the Laws of Kenya to give Parliament library Legal Deposit Status;
- (xi). Parliament should legislate a law on National Information Policy which will set standards of information management in Kenya;
- (xii). The government should consider libraries as a critical sector in the achievement of vision 2030.

Min. 01/LIBCOM/July 2009: Preliminaries

The Chairman called the meeting to order at 11.15 am. He welcomed the Committee members and thanked them for attending the meeting. While going through the list of Committee members, he noted that the name of Hon. Thombe Nyammo was missing. After a brief discussion, the chairman made a proposal to have one of the members replaced with Hon. Thombe Nyammo,

who was a publisher by profession. His proposal was unanimously agreed by members and the Chairman promised to take up the issue with the Liaison Committee so as to have the change made.

Min. 02/LIBCOM/July 2009: Adoption of the Agenda

The Chairman introduced the agenda. The agenda was proposed by Hon. Sammy Mwaita and seconded by Hon. Benson Mbai.

Min.~03/LIBCOM/July~2009: Remarks by the Clerk of the National Assembly

The Chief Librarian, on behalf of the Clerk of the National Assembly, welcomed the committee members to the meeting. The Chief Librarian explained to the members how the Library Committee was established and the mandate of the Committee. She also gave a brief on the core functions of the Library, Research and ICT departments in Parliament, which fall under the mandate of the Library Committee. She informed members that, like all other committees of the House, the Library Committee is guided by the provisions of the Standing Orders and the Powers and Privileges Act. In particular she singled out the following provisions of Standing Orders (S.O) that apply to the Library Committee: S.O 162 - Quorum is three members; S.O. 167 - Achievement of quorum within 30 minutes; S.O. 168 - Frequency of meetings at least once every month; S.O. 169 - Failure to attend 4 consecutive meetings without written consent of the Chairperson; S.O 176 - Vacancy by either removal or resignation within 7 days; S.O. 182 - Submission of half yearly reports by the Committee to the House.

Min. 04/LIBCOM/July 2009: Programme of Committee Meetings

The committee members discussed the mandate of the committee at length and it was unanimously agreed that there was need for exposure of the committee members to institutions with similar mandates for purposes of benchmarking. The members proposed study tours to the Library of Congress (USA), House of Commons library (UK) library, German Parliament (Bundestag) and Parliamentary libraries in India, Indonesia, Malaysia and Singapore. Members

also proposed study visits to both national and international institutions of excellence, such as universities and research institutions.

Min. 05/LIBCOM/July 2009: Strengthening Library, Research and ICT Services

Members noted that the services currently offered by Library, Research and ICT departments needed to be enhanced. Members agreed that there was need to put up a modern purpose-built Library and Archives for easy access, retrieval and dissemination of information. They also proposed establishment of a back-up system for all the resources held in the Library and Archives in order to avoid any loss of information in case of disasters. Members further recognized the fact that research was an integral part of an institution, hence there was need to ensure that research services offered in Parliament met global standards so as to enable Members of Parliament to legislate effectively. In this regard, members proposed the strengthening of the human resource capacity of the departments under its mandate, which are Library, Research and ICT, respectively. Members present particularly emphasized on the need of strengthening the Research department so as to enable it produce bulletins and briefs on contemporary issues of the day for Members of Parliament.

The committee agreed to form a sub-committee to meet with Departmental Heads from Library, Research and ICT to discuss ways of strengthening the services currently offered by the departments and come up with a way forward. Min. 01/LIBCOM/Sept. 2009: Preliminaries

The Chairman called the meeting to order at 11.15 am. He welcomed the Committee members and thanked them for attending the meeting. Thereafter he introduced the Heads of Departments who were present in the meeting.

Min. 02/LIBCOM/Sept. 2009: Adoption of the Agenda

The Chairman introduced the Agenda. The agenda was proposed by Hon. Silas Ruteere and seconded by Hon. Benson Mbai.

Min. 03/LIBCOM/Sept. 2009: Report by the Chief Librarian

The Chief Librarian thanked Members for inviting her to the meeting. While presenting her report informed members that lack of space was the major challenge facing the Parliament Library thus hindering its expansion. As a result, the library collection is currently housed in two buildings namely: Main Parliament Building and County Hall, respectively. She requested the Library Committee to assist in lobbying for the construction of a modern purpose-built library by the Parliamentary Service Commission.

The Chief Librarian also requested members to amend the Books and Newspapers Act – CAP 111 of the Laws of Kenya so as to give the Parliament Library a Legal Deposit Status. In so doing, she said, the Parliament Library would become a depository of copies of all books and newspapers published in the country. She further requested members to sensitize other Members of Parliament on the importance of using the available facilities in the library.

In response to her requests, the Committee resolved that the Books and Newspapers Act be reviewed and mandated the Chief Librarian and the Principal Research Officer to liaise with the Legal Counsel department to have proposals of the amendment drafted and presented in the next meeting.

Min. 04/LIBCOM/Sept. 2009: Report by the Head of ICT Department

The head of Information and Communication Technology Department thanked the Chairman for inviting him to the meeting. He informed members that his department was understaffed, hence faced a major challenge in offering effective and efficient services to Members of Parliament and staff of the National Assembly. He also informed members that the department had established ICT training facilities in the conference room on 3rd floor, Continental House to offer in-house training for both MPs and staff, respectively and that the facilities were under-utilized.

He further informed members that ICT was very dynamic, thus ICT staff required periodic capacity-building to enable them cope up with the rapid technological developments. He requested members to help in spearheading the adoption of ICT policy in Parliament to provide for a framework for the provision of efficient and effective ICT services. He also stressed on the need for adopting e-Parliament strategies so as to reduce over- reliance of paper in Parliament.

The Principal Research Officer thanked the Chairman for inviting him to the meeting. He briefed the Members on the activities undertaken by the department, their functions and roles. He informed members that his department was understaffed and that the staff needed exposure to foreign Parliaments and research institutions so as to provide effective and efficient services to Members of Parliament.

He also informed members that the department had started a programme of integrated research where by researchers go through bills, analyze them and come up with detailed papers to assist relevant committees of the House before the bills are debated on the floor of the House. He further informed members that the department had plans to teach Personal Assistants to Members of Parliament some basic research techniques to enable them do technical research work to support Members of Parliament. He further informed members that researchers needed exposure to other Parliaments and institutions of higher learning.

Members requested the department to come up with a proposal on how the Personal Assistants should be trained so that they could forward it to the Parliamentary Service Commission.
