### **REGARDING SETTLEMENT OF OVER 25,000 SHAREHOLDERS OF MUTUKANIO GWATANIRO COMPANY LAND IN NAKURU AND LAIKIPIA**

#### I, the UNDERSIGNED;

DRAW the attention of the House to the following:-

- **1. THAT,** my name is Mr. Peter Kairang'a, a Kenyan citizen and shareholder of Mutukanio Gwataniro Company in which my family owns eight shares;
- 2. THAT, the Mutukanio Gwataniro Company was registered in the 1960s and it's main objective at registration was to collect money from its shareholders, who currently number over 50,000 shareholders, and invest the same in buying land for them to settle in;
- **3. THAT**, currently the Company owns a total of 82,000 acres in Nakuru and Laikipia, as well as the Amigos House (formerly Kanu House), Oyster Shell building in Nakuru Town, Farm Houses in Bahati, various buildings in Laikipia and Rumuruti, three plots in Nakuru Town, among other properties;
- **4. THAT,** in 1983, balloting of land was undertaken in a bid to ensure that each shareholder got a piece of the Mutukanio Gwataniro land, but this initiative ended up being a flawed process since the majority of the shareholders (over 25,000) got ballots with no land, there were instances of double allocation of land, and in areas such as Ngarua balloting was done on non-surveyed land;
- **5. THAT,** some of the Company properties including Amigo House, Oyster Shell and other properties grabbed or illegally sold without the consent of the shareholders under the

watch of the Company directors and provincial administration that was incumbent at the time, and as a result my rightfully-owned land is currently occupied by a shareholder in Malan Ngarua;

- **6. THAT,** many plots in Bahati farms were left unnumbered and later after balloting, were numbered and given out;
- **7. THAT,** Ndungiri plots in Solai were never placed in the Ballot Box but were nevertheless issued out;
- 8. THAT, efforts have been made by myself and other stakeholders to resolve the issue by way of sending complaints to the provincial administration, lands office in Nakuru and Laikipia, the Attorney General, the lands office in Nairobi and the National Land Commission, but all to no avail since no responses have been forthcoming from any of these offices;
- **9. THAT**, the issues in respect of which this Petition is made are not pending before any court, or any constitutional or legal body.

**THEREFORE** your humble Petitioner PRAYS that the National Assembly, through the Departmental Committee on Land:-

- **1.** Investigates the affairs of Mutukanio Gwataniro Company with a view to attaining the recovery of the irregularly allocated plots of land and other lost properties;
- 2. Urges the Ministry of Land or the National Land Commission to conduct a fresh survey of the Mutukanio Gwataniro land so as to ensure that all shareholders acquire a ballot that corresponds to actual land; and

- **3.** Makes any other order or direction that it deems fit in the circumstances with the anatter.




