EXECUTIVE SUMMARY

The 50th Session of the Executive Committee of the African Parliamentary Union(APU) was held in Khartoum (Sudan) on 26 and 27 May 20007.

The formal opening ceremony took place in the presence of His Excellency Omar Hassan Ahmed AL-Bashir, President of the Republic of Sudan accompnaied by the Honourable Ebenezer Begyian Sekyi Hughes, Speaker of the Parliament of Ghana, Vice-Chairperson of the Executive Committee, the Honourable Ahmed Ibrahim El Tahir, Speaker of the National Assembly of Sudan, Mr. Pierre Ngolo, Rapporteur of the Executive Committee and Honourable Abdulgadir Abdalla, Secretary General of the African Parliamentary Union.

The Delegates that participated in the proceedings of the 50th Session of the Executive Committee are from the following countries: Algeria, Angola, Burkina Faso, Burundi, Cameroon, Congo, Cote d'Ivoire, Democratic Republic of Congo, Djibouti, Egypt, Ethiopia, Gabon, Equatorial Guinea, Kenya, Liberia, Libya, Mali, Morocco, Uganda, Rwanda, Somalia, Sudan, Sudan, Togo, Tunisia and Zimbabwe and Namibia.

Honourable Nourredine Bouchkouj, Secretary General of the Arab Inter-Parliamentary took part in the deliberations of this session.

The Speaker of the National assembly of Sudan gave a key note speech and emphasized that the 50th Session of the Executive Committee of the African Parliamentary Union is being held at a time when Sudan is living in an era characterised by the end of one of the longest wars in Africa following the signing of the comprehensive peace agreement. In this regard, he hailed the efforts of all those who helped to sign this agreement which established the ethnic, religion and linguistic of Sudan.

The Speaker also underscored the need to strengthen parliamentary institutions in Africa and improve democratic practices with a view to establishing lasting peace. In addition, he expressed his confidence in the capacity of the Parliamentarians to achieve the objectives of development, modernizations and progress for which the African peoples are aspiring. To this end, he underlined the need to strengthen cooperation between Africans, privilege dialogue for settling armed and political conflicts, consolidate democracy and promote good governance, fight against corruption, promote cultures and strengthen the role of women in Africa.

The Vice- Chairperson of the Executive Committee, in turn, gave a speech in which he thanked the Sudanese parliamentary authorities for the warm welcome and facilities provided the parliamentarians for the purpose of holding their session in Khartoum.

In view of women participation, the vice-chairperson of the Executive commended the presence of women parliamentarians within the organ of the APU. Moreover, he appealed for the strengthening of the African National Parliaments, on the one hand, and as an organ of coordination of our activities at regional and international levels.

He called on parliamentarians to pursue their efforts with a view to strengthening the APU and to mobilize all energies to build an Africa where, democracy, development and social justice rein.

The President of the Republic of Sudan, His Excellency Omar Hassan Ahmed Al-Bashir delivered a keynote speech. He also hailed the African fight of the leaders and parliamentarians of the continent which contribute to the championing of democracy and governance, such as the African Parliamentary Union is so well promoting.

The President also hailed the African Union, particularly, in regarding the preservation of security and peace in our continent, thereby, emphasizing the right of African to manage their affairs and object the temptations of marginalization of this role for the benefit of the United Nations. Such visions will only complicate the problem and render solutions more difficult to obtain.

Concerning the difficulties encountered in the implementation of the Abuja Agreement for peace in Darfur, he emphasized that this issue falls within the competence of the African Union in spite of fruitless attempts to withdraw this case.

He also assured the parliamentarians that the issue of Darfur has been resolved in conformity with the plan of the secretary General of the United Nations and modified by the Peace and Security Council of the African Union and this, under the command of the forces of this institution.

The President further said that the end of the long war which Sudan experienced has opened up great prospects of sustainable economic growth supported by the Sudanese parliament which are favouring African cooperation.

The Secretary General presented the following agenda for the Session which was subsequently adopted by the delegates:

- 3. Consideration of the Management Audited Account for 2006

- 6. Draft agenda for the 51st Session of the Executive Committee.
- 7. Date and venue of the 51st Session of the Executive Committee.
- 8. Election of the Chairperson of the Executive Committee.

The delegates considered the items on the agenda and made various resolutions;

In admission (s) and re-admission(s), the Secretary General informed the members of the Executive Committee that contacts with non-member parliaments are ongoing with a view to encouraging them to become members of the Union.

The meeting considered the implementation of the decisions and recommendations of the Conference At the end of the presentation by the Secretary General of the documents on the implementation of the decisions and recommendations of the Conference, the members of the Executive pointed out that considering that APU is an instrument of the Interparliamentary and international coordination and cooperation and that Pan African Parliament is a legislative organ of the African Union. These differences in nature although stipulated in Libreville in 2002, should be recalled in future discussions. It was also noted that it is also necessary to see to the observance of the objectives of each other organization in accordance with their respective role and this, with a view to establishing and advantageous mutual cooperation.

The meeting discussed and adopted the audited Management account for 2006 and the report of the Auditors and raised concern over issue of contributions in arrears. This subject, on which the Auditors made remarks in order to find a solution, raised several questions on the efficiency of the measures which may be recommended. Although some countries had difficulties in fulfilling their commitments, efforts should be made to start paying up their contributions in arrears.

In order to preserve the statutory provisions, the members of the concerned Executive committee suggested that the general secretariat should contact the countries concerned in order to adopt in case by case bases, a procedure for payment of contributions with the possibility of drawing up a payment schedule with the assurance of settlement of the contributions of the current financial year. By so doing the Executive Committee convinced that the financial resources of the Union will be better assured and that the existence of APU will be guaranteed.

The meeting discussed an opinion of the Bureau of the Executive Committee on the amendments proposed by the National Group of Burundi to the Rules of Procedure. The Executive deliberated on the proposal and adopted the following amendments;

Add an Article 28 worded as follows: "The Statutes enter into force on the day of their adoption by the conference of the APU"

Rule 31, rewrite it to read: "For the final drawing up of s draft text, the Committee shall set up within it a Drafting Committee composed of six members at most. This composition shall take into account equitable geographical and gender distribution".

The meeting resolved to adopt the following draft agenda of the 30th Conference.

- 1. Election of the President of the Conference
- 2. Admission (s) and readmission (s)
- 3. Report of the Chairperson of the Executive Committee
- 4. Activity Report of the Secretary General
- 5. Approval of the amendments to the Statutes and Rules of Procedure
- 6. Report of the Committee of Women Parliamentarians
- 7. The role of Parliaments in the protection of environment and the implementation of sustainable development.
- 8. Development of inter-African trade with a view to speeding up the process of integration.
- 9. Date and venue of the 31st Conference.

In addition the Executive Committee took note of the themes proposed by the Women Parliamentarians within the framework of their meeting scheduled to take place the day before the next Conference of the APU, as follows:

- 1. School drop- out as a major cause of the spread of illiteracy and homelessness in Africa countries: role of Parliaments
- 2. Role of Parliaments in the promotion of the health services, combating the phenomena of mortality among women on delivery and the protection of infants from diseases transmitted from mothers.

The Secretary General of the Arab Inter-Parliamentary Union (AIPU) Hon. Nourre Bouchkouj also addressed the meeting.

The meeting discussed the need to elect a Chairperson of the Executive Committee and resolved to postpone the election to the next 51st Session of the Executive Committee. However, the delegates noted that there no provisions in the Rules of procedure providing for mechanisms of electing a chairperson when the sitting Chairperson seizes to be the Speaker of his/her National Assembly before end of the term and that there is a need form a caucus comprising of one member from each regional Parliaments to review the Rules of Procedure ahead of the 51st Session of the Executive Committee.

REPORT OF THE 50TH SESSION OF THE EXECUTIVE COMMITTEE

The 50th Session of the Executive Committee of the African Parliamentary Union (APU) was held in Khartoum (Sudan) on 26 and 27 May 20007.

1.0: OPENING CEREMONY

The Speaker of the National assembly of Sudan, in his speech, expressed the delight of the Sudanese National Group in welcoming the African Parliamentarians to Sudan.

He emphasized that the 50th Session of the Executive Committee of the African Parliamentary Union is being held at a time when Sudan is living in an era characterised by the end of one of the longest wars in Africa following the signing of the comprehensive peace agreement. In this regard, he hailed the efforts of all those who helped to sign this agreement which established the ethnic, religion and linguistic of Sudan.

The Speaker also underscored the need to strengthen parliamentary institutions in Africa and improve democratic practices with a view to establishing lasting peace. In addition, he expressed his confidence in the capacity of the Parliamentarians to achieve the objectives of development, modernizations and progress for which the African peoples are aspiring. To this end, he underlined the need to strengthen cooperation between Africans, privilege dialogue for settling armed and political conflicts, consolidate democracy and promote good governance, fight against corruption, promote cultures and strengthen the role of women in Africa.

The Vice- Chairperson of the Executive Committee, in turn, gave a speech in which he thanked the Sudanese parliamentary authorities for the warm welcome and facilities provided the parliamentarians for the purpose of holding their session in Khartoum.

He then tackled the agenda of the 50th Session of the Executive Committee which contained important items such as the preparation of the 30th Conference of the African Parliamentary Union.

Concerning membership in the APU, he pointed out the efforts being made to bring together all the national parliaments of the continent within the union which will further contribute to the promotion of democracy and sustainable development.

On implementation of the decisions and recommendations of the Conferences the vice-Chairperson of the Executive Committee called on parliaments to develop mechanisms for implementing resolutions and forward the relevant reports to the Secretary General of the APU.

The Vice Chairperson also informed the delegates that financing of the Union as a vital requirement. With regard to this item he pointed out that

the implementation of the work programme and the efficiency of our organization largely depend on the availability of resources, hence there is need for improving the rate of recovery of contributions and avoiding accumulation of arrears.

In addition to the choice of themes to be discussed at the next conference, further, he stated that the members of the Executive Committee will have to elect their chairperson to replace Mrs. Immaculee NAHAYO who is no longer the speaker of the National Assembly of Burundi.

In view of women participation, the vice-chairperson of the Executive commended the presence of women parliamentarians within the organ of the APU. Moreover, he appealed for the strengthening of the African National Parliaments, on the one hand, and as an organ of coordination of our activities at regional and international levels.

He called on parliamentarians to pursue their efforts with a view to strengthening the APU and to mobilize all energies to build an Africa where, democracy, development and social justice rein.

Lastly, he prayed that the deliberations in Khartoum become fruitful and declared the 50th Session of the Executive Committee of the African Parliamentary Union open.

After the two speeches, the president of the Republic of Sudan, His Exellency Omar Hassan Ahmed Al-Bashir delivered his speech.

First of all, he welcomed the parliamentarians to Sudan, crossroad of cultures and civilizations, African and Arab country. He recalled that it was from Sudan that the most important liberation movements and the fight against colonialism triggered off in Africa, colonialism which has today put on new clothes, called humanitarian action has established itself in our continent.

He also hailed the African fight of the leaders and parliamentarians of the continent which contribute to the championing of democracy and governance, such as the African Parliamentary Union is so well promoting.

He also hailed the African Union, particularly, in regarding the preservation of security and peace in our continent, thereby, emphasizing the right of African to manage their affairs and object the temptations of marginalization of this role for the benefit of the United Nations. Such visions will only complicate the problem and render solutions more difficult to obtain.

Concerning the difficulties encountered in the implementation of the Abuja Agreement for peace in Darfur, he emphasized that this issue falls within the competence of the African Union in spite of fruitless attempts to withdraw this case.

The President of the National Group of Ethiopia confirmed the invitation of his Parliament and said that this meeting will coincide with the celebration of the Millennium of Ethiopia.

The Vice Chairperson of the Executive Committee invited the Secretary General of the Arab Inter-Parliamentary Union (AIPU) Hon. Nourre Bouchkouj to address the delegates.

In his speech, the Secretary General of the AIPU expressed the great interest of his organization in following the proceedings of the Session of the Executive Committee of the APU. He recalled the importance of the Afro-Arab cooperation as regards the link which unites the African continent and the Arab world. He also underscored the close relations between the APU and the AIPU and announced that the next Afro-Arab Parliamentary conference will be held in Damascus (Syria) from 26 to 28 July 2007.

IMPLEMENTATION OF THE DECISIONS AND RECOMMENDATIONS OF THE CONFERENCE

I – <u>SESSIONS OF THE AFRICAN PARLIAMENTARY UNION (APU)</u>

1. Results of the 49th Session of the Executive Committee and the 29th Conference (Bujumbura, 27 – 28 November 2006)

After the sessions of Bujumbura, the General Secretariat sent to the members National Parliaments of the Union and to the non members, as well as to the inter-parliamentary and international Organisations the results of the proceedings of the 29th Conference of the APU, and particularly, the resolution on "the role of Parliaments in process of national reconciliation and preservation and strengthening of the social cohesion" and the resolution on the "role of Parliaments in the promotion of education and culture in Africa"

The General Secretariat also sent to the members of the Union the Report of Proceedings of the 49th Session of the Executive Committee.

The report of the sessions of Bujumbura was also sent to the member parliaments and to the non members who took part in the proceedings

2 Preparation of the 50th Session of the Executive Committee

At the invitation of the Parliament of the Republic of Sudan to host the 50th Session of the Executive Committee of the APU, the Secretary General of the APU, accompanied by one of his administrators, traveled to Khartoum in March 2007 to discuss the organization and the preparation of the Session

The Secretary General expressed, on behalf of the APU, his thanks and gratitude to the Sudanese authorities and Parliament for their readiness and support and assured them of the arrangements that would be made by the General Secretariat of the APU in order to make information concerning the 50th Session of the Executive Committee available for the members of the Union The Parliament of Sudan, expressed its readiness to provide the African parliamentarians with all the means for the proceedings to take place in the best conditions

3. 51st Session of the Executive Committee and 30th Conference

During the sessions of the APU in Bujumbura, the National Group of Ethiopia renewed and confirmed its invitation to host the 51st Session of the Executive Committee and the 30th Conference of the APU in Addis Abeba The 29th Conference took not of the invitation.

II – <u>INTERNATIONAL ACTIVITIES</u>

4. The 49th Session of the Council of the Arab Inter-Parliamentary Union

The African Parliamentary Union took part in the 49th Session of the Council of the Arab Inter-Parliamentary Union which was held in Akaba (Jordan) on 26 and 27 February 2007. Resolutions adopted in this session have dealt with several political issues. Moreover, the session decided that coordination with the APU General Secretariat should continue with a view to convening the 11th Afro-Arab Parliamentary Conference in Damascus

(The text of the Declaration will be made available to delegates)

5. The 9th Session of the Council of the Parliamentary Union of the OIC member countries

At the invitation of the Parliamentary Union of the OIC member countries (PUIC) and the Parliament of Malaysia, the General Secretariat of the APU took part un 9th Session of the Council of the PUIC which was held un Kuala Lumpur on the 15 and 16 February 2007 The results of the session, and namely the Declaration of Kuala Lumpur which was adopted, are available for the members of the APU at the General Secretariat

(the text of the Kuala Lumpur Declaration is available for delegates)

6. The 116th Assembly of the Inter-Parliamentary Union (Bali, Indonesia, April 29-May 4, 2007

At the invitation of the Secretary General of the Inter-Parliamentary Union and the Speaker of the Parliament of Indonesia, the APU took part, as observer, to 180th session of the Governing Council and the 116th Assembly in Bali, Indonesia from April 29 to May 4, 2007

The Governing Council considered and adopted the report on the consolidation of the reforms of the IPU This important report modifies the shape of the Assemblies of the IPU as follows

The first Assembly will become the only major political event of the IPU and the second meeting of the Assembly will devote more time to the Governing Council and will deal with a major political issue

- The Standing Committees will no longer meet in plenary sessions during the 2nd Assembly which will last three days; the Governing Council, the Committee on Human Rights of Parliamentarians, Coordinating Committee of the Meeting of Women MPs and the Committee on the Middle-East Questions will meet during the session of the 2nd Assembly The 2nd Assembly will choose and debate an emergency item.
- A Committee on the United Nations affairs will be established in order to ensure a wider parliamentary dimension and stronger support on the part of Parliaments to the activities of the U.N.. Each parliament will appoint two members to this Committee

Meetings and activities of the African geopolitical Group:

On the sidelines of the sessions of the IPU, the General Secretariat of the African Parliamentary Union held a meeting with the African Geopolitical Group on the 28th and 29th April 2007 in order to reach a common position on the items of the Assembly's agenda The first session of the meeting of April 28 was chaired by Honourable Francis OLE-KAPARO, Speaker of the Parliament of Kenya, member of the Executive Committee of the IPU, on behalf of Honourable Ebenezer Begyina SEKYI HUGHES, Speaker of the Parliament of Ghana and Vice-Chairperson of the Executive Committee of the APU The second session of the meeting was held on April 29 and was chaired by Mrs Margaret MENSAH-WILLIAMS (Namibia) Vice-Chairperson of the Executive Committee of the IPU

Concerning the emergency item, the African Group decided to support the items presented by India and Algeria on terrorism Both proposals were merged as follows International cooperation to combat terrorism, its root causes and its financing, including cross-border funding. This item was adopted by the Assembly and included in the agenda

The African Group meeting heard a detailed report on the activities of the IPU Executive Committee, particularly with respect to the implementation of the Reports on the Reform of the IPU (as mentioned above in this report)

In addition, the African Group appointed its representatives in the bureaus of the Standing Committee and of the drafting committees of the IPU

Lastly, the Secretary General informed the delegates that the amendments to the Rules of the African Group must be sent to the General Secretariat of the APU amply prior to the next meeting of the Group in October 2007

7. 11th Afro-Arab Conference

In order to maintain and enhance the relations of cooperation and solidarity between the African Parliamentary Union and the Arab Inter-Parliamentary Union, the General Secretariat of the APU is constantly in touch with the General Secretariat of the AIPU to speed up the preparations of the 11th Afro-Arab parliamentary conference

8. Preparation of the African Parliamentary Conference on migration

The General Secretariat of the APU is in contact with its partner, the Inter-Parliamentary Union, to define the goals and the content of this conference. This step is necessary to have international organizations like the International Organization for Migration and those of the system of the United Nations support this parliamentary meeting

9. Other activities

At the invitation of H.E Ebenezer Begyina Sekyi Hughes, Speaker of the Parliament of Ghana, the Secretary General of the APU took part in the celebration of the Golden Jubilee of Ghana's independence. It was an occasion attended by a number of Heads of States and Speakers of African Parliaments. The Parliament of Ghana held a special sitting on the eve of the independence anniversary in addition to other functions to commemorate the independence day.

Furthermore, the APU General Secretariat prepared a memoir on the prospect of relations between the African Parliamentary Union and the Pan-African Parliament This document which is at your disposal for any eventual remarks will be also communicated to the Pan-African Parliament

In conformity with the provisions of articles 15 and 16 of the Financial Regulation of the African Parliamentary Union, the Annual Management Account for the financial year 2006 drawn up on 31st December 2006 is divided in four parts:

- I. Execution of the 2006 Budget
- II. Results of the financial year 2006
- III. Funding of extra-budgetary activities
- IV. Annexes

I. EXECUTION OF THE 2006 BUDGET

A - RECEIPTS

1. CONTRIBUTIONS OF THE FINANCIAL YEAR 2006

Twenty two (22) National Groups out of 39 included in the table of contributions have made payments for the financial 2006. They are the following:

Algeria, Benin, Burkina Faso, Burundi, Congo, Cote d'Ivoire, Egypt, Equatorial Guinea, Ethiopia, Gabon, Ghana, Kenya, Morocco, Namibia, Niger, Uganda, Rwanda, Sao Tome & Principe, Sudan Togo, Tunisia and Zimbabwe.

The amount of the contributions settled for the financial year 2006 was US \$574,603, which equals a collection rate of 59,67%.

The amount of the contributions that have not been paid is therefore 388 290 dollars (see table 1, appendix)

2. CONTRIBUTIONS IN ARREAR

Following are the payments for outstanding contributions which totalled US \$ 178, 910:

- ♦ US \$ 11 581, paid by Congo for its 2005 contribution;
- ♦ US \$13 868, paid by Niger for 2005 contribution;
- ♦ US \$ 73 602, paid by Nigeria for 2004 contribution;
- ♦ US \$ 34 549, paid by the Republic Democratic of Congo for its 2005 contribution;
- US \$ 13 420, paid by Rwanda for its 2005 contribution;
- ♦ US \$ 4 135, paid by Togo for its 2002 contribution;
- US \$ 27, 755, paid by Zimbabwe for its 2005 contribution.

3. OTHER RECEIPTS

As for the other receipts, the APU received from Cote d'Ivoire, the remainder of it's subvention for 2005, which is US \$ 57,523. It also received a financial aid of US \$ 25,000 from the Arab Inter-Parliamentary Union. The total receipt is therefore US \$ 82,523.

• US \$ 64 053, amount paid by CAMEROON in settlement of its 2005 and 2006 contributions.



REPORT
OF THE AUDITORS
FOR THE FINANCIAL YEAR 2006



- In conformity with the provisions of article 17 of the Financial Regulations, the Auditors of the African Parliamentary Union examined the Annual Management Account for the financial 2006.
- 2. The audit of the accounts which was carried out at the closure of the financial year set for 31 December 2006 focused on the one hand, on the documents and vouchers relating to the receipts and expenditures, and on the other hand to the conformity of the management with the statutory and budgetary provisions.

I. RECEIPTS OPERATIONS

3. At the closure of the financial year 2006, the total receipts was US \$836 036, which is an 8.34% drop compared to 2005.

The breakdown of the receipts is as follows:

- US \$ 574 603 representing the 2006 contributions, this a collection rate of 59.67 %;
- US \$ 178 910 for outstanding contributions;
- US \$ 82 523\$\$ for other receipts.

II. EXPENDITURE OPERATIONS

- 4. The expenses incurred during the financial year 2006 added up to US \$743 668 from a budget of US \$ 1 093 563. The expenses were made within the limits of the budget allocated for the financial 2006 and 68% of the budget was used. Therefore, the expenses for the year 2006 were reduced by 18.32% compared to 2005. In fact, the budget for some expenditure headings was underused and amounted to US \$ 349 895.
- 5. The amount of the budget allocations that have not been used shows indeed the constant efforts made by the General Secretariat in order to ensure that the available funds allow the Union to carry on its activities.
- Generally, the expenses were executed considering the receipts of the year. Therefore, the efforts made both by the National Groups and the General Secretariat have to be maintained in order to provide our Union with the resources that would allowed it to efficiently fulfil its mission as the organization of National Parliaments.



III. RESULTS OF THE FINANCIAL YEAR 2006

7. The financial year 2006 closed with a positive balance of US \$ 92 368. This credit balanced made it possible to bail out the Working Capital which was of US \$ 747 820 at the start of the year. Thus, the Working Capital increased to US \$ 840 188 at the closure of the year 2006.

IV. OBSERVATIONS

- 8. The amount of the receipts collected in 2006 has decreased compared to 2005, mainly because of the weak recovery of the contributions. However, the number of the countries that have settled their contributions in 2006 is slightly higher (22 countries) than in 2005 (21 countries)
- 9. Concerning the contributions relating to the financial year 2006, the members have made a constant effort to fulfil their commitments. However, more efforts need to be done concerning the unpaid contributions. In fact, only 7 countries have settled their overdue contributions.
- 10. The amount of the contributions prior to 2006 that the APU has recovered was US \$ 178 910, which is 18% of the total due. Therefore, the total amount of the outstanding contributions prior to 2006 was US \$ 986 440 at the closure of the year.
- 11. Once again, the Auditors remind that unpaid contributions weigh on the financial situation of the APU and prevent our organisation from carrying its activities. They deem that the contribution issue has to be settled through the payment of the arrears on examination of the situation of the countries facing difficulties to meet their obligations. Therefore, only the amount that is likely to be recovered will be reported. In this respect, the Auditors submit to the Executive Committee the case of the following countries: Cabo Verde, Central Africa, Chad, Djibouti, Guinea, Guinea Bissau, Liberia, Sao Tome and Principle, Sierra Leone, Somalia, and Togo.

 In addition, all the members awareness, especially those mentioned above must be increased concerning the scrupulous respect of the payment of their contributions.
- 12. As for the heading « Other receipts », the Auditors have observed the constant financial support of the Arab Inter-Parliamentary Union on the one hand and have appreciated the payment of the remainder of the subvention of Cote d'Ivoire for 2005, in anticipation of the settlement of the contribution of the financial year 2006.
- 13. Concerning the Expenses, we have observed that the resources of the APU have been used with rigour in order to maintain a financial stability, this translated in an appreciable positive financial result.

- 14. Therefore, at the closure of the year 2006, thanks to the careful management of the resources of the Union, the financial results manifest themselves in a positive balance. This made it possible to replenish the resources of the Working Capital which stabilises now at a level that meets the budget requirements. The members of the Union therefore have to maintain their efforts and increase their support not only to preserve the results of the year, which bring financial stability, but also allow the Union to strengthen its capacity.
- 15. In conclusion, the Auditors of the APU noted that the operation of receipts and expenditure for year 2004 have been properly reported in the Annual Management Account and were carried out in conformity with the statutory and budgetary provisions.
- 16. Considering that the financial results appearing in the Annual Management Account for the year 2006 reflect correctly the financial situation of the APU, the Auditors request final discharge for the Secretary General of the African Parliamentary Union for the management of the financial year 2006.

IN THE 50TH SESSION OF THE EXECUTIVE COMMITTEE OF THE AFRICAN PARLIAMENTARY UNION (APU), KHARTOUM – SUDAN, 26-27 MAY 2007

ADDRESS BY RT. HON. EBENEZER BEGYINA SEKYI HUGHES, SPEAKER OF THE PARLIAMENT OF GHANA AND VICE-CHAIRPERSON OF THE EXECUTIVE COMMITTEE OF THE APU

Honourable Ahmed Ibrahim El Tahir, Speaker of the National Assembly of Sudan,
Honourable Members of the Executive Committee,
Honourable Secretary General of the APU,
Invited guests,
Ladies and gentlemen.

I welcome you all to the 50th Session of the Executive Committee of the African Parliamentary Union. I am pleased to see many of you once again, this time in the capital of Sudan, Khartoum. I sincerely thank the Sudan National Group especially the Honourable Ahmed Ibrahim El Tahir, Speaker of the National Assembly and the entire people of Sudan for their very warm welcome and the resources mobilised to ensure a comfortable conduct of proceedings of this 50th Session of the Executive Committee. I also wish to thank the Secretary General for the successful organization of the Session.

Honourable Members of the Executive Committee,

In this Session, we are called upon to examine important items on the agenda and to prepare for the 30th Conference of our Union. I would like to take this opportunity to make a few comments on the agenda.

Membership Drive

With regard to membership of the African Parliamentary Union, the Executive Committee through the secretariat is making frantic efforts to ensure that the APU brings together all National Parliaments in Africa. Our efforts must be directed at urging Parliaments that are not yet members of the Union to join us. Member-states are also enjoined to be committed to strengthening the Union by participating

in its activities aimed at promoting democracy and sustainable development. The Pan African Parliament is also one institution which is contributing to the development of Africa through the realization of African integration. These two institutions must therefore complement each other in serving the interest of the continent. In this respect the Secretary General will brief us on new measures on achieving harmony and cooperation between the two institutions.

2. Implementation of Resolutions and Recommendations

On the implementation of resolutions and recommendations of our last Conference, I would like to state that we adopted themes of great ımportance, "national reconciliation", and "culture education". These themes were adopted following extensive debate, exchange of ideas and experiences. The realization of the terms of these resolutions and recommendations would depend on the level of action we undertake in our individual Parliaments. I urge Member-Parliaments therefore to develop their own implementation mechanisms and inform the APU General Secretariat so that the Secretariat can report on the implementation of decisions and recommendations of the Conference.

I would also wish to assure you that you will be duly informed about action taken so far on the proposal at our last Session to organise a specialized conference on the issue of migration, in collaboration with other regional and international institutions.

Audited Management Account

We shall also be invited to examine the Audited Management Account of the Union for the year 2006, and we will have the opportunity to review the Report of the Auditors. This is an indication of the great importance we attach to the Union's finances because the implementation of our work programmes and the efficient functioning of our Union largely depend on the availability of material and financial resources. It is an undeniable fact that there is need to improve the rate of recovery and avoid accumulation of arrears.

Amendments to the Statutes and Rules of Procedure

We shall also consider some proposals for amendments to the Statutes and Rules of Procedure of the APU. Such amendments are intended to clarify the drafting of certain provisions to remove ambiguities.

Agenda for 31st Conference 5.

The agenda for our next Conference scheduled for Addis Ababa will also be finalized here. Thus, we will have to consider the choice of themes with due cognisance to the priorities of our continent. We must particularly bear in mind that our efforts ought to be directed at realising the objectives of NEPAD as well as the achievement of the Millennium Development Goals of the UN. We must also be reminded that we are to set an agenda for the meeting of the Committee of Women Parliamentarians which will report on their meetings to the Conference.

Agenda for 51st Executive Committee б.

In accordance with our tradition, we will have to determine the agenda and venue for the next Session of the Executive Committee.

Honourable Members,

As you will recall, during the last Session of the Executive Committee, we elected Hon. Mrs. Immaculée NAHAYO, then President of the National Assembly of Burundi as Chairperson of the Executive Committee. Hon. Mrs. Immaculée NAHAYO is no longer in office. We are enjoined by our own Statutes, to consider the election of a Chairperson of the Executive Committee.

Honourable Members,

I would like to remind you that we have continuously called for a more consolidated role of women parliamentarians in the work of the APU. We have implemented our recommendation adopted in Algiers regarding "women representation in decision-making", by setting up the Committee of Women Parliamentarians within the APU. May I remind you here that this is the first meeting of the Executive

Committee after that amendment to our Statutes and Rules to increase representation of National Groups in the Executive Committee to include the representation of women parliamentarians.

On this occasion, I wish to salute women parliamentarians who are today participating in the deliberations of this important decision-making organ of our Union.

Honourable Members,

We have to strengthen the African Parliamentary Union as it remains an instrument of co-operation amongst national parliaments and a co-ordinating body of our activities at both regional and international levels, notably the IPU. We should do everything possible to pursue the noble objectives the APU has set for itself. We must continue in our efforts at strengthening the African Parliamentary Union. We must mobilize our energies to transform into reality, our noble dreams of providing the African peoples access to democracy, development and social justice and unity.

Honourable Members,

I pray that our deliberations in Khartoum become fruitful. On this note, I would like to welcome you once again to the 50th Session of the Executive Committee and declare the meeting duly open.
