PARLIAMENT

BY RESIDENTS OF WESTLANDS ON THE MISSING PEOPLE FOLLOWING  
THE WESTGATE MALL ATTACK ON 21<sup>ST</sup> SEPTEMBER 2013

**WE, THE UNDERSIGNED** being Kenyan citizens and residents of Westlands Constituency

**DRAW** the attention of the House to the following;

**THAT** the Westgate Mall attack and eventual hostage situation occurred on Saturday 21<sup>st</sup> September 2013 and His Excellency the President announced its end and defeat of the hostage takers on Wednesday 24<sup>th</sup> September 2013. In his address to the nation, he declared a total of 61 dead, 175 as injured and 62 as being admitted in hospital. However, the residents of Westlands Constituency have reported their kin as missing while there has been no transparency on the circumstances surrounding attack.

**THAT** we sought assistance from the Kenya police, the Ministry of interior and Coordination of National Government, visited hospitals and mortuaries and the Kenya Red Cross which established a tracking service for our missing kin, but we have received satisfactory assistance.

**THAT** we confirm that the issues in respect of this petition are made are not pending before any court of law, constitutional or legal body.

**THEREFORE** your humble petitioners pray that the Government of Kenya through the National Assembly engages with the Kenya security agencies involved, the ministry of Interior and Coordination of National Government, the Kenya Red Cross to help determine the following;

- i) The number of civilians held hostage, trapped in the rubble or killed by the militants
- ii) The total hospital bill and the one who will foot the cost of both burial and psychosocial support?
- iii) The one who audited to the support offered by Kenyans and handed over to the Kenya Red Cross?

- iv) The security authority whose responsibility lies and the one who was in charge of the overall command?
- v) Whether there has been any investigation into the reported looting of property after the securing of the first and second floors of the mall, and does and whether the government plans to compensate the affected entrepreneurs and hold those culpable to account.

**THAT,**

The issues within this petition are not pending before any constitutional, legal or judicial body.

**HEREFORE your humble petitioners pray that Parliament** engages with the Kenya security agencies involved, the Ministry of Interior and Coordination of National Government, the Kenya Red Cross to help determine the following:

- i. How many civilians were held hostage, were they trapped in the rubble or killed by the militants.
- ii. What is the total number of the victims and cause of death/injuries.
- iii. What is the total hospital bill, who will foot the cost of both burial and psychosocial support.
- iv. Who audits the support offered by Kenyans and handed over to the Kenya Red Cross.
