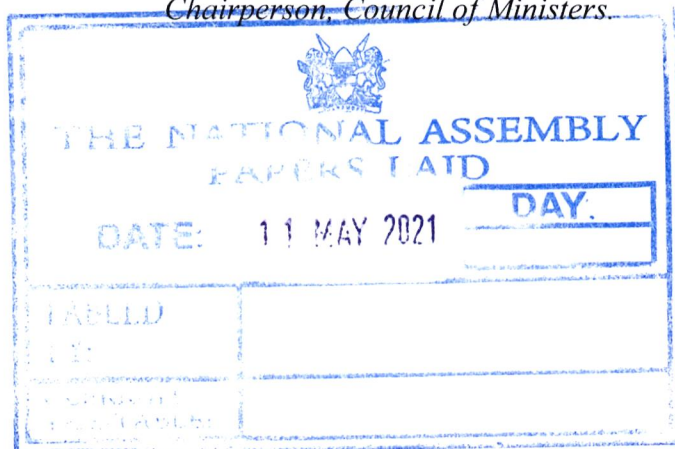

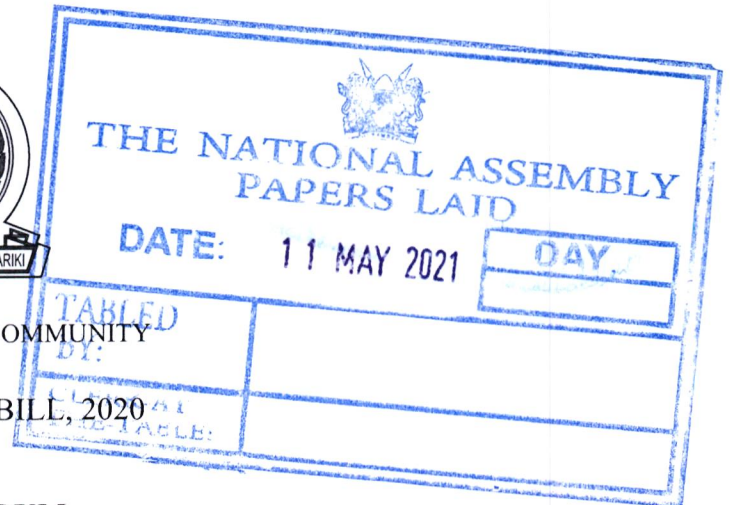

**An Act of the Community to appropriate a sum of United States Dollars ninety-seven million, six hundred and sixty-nine thousand, seven hundred and eight out of the budget of the Community to meet expenditure for the Organs and Institutions of the Community for the financial year ending 30<sup>th</sup> June, 2021.**

ENACTED by the East African Community and assented to by the Heads of State.

1. This Act may be cited as the East African Community Appropriation Act, 2020 and shall be deemed to have come into force on the 1<sup>st</sup> day of July, 2020. Short title and Commencement.

Appropriation of the sum of United States Dollars ninety-seven million, six hundred and sixty-nine thousand, seven hundred and eight is allowed out of the budget of the Community to meet expenditure of the Organs and Institutions of the Community, as specified in the Schedule, for the financial year ending 30<sup>th</sup> June, 2021.
