

1.0 PREFACE

Mr. Speaker, Sir,

On behalf of the Departmental Committee on Education and Research and pursuant to provisions of Standing Order 199(6), it is my pleasant privilege and honour to present to this House the Report of the Committee on its consideration of the nomination for appointment of **Dr. Kevit Desai, Principal Secretary Nominee,** State Department for Vocational Training and Technical Training.

1.1 Mandate

The Departmental Committee on Education and Research is established under Standing Order 216 and mandated to, *inter alia*,

1.4 Message from H.E. the President

On Tuesday 13th February, 2018 and the Speaker of the National Assembly communicated a message from H.E. the President to the House pursuant to Standing Order 42(1), regarding nominees to the positions of Principal Secretaries. He further informed the House that Pursuant to Article 155(3)(a) and (b) of the Constitution, H.E. the President had sought the approval of the nominee by the National Assembly in accordance with the law. The Speaker therefore referred the name of the nominee to the Departmental Committee on Education and Research to conduct approval hearings.

He further directed the Committees to conduct extensive public participation as provided for under Article 118 of the Constitution and Section 6(4) of the Public Appointments (Parliamentary Approval) Act, 2011 and Standing Order 45(3).

1.5 Nomination and appointment process of Principal Secretaries

Pursuant to Article 155 (3)(a) and (b) of the Constitution, the President is required to nominate a person for appointment as a Principal Secretary from among persons recommended by the Public Service Commission; and with approval of the National Assembly, appoint Principal Secretaries. After receipt of names of nominees, the National Assembly is obligated to conduct approval hearings and make a determination of the nominees' suitability or otherwise within fourteen days as provided for in section 8(1) of the Public Appointments (Parliamentary Approval) Act, 2011.

1.6 Committee proceedings

Based on its mandate, the nominee for State Department for Vocational and Technical Training, Ministry of Education, Research and Technology was forwarded to the Departmental Committee on Education and Research for vetting.

During the approval hearings, the Committee held a total of three sittings. In conducting the vetting exercise, the Committee was guided by the Constitution of Kenya, the Public Appointments (Parliamentary Approval) Act, No.33 of 2011 and the Standing Orders. The vetting process involved interviewing the nominee, examining correspondences from the Ethics and Anti-Corruption Commission, the Higher Education Loans Board, the Kenya Revenue Authority, Criminal Investigation Department and affidavits from the Public.

The Committee received no memorandum for or against the suitability of Dr. Kevit Desai's appointment to the position of Principal Secretary, TVET.

1.7 Committee Observations and Recommendations

The Committee's findings, as outlined in this report, enabled it to conclude that Dr. Kevit Desai was suitable to serve as Principal Secretary in the State Department of Vocational and Technical Training, Ministry of Education and Research. The Committee further noted that due process was followed on the nomination process as provided for by the Constitution and the Public Appointments (Parliamentary Approval) Act, 2011.

2.0 BACKGROUND INFORMATION

2.1 Legal Provisions

The criteria used in nomination and appointment of Principal Secretaries are set out in Article 155(3) of the Constitution. Section 7 of the Public Appointments (Parliamentary Approval) Act, No.33 of 2011 requires that the vetting Committee and indeed the House shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background.

Standing Orders 42 and 45 provide for the manner in which messages from the President are communicated to the House and the procedure to be followed during approval hearings respectively.

2.2 Message from H.E. the President

On 13th February 2018, H. E. the President presented names of the nominees for appointment as Principal Secretaries to the Speaker for approval by the National Assembly pursuant to Article 155(3)(b) and Standing Order 42. In his communication from the Chair on 13th February 2018 and Pursuant to Standing Order 42 regarding messages from the President, the Speaker read H.E. the President's message and referred the names of the nominees of Principal Secretaries to the relevant Departmental Committees to conduct approval hearings.

Dr. Kevit Desai's Curriculum vitae, Educational certificates and other testimonials were forwarded to the Departmental Committee on Education and Research to contact approval hearings.

2.3 Clearance requirements

On Wednesday 14th February, 2018, the Clerk of the National Assembly wrote to Mr. Kevin Desai notifying him on the place, time and venue for the vetting by the Departmental Committee on Education and Research on Wednesday 21st February, 2018 at 9.00 am. He further requested the nominees to bring with them clearance certificates from the Ethics and Anti-Corruption Commission (EACC); Kenya Revenue Authority (KRA), Higher Education Loans Board (HELB); Criminal Investigation Department (CID); and any of the Credit Reference Bureaus.

On the same date (Wednesday 14th February 2018) the Clerk of the National Assembly wrote to the KRA, HELB, EACC, and CID requesting for tax, loans, integrity and criminal record status respectively of the nominee. The institutions wrote back on 16th and 19th February 2018 to the National Assembly confirming clearance of the nominee.

2.4 Notification to the Public

Section 6(9) of the Public Appointments (Parliamentary Approval) Act (No.33 of 2011) provides that "any person may, prior to the approval hearing and by a written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

On Wednesday 14th February, 2018, the Clerk of the National Assembly placed an advertisement in the print media inviting the public to submit memoranda by way of written statement on oath **(sworn affidavit)** on the suitability or otherwise of the nominee in conformity with Section 6(9) of the Public Appointments (Parliamentary Approval) Act 2011. The submissions were to be received latest by Tuesday 20th February, 2018.

Pursuant to provisions of Article 118 of the Constitution, Section 6(4) of the Public Appointments (Parliamentary Approval) Act (No.33 0f 2011) and Standing Order 45(3), the general public was also notified in the print media by the Clerk of the National Assembly on Wednesday 14th February 2018 of the intention of the Departmental Committee on Education and Research to conduct the vetting and approval hearings of the nominee on Wednesday 21st February 2018 in Committee Room, 4th Floor, Continental House at 9.00 am.

3.0 Approval hearings

The Committee held a meeting with the nominee on Wednesday 21st February 2018 and conducted approval hearings. During the process, the Committee was guided by the Constitution; Public Appointments (Parliamentary Approval) Act No. 33 of 2011, the Technical and Vocational Training Act No. 29 of 2013, National Assembly Standing Orders and other relevant statutes. Specifically, the nominee was examined on the following criteria as set out in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011:-

- Academic qualifications
- Employment record
- Professional affiliations
- Potential conflict of interest
- Knowledge of the relevant subject
- Integrity
- Vision and leadership
- Expectations and key priorities

3.1 Vetting Process: Dr. Kevit Desai – Principal Secretary Nominee, State Department of Vocational and Technical Training

Dr. Kevit Desai appeared before the Committee on Wednesday 21st February, 2018. He was orally interviewed by the Committee and responded to questions during the vetting as follows:-

(a) Self-introduction and educational background

Dr. Kevit Desai submitted as follows:-

He is a Kenyan citizen, who was born on 29th August, 1968. He holds a Doctor of Philosophy Degree (PhD) in Robotics Control Systems Engineering, from Shibaura Institute of Technology (SIT), Tokyo, Japan between 1989 and 1993. He also graduated with a Masters degree from the same Institute between 1986 and 1989.

He undertook his undergraduate course in Electrical/Electronic/Computer Engineering from City University, City College and London Metropolitan University in London, England from 1982 to 1985. He also pursued a course in Factory Automation Systems Research and Development from Toyohashi, Japan, in 1990.

(b) Professional/Work experience

Until his nomination, he was Chairman and Board Member of a number of organizations and institutions where he had gained considerable experience for a period spanning over twenty (20) years.

The Nominee underscored that he had served as the Chair of KEPSA between the year 2007 to 2009 where he played a key role in creating linkages between the private sector and the Ministry of Education through informing policy and legislation on education reforms. This culminated into the development of various Legislation such as; TVET Act, Universities Act and Kenya National Qualifications Framework Act.

The Nominee further stated that he had gained substantive experience from chairing a number of Boards dealing with the TVET sector. Some of these Institutions included;- United States International University (USIU), Technical University of Mombasa, Karen Technical Training Institute for the Deaf and Permanent Working Group on vocational training. Specifically, as the Chairman of the Working Group on vocational training, Dr. Desai underlined that he had championed the private sector, academia, government and development partner's linkages towards the transformation of Kenya's vocational training platform.

The Nominee also stressed that he was a member of a number of taskforces, among them; the taskforce on the alignment of higher education with the Constitution which informed the development of the TVET Act, STI Act, Universities Act and the taskforce for research and development National Council for Science and Technology.

Dr. Desai further highlighted that over the years he had been very instrumental in supporting the youths in the country in setting up various businesses.

(c) Vision for the sector

On the vision for the sector, the Nominee underscored that he would hasten the competence based curriculum reforms and would also ensure that there was quality assurance policy in place considering that quality human resource was an important determinant of sustainable national growth and development.

Further he noted that linkage between the industry and academia would be top of his priority to ensure that courses being offered met quality and relevance required by the private sector. In regard to this, he emphasized that he would put in place a partnership policy with the private sector which would include occupation standards.

Moreover, he observed the need to evaluate teacher training curriculum considering the critical role of the teachers in transferring knowledge to the youth or learners in skills development.

(d) Good working relationship with the Legislature in reforming the TVET sector

The Nominee explained that he would put in place policy measures to deliver demand driven skills through a competency based curriculum geared towards self-employment. He further noted that significant economic transformation was enhanced through dynamic industry-institution linkages.

(e) Key deliverables expected in the short term

The Nominee underscored the importance of delivery Quality Based TVET. He would accomplish this through setting clear policies as a requisite to quality international standards.

In addition, he emphasized the need to encourage industrial organizations to participate in the formulation of the curricula, provide on-the-job Training programmes through apprenticeship and centres of excellence.

(f) Revamping TVET Institutions

The Committees' concern was on the low students applicants to TVET institutions. The Nominee underscored that there was need for an enabling TVET environment that will be achieved through:- putting in place harmonized and well-coordinated TVET institutions, policies, acquisition of appropriate and up-to-date equipment and tools and management of TVET institutions; provision of adequate funds; developing positive social attitudes towards training and enhanced management to make TVET institutions attractive.

The Nominee further emphasized that TVET colleges were instrumental in transforming economic development. He gave an example of Utalii College which he described as an excellent institution.

(g) Conflict of Interest

The Nominee underscored that many of his leadership positions were voluntarily, but nonetheless he would step down from the positions which would bring conflict of interest.

(h) Management of the many responsibilities

The Committee wondered how the Nominee managed the many responsibilities as was evident in his Curriculum Vitae. The Nominee was quick to respond that leadership came naturally and that he was passionate in serving hence he managed his time well.

(i) Measures to actualize the vision for the TVET sector

The Nominee noted that he would put into place necessary legislations to enable the implementation of various Sessional papers so that the thousands of young people joining secondary education could transit to some of the TVET institutions and eventually gain skills for gainful employment.

(j) Most significant contribution in the Nominee's career

Dr. Desai underlined that he had been very instrumental in transforming the education sector through public participation in the legislation process. He further highlighted that he had been actively involved in supporting youths in developing skills with a goal of connecting them to the market.

(k) Meeting the expectations of the public service

He stated that he will endeavor to link industry needs to TVET education, to ensure a match between graduates from learning institutions and human resource needs. All stakeholders therefore need to come together and be more innovative to ensure enhanced quality of TVET to produce self-reliance graduates and promote gainful employment.

(1) Upholding good working relationship with the Cabinet Secretary, Ministry of Education

The Nominee stressed that the Cabinet Secretary and Principal Secretary had a role to play in the implementation of the Development plans and other Policy instruments hence the importance of dialogue and good work relationship could not be overemphasized in the delivery of the Ministry's' mandate.

(m)Funding of TVET

The Nominee underscored the need for enhanced funding of the TVET State Department considering its critical role in meeting the needs of the vision of the country, especially in driving the 'big four' agenda.

(n) Controlling courses offered in Universities and TVET Institutions

The Committee was deeply concerned about universities offering courses that should be offered by TVET Colleges. The Nominee emphasized that since the introduction of the parallel courses in the Universities, most of the Universities concentrated on offering courses for their survival. However, he stressed that clear path ways needed to be created for smooth transition from TVET institutions to Universities Education.

He further observed that universities needed to create centres of excellence, concentrate on applied research and promote economic blocks in their counties.

(o) Honours and Awards

He was awarded Honorary Doctor of Science *honoris causa* of KCA University in 2013. He is a decorated Moran of the Order of the Burning Spear (MBS) for Engineering Contribution in 2008. He received a citation by the Professional Society of Kenya. He was also honoured with a Board Member of the Year Award by AISEC Kenya in 2009.

(p) Publications

He has written one publication; "Stimulating innovation and entrepreneurship in Kenyan universities and public research institute", in 2005, while he co-authored some work with B.O.

(q) Public Office, Political Activities and Affiliations

He did not hold any public office as he had relinquished all the public positions he held prior to the appointment. He was not involved in political activities and was not a member of any political party or affiliation.

(r) Sources of Income

His income was mainly from employment by Centurion Systems Ltd amounting to Kshs. 3,600,000.00 per annum and Kenya Markets Trust, at Kshs. 109,000.00 per annum.

(s) Tax Status

He was tax compliant.

(t) Statement of Net Worth

His financial net worth currently stood at Kshs. 100,000,000.

(u) Potential Conflicts of Interest

He would officially resign from all positions of Board Chairmanship and Memberships in institutions that may present conflict of interest. He would forward an official communication to the Committee by 27th February, 2018.

(v) Pro-bono, charity work or donations to charity

He was involved in a number of charity work all over Kenya.

3.0 COMMITTEE OBSERVATIONS

The Committee, having considered the nominee's filled questionnaire pursuant to Section 6(8) of the Public Appointments (Parliamentary Approval) Act, No. 33 of 2011, his curriculum vitae and having heard his oral submission during the approval hearing, made the following observations on his suitability for appointment as Principal Secretary, State Department of Vocational and Technical Training (TVET), Ministry of Education, Science and Technology:-

- a) He exhibited vast knowledge and experience having served in various capacities as Board Chairman or Member of a number of reputable organizations in the private sector and in government institutions.
- b) His contribution to the education sector, especially in the technical training field was commendable.
- c) By the time of conducting the approval hearing, no affidavit had been received for or against his suitability for appointment.
- d) He is a Kenyan citizen in accordance with Article 78(1) and (2) of the Constitution, does not hold dual citizenship and is therefore fit to hold office as Principal Secretary;
- e) His academic credentials, and professional training and experience are impressive and in compliance with Section 6(7) of the Public Appointments (Parliamentary Approval) Act, 2011;
- f) He satisfies the requirements of Chapter 6 of the Constitution on leadership and integrity having been cleared by the Directorate of Criminal Investigation (DCI), Kenya Revenue Authority (KRA), Higher Education Loans Board (HELB) and the Ethics and Anti-Corruption Commission (EACC).
- g) He has never been charged in a Court of Law;
- h) He has no potential conflict of interest in line with Article 75(1) of the Constitution. He undertook to resign as Chairman or Board Member from all the institutions.

- i) He satisfies the requirements of Article 77(1) of the Constitution in that he does not intend to participate in any other gainful employment.
- j) He does not hold office in any political party hence satisfies the provisions of Article 77(2) of the Constitution;
- k) He has never been dismissed from office for contravention of the provisions of Articles 75(1) (conflict of interest), 76(financial probity), 77(restriction of State Officers) and 78(2) (dual citizenship) and is therefore fit to hold office as a Principal Secretary;
- 1) He exhibited impressive knowledge of topical issues.

The Committee noted that the nominee had in-depth knowledge on matters relating to vocational and technical training, having previously served in various capacities in such institutes. He possessed the requisite abilities, qualifications and experience to serve as Principal Secretary, State Department of Vocational and Technical Training, Ministry of Education, Science and Technology.

4.0 COMMITTEE RECOMMENDATION

Having conducted approval hearings and pursuant to Article 155(3) of the Constitution, and Section 8 (1) and (2) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011; the Committee recommends that this House approves the nomination and subsequent appointment of Dr. Kevit Desai as Principal Secretary, State Department of Vocational and Technical Training, Ministry of Education, Science and Technology.

MIN. NO. 023/EDUC/2017: PRELIMINARIES/ADOPTION OF THE AGENDA

The Chairman called the meeting to order at 9.25 am. The Prayer was said and introductions made. The Agenda was adopted as the true business for the day after having been proposed by Hon. (Dr.) Pamela Ochieng, MP and seconded by Hon. Eric Muchangi Njiru, MP.



MIN. NO. 024/EDUC/2017: CONFIRMATION OF MINUTES

Confirmation of Minutes of the previous Sitting was deferred to the next Meeting. There were no matters arising under this item.

MIN.NO. 025/EDUC/2018: APPROVAL HEARING - DR. KEVIT DESAI, PS NOMINEE, TVET

The Chairman informed the Principal Secretary Nominee that the sole purpose of the Meeting was to conduct a Vetting exercise to establish whether he was suitable or not for the appointment to the post. The relevant statutes governing the vetting, including the Constitution, the Public Appointments (Parliamentary Approval Act No. 33 of 2011 and the Standing Orders were read to him. His original identification documents, certificates and testimonials were examined. The Clerk administered the oath to the Nominee. He was then invited to introduce himself, his family and educational background.

Dr. Kevit Desai submitted as follows: -

Educational Background

On education background, Dr. Kevit Desai responded that he was born in Kenya and that he was a Hindu by faith. He also highlighted that he holds an undergraduate degree in Electrical and Electronic Computer Engineering from the City University, City College and London Metropolitan University, London, England. Additionally, he is a Master's Degree holder in Master of Science Robotics Control Systems Engineering, SIT, Tokyo, Japan. The Nominee also holds a Postgraduate degree in Robotics Control Systems Engineering, SIT, Tokyo, Japan.

Work experience

The Nominee underscored that he had served as the Chair of KEPSA between the year 2007 to 2009 where he played a key role in creating linkages between the private sector and the Ministry of Education through informing policy and legislation on education reforms. This culminated into the development of various Legislation such as; TVET Act, Universities Act and Kenya National Qualifications Framework Act.

The Nominee further highlighted that he had gained substantive experience from chairing a number of Boards dealing with the TVET sector. Some of these Institutions included; - United States International University (USIU), Technical University of Mombasa, Karen Technical Training Institute for the Deaf and Permanent Working Group on vocational training. Specifically, as the Chairman of the Working Group on vocational training, Dr. Desai underlined that he had championed the private sector, academia, government and development partner's linkages towards the transformation of Kenya's vocational training platform.

The Nominee also stressed that he was a member of a number of taskforces, among them; the taskforce on the alignment of higher education with the Constitution which informed the development of the TVET Act, STI Act, Universities Act and the taskforce for research and development National Council for Science and Technology.

Dr. Desai further highlighted that over the years he had been very instrumental in supporting the youths in the country in setting up various businesses.

Vision for the sector

On the vision for the sector, the Nominee underscored that he would hasten the competence-based curriculum reforms and would also ensure that there was quality assurance policy in place considering that quality human resource was an important determinant of sustainable national growth and development.

Further he noted that linkage between the industry and academia would be top of his priority to ensure that courses being offered met quality and relevance required by the private sector. In regard to this, he emphasized that he would put in place a partnership policy with the private sector which would include occupation standards.

Moreover, he observed the need to evaluate teacher training curriculum considering the critical role of the teachers in transferring knowledge to the youth or learners in skills development.

Good working relationship with the Legislature in reforming the TVET sector

The Nominee explained that he would put in place policy measures to deliver demand driven skills through a competency-based curriculum geared towards self-employment. He further noted that significant economic transformation was enhanced through dynamic industry-institution linkages.

Key deliverables expected in the short term

The Nominee underscored the importance of delivery Quality Based TVET. He would accomplish this through setting clear policies as a requisite to quality international standards.

In addition, he emphasized the need to encourage industrial organizations to participate in the formulation of the curricula, provide on-the-job Training programmes through apprenticeship and centres of excellence.

Revamping TVET Institutions

The Committees' concern was on the low students' applicants to TVET institutions. The Nominee underscored that there was need for an enabling TVET environment that will be achieved through: - putting in place harmonized and well-coordinated TVET institutions, policies, acquisition of appropriate and up-to-date equipment and tools and management of TVET institutions; provision of adequate funds; developing positive social attitudes towards training and enhanced management to make TVET institutions attractive.

The Nominee further emphasized that TVET colleges were instrumental in transforming economic development. He gave an example of Utalii College which he described as an excellent institution.

Conflict of Interest

The Nominee underscored that many of his leadership positions were voluntarily, but nonetheless he would step down from the positions which would bring conflict of interest.

Management of the many responsibilities

The Committee wondered how the Nominee managed the many responsibilities as was evident in his Curriculum Vitae. The Nominee was quick to respond that leadership came nationally and that he was passionate in serving hence he managed his time well.

Measures to actualize the vision for the TVET sector

The Nominee noted that he would put into place necessary legislations to enable the implementation of various Sessional papers so that the thousands of young people joining secondary education could transit to some of the TVET institutions and eventually gain skills for gainful employment.

Most significant contribution in the Nominee's career

Dr. Desai underlined that he had been very instrumental in transforming the education sector through public participation in the legislation process. He further highlighted that he had been actively involved in supporting youths in developing skills with a goal of connecting them to the market.

Meeting the expectations of the public service

He stated that he will endeavor to link industry needs to TVET education, to ensure a match between graduates from learning institutions and human resource needs. All stakeholders therefore need to come together and be more innovative to ensure enhanced quality of TVET to produce self-reliance graduates and promote gainful employment.

Upholding good working relationship with the Cabinet Secretary, Ministry of Education

The Nominee stressed that the Cabinet Secretary and Principal Secretary had a role to play in the implementation of the Development plans and other Policy instruments hence the importance of dialogue , and good work relationship could not be overemphasized in the delivery of the Ministry's' mandate.

Funding of TVET

The Nominee underscored the need for enhanced funding of the TVET State Department considering its critical role in meeting the needs of the vision of the country, especially in driving the 'big four' agenda.

Controlling courses offered in Universities and TVET Institutions

The Committee was deeply concerned about universities offering courses that should be offered by TVET Colleges. The Nominee emphasized that since the introduction of the parallel courses in the Universities, most of the Universities concentrated on offering courses for their survival. However, he stressed that clear path ways needed to be created for smooth transition from TVET institutions to Universities Education.

He further observed that universities needed to create centres of excellence, concentrate on applied research and promote economic blocks in their counties.






