Mr. Speaker, Sir,

The Kenya Qualifications Bill was read for the First time in the House on 30th October, 2013 and thereafter committed to the Departmental Committee on Education, Research and Technology for consideration pursuant to the provisions of the standing orders no. 127.

"A bill having been read a first time shall stand committed to the relevant departmental committee without question put."

Pursuant to Article 118(1) (b) of the Constitution and Standing Order 127(3), the Committee invited (through local dailies) interested members of the public to submit any representations they had on the Bill. The Committee also held a stakeholders forum on the 22nd April, 2014 at the Kenya Technical Training College, where stakeholders drawn from various sectors attended.

2.0 OBJECTS OF THE KENYA QUALIFICATIONS FRAMEWORK BILL

In examining the Bill, the Committee noted the following:

- 1. The main Objective of the Bill is to establish a framework for the recognition and standardization of qualifications obtained in institutions within and outside Kenya;
- 2. Part 1 of the Bill has the preliminary provisions;
- 3. Part 11 of the Bill establishes and assigns functions and powers of the Kenya Qualification Framework Authority. The functions of the authority include the supervision of the development of policies on National qualifications and accreditation of the same and advise institution and other persons who award national qualification. The Bill establishes and makes provisions with respect to the council of the authority;
- 4. Part III of the Bill makes financial provisions with respect to the council of the authority covering annual estimates, accounts and audit;
- 5. Part IV has the miscellaneous provisions and that the Bill concerns the County Government and will also occasion public expenditure; and
- 5. The Authority will act as an umbrella body that will provide the requirements for all the courses offered within and outside Kenya. This will eliminate the possibility of students

being awarded degrees that are not recognized by employers on account that they do not meet the requirements as needed by the specific employers.

3.0 CONSIDERATION OF THE KENYA QUALIFICATIONS FRAMEWORK BILL

In principle, the Committee and stakeholders were in agreement with the contents of the Bill. However the Committee sought to make amendments to the following **key** areas:

- i. The Title of the Bill: The Bill to be referred to as "The Kenya National Qualification Framework Bill
- ii. Justification for the Authority: The Committee noted that the Bill is necessary in order to bring sanity in the award of qualifications and to also allow technical skills that have not previously awarded certificates, be able to acquire certificates. The Committee had reservations on the role of the authority visa viz the role of other examining bodies. The Committee was able to go through the Bill and was convinced that the Bill was necessary in order to establish a regulatory framework that will guide the sector.

The Committee is thankful to the Offices of the Speaker and the Clerk of the National Assembly for the logistical and technical support accorded to it during its sittings. The Committee wishes to thank all the stakeholders for their participation in scrutinizing the Bill. The meeting was called to order at 10.30 a.m and started with a word of prayer from Ms. Leah Wanjiru. The Chair then proceeded to welcome the Officials from the Ministry of Education, Science and Technology. Thereafter a round of Introductions was done.

MIN. NO. DC.D/ 46/ 2014 CONSIDERATION OF THE KENYA QUALIFICATIONS FRAMEWORK AUTHORITY BILL

The meeting had been convened to consider the Kenya Qualifications Framework (KQF) Bill that was read a first time and thereafter it was committed to the Committee on Education, Research and Technology in accordance to the provisions of Standing Order No. 127 of the National Assembly. The Committee was informed as follows:-

- 1) The legislative proposal was seeking to establish a framework for the recognition and standardization of qualifications obtained in institutions within and outside Kenya;
- 2) The KQF Bill was a national policy that was seeking to describe the levels of educational qualifications and set standards for qualification outcomes;
- 3) The Objectives of the KQF Bill was to establish national standards and levels for outcomes of education and training;
- 4) The KQF Bill was also intended to support the development and maintenance of pathways and equivalencies which provided access to qualifications and assist people to move easily and readily between the different Education & Training sectors as well as between these sectors and the labour market; and
- 5) The Bill sought to align the KQF with international qualifications framework to support the national and international mobility of workers through increased recognition of the value and comparability of Kenyan qualifications.
- 6) KQF would encourage lifelong learning to allow individuals to start at the level that suits them and then build up their qualifications as their needs and interests develop and change over time.
- 7) KQF would also provide access to certificates and licences recognized by the Government;
- 8) KQF would ensure consistency between the standards and qualifications and the job requirements/ demands;

- 9) KQF would ensure transparency in training provision, conformance to standards and preciseness of accountability for learning outcomes;
- 10) KQF would provide common understanding of policies and guidelines on credit transfers, articulation, portability, bridges pathways and a Recognition of Prior Learning (RPL)

11) Finally, the KQF would also provide the standards, taxonomy and typology of qualifications as bases for granting approvals to providers and stakeholders. It would also harmonize qualifications in education and training across Kenyans.

The Committee having gone through the KQF Bill noted that the Bill would be timely if enacted would ensure regulation of certificates offered by different colleges both locally and internationally. The KQF Authority would also work closely with professional bodies and institutions to ensure that learners are given the right qualifications.

Committee's Concerns

The Committee was concerned that:-

- i. The Bill if enforced into law would lead to the KQAF superintending over other examining bodies like KASNEB, KNEC and others. The Committee was informed that KQAF would only work to regulate the qualifications thus will not hamper their operations; and
- ii. The Framework should also encompass the spirit of regional integration in so far as harmonizing educational qualifications in the East Africa region was concerned. In response, PS informed the Committee was in the process of finalizing Regional Qualifications Framework.

MIN. NO. DC.D/ 47/ 2014 CONSIDERATION OF THE BUDGET POLICY STATEMENTS 2014

The Committee was informed as follow:-

The sector had been allocated Kshs. 268 billion which was a reduction of Kshs. 7.1 billion from what was requested when the sector was submitting their request.

On the part of TSC, the Commission would not be able to recruit teachers if their allocation was not increased. In addition, the Commission would not be able to embark on the promotion of teachers, bearing in mind that most teachers are eligible for promotion.

Noting, that the Ministry and the TSC could only work with the ceilings provided by National Treasury, the Committee directed the Ministry and the TSC to rationalize their shortfalls including the areas that they feel would be negatively impacted.



Committee sittings

The Committee raised that meetings should be called on Mondays afternoon instead of Fridays since most of the Members are engaged in their Constituencies on Mondays.

Budget Estimates FY 2014/15

The committee noted that the B & AC had recommended in their report the reduction of the amounts (by Kshs. 500 million) allocated to Youth Polytechnic on account that the matter was under the County Governments mandate. The money had been reallocated to Kenyatta University for construction of a modern children's hospital. The Committee noted that the idea was noble but it would have serious financial implications on the management of the Youth Polytechnics including the students. The Committee registered its objection to the recommendation and Members were urged to be present in the House to defend the Committee's position.

In addition, the Committee noted that the Kshs. 243 million, being the money allocated to the MOEST to take care of infrastructural development of schools had been recommended for reallocation to CDF by B& AC to be divided equally among all the 290 constituencies. The Committee agreed to support the redirection of the money back to the Ministry. The Committee added that some constituencies had very poor infrastructure than others hence it would be improper to channel the moneys through the CDF framework.
