The Committee wishes to thank the Offices of the Speaker and Clerk of the National Assembly for providing guidance and necessary technical support without which its work would not have been possible. The Chairperson expresses gratitude to Committee Members for their devotion and commitment to duty during the consideration of this Petition.

On behalf of the Committee, I now wish to table this report for consideration and passage by the House.

2.0 MANDATE OF THE COMMITTEE

The Committee on Education, Research and Technology is one of the Committees of the National Assembly established under Standing Order 216 and mandated to,

- investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- 2. study the programme and policy objectives of ministries and departments and the effectiveness of the implementation.
- 3. study and review all legislation referred to it;

4.0 BACKGROUND

4.1 Committal of the Petition to the Committee

Pursuant to Standing Order 227 (1), the petition was referred to the Departmental Committee on Education, Research and Technology for consideration and preparation of a report within 60 days. The Committee considered the petition pursuant to the provisions of Standing Order 227

(1) and (2). In the Petition, the Petitioner plight was that the Committee investigates into the circumstances that the led to the interdiction of Mr. Ephraim Wambugu and recommends that he be reinstated as a principal and his dues be paid.

The Committee proceeded with the consideration of the petition by holding meetings to set up terms of reference and scheduling meetings.

In considering the petition, the Committee invited and held meetings with the petitioner, Mr. Ephraim Kamuhu Wambugu and Hon. Esther Gathogo, M.P. The Committee also received written submissions from the Teachers Service Commission. The meetings were aimed at responding to issues raised by the petitioner.

4.2 Consideration of the Petition

In considering the Petition, the Committee was guided by the Provisions of Standing Order 227 (2) and (3). The Committee held meetings with the Petitioner and the Teachers Service Commission. During the meetings, written and oral evidence was adduced as recorded hereunder:-

Submissions by the Petitioner, Hon. Esther Gathogo, M.P;

The Hon. Esther Gathogo, M.P appeared before the Committee on 7th March, 2017. He was accompanied by Mr. Ephraim Kamuhu Wambugu. Hon. Gathogo informed the Committee that:-

- 1. That Mr. Ephraim Kamuhu Wambugu was employed by TSC as a graduate teacher and posted to Masinga Girls Secondary School in 1993. He had served as Chairman of Mathira District Schools Heads Association;
- 2. He was promoted to the position of the Deputy Principal in 1997 and later on promoted to the position of a Principal in 2002 at St. James Kiaritha Secondary School. He was later on in January 2006 he was transferred to Kiamariga Secondary school until December 2011;

- **3.** In 2012, he was demoted and transferred to Kangocho Secondary School as an ordinary classroom teacher. This caused him social, emotional and psychological trauma which led to depression;
- 4. Mr. Ephraim Kamuhu was interdicted on 16th March, 2015 with allegation of desertion of duty. The said letter was signed by the then Nyeri TSC County Director, Mr. Kinoti Imanyara was appointed as a Commissioner with TSC
- **5.** He lodged several appeals with TSC Commission for intervention regarding the matter but efforts to resolve the matter borne no fruit.
- **6.** The demotion had greatly affected Mr Ephraim Wambugu both psychologically and emotionally and therefore could not attend to his assigned classes.

4.2.2 Submissions by Mr. Ephraim Kamuhu Wambugu TSC No. 334898

The concerned teacher (Mr. Ephraim Kamuhu Wambugu) informed the Committee that:-

- He was an employee of the Teachers Service Commission from 1993 to 16th March, 2016 when he was interdicted on allegation of desertion of duty and fraudulently earning Kshs.
 027, 838.17; this was the second interdiction the first one being on 16th March, 2015 which was later on revoked.
- He taught as a graduate teacher at Masinga Girls in 1993. In 1994, he was transferred to Magutu Secondary School where he served as an acting Deputy Principal from 1997 to October 2000 when he was confirmed as Deputy Principal;
- **3.** He was deployed to St. James Kiaritha Secondary School in 2002 where he was promoted to the position of a head teacher. He served in the same capacity till 2003 when he was transferred to Mutitu Secondary School in the same capacity till December 2005.
- In January 2006, he was transferred to Kiamaringa Secondary School as a Principal and served till December, 2011.
- 5. On December 1st, 2011 he received a transfer letter from the then Provincial Director of Education from Kiamariga Secondary School to Ichuga Secondary School to teach Kiswahili and Geography with effect from 19th December, 2011. The transfer was revoked and instead he was issued with a deployment letter to Kangocho Secondary School to teach the same subjects;

- 6. He received a letter from TSC dated 12th September, indicating that he had been demoted from Principal to regular teacher due to mismanagement of school funds.
- Neither did the Teachers Service serve him with a copy of the audit report nor a copy of the disciplinary Committee report;
- That he was interdicted on 15th December, 2015 but received the letter of interdiction three months later; 22nd August, 2016;
- **9.** He was subjected to disciplinary hearings where he defended himself against the allegation of deserting duty. It was while he was awaiting the outcome of the disciplinary hearing that he was informed that it was deferred but a year later he received a second interdiction letter with further allegation.
- **10.** When he was demoted from a Principal to a regular teacher, he developed emotional stress and suffered from severe neurotic depression. He started attending medical sessions and he could not therefore teach students effectively. He was unfairly demoted without being given a hearing
- **11.** He still uses his phone number and that it was possible to obtain Mpesa statement from relevant authorities.
- 12. He has been out of employment for six years.

4.2.3 Written Submissions by the Teachers Service Commission

The Teachers Service Commission submitted its written Submission vide its letter **Ref. No. TSC/LS/250//2012/VOL.2/46/2012** dated 16th February, 2017. The Commission informed the Committee that:-

- 13. Mr. Ephraim Wambugu was assigned TSC no. 334898. He was first employed by TSC on or about 19th December, 1992 as a graduate teacher and posted to Masinga Secondary School to teach Kiswahili and Geography;
- 14. In July, 2011 while at Kiamariga Secondary School, it was alleged by the then school Accounts Clerk against Mr. Wambugu that he had among other things, mismanaged school funds, collected fees through his persona Mpesa and not remitting to the school accounts;

- 15. The allegations raised against Mr. Wambugu were also touching on the entire School Board of Management. The then Provincial Director of Education invited the Provincial School Auditor to undertake a comprehensive audit of the schools' books of accounts.
- 16. The Provincial School auditor undertook a comprehensive audit of the schools' books of accounts and prepared an audit inspection report with the following highlights:-
 - (i) Some receipts were not entered in the school fees register hence inflating the fees debtors;
 - (ii) Some receipts were under casted in the cashbook;
 - (iii) There was extreme flouting of procurement procedures in the procurement of goods and services for the school for example members of the Board of Governors were trading with school;
 - (iv) The teacher admitted receiving school fee through personal Mpesa;
 - (v) The teacher had used his office to enrich himself;
 - (vi) The teacher was unable to account for Kshs. 220, 635/= collected from a Harambee on 2010; and
 - (vii) The head teacher and the Board of Management had mismanagement the school.
- **17.** The audit was forwarded to the Provincial Director of Education who recommended that the teacher be redeployed from his administrative position to perform teaching duties.
- 18. Mr. Wambugu was transferred from Kiamariga Secondary schools head teacher to Icuga Secondary School to perform teaching duties with effect 1st December, 2011.
- 19. Mr. Wambugu requested through a letter dated 28th Dec, 2011 to TSC requested to be posted to Kangocho Secondary School, Mathira East instead of Icuga Secondary School which was acceded to by the Teachers Service Commission.
- 20. Following the transfer, Mr. Wambugu reported to Kangocho Secondary School on 10th January, 2012 but left the following day on 11th January, 2012 and hence failed to perform teaching duties.
- **21.** Mr. Wambugu's absence from school persisted for about three years before it came to the knowledge of the TSC County Director in February, 2015. The County Director undertook investigations which revealed that;
 - Mr. Wambugu had never taken up his teaching duties from the time he was posted to the school;

- (ii) He was not allocated duties and his name didn't appear in the school timetable and that the students didn't recognize Mr. Wambugu as one of their teachers;
- (iii) The Deputy Head teacher confirmed that the teacher had never been recognized as one of the staff.
- **22.** Despite not teaching, Mr. Wambugu was on the payroll and was earning salary irregularly for work not done which amounted to breach of the Code of Regulations for teachers.
- **23.** His salary was therefore stopped with immediate effect and he was served with a letter of interdiction asking him to show cause why disciplinary action should not be taken against him on the following grounds:-
 - (i) Desertion of duties;
 - (ii) Fraudulent earning of salary totaling to Kshs. 2,027,838.15/= with effect from 11th January, 2012 to 1st January, 2015.
- 24. Mr. Wambugu was afforded an opportunity to be heard in person and was advised to prepare a statement of defense in answer to the allegations leveled against him. He prepared a statement of defense denying the allegations.
- **25.** The disciplinary case was heard by TSC on 11th November, 2016 where the panel considered the allegations against him, the investigation report, witness statements and his defense. Mr. Wambugu was given an opportunity to present his case orally and cross examined witnesses present.
- **26.** The discipline panel found that he was guilty of the charges leveled against him as he had indeed had desert duty and earned salary fraudulently.
- 27. The discipline panel found the teacher guilty and suspended him for one month and surcharged him the sum of Kshs. 2, 027, 838.15 that it was alleged that he earned fraudulently. He was informed of the decision by TSC vide a letter date 19th January, 2017.
- **28.** The Principal, Kangocho Secondary School was also issued with a show cause letter for covering up the absence of Mr. Wambugu.
- **29.** Teachers Service Commission did not receive any appeal from Mr. Wambugu regarding his interdiction.

5.0 COMMITTEE OBSERVATIONS

Having held meetings and considered the submissions presented on the petition, the Committee observed that-

- The Teachers Service Commission carried out disciplinary proceedings and found the petitioner guilty and suspended him for one month and surcharged him the sum of Kshs. 2,027,838.15 which it was alleged that he earned fraudulently. He was informed of the decision by TSC vide a letter dated 19th January, 2017.
- The Petitioner has not been dismissed from employment by the service by the Teachers Service Commission.
- 3. Following its decision, the Teachers Service Commission had not received any appeal from the Petitioner as at the time the Committee was receiving the submission.

6.0 COMMITTEE RECOMMENDATIONS

In response to the above prayers, the Committee recommends;

- 1. **THAT** with regard to the prayer that the petitioner be reinstated as Principal by the Teachers Service Commission, the Committee noted that the petitioner has not been dismissed from service and is still an employee of the TSC hence the Committee cannot issue an order of reinstatement. The Petitioner is advised to make efforts to exhaust the appeal mechanisms available in law including applying for review of the decision by TSC as stipulated under the Teachers Service Commission Code of Regulations for Teachers; and
- 2. THAT going forward, in new and pending disciplinary cases, the Teachers Service Commission should strictly observe and adhere to its rules and in exercise of its authority in disciplinary proceedings it should administer justice without undue delay or undue regard to procedural technicalities in order to ensure that a teacher facing such proceedings is not disadvantaged owing to a failure by the Commission to observe rules or owing to procedural technicalities.

 - (iii) There was extreme flouting of procurement procedures in the procurement of goods and services for the school for example members of the Board of Governors were trading with school;
 - (iv) The teacher admitted receiving school fee through personal Mpesa;
 - (v) The teacher had used his office to enrich himself;
 - (vi) The teacher was unable to account for Kshs. 220, 635/= collected from a harambee on 2010; and
 - (vii) The head teacher and the Board of Management had mismanagement the school.
- 5. The audit was forwarded to the Provincial Director of Education who recommended that the teacher be redeployed from his administrative position to perform teaching duties.
- Mr. Wambugu was transferred from Kiamariga Secondary schools head teacher to Icuga Secondary School to perform teaching duties with effect 1st December, 2011.
- Mr. Wambugu requested through a letter dated 28th Dec, 2011 to TSC requested to be posted to Kangocho Secondary School, Mathira East instead of Icuga Secondary School which was acceded to by the Teachers Service Commission.
- Following the transfer, Mr. Wambugu reported to Kangocho Secondary School on 10th January, 2012 but left the following day on 11th January, 2012 and hence failed to perform teaching duties.
- Mr. Wambugu's absence from school persisted for about three years before it came to the knowledge of the TSC County Director in February, 2015. The County Director undertook investigations which revealed that;
 - Mr. Wambugu had never taken up his teaching duties from the time he was posted to the school;
 - (ii) He was not allocated duties and his name didn't appear in the school timetable and that the students didn't recognize Mr. Wambungu as one of their teachers;
 - (iii) The Deputy head teacher confirmed that the teacher had never been recognized as one of the staff.

- 10. Despite not teaching, Mr. Wambugu was on the payroll and was earning salary irregularly for work not done which amounted to breach of the Code of Regulations for teachers.
- 11. His salary was therefore stopped with immediate effect and he was served with a letter of interdiction asking him to show cause why disciplinary action should not be taken against him on the following grounds:-
 - (i) Desertion of duties;
 - (ii) Fraudulent earning of salary totaling to Kshs. 2,027,838.15/= with effect from 11th January, 2012 to 1st January, 2015.
- 12. Mr. Wambungu was afforded an opportunity to be heard in person and was advised to prepare a statement of defense in answer to the allegations leveled against him. He prepared a statement of defense denying the allegations.
- 13. The disciplinary case was heard by TSC on 11th November, 2016 where the panel considered the allegations against him, the investigation report, witness statements and his defense. Mr. Wambugu was given an opportunity to present his case orally and cross examined witnesses present.
- 14. The discipline panel found that he was guilty of the charges leveled against him as he had indeed had desert duty and earned salary fraudulently.
- 15. The discipline panel found the teacher guilty and suspended him for one month and surcharged him the sum of Kshs. 2, 027, 838.15 that it was alleged that he earned fraudulently. He was informed of the decision by TSC vide a letter date 19th January, 2017.
- 16. The Principal, Kangocho Secondary School was also issued with a show cause letter for covering up the absence of Mr. Wambugu.
- 17. Teachers Service Commission didn't any appeal from Mr. Wambugu regarding his interdiction.

Submissions by Mr. Ephraim Wambugu, TSC no. 334898

Mr. Wambugu informed the Committee that;

- He was an employee of the Teachers Service Commission from 1993 to 16th March, 2016 when he was interdicted on allegation of desertion of duty and fraudulently earning Kshs.
 2, 027, 838.17; This was the second interdiction the first one being on 16th March, 2015 which was later on revoked.
- II. He taught as a graduate teacher at Masinga Girls in 1993. In 1994, he was transferred to Magutu Secondary School where he served as an acting Deputy Principal from 1997 to October 2000 when he was confirmed as Deputy Principal;
- III. He was deployed to St. James Kiaritha Secondary School in 2002 where he was promoted to the position of a head teacher. He served in the same capacity till 2003 when he was transferred to Mutitu Secondary School in the same capacity till December 2005.

- IV. In January 2006, he was transferred to Kiamaringa Secondary School as a Principal and served till December, 2011.
- V. On December 1st, 2011 he received a transfer letter from the then Provincial Director of Education from Kiamariga Secondary School to Ichuga Secondary School to teach Kiswahili and Geography with effect from 19th December, 2011. The transfer was revoked and instead he was issued with a deployment letter to Kangocho Secondary School to teach the same subjects;
- VI. He received a letter from TSC dated 12th September, indicating that he had been demoted from Principal to regular teacher due to mismanagement of school funds.
- VII. Neither did the Teachers Service serve him with a copy of the audit report nor a copy of the disciplinary Committee report;
- VIII. That he was interdicted on 15th December, 2015 but received the letter of interdiction three months later; 22nd August, 2016 ;
 - IX. He was subjected to disciplinary hearings where he defended himself against the allegation of deserting duty. It was while he was awaiting the outcome of the disciplinary hearing that he was informed that it was deferred but a year later he received a second interdiction letter with further allegation.

Mr. Ephrahim Wambugu further informed the Committee that;

- When he was demoted from a Principal to a regular teacher, he developed emotional stress and suffered from severe neurotic depression. He started attending medical sessions and he could not therefore teach students effectively. He was unfairly demoted without being given a hearing
- 2. He still uses his phone number and that it was possible to obtain Mpesa statement from relevant authorities.
- 3. He has been out of employment for six years.

Submissions by Hon. Esther Gathogo, M.P

- 1. Pursuant to the Provisions of Standing Order No. 90 Hon. Gathogo wished to declare her interest in the matter in that Mr. Ephraim Wambugu was a close relative of hers.
- Hon. Gathogo submitted to the Committee that the demotion had greatly affected Mr Ephraim Wambugu both psychologically and emotionally and therefore could not attend to his assigned classes.
- 3. Mr. Ephraim Wambugu got the interdiction letter immediately when the then Nyeri TSC County Director, Mr. Kinoti Imanyara was appointed as a Commissioner with TSC.
- That Mr. Ephraim Wambugu should be reinstated as a Principal by the TSC and be paid his dues.

Members Observations

Having gone through the TSC submissions and listened to the Petioner, the Committee observed that there were gaps in the TSC submissions. That TSC was not consistent in following the teachers code of regulation when they handled Mr. Wambugu's case especially when they failed to follow Section 139(1)(a)(b)(c) and 146(8)(9)(10)(11)(12).

Way forward

Having listened to the presentation by Mr. Ephraim Wambugu and gone through the submission by the Teachers Service Commission, the Committee resolved to schedule a meeting with the Teachers Service Commission and the then TSC Director, Nyeri County to deliberate on the issues raised by the Petitioner.



RE: INTERDICTION

I refer to the above matter and wish to respond to a second letter of interdiction dated 15th December, 2015 which I received on 22nd August 2016.

In the said letter, I am alleged to have committed two (2) offences leading to my interdiction. They are:-

- You deserted duty with effect from 11th January, 2012 to date while teaching at Kangocho Secondary School.
- You therefore fraudulently earned Kshs.2,027,838.15 with effect from 11th January, 2012 to 1st February, 2015 without working.

(Attached herein and marked Appendix A is a copy of the said letter).

I had received an earlier interdiction letter dated 16th March, 2015 where I was alleged to have committed on offence leading to my interdiction. The said offence was that I had deserted duty with effect from 11/1/2012 to 16th March, 2015 while a teacher at Kangocho Secondary School. (Attached herein and marked Appendix B is a copy of the said letter).

A. WORK EXPERIENCE

I have been an employee of the Commission since 1993 where I have served the Commission in different capacities.

In 1993, I taught as a graduate teacher at Masinga Girls. In 1994 I was transferred to Magutu Secondary School where I served as an acting Deputy Principal from 1997 till 2000 when I was confirmed as Deputy Principal of Magutu Secondary School (October 2000).

In 2002 I was deployed to St. James Kiaritha Secondary School where I was promoted to the position of head teacher. I served in the said capacity till 2003 when I was transferred to Mutitu Secondary School to serve in the same capacity till December 2005. In January 2006 I was transferred to Kiamariga Secondary School as Principal and served till December, 2011.

I received a transfer letter on 1st December 2011 from the Provincial Director of Education, Central Province which indicated that I had been transferred from Kiamariga Secondary School to Ichuga Secondary School to teach Kiswahili/Geography with effect from 19th December 2011. (Attached and marked Appendix C is a copy of the said letter). However, the said deployment to Ichuga Secondary School was cancelled and replaced with deployment to Kangocho Secondary School to teach the same subjects (Attached and marked Appendix D is a copy of the said letter).

By a letter dated 3/7/2013, to your offices 1 challenged the said demotion and deployment. (Attached and marked Appendix F is a copy of the said letter). 1 got a response from your offices via letter dated 20/8/2013, confirming my deployment to Kangocho Secondary School. (Attached and marked Appendix F is a copy of the said letter). I got further communication from your offices via letter dated 12/9/2013 indicating that I had been demoted from Principal to regular teacher due to mismanagement of school funds (attached herein and marked Appendix G is a copy of the said letter). I continued to serve in the said capacity till 16th March, 2015 when I received a letter of interdiction The same has been marked as Appendix 'B' above.

B. INTERDICTION

By a letter dated 16/3/2016, I was interdicted from employment on allegation that I had deserted duty with effect from 11/1/2012 to date (I suppose it is till the date of the letter i.e. 16/3/2015).

I responded to the interdiction letter through a letter dated 2/4/2015 (attached and marked Appendix H is a copy of the said letter). During the time I am alleged to have absconded my duties, I was a teacher at Kangocho Secondary School and reported to the said school on 10/1/2012 and a casualty was written by the Principal to that effect and sent to your offices.

By a letter dated 14/7/2015 I was invited to hearing of my disciplinary case that was scheduled to be heard on 4/8/2015 at 8.30 a.m. at the TSC Headquarters Upper Hill Nairobi (attached and marked Appendix I is a copy of the said letter). On 4/8/2015 I attended the said disciplinary hearing where I defended myself. I later on received a letter dated 07/9/2015 from your offices informing that my disciplinary case that was heard on 4/8/2015 had been deferred. (Attached and marked Appendix J is a copy of the said letter).

While still on interdiction and awaiting further communication from your office with respect to my disciplinary case, I received a letter dated 15th December 2015 but received the same on 22/8/2016. This was a 2nd interdiction letter. The said letter is said to be an amendment to my earlier interdiction.

C. <u>DEFENCE</u>

The 2nd interdiction letter dated 15/12/2015 contains a 2nd allegation of fraudulently earning Kshs.2,027,838.15 with effect from 11th January, 2012 to 1st February, 2015.

I find the 2nd interdiction letter as a case of double jeopardy on mc. This is because I have been out of employment since 16/3/2015 when I received my first interdiction letter; I have been subjected to a disciplinary hearing where I defended myself against the allegation of deserting duty. It is while awaiting the outcome of the disciplinary hearing that I was informed the same has been deferred and a year later on received a second interdiction letter with a further allegation.

I have served this Commission faithfully and diligently and have risen through ranks since I was employed in the year 1993. It is my hard work and commitment to my job that has seen me get promotion after promotion (Attached herein and marked Appendix K 1-12 is a bundle of documents evidencing the same). I have always had the best interest of the students I teach at heart and would never engage in any activities prejudicial to them or the public at large. I reported to my work station following my demotion despite going through difficult moments as a result of the demotion I underwent treatment and was given a clean bill of health. (Attached herein and marked Appendix L is a copy of the said letter). It was during the period I am alleged to have deserted duty that I was appointed to Principal Graduate/Approved Teacher, Job Group 'N'. This was communicated to me via letter dated 13th October 2014 (Attached herein and marked Appendix M is a copy of the said letter). It is not practical for the Commission to upgrade my job group and salary and yet allege that I had committed offences that warranted me to be interdicted.

I have worked for this Commission for over 22 years and my work record speaks for itself. I have been appointed to various positions. In 2010 I was appointed as a member of the District Education Board- Mathira West by the then Minister for Education Prof. Sam K. Ongeri. While serving in this capacity I was invited to various meetings. I was also the head of Kenya Secondary Schools Heads Association. I was elected to this position as I am a man of integrity and had a track record of good performance in the schools I headed. (Attached herein and marked Appendix N 1-4 are copies of documents evidencing the same).

It is not fair for me to be subjected to such unfair treatment. I seek the indulgence of this Commission in exonerating me from all the allegations leveled against me and have me reinstated to work and promoted to position of Principal in order to continue serving people in the best way I know how.

1) I started teaching in 1993 in Masinga girls as graduate teacher. Later, I was transferred to Magutu secondary school in 1994 where I rose to a position of acting deputy Principal in the year 1997, this position was confirmed in the year 2000. In 2002, I was deployed Principal, St. James Kiaritha secondary school and later to Mutitu Secondary School in 2003. I was appointed principal Kiamariga Secondary School where I served from January 2006 to December 2011.

While serving as a principal Kiamariga Secondary school, I also served as a chairman District schools head Association, Mathira west District and a member of D.E.B for three years, a position only held by people of high integrity. My achievements in all the schools I served during the period of my administration is also a true testimony of my ability and integrity.

- 2) I was deployed from Kramariga Secondary School on 10th January 2012 to Ichuga Secondary and subsequently to Kangocho Secondary School as an ordinary classroom teacher where I reported on the same day (see deployment letters attached). My demotion without any tangible case, affected me socially, emotionally and psychologically to an extent that I had to go undergo treatment for trauma and depression (Attached are my medical document for ease of reference).
 - 3) After sharing my experiences with the school principal, he took my case to the Board of management who agreed that I be given light duties until I fully recover. The principal





BRIEF TO THE NATIONAL ASSEMBLY ON THE DISCIPLINARY CASE OF KAMUHU WAMBUGU EPHRAIM TSC/334894

- 1) Mr. Ephraim Wambugu (teacher) assigned TSC no. 334898, was employed by the TSC on or about 19th December, 1992 as a graduate teacher and initially posted to Masinga Girls Secondary School to teach Kiswahili and Geography.
- 2) The teacher was subsequently transferred to Magutu Secondary School as per his request.
- 3) While at Magutu Secondary School, the teacher was appointed to the position of Deputy Head teacher sometimes in October, 2000.
- 4) Sometimes in December, 2002, the teacher was appointed as head teacher and posted to St. James Kiaritha Secondary School then to Mutitu Secondary School and thereafter to Kiamariga Secondary School.
- 5) Sometimes in July, 2011, while at Kiamariga Secondary School, there were allegations by the then School Accounts Clerk against Mr. Wambugu in that, he had among other things, mismanaged school funds, was collecting fees through his personal MPESA and not remitting to the school accounts.

- 6) Taking into account the veracity of the allegations raised against Mr. Wambugu and which were also touching on the entire School Board of Management, the then Provincial Director of Education, Central Province invited the Provincial School Auditor to undertake a comprehensive audit of the school books of accounts.
- 7) The Provincial School Auditor undertook a comprehensive audit of the schools' books of accounts and prepared an Audit Inspection Report.
- 8) The audit team interviewed the teacher, his deputy and some members of staff.
- 9) The highlights of the Audit Inspection Report are as follows;
 - *i.* Some receipts were not entered in the School Fees Register hence inflating the fees debtors;
 - *ii. some receipts were under-casted din the cashbook;*
 - *iii.* There was extreme flouting of procurement procedures in the procurement of goods and services for the school e.g members of the Board of Governors were trading with the school;
 - iv. The teacher admitted receiving school fees through his personal MPESA;
 - v. The teacher had used his office to enrich himself;
 - vi. The teacher was unable to account for Kshs 220,635/= collected from a Harambee in 2010; and

- vii. In summary, the head teacher and the Board of Governors had mismanaged the school.
 (The said Audit Inspection Report is annexed hereto and marked Appendix 1)
- 10) The Audit Report was forwarded to the Provincial Director of Education, whereupon examining the same and noting the findings, recommended that the teacher be redeployed from his administrative position to perform teaching duties.
- 11) Subsequently, the teacher was transferred from Kiamariga Secondary School as head teacher to Icuga Secondary School to perform teaching duties w.e.f 1st December 2011.
- 12) The teacher vide his letter dated 28th December, 2011 to TSC, requesting to be posted to Kangocho Secondary School, Mathira East instead of Icuga Secondary School. (The said letter is annexed hereto and marked Appendix 2)
- 13) Following his request, the teacher's posting was on the same date changed from Icuga Secondary School and was re-routed to Kangocho Secondary School. (The said transfer letter is annexed hereto and marked Appendix 3)

- 14) Following the transfer, he reported to Kangocho Secondary School on 10th January, 2012. However, he left the following day on 11th January, 2012 and hence failed to perform teaching duties.
- 15) The teacher's absence from school persisted for about 3 years before the same came to the knowledge of the TSC County Director sometimes in February, 2015.
- 16) Subsequently, the County Director undertook investigations which revealed among others that;
 - *i.* The teacher had never taken up his teaching duties from the time he was posted to the school;
 - *ii.* He had not been allocated lessons to teach and his name did not appear in the School time table;
 - *iii.* The students did not recognize him as one of their teachers;
 - *iv.* The staff did not recognize him as one of their colleagues; and
 - v. The deputy head teacher confirmed that the teacher had never been recognized as one of the staff;
 (The said investigation report is annexed hereto and marked Appendix 4)
- 17) Despite not teaching, the teacher was on the payroll and was earning salary irregularly for work not done. This act amounted to breach of the Code of Regulations for Teachers.

- 18) Subsequently, Mr. Wambugu's salary was stopped with immediate effect and he was served with a Letter of Interdiction asking him to "*show cause*" why disciplinary action should not be taken against on the following grounds;
 - *i.* Desertion;
 - *ii.* Fraudulent earning of salary totaling the sum of Kshs 2,027,838.15 w.e.f 11th January, 2015 to 1st January, 2015.
- 19) He was informed through the said letter that he will be afforded an opportunity to be heard in person and was also advised to prepare a statement of defence in answer to the allegations levelled against him.
- 20) The teacher prepared a statement of defence denying the allegations.
- 21) The teacher's disciplinary case was heard by TSC on 11th November, 2016 where the panel considered the allegations against him, the investigation report, witness statements and his defence.
- 22) The teacher was given an opportunity to present his case orally and to cross examine witnesses present.

- 23) The discipline panel found that he was guilty of the charges leveled against him as he had indeed had desert duty and earned salary fraudulently.
- Accordingly, the discipline panel found the teacher guilty and suspended him for one month and surcharged him the sum of Ksh.2, 027,838.15 he earned fraudulently.
- 25) The teacher was informed of the decision by TSC vide its letter of 19th January, 2017.
- 26) The Principal, Kangocho Secondary School was also issued with a Show Cause letter for covering up the absence of the teacher; (The said Show Cause letter is annexed hereto and marked Appendix 5)
- 27) TSC has not received any appeal from the teacher in regard to his interdiction.

KIAMARIGA SECONDARY SCHOOL AUDIT INSPECTION REPORT 2ND AGUST 2011

1.0 INTRODUCTION

Kiamariga Secondary School is a mixed day and Boarding school with an enrolment of 320 boys (178 – Boarders and 142 day scholars).

The school was situated at Runguru zone, Kiamariga Division of Mathira West District.

The current principal Mr.Ephraim Wambugu Kamumuhu TSC.NO.334898 took over the school on 4th January, 2006.

1.1 STATEMENT OF PROBLEM

The Board of Governor Chairman Mr.Eustace G.Karanja wrote a letter to the principal dated 22nd July, 2011 and copied to the Provincial Director Education and attached a copy of another letter written by the suspended school accounts clerk (The Accounts Clerk letter was dated 8th July, 2011 and addressed to the principal/BOG/PTA secretary) which had raised several issues of financial mismanagement in the school by the Accounts Clerk on instructions of the principal (see App.I & II attached)

The following were the allegations as contained in the Accounts Clerk letter:-

- i. Collecting school fees using parallel Receipt Books
- ii. Failure to remit cash collected in school for banking
- iii. Non appearance before the Board of Governors Audit committee on various dates
- iv. Inflated goods payments to Board of Governor members
- v. Board of Governor secretary cashing money orders from the post office and not banking nor accounting for the same
- vi. Receiving of fees through M-pesa through the principal's mobile phone and not issuing receipts nor accounting for the same
- vii. Board of Governor having vested interests in the procurement process and payment to the suppliers
- viii. Buying and paying for relief food
- ix. The principal purchased his personal car using school funds by instructing the Accounts Clerk to issue cheques to none existing suppliers.

- x. Imprest surrendered using fictions cash sale receipts and invoices
- xi. The principal transferring building materials from the school to his own construction sites
- xii. The principal receiving and pocketing Kshs.1000/= admission fees for all the new students

1.2 OBJECTIVE

The objective of the Audit Investigation was to ascertain whether the allegations made by the School Accounts Clerkl M/S Mary Wangaui Wachira had any truth or not and to recommend any necessary remedial measures to arrest and correct the situation in order to enhance good governance and prudent financial management for the institution to be able execute and realize its goals.

1.3 TERMS OF REFERENCE

- i. Establish whether the recommended books of account were being maintained in the school
- ii. Examine all the financial transactions made in the school to determine and establish whether they were a proper charge as per the laid down financial procedures and regulations.
- iii. Establish the mode of fees collection in the school and the mode of accounting for the same
- iv. Establish whether the school had sound internal controls systems in place including maintainces of stores ledgers
- v. Determine whether the current procurement procedures and regulations were in place and operational in the school.

1.4 METHODOLOGY

The team used the following methods in carrying out the Audit investigations

- a. Examination and perusal of all financial records and documents for the years 2010 and 2011
- b. Physical verification of stores records
- c. Interviewed some school workers, deputy principal and principal,
- d. Visited the institution

1.5 TEAM MEMBERS

The team which carried out the Audit Investigations was composed of the following:-

→ D.M.Mutia - PSA Central
 → H.M. Kisinga - DSA Nyeri

1.6 SCOPE:-

The Audit Investigation covered the period from 1st January 2010 to 31st December 2010 and 1st January 2011 to 2nd August 2011

1.7 FINDINGS

COLLECTING FEES USING PARALLEL RECEIPT BOOKS

The principal was requested to ask the parents to submit their original receipts. However, all the original receipts the principal handed over to the Auditors were all genuine.

The Board of Governors had formed an Audit Committee which had earlier asked for the original receipts from specific parents (see the Audit committee report App.2 attached)

A further examination of the receipts revealed the following

- a. There were receipts not entered into the fees registers hence inflating the fees debtors amount (see App.3 attached)
- b. Some receipts were under casted into the cash book e.g. receipt number 16808 in the name of Joseph K. Gathatwa Adm.No.1584 for Kshs.2000.00 had only Ksyhs.500/= entered into the cash book thus it was under casted by Kshs.1500.00 (see App.4 attached) from the foregoing it was clear that the accounts clerk was using several methods to defraud the school which included not using carbon paper on the duplicates, under casting when posting into the cash book e.t.c. When submitting the original receipts, a defaced duplicate receipt was also submitted which did not conform to the serial numbers in the 2010 submitted books of account. It was also not clear who defaced it (see App.5 attached)

It was further established that the principal was not checking the work of the accounts clerk. There was no formal handing over of the day's collection even when banking.

ii. PROCUREMENT OF GOODS AND SERVICES IN THE SCHOOL

The school had a tender committee in place. However, the following was noted:-

- a. During a tender committee meeting held on 21st November 2011 to award tenders for the year 2011, except for text books, stationers and food stuff cereals which had at least three bids, the rest of the items had either one or two bids thus the procurement process in the school lacked competition as provided for in the procurement procedures and regulations currently in force (see App.6 attached)
- Some of the tender committee meetings lacked quorum and therefore the award given were not biding as per the Act.(see App.6(i) attached)
- c. During a tender committee meeting held on 2nd June 2010 which was to award the tender for the construction of the dormitory and supply of materials, the chairman of the committee Mr.Francis Ngari Migwi and a Mr.Lawrence Macharia Mbawa were not members of the Board of Governor nor the teaching paternity in the school, nor ex-officials from the various government ministries. It was therefore not clear why they took part in the school tendering process where even one of them chaired the meeting. The school principal Mr.Ephraim Wambugu Kanuhu TSC.No.334894 failed to advise the Board and even went ahead to take part in the process (See App. 6(ii) and App.7 attached)

Further, during the tender committee meeting held on 9th November 2008 (App.6 (ii) attached), a Mr. Peter Gachie was awarded a tender to supply computers in the school. He was not only a Board member, but was also the chairman of the P.T.A. in the school.

The other Board of Governor members who have been trading with the school were:-

 Mr. Eustace G. Karanja chairman Board of Governor. He was paid through payment voucher No.456 dated 15th Sept.2010 in respect of supply of 16 buckets of potatoes @Kshs.300.00 total

Kshs.4800.00 cheque No.00779 was issued (See App. (8) attached). This payment was also not supported.

 Mr Eustace G.Karanja was issued with cheque No.963 of Kshs.10, 500.00 dated 30th January, 2010 which was posted in the cash book without any supporting document or a payment voucher. Another payment voucher No.46 in favour of Mary G. Murigu for Kshs.300.00 dated 1st February, 2010 supported with a petty cash voucher was raised and entered into the cash book in February 2010 (see App.(9) attached)

Mrs Alice Wangui Kainga a Board of Governor member supplied the school with the following (see app.7 attached)

It is worthy to note that the two members of the Board of Governor were not among the tenderers and were not among the list of those awarded tenders to Supply the school (see App.(6) attached)

iii. PRINCIPAL CASHING MONEY ORDERS AND COLLECTING SCHOOL FEE THROUGH HIS PERSONAL MPESA ACCOUNT AND NOT REMITTING THE SAME FOR ACCOUNTING PURPOSES

The school did not maintain a cheque and money orders register. The money orders taken to the post office did not have any kind of a record in the school. It was therefore difficult to establish this. However, further investigations shall be carried out on this matter.

The principal admitted that he once received school fee through his Mpesa account in favour of a form three student, David Mugwe Kshs.3025.00. However, he could not remember when this was. Further, it was beyond the scope of this team to investigate this matter further.

iv. BUYING AND PAYING FOR RELIEF FOOD

The school received relief food from the area Chief Mr. Wilfred Karangi Murigu in June 2011 as follows:-

1st consignment 11th June 2011

- 19 bags of Maize 90kgs
- 20 bags of Beans 90kgs

2nd consignment June 2011

- 16 bags of Maize 50kgs
- 12 bags of Beans 50kgs

During the year 2011, there was no payment voucher raised in respect of the Area Chief Mr.Wilfred Karangi Murigu ID.NO.0268006. However, the school paid him Kshs.51, 000.00 vide payment voucher No.57 and cheque No.000828 for supplying 30 bags of maize supplied in 2010 at a cost of Kshs.1700.00 per bag. It should be noted here that the Area Chief was not among the list of those who had won tenders in the school during this period. Further, the payment voucher was supported with only a invoice note which apparently was stamped and signed on 3rd February 2011 and yet the supply was paid under creditors.(lunch). The Headteacher should therefore be called upon to explain how he paid a creditor who was supported by an invoice stamped and signed this year. Further, the said creditor was not appearing in the list of creditors for the year 2010.

v. THE PRINCIPAL USING HIS OFFICE TO ENRICH HIMSELF

Examination of the school payment vouchers revealed the following anomalies (see App.11(9) – App.11

Further, the principal entered into a sale agreement with one Catherine Wairimu holder of ID.NO.9669144 on 9/11/2009 and which was witnessed by the school Accounts Clerk M/S Mary W. Wachira for the purchase of a calf at a cost of Kshs.13,000/=. Kshs.7,100/= was to be used to pay fees for Kelvin Murathimi Macharia Form one 'W'. On the face of the payment voucher, no receipt number was indicated. The parent was supposed to have received Kshs.2000/= as a refund leaving a balance of Kshs.3, 900.00.

Further on the same date another payment voucher No.53 was raised where the whole amount Kshs.13, 000/= was again paid out thus the school lost Kshs.13,000.00

1.8 OTHER FINDINGS

a.<u>B.O.G</u>

The school had a functional Board of Governors. However, an examination of their profile and length of stay as B.O.G members in the school revealed the following anomalies:- (see App.7 attached)

 The following members have been B.O.G. members for a long period and therefore should not have been nominated in the current B.O.G.

In view of the above, the current B.O.G of Kiamariga Secondary School should be reconstituted in order to give the school committed members who can be able to give the school a new beginning.

b. HARAMBEE

In the year 2010 the school conducted an Harambee where a total of Kshs.915, 700.00 was raised. A total of Kshs.695, 065.00 was utilized in the construction of a semi-permanent dormitory. There was no indication of how the balance of Kshs.220, 635.00 was utilized.

c. PHYSICAL FACILITIES

All the structures in the school axcept the administration block were all semipermanent. The school had no site plan and structures were erected in an haphazard manner. The administration block had big cracks thus suggesting poor workmanship. Though there were suggestions that the land might not be fit for construction, the school management never sort the advise of the public work and there was absolutely no indication that they ever supervised any of the school construction works. There was no rational explanation why the school management would construct semi-permanent structures even when the resources to put up better structures were available e.g. the construction of a semi-permanent dormitory where Kshs.220,635.00 remained.

d. NON-TEACHING STAFF

A perusal of the non-teaching staff files revealed the following anomalies:-

- > Most of the workers did not have a copy of their identity cards in their files
- Most had no application letters and therefore not clear how they were employed
- Most of them did not have appointment letters.
- Most did not have copies of their education certificates and testimonies. These included the school Accounts Clerk M/S Mary Wangui Wachira

1.9. CONCLUSION

In view of the foregoing it was evident that the current principal Mr.Eprahaim Wambugu Kamuhu TSC.NO.334894 and his entire Board of Governors have mismanaged the Institution and used their position for personal gain by having vested interest in the procurement of goods and services leading to conflicts of interest.

Therefore, the Board of Governors of Kiamariga Secondary school should be dissolved forthwith and the principal deployed in order to allow for the proper nomination of a new Board of Governors, to inject new governance and give stability and new focus to the school.


1.10 RECOMMENDATIONS:

- The principal should ensure that all receipt books have been registered with the District Schools Auditor before being issued for use in the school. A counterfoil receipts book register should be in use where the person using the receipt books signs for it.
- The school administration should ensure that effective internal controls are put in place. Cash books, receipt books and banking etc should all be counter checked and signed for.
- The school tender committee should be re-constituted and inducted properly of what is expected of them.
- 4. The school Board of Governor should stop trading with the school.

- 5. The current Board of Governor should be dissolved and a fresh one constituted.
- -6. The principal-Mr.Ephrahim Wambugu Kamuhu-should be called upon to account for a total Kshs.209,000.00 being unsupported payments he made. This includes Kshs.13, 000.00 refunded twice for purchase of a calf from a parent.
- The Board of Governor should be called upon to explain why they have continued putting up semi-permanent structures and the only permanent structure was in poor state and had developed cracks.
- 8. The Board of Governor should regularize the employment of all the non-teaching staff and those not qualified for their positions should be done away with.
- The principal should explain the source of the food stuff purchased and paid to Mr.Wilfred Karangi Mirugi.

It has been decided that the said letter be cancelled and you be transferred to **Kangocho Secondary School** to teach **Kiswahili/Geography** with immediate effect.



2.0 PREAMBLE

The officers arrived at school at 9.30am. They were ushered in by the school principal. The school was about 3kilometres from karatina town. It was on the Nairobi/Karatina highway. Its immediate neighbouring school was Kangocho primary school.

2.1 ENROLMENT

The school had an enrollment of 226 boys and 183girls, Total 409. It had two streams.

2.2 STAFFING

The school had 4 male and 6 female teachers .BOM teachers were 2 males and 2 females. Therefore there were 10 Tsc teachers and 4 BOM teachers. Among the 10 Tsc teachers Mr. Kamuhu had not been captured.

2.3 LEADERSHIP AND MANAGEMENT

Principal

Mr. Peter Njenga King'oro was the school principal. TSC/305568 Job group 'P'. He had served the school since 2008 to date, a period of 8 years. He taught Geography/ CRE.



He had been a principal for 12 years. He had been a teacher since 1990 - total of 25 vears.

Deputy principal

Mrs Janeffer Njuguna TSC 357172, Job Group N. She had served as a deputy for 7 years. She had been a techer for 20 years. She taught English/ Literature.

PURPOSE OF THE VISIT 3.0

The purpose was to find out if Mr Kamuhu had been an active member of staff at Kangocho Secondary School.

EPHRAIM WAMBUGU KAMUHU 3.1

Mr Kamuhu was TSC No. 334894, Job Group N. the teacher reported to this school on 10th Jan, 2012. He had been deployed from Kiamariga where he was a principal. He reported but did not take up any duties then and had not been teaching since then. He is said to have faithfully collected his payslips fropm the school and made visits from time to time to the school to update the principal on his efforts for redeployment as principal.


FINDINGS 3.2

It was established that :

- 1. Mr. Kamuhu reported to the school on 10th Jan, 2012
- 2. Has never been allocated teaching lessons-does not appear on the teaching timetable.
- 3. He did not take up any teaching duties in the school.
- 4. The students did not recognize him as one of their teachers
- 5. The staff members did not recognize him as a member of staff.
- 6. He visited the school once in a while to collect his payslips and to update the principal on the efforts he was making to be redeployed as principal
- 7. There had been correspondences between him and the TSC and teachers union as per the attached documents.
- 8. He had been promoted to job group N in 2014 in a letter dated 13th Oct, 2014.
- 9. The school did not maintain his personal file.
- 10. The teacher had not been captured in any of the school's documents eg Form As..
- 11. There was no documented evidence to indicate that the teacher had ever been allocated duty.
- 12. The deputy confirmed that the said teacher had never been recognized as a member of staff.

CONCLUSION

It was evident that Mr Kamuhu was not a practicing teacher in the school.
