#### **PREFACE**

## Mr. Speaker, Sir,

The Departmental Committee on Administration of Justice and Legal Affairs is established under Standing Order No.151.Its mandate pursuant to Standing Order 151(4) is:-

- a) to investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
- b) to study the programme and policy objectives of the Ministries and departments and the effectiveness for implementation;
- c) to study and know all legislation after First Reading, subject to the exceptions under Standing Order 101A (4);
- d) to study, assess and analyze the relative success of Ministries and departments as measured by the results obtained as compared with its stated objective;
- e) to investigate and inquire into all matters relating to all assigned Ministries and Departments as they may deem necessary, and as may be referred to them by the House or a Minister and;
- f) to make reports and recommendations to the House as often as possible, including recommendation of proposed legislation.

#### 1.0 BACKGROUND

- 1. **Mr. Speaker, Sir**, the National Cohesion and Integration Act No.12 of 2008 is an Act of Parliament meant to encourage national cohesion and integration by outlawing discrimination on ethnic grounds and to provide for the establishment, powers and functions of the National Cohesion and Integration Commission and for connected purposes.
- 2. The National Cohesion and Integration Commission is established pursuant to the provisions of section 15 (1) of the Act which states as follows:-
  - (1) There is established a Commission to be known as the National Cohesion and Integration Commission.
- 3. The membership of the Commission is stipulated in the provisions of section 17 of the Act.

Section 17 of the Act states as follows:-

# 1. The Commission shall consist of -

- a) a Chairperson appointed by the President from amongst the commissioners appointed under paragraph (b);
- b) eight commissioners nominated by the National Assembly in accordance with the First Schedule and appointed by the President;
- c) the Chairperson of the Kenya National Commission on Human Rights;
- d) the Chairperson of the National Commission on the Gender and Development; and
- e) the Chairperson of the Public Complaints
  Standing Committee(Ombudsman)

- 3. The commissioners shall, at their first meeting, elect a vice-chairperson from amongst the commissioners appointed under subsection (2)(b);
- 4. In appointing members to the Commission, the principle of gender shall apply.

# 2.0 MANDATE OF THE COMMITTEE

- 4. **Mr. Speaker, Sir,** pursuant to the provisions of Section 17 and paragraph 1 of the First schedule of the National Cohesion and Integration Act, the National Assembly advertised in the daily newspapers on 13th March,2009 and 20th March, 2009 inviting qualified persons for nomination as Commissioners and caused the Departmental Committee on Administration of Justice and Legal Affairs to consider applications for the positions of commissioners to the National Cohesion and Integration Commission pursuant to the provisions of paragraph 3 of the First Schedule of the Act which states as follows:-
  - 3. The relevant Parliamentary Committee in consultation with the Minister shall, within seven days of the expiry of the period prescribed under paragraph 2
    - a) consider all the applications received under paragraph 2; and
    - b) recommend to the National Assembly suitably qualified persons for nomination as commissioners.
- 5. At the expiry of twenty one days of the advertisement (3rd April, 2009) a total of one hundred and nine (109) applications had been received by the Committee. The Committee then established a Sub-Committee consisting of the Hon. Amina Abdalla, Hon. Ababu Namwamba, Hon. Millie Odhiambo, Hon Isaac Ruto and Hon. Mutava Musyimi whose mandate was to scrutinize the applications and shortlist those who met the minimum qualifications as per the provisions of Section 18 (1) & (2) of the National Cohesion and Integration Act which states as follows:-

- 1. A person shall be qualified for appointment as a Commissioner if such person
  - a) is a citizen of Kenya;
  - b) is a person of high moral character and proven integrity; and
  - c) has knowledge and experience in matters relating to race, ethnic and human relations, public affairs and human rights.
- 2. No person shall be qualified for appointment as a commissioner if such person
  - a) is a member of the National Assembly;
  - b) is a member of a local authority;
  - c) is a member of the executive body of, or is actively involved in the affairs of a political party;
  - d) has promoted sectoral, ethnic, racial or religious animosity or openly advocated for partisan ethnic positions or interests.

# 3.0 REPORT OF THE SUB-COMMITTEE

- 7. On April 8, 2009 the Committee held a sitting to consider all the applications received for positions of Commissioners in the National Cohesion and Integration Committee.
- 8. A total of one hundred and nine (109) applications were received.

- 9. The Committee scrutinized all the applications including Curriculum Vitaes' of the applicants taking into consideration academic qualifications, gender, regional balance and relevant experience.
- 10. Thirty (30) applicants were short listed for consideration by the Committee.
- 11. The Sub-Committee developed a criteria to be applied when conducting the interviews where it was recommended that each candidate would be awarded a total of fifty (50) points depending on academic qualifications and knowledge of matters relevant to the Act which matters were categorized under the following topics:-
  - (i) Academic and Professional Qualifications Knowledge of National Cohesion & Integration Act
  - (ii) Knowledge of working with marginalized and disadvantaged, diverse groups
  - (iii) Knowledge on Public Affairs and Human Rights
  - (iv) Conflict Management & Resolution
- 12. The Sub-Committee submitted its report to the Committee at a sitting held on April 8,2009

# 4.0 REPORT ON THE NOMINATION OF COMMISSIONERS TO THE NATIONAL COHESION AND INTEGRATION ACT

- 13. At its meeting held on April 8, 2009, the Committee adopted the list of the thirty (30) applicants short listed by the subcommittee for interviews. The Committee further adopted the system of scores established wherein each candidate would be graded and awarded a total of fifty (50) points depending on their knowledge on topical areas relevant to the Act as well as academic qualifications. The topics to be graded included:
  - (i) Academic and Professional Qualifications
  - (ii) Knowledge of National Cohesion & Integration Act

- (iii) Knowledge of working with marginalized and disadvantaged, diverse groups
- (iv) Knowledge on Public Affairs and Human Rights
- (v) Conflict Management & Resolution
- 14. On April 16, 2009, the Committee interviewed twenty four (24) candidates.
- 15. On April 21,2009, the Committee interviewed five (5) candidates.
- 16. Twenty nine (29) candidates were interviewed for the positions of Commissioners after one of the short listed candidates withdrew in writing citing personal reasons.
- 17. In conducting the interviews the Committee was guided by the provisions of Section 18(1) & (2) of the National Cohesion and Integration Act herein earlier cited in this report.

#### 5.0 RECOMMENDATION

- 18. The Committee recommends to the House, that the following fifteen (15) nominees be considered and approved for onward transmission to H.E the President to nominate eight commissioners to the National Cohesion and Integration Commission in accordance with the provisions of paragraphs 5 and 6 of the First Schedule of the Act.

# MIN NO 152/2009 -INTRODUCTORY REMARKS

The meeting opened with a word of prayer after which the Chairman welcomed members and stakeholders to the meeting to discuss the developments in the Judicial Sector.

# MIN NO 153/2009 - JUDICIAL REFORMS

The stakeholders were invited to discuss the way-forward on Judicial reforms with particular emphasis to the Judicial Service Bill. They stated as follows:

# LAW SOCIETY OF KENYA (LSK)

The reforms in the Judiciary were intended to guarantee independence of the Judiciary, transparency, judicial structures, strong commitment to human resources and the eventual enactment of the Judicial Service Bill The Judicial Service Bill should be anchored in the Constitution since the Judicial Service Commission is a creature of Chapter IV of the Constitution.

The proposed Judicial Reforms should address issues including; -

- a) The tenure of the Chief Justice's tenure should not be more than 10 years with an age limit of 70 years.
- b) Presidential disputes should be handled by a Supreme Court.
- c) Financial Autonomy
- d) Introduction of a Supreme Court
- e) Review of the composition of the Judicial Service Commission

The LSK proposed the introduction of performance contracts in the Judiciary after the streamlining modalities of auditing judges.

The LSK also confirmed that their petition to the President was on the powers of the office of the Chief Justice and not on the incumbent parse.

# THE ATTORNEY GENERAL

He stated that the Judicature Chapter in the Bomas and Wako drafts had addressed the Judicial System comprehensively. He further stated that the Chapter would require minimal amendments in relation to Kadhi Courts.

Financial Autonomy of the Judiciary and the State Law Office was a priority to ensure efficient delivery of services and retention of competent staff.

He was in favour of minimum reforms spearheaded by the Committee but only after the comprehensive review of the Constitution became untenable.

## THE POLICE COMMISSIONER

The Police Commissioner was in favour of Judicial reforms with particular reference to the Criminal Justice System .In this respect he recommended review of remuneration of prosecutors to attract and retain qualified officers.

This will ensure that qualified prosecutors are available to prosecute cases thereby improving deliverance of Justice. The reforms should also be aimed at rehabilitating criminals after release from prisons.

The Committee observed that there was need for minimum constitutional reforms targeting the Judiciary and other state bodies and the committee was committed to spearhead the reforms.
