### Hon. Speaker Sir,

- 1. The Inter-parliamentary Committee of East Africa is a forum for Members of Parliament from the five member states of the East African Community, Kenya, Uganda, Tanzania, Rwanda and Burundi and the committee's objectives are:-
  - (i) Establishing permanent framework of dialogue as an avenue for discussing challenges facing the region;
  - (ii) Strengthening inter-parliamentary confidence;
  - (iii) Supplementing government efforts in conflict resolution mechanisms and in pursuit for peace and security;
  - (iv) Fostering political and economic cooperation, freedom of movement of goods and services;
  - (v) Harmonizing views in international fora and encouraging the taking of joint positions for the benefit of the region
  - (vi) Setting up regional inter-parliamentary verification mechanisms especially in matters of cross border accusations
- 2. The committee held its third sitting from 1<sup>st</sup> to 3<sup>rd</sup> April, 2008 at the Protea Hotel, Courtyard in Dar-es-Salaam, Tanzania. Participants were drawn from Kenya, Tanzania and Rwanda. The Kenyan delegation comprised:-

#### 1.0 INTRODUCTION

### 1,1, Convening of the Session

The Meeting of the Inter-Parliamentary Committee for East Africa ("the Inter-Parliamentary Committee") was convened in accordance with the Calendar of the Activities for the period January – June 2008. The purposes of the Meeting were to address the following issues:-

- (a) A review of the implementation of previous decisions;
- (b) Articulation of a Comprehensive Plan of Action in Inter-Parliamentary Co-operation; and
- (c) A review of the Committee's placement within the East African Community's institutional framework.

### 1.2. Participation

The Meeting was attended by the Representative of the Speaker of the National Assembly of The United Republic of Tanzania, Hon. Job Yusto Ndugai, MP, (Presiding Officer, National Assembly); the Representative of the Speaker of the Republic of Kenya, Hon. Prof. Hellen Sambili, MP; the Representative of the Speaker of the of the Republic of Rwanda, Hon. Seth Esri Kamanzi, Senator, Chamber of Deputies, Republic of Rwanda; and Members of the Inter-Parliamentary Committee whose names are shown in the list attached hereto as **Annex VI**.

Apologies from the Rt. Hon. Speakers of the National Assemblies of The United Republic of Tanzania, the Republic of Kenya and the Republic of Rwanda who, on account of other pressing official commitments, could not attend the Meeting, were noted.

The Inter-Parliamentary Committee noted the inability of the National Assemblies of the Republic of Burundi, the National Assembly of the Republic of Uganda and the East African Legislative Assembly to attend the Session. In view of the strict requirements of the Rules of Procedure on representation of all the Partner States, the Inter-Parliamentary Committee

decided to proceed on a consultative basis in order to save on costs that would be occasioned by an adjournment. The report of the outcome should thereafter be availed to the non-represented parties for comment and adoption.

#### 1.3. Bureau

Upon consultation among the delegations present, the Meeting was chaired by Hon. Job Y. Ndugai, MP, of the National Assembly, The United Republic of Tanzania The rapporteur was Hon. Capt. Clement M. Wambugu, MP, Member of the National Assembly, Republic of Kenya.

# 1.4. Adoption of the Agenda

The Inter-Parliamentary Committee adopted the Agenda attached hereto as **Annex I.** 

# 1.5. Opening Statements

In her welcoming remarks, the Deputy Secretary General (Political Affairs), Hon. Beatrice B. Kiraso, thanked the Speaker and National Assembly of The United Republic of Tanzania for hosting the meeting. Noting with regret the inability of the Inter-Parliamentary Committee to meet for the last three years, on account of electoral and related national processes, she called upon the Partner States to devise a way out of this problem which paralyses many EAC Activities. She briefed the Inter-Parliamentary Committee on the Community's progress in political affairs including the steps being systematically undertaken towards the establishment of a Political Federation. The Deputy Secretary General also highlighted the programmes being undertaken to address such fundamental issues as good governance, democracy, public accountability and social justice. In respect of all this she called for support from the Partner States and all EAC stakeholders.

In a statement read on his behalf by Hon. Ndugai, MP, the Speaker of the National Assembly of The United Republic of Tanzania, Rt. Hon. Samuel Sitta, MP, warmly welcomed the members of the Inter-Parliamentary Committee to Dar es Salaam. While outlining the basis for integration he cited the late Mwalimu Nyerere's 1997 assessment and prioritization of unity for purposes of social and economic progress of the African peoples.

In this regard, he lauded the revival and progress to date of the East African Community as a purposeful engine for change in the region. While underscoring the need for a big market and investment area in the EAC region, Rt. Hon. Sitta lauded the expansion of the Community's country membership to include the Republic of Burundi and the Republic of Rwanda. For purpose of further progress in the integration process, he emphasized the need for wide consultations with the people and all stakeholders to be spearheaded by, among others, parliaments and parliamentarians. This would be the most effective channel for realizing a people centred regional integration.

In a statement read on his behalf by Hon. Prof. Sambili, MP, the Speaker of the National Assembly, Republic of Kenya, Rt. Hon. Kenneth Marende, MP, emphasized the role of the Inter-Parliamentary Committee as a forum for enhancing inter-state co-operation at the level of parliamentarians. He underscored the primary role which parliaments, as the representatives of the population, play in enhancing and sustaining good governance through legislation and oversight. On the issue of co-operation and ultimate integration, Hon. Marende lauded the East African Community as a mechanism for collectively addressing such undertones to development as poverty, poor infrastructure, illiteracy, regional conflicts, HIV/AIDs and other sicknesses and terrorism. He urged for wide consultations and consensus on all aspects of integration and development. He further advised on the need for periodic assessment of the achievements and progress in all integration programmes and activities.

The Leader of the Delegation of the Parliament of the Republic of Rwanda, Hon. Seth Esri Kamanzi expressed his delegation's gratitude for the invitation to the meeting. He noted that the Inter-Parliamentary Committee as a key forum for Rwanda for purposes of further induction into the integration process. He briefed the Meeting about Rwanda's parliamentary system which comprises the Senate and Chamber of Deputies and in which women representation stands at 48.8%, the highest in the world. Sen. Kamanzi reiterated Rwanda's commitment to regional integration as a conduct for the region's socio-economic development.

# 2.0 REVIEW OF THE IMPLEMENTATION OF PREVIOUS DECISIONS / RECOMMENDATIONS OF THE INTER-PARLIAMENTARY COMMITTEE FOR FAST AFRICA

The Inter-Parliamentary Committee recalled that at its last meeting held on  $23^{rd} - 25^{th}$  February, 2005, it reviewed the implementation of previous decisions (covering the proposed appointed of EAC Ministers, according EAC sufficient prominence of home and abroad; proposed establishment of a project monitoring mechanism exchange of information by legislatures; Policy harmonization and rationalisation, co-ordination of efforts and enhancement of the role of the National Assemblies in EAC matters;). The Inter-Parliamentary Committee also took note of the outcome of the Nanyuki II Inter-parliamentary Seminar which took place in Entebbe on February  $21^{st} - 22^{nd}$ , 2005.

Regarding the follow up of the recommendations then made and subsequently adopted by the Council of Ministers at its  $10^{th}$  Meeting held on  $8^{th} - 9^{th}$  August, 2005, the Inter-Parliamentary Committee noted reports that-

- (a) the National Assemblies and the East African Legislative Assembly have been following up closely on the implementation of the outcome of Nanyuki II and Nanyuki III Seminars on enhancement of inter-parliamentary co-operation in political affairs;
- (b) the Governments of the Partner States have appointed Ministers solely responsible for EAC matters; the question of such Ministers residence in Arusha may not be feasible now as these Ministers are still members of the Cabinet in the Partner States and are answerable to their respective National Assemblies;
- (c) the question of the National Assemblies' amendment of their Standing Orders to enable reports by Members of the East African Legislative Assembly on EAC matters to be debated by the respective National Assemblies is being handled through appropriate Standing Committees;
- (d) each National Assembly has a budget line for EAC matters;

- (e) the Clerks of the National Assemblies and the Clerk of the East African Legislative Assembly need to be reminded to transmit to each other copies of the records of all relevant debates of meetings of their National Assemblies and the East African Legislative Assembly respectively;
- (f) establishment of parliamentary committees specifically for EAC matters may not meet the requirements of each National Assembly's Standing Orders on the establishment of Committees;
- (g) that the following matters were taken within the context of the fast tracking process on whose progress the Heads of State decided at the 6<sup>th</sup> Extraordinary Summit which was held in Ngurdoto, Arusha, on 20<sup>th</sup> August, 2007:
  - (i) Sensitization of the people of East Africa on the projections of the integration process with a view to preparing them for a possible referendum on the establishment of a Political Federation;
  - (ii) Including progress in the Comprehensive Plan of Action in Political Co-operation in the process of Fast Tracking the Political Federation;
  - (iii) The Partner States' establishment of regional election monitoring systems in tandem with the Fast Tracking process; and
- (h) the Heads of State cover EAC developments, projects and related matters in their state of the nation addresses;
- (i) the implementation, by the Partner States, of all the ratified protocols and other instruments is on course;
- (j) the National Assembly of the Republic of Kenya urged the Government of Kenya to legislate the increased participation of women in effective positions and to engender all her legislation; this matter is being taken care of;

the National Assemblies do support the Great Lakes Inter-Parliamentary Forum (whose membership includes the 5 EAC Partner States and whose mandate stems from the Dar es Salaam Declaration on Peace, Security, Stability and Development), the Great Lakes and Horn of Africa Inter-Parliamentary Forum (which was formed in Mombasa in 2004, and whose membership includes the EAC Partner States), the Amani Forum (whose membership comprises individual Parliamentarians) and do liaise with governmental authorities on this matter.

# The Inter-Parliamentary Committee recommends to the Council that -

- (a) co-operation and exchange of views through the Nanyuki series be maintained and strengthened;
- (b) the National Assemblies examine the existing Great Lakes inter-parliamentary for whose focus is similar and harmonise them in order to avoid duplication of efforts;
- (c) that the East African Legislative Assembly, through its appropriate Committee, prepares a brief on the role, mandate and progress of the different fora;
- (d) parliamentary efforts and contribution on the Political Federation be pursued within the context of the decisions made by the Heads of State at the 6<sup>th</sup> Extraordinary Summit held on 20<sup>th</sup> August, 2007.

# 3.0 ARTICULATION OF A COMPREHENSIVE IMPLEMENTATION PROGRAMME OF ACTION ON INTER-PARLIAMENTARY CO-OPERATION

The Inter-Parliamentary Committee observed that pursuant to the Treaty for the Establishment of the East African Community "the Treaty"), the Inter-Parliamentary Committee is charged with formulating a Comprehensive Implementation Programme of Action for its role in the integration process i.e. in inter-parliamentary co-operation as far as implementation of the

Treaty and the East African Community Development Strategy is concerned.<sup>2</sup>

In determining this programme, the Inter-parliamentary Committee will take into account the following:

- (a) the provisions (strategic interventions) of the East African Community Development Strategy 2006 2010);<sup>3</sup>
- (b) the expansion in 2006 of the country membership of the East African Community to include the Republic of Burundi and the Republic of Rwanda whose parliamentary traditions, practices and procedures bear salient differences from the Westminster version that applies to the Republic of Kenya, the Republic of Uganda, The United Republic of Tanzania and East African Legislative Assembly; this expansion has brought a new dimension in the strategies and focus of, and challenges to the regional integration momentum;
- (c) the need for amendment of the Treaty; and
- (d) relevant political developments in the EAC region.

The Inter-Parliamentary Committee decided that its Comprehensive Implementation Programme of Action for the period 2006 – 2010 will project the following key specific pre-occupations:

- (a) Support for EALA's forging of stronger linkages between EALA and the five National Assemblies;
- (b) Enhancement of the involvement of the National Assemblies of the Republic of Burundi and the Republic of Rwanda in interparliamentary co-operation; and
- (c) Contribution to the Council of Ministers' proposal to amend the Treaty.

# 4.0 REVIEW OF THE INTER-PARLIAMENTARY COMMITTEE'S PLACEMENT IN THE EAST AFRICAN COMMUNITY'S INSTITUTIONAL FRAMEWORK

The Inter-Parliamentary Committee, which acquired its current name and definite mandate after the coming into force of the Treaty<sup>4</sup> recalled that it started as a forum for the Speakers of the National Assemblies. The role of that forum, which started in 1997, was to enable the Rt. Hon. Speakers and other parliamentarians contribute to:

- (a) the revival of co-operation in different fields; and
- (b) the subsequent negotiations of a Treaty to establish a firm basis for co-operation and ultimate integration.

As a sectoral committee, the Inter-Parliamentary Committee has been primarily charged with policy input on matters of inter-parliamentary interfacing, exchange of views, drawing on best practices and keeping under constant review the implementation of sectoral programmes on interparliamentary co-operation..

A view has been expressed by East African Legislative Assembly that to the extent that inter-parliamentary co-operation is largely a political process on such issues as parliamentary oversight and legislation, the Inter-Parliamentary Committee ought to be an East African Legislative Assembly Committee. According to the East African Community Development Strategy 2006 – 2010, the development objective of the East African Legislative Assembly, includes as strategic interventions "the forging of stronger linkages between the East African Legislative Assembly and national parliaments".

# The Inter-Parliamentary Committee -

(a) observes that its role and mandate under the Treaty and its focus within the Development Strategy are political in nature and inter-parliamentary in practice;

# WELCOMING STATEMENT BY THE DEPUTY SECRETARY GENERAL (POLITICAL AFFAIRS), HON. BEATRICE B. KIRASO

# Hon. Members of the Inter-Parliamentary Committee

On behalf of the Hon. Secretary General of the East African Community and on behalf of the Secretariat, I have the honour to welcome you to this Meeting of the Inter-Parliamentary Committee for East Africa. Much as two of the five Partner States and the East African Legislative Assembly have not been able to send their respective delegations to this Meeting, there is need to appreciate your presence and utilize it for consultative purposes. Normally when at EAC meetings we do not realize a quorum, which is made up of all Partner States' representation, we transform the meeting into a consultative forum.

I express my appreciation to the Rt. Hon. Speaker and National Assembly of The United Republic of Tanzania for accepting to host this meeting in Dar es Salaam. Dar es Salaam has a special place in the history of the revived East African Community. It was in Karimjee Hall, a short distance away from here, that the Treaty for the Establishment of the East African Community finally came into force with the conclusion of the deposit of Partner States' Instruments of Ratification of the Treaty. The ambience and comfort of this aptly called Westminster Hall should augur well with the Committee's deliberations.

# Rt. Hon. Chairperson,

Since 1998, when it used to be a forum for the Rt. Hon. Speakers, the Inter-Parliamentary Committee has, played a significant eloquent and sustained role in shaping the revived East African Community. This forum contributed to the negotiations of the Treaty and that of the Treaty's key annextures such as the Protocol on the Establishment of the East African Community Customs Union. The Committee has also contributed to the institutional development of the Community. It, therefore, behoves me to applaud the Committee for its continued contribution to progress of the integration process.

# Rt. Hon. Chairperson,

It is with regret that this Committee has not had its regular meetings for almost three years. This unsavoury circumstance has arisen out of Partner States' requests for postponements of meetings during times of national political processes such as elections, and sometimes other commitments. There was always a three year period when elections followed each other in Tanzania, Uganda and Kenya. And now with the admission of Burundi and Rwanda the situation is likely to get worse as their election years will further affect meetings like this one and others. This process has the tendency to paralyse EAC activities. The Secretariat is urging the Partner States to find a way out of this undesirable tendency, possibly by harmonizing on the National Elections' period of the Partner States. This will be even more necessary as we move to the ultimate goal of a Political Federation where again Partner States will participate in election of office bearers at that level.

# Rt. Hon. Chairperson,

The agenda before you is designed largely to ensure continuity in the discharge of the Committee's work. It is also tailored in such a manner that the Committee's evidently new membership gets inducted in the work of the Committee. To this extent while you review the implementation of the Committee's previous decisions and recommendations you will be obliged to look ahead and perceive what contribution you will make in realizing the Community's strategy on inter-parliamentary co-operation.

While conceiving a Comprehensive Plan of Action, you will be enjoined to take into account the Treaty provisions of establishing an East African Political Federation and decisions of the Summit of Heads of State regarding the fast tracking. This remains the ultimate goal of the cooperation arrangements which are fast metamorphosing into full integration of the five Partner States' social political and economic arenas.

# Rt. Hon. Chairperson,

I need to note there that the work of this Committee will to a large extent support the activities of my Department of Political Affairs, which is charged with the implementation of Article 124 of the Treaty. The mandate of this provision covers developing and consolidating democracy, the rule of law and respect for human rights and fundamental freedoms, promotion of peaceful resolution of conflicts among the Partner States, safeguarding common values and fundamental interest and independence of the Community and to promote and enhance interface between the National Assemblies and the East African Legislative Assembly.

I take this opportunity to also update you on the process of Consultations on Fast Tracking the Political Federation. At the conclusion of Consultations in Kenya, Tanzania and Uganda a report was presented to the Summit in August, 2007, and while there was support for the Political Federation, the Summit decided that it will remain the ultimate goal to be established after the Common Market and Monetary Union by 2012. The Summit directed us to continue to mobilize and deepen sensitization on political integration, stimulate greater political will to promote deeper economic integration and to lock-in gains achieved from economic co-operation; and further noted that the Republic of Rwanda and the Republic of Burundi shall commence consultation processes on the establishment of a Political Federation.

Consequently National Consultations were launched in Burundi and Rwanda on 28<sup>th</sup> February to 3<sup>rd</sup> March, 2008 respectively.

Your Committee, drawn from arms of Governments that represent the people, is therefore, a key stakeholder in this activity and allow me to invite you to work with us to realize the abovementioned Summit decisions.

Finally, on governance, the Secretariat has initiated meetings with Experts from governments' departments that deal with:

- Democracy and rule of law;
- Anti-corruption, ethics and integrity;
- Social justice and equal opportunities;
- Human rights; and
- Gender equality

The result will be a Regional Framework on Good Governance and Anti-Corruption in East Africa with the above listed areas as the main pillars.

# Rt. Hon. Chairperson,

In conclusion, let me assure you of the Secretariat's commitment and ability to facilitate deliberations of this Committee to enable you have your meetings on a regular basis.

With these remarks, I thank you for listening to me and wish you well.

# WELCOMING STATEMENT BY HON. SAMUEL J. SITTA (MP), SPEAKER OF THE NATIONAL ASSEMBLY TO THE EAST AFRICAN INTER-PARLIAMENTARY COMMITTEE ON 3<sup>RD</sup> APRIL, 2008 AT COURTYARD HOTEL DAR ES SALAAM

Honourable Chairperson;

Honourable Members of Parliament;

Distinguished guests;

Ladies and Gentlemen:

# Hon. Chairperson,

I can think of no better way to preface my remarks this morning than with the words of the founding father of the Tanzanian nation, the late Mwalimu Julius Kambarage Nyerere. At the 40<sup>th</sup> Anniversary of Ghana's independence in 1997, Mwalimu declared: "...of all the sins that Africa can commit, the sin of despair would be the most unforgivable... unity will not make us rich, but it can make it difficult for Africa and the African peoples to be disregarded and humiliated... my generation led Africa to political freedom. The current generation of leaders and peoples of Africa must pick up the flickering torch of African freedom, refuel it with their enthusiasm, and carry it forward".

I feel greatly honoured and privileged (on behalf of the Parliament of Tanzania) to warmly welcome you all distinguished delegates to this important meeting. In particular I welcome you to Dar es Salaam, the cradle of the Inter-Parliamentary Committee for East Africa. I trust that given the vicinity of our countries, most of you might have visited Dar es Salaam before. I hope that you will find the weather in Dar es Salaam this time around much more pleasant than the rest of the year. On our side I am gratified to inform you that we have put in place the requisite facilities and arrangements to make this meeting a success and your stay comfortable.

### Hon. Chairperson,

East African Community like any other human family has expanded in size over the past few years. This has happened with the admission in recently of our brothers Rwanda and Burundi to the East African Community. We all know that when the treaty to the establishment of the community was signed in 1999, there were only three namely: Tanzania, Uganda and Kenya. members, But membership has increased to five. In this respect, I extend a special welcome to our Rwandan and Burundian brothers and sisters who are attending the Inter-Parliamentary Meeting for the first time. We in Tanzania we have a popular Swahili saying which goes: "Umoja ni nguvu na utengano ni udhaifu". It is our conviction therefore, that the coming of Rwanda and Burundi to the East African family will further underpin our resolve to achieving sustainable regional integration in the region.

#### Hon. Chairperson,

This meeting is taking place after the postponement of similar consecutive meetings in the past two years. The last meeting, I am told, took place in Entebbe, Uganda in February, 2005. These meetings did not take place because, in almost all member countries, elections were still going on. Of course, we all know that, we Parliamentarians are a product of the electoral Unless elections are conducted there is no way we can claim our existence.
