1.0 Preface

On behalf of the Departmental Committee on Labour and Social Welfare, it is my pleasure and duty to present the Committees report on the Sessional Paper No.3 of 2013 on the National Productivity Policy.

The Ministry intends to transform the Current Productivity Centre of Kenya into a strengthened National Productivity Council to effectively deal with Productivity in the Country through the aforesaid Policy which was tabled on 17th July, 2013.

As set out in standing order 216 (5), the Committee is mandated to;

- Investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments.

1.6 Committee Observations and Recommendations

1.6.1 Committee Observations

Having interrogated the Principal Secretary, Ministry of Labour, Social Security & Services and the relevant Heads of Departments while scrutinizing the policy paper, the Committee made the following observations, that;

- 1. The Country's level of productivity remains low and this is responsible for the low unsustainable economic growth.
- 2. The Country lacks policy, legal and Institutional framework to anchor the existing productivity initiatives and provide the required impetus for effective productivity management in the Country.
- 3. Well defined productivity policy guarantees an increased global competitiveness, creation of productive and sustainable jobs, rapid economic growth and high standard of living for all Kenyans.
- 4. A Country with a high productive organization is able to produce more quality and cost effective goods and services with the same amount of resources that are competitive in the local, regional and global markets.
- 5. Productivity is a key driver in economic growth of newly industrialized Countries in Asia, e.g. Japan, Malaysia, China etc.
- 6. The Ministry intends to transform the current Productivity Centre into a strengthened National Productivity Council to effectively deal with Productivity in the Country.

2.0. CONSIDERATION OF SESSSIONAL PAPER NO.3 OF 2013 ON NATIONAL PRODUCTIVITY POLICY

The Principal Secretary, Ministry of Labour, Social Security and Services Mr. Alinoor Ismail appeared before the Committee and briefed the Members on the aforesaid Sessional Paper as follows;

2.1. Background

- 1. Productivity is defined as a relationship between inputs and outputs in the production of goods and services. Socially, productivity is viewed as an attitude of mind which seeks to continually improve what already exist.
- 2. Productivity is also the efficiency and effectiveness with which factors of production are combined and utilized in an economically and environmentally sustainable manner to produce quality and cost effective goods and services.
- 3. Kenya has in the past made several attempts aimed at promoting productivity. Some of these initiatives are contained in the first National Development Plan (1964-1970); Wage Guidelines (1973-2005); Sessional paper No.1 of 1986 on Renewed Economic Growth; National Development Plan(1997-2001); Economic Recovery Strategy for Wealth and Employment Creation(2003-2007); Kenya Vision 2030 and its first medium Term Plan(2008-2012).
- 4. Kenya is faced with low productivity levels with a total factor productivity index of less than a unit. The Country's labour and capital productivity indices were 0.84 and 0.46 respectively in 2009. This is in contrast with the benchmark of a productivity index of at least 5 for global competitiveness. This is an implication Kenya's competitiveness is low.
- 5. Kenya is ranked behind Tunisia, South Africa, Mauritius Egypt, Morocco, Algeria and Libya in terms of global competitiveness.
- 6. Generally productivity has been incorrectly equated to production; that it only benefits the employers; is applicable to blue collar job workers; that productivity improvement leads to loss of jobs; and is just a means of working harder.

7. However productivity is about efficiency in resource utilization in the production of quality goods and services. Productivity leads to increased production with available resources and also leads to job creation and retention.

3.0. ANALYSIS OF THE NATIONAL PRODUCTIVITY POLICY

3.1 Scope of the policy.

The policy addresses the multiple challenges impending productivity advancement in the economy under four pillars namely; productivity culture, labour market, development, technological change and innovation; and institutional and legal arrangements.

3.2 Rationale for developing a productivity policy.

- 1. Whereas Kenya has implemented several productivity improvement interventions in the past, the country's level of productivity remains dismally low and is responsible for the low, unstable and unsustainable economic growth.
- 2. The previous productivity improvement interventions lacked focus were non comprehensive, poorly coordinated and hardly implemented. The Country also lacked policy, and legal and institutional framework to anchor the productivity initiatives and provide the required impetus for effective productivity management in the Country.
- 3. This Sessional Paper on National Productivity contains specific measure that will be undertaken to address past weaknesses. The ultimate goal is to guarantee increased global competitiveness, creation of productive and sustainable jobs, rapid economic growth and high standards of living for all Kenyans.



3.3 Emerging issues and Challenges.

- 1. Poor productivity culture- work ethics
- Weak human resource base- A well educated workforce but lacking in key skills, ingenuity and creativity, skills mismatch
- 3. Weak labour-management partnership. Manifested in poor involvement of employees in decision making
- 4. Poor work environment.
- 5. Lack of productivity measurement
- 6. Low prioritization of research & development critical for innovation and inventions
- 7. Slow pace in technological adoption due to lack of relevant information & cost aspects
- 8. Lack of legal and institutional framework

4.0. COMMITTEE OBSERVATIONS.

Having interrogated the principal secretary, Ministry of Labour, Social Security & Services and the relevant Heads of Department while scrutinizing the policy paper, the Committee made the following observations. That;

- 7. The Country's level of productivity remains low and this is responsible for the low unsustainable economic growth.
- 8. The County' lacks policy, legal and Institutional framework to anchor the existing productivity initiatives and provide the required impetus for effective productivity management in the Country.
- Well defined productivity policy guarantees an increased global competitiveness, creation of productive and sustainable jobs, rapid economic growth and high standard of living for all Kenyans.
- 10. A Country with a high productive organization is able to produce more quality and cost effective goods and services with the same amount of resources that are competitive in the Local, regional and global markets.
- 11. Productivity has acted as the key driver in economic growth of newly industrialized countries in Asia. e.g. Japan, Malaysia, and China.
- 12. The Ministry-intends to transform the Current Productivity Centre of Kenya into a strengthened National Productivity Council to effectively deal with Productivity in the Country.

5.0 COMMITTEE RECOMMENDATIONS

The Committee recommended that:

1. The House adopts the National Productivity Policy as contained in the Sessional Paper No. 3 of 2013.

- 2. The Ministry of Labour, Social Security and Services should ensure that the policy:
