

#### 2.0 BACKGROUND

#### 2.1 The Petition

()

The Petition was presented to the National Assembly by Hon. Beatrice Nkatha Nyaga, MP and member for Tharaka Nithi County on behalf of the residents of Tharaka Nithi County.

The Petition is on alleged non-refunded cash bails by Marimanti Law Courts and draws the attention of the House to the following;

- a. That, Article 49 (1) (h) of the Constitution entitles an arrested person to the right to be released on bond or bail, on reasonable conditions, pending a charge or trial, unless there are compelling reasons not to be released.
- b. That, majority of the petitioners are living in abject poverty and have therefore been subjected to untold suffering considering that many of them paid their cash bails from funds secured through loan facilities.
- c. That the petitioner's representatives have sought redress from relevant authorities, namely Marimanti Law Courts officials, the area criminal investigation Department, human rights groups and area sub-county Commissioner without success.
- d. That the frustrated victims of unpaid cash bails have since been forced to form an association with elected representatives to pursue the matter on their behalf.
- e. That the matter in which the petition is raised is not pending before any court of law or constitutional body.

#### 2.2 CONSIDERATION OF THE PETITION BY THE COMMITTEE

The Committee through the office of the Clerk of the National Assembly wrote to the Chief Registrar of the Judiciary for more information on the matter under consideration. The Chief Registrar vide a letter dated 16<sup>th</sup> March, 2016 informed the Committee as follows:

- a. Marimanti Law Courts was established in 2007 to serve the community of Tharaka South District who were travelling 70 km and more to seek justice at Chuka Law Courts in Meru South District.
- b. The Station is housed on premises rented from the DC and has two magistrates.From inception, the Station had never had an accountant until March 2014, when an Accounts Assistant was posted there.

The Deposits of the Station are in two categories:

- Old Deposits with the National Treasury (for period 2007 to August 2012).
- Current Deposits in the Station's Bank Account (from September 2012 to date)

#### Old Deposits with the National Treasury – Ksh. 1,127,000

#### i. The operation

From the inception of the Court up to August 2012, the legal deposits of the Court used to be managed at the National Treasury at the Tharaka South District Treasury. The Court Station would collect deposits in cash then surrender the cash to the District Treasury which was then being banked in a pool Bank account together with monies for other Government Departments. Refunds of the deposits were being also made through the District Treasury.

In September 2012, the Court Station within the framework of Judicial transformation opened its bank account with the Cooperative Bank of Kenya. Thus, deposits were now in two pockets: one the deposits banked in the District Treasury bank account and two, the deposits banked in the Station's bank account. Consequently, depositors' refunds would be made from the account where the money was banked.

#### ii. Discovery of misappropriation

It was around April 2013 after an experience of difficulties and delays in making refunds, when it was discovered that the legal deposit monies surrendered to the District Treasury for banking had been instead misappropriated by the cashier. The District Treasury informed the Station that their bank account ledgers didn't reflect any money held as legal deposits despite the Station's Deposits Ledger Book reflecting outstanding deposits. The outstanding Deposit Ledger listing with respect to this account amount to Kshs.1, 127,000 of which most cases were concluded, but refunds can not be made due to unavailability of the funds. This has caused unrest by the affected parties.

#### Actions taken

()

- a. 11<sup>th</sup> April 2013, the Station reported the matter to the District Commissioner's office.
- b. 18th April 2013, the District Accountant made a formal report to the police.
- c. 24<sup>th</sup> July 2013, the District Accountant forwarded the Official Loss Report Forms to the Principal Secretary, The National Treasury through the Tharaka South District Commissioner.
- d. After the Loss Report, the Principal Secretary interdicted the concerned officer for gross misconduct and DCIO commenced investigations which have not been concluded to date.
- e. 21<sup>st</sup> April 2015, the Station wrote to the District Accountant and DCIO Tharaka South seeking to be updated with the progress on the matter.
- f. 23<sup>rd</sup> April 2015, the District Accountant informs the Station that the matter was still with the DCIO.
- g. 23<sup>rd</sup> April 2015, DCIO responded confirming that the case was still pending under investigations as they were yet to receive an external audit report which they requested to be done at the Treasury.
- h. 20th May 2015, The Chief Registrar of the Judiciary requested the Principal Secretary, The National Treasury to avail the lost funds to enable finalization of outstanding deposit refunds for the concluded cases.
- i. 25th August 2015, Office of the Principal Secretary, The National Treasury advised the Judiciary to factor the lost funds in its budget.

#### 2.2 PRAYERS

#### The Petitioner prays that the National Assembly:

a. Commences inquiry into the unclear circumstances cash bails due to be refunded to the petitioners have not been paid long after their cases were heard and determined by the court. N.

b. Intervenes to ensure that the Judiciary reimburses the petitioners the cash bail owed, together with accrued interest as computed from the date the cases were determined and disciplinary action be instituted against any officer (s) who obstructed payment of the said cash bail refunds in one way or another. have the Government provide social assistance to the family and other victims of terror attacks for the loss of livelihood, injuries and any properties.

#### 3.0 COMMITTEE'S OBSERVATIONS

- a. The Judiciary has acknowledged non-refund of cash bails at the Marimanti Law Courts and taken steps to address the settle the issue.
- b. The Judiciary has factored the lost funds of Ksh.1, 127,000 in the FY 2016/2017 budgetary estimates for settlement from July 2016 when the funds are received from the National Treasury.
- c. The refund of current deposits whose funds are held at the Station's bank account with the Cooperative Bank, Chuka Branch is being done promptly through cheques as the cases are concluded (see attached notice to the members of the public notifying them of the uncollected cheques).
- d. There is no bank located within the Marimanti shopping center, thus, the Station collects cash and then banks weekly during the Thursday's Cooperative Bank mobile visits.
- e. The Judiciary's plans are at an advanced stage to introduce cashless collections with the bank via mobile banking.
- f. Save for the Kshs.1,127,000 outstanding deposits with respect to the lost funds, the Station has endeavored to comply with the Judicial requirements of making deposits refunds within the shortest time possible.

#### 4.0 RECOMMENDATION

The Committee recommends that;

- i. The outstanding cash bails be refunded by the Judiciary in the current financial year 2015/2016 Supplementary Budget Estimates.
- ii. The, Directorate of Criminal Investigations should conclude its investigations expeditiously and take legal action against persons who may have fraudulently contributed to non-refund of cash bails by Marimanti Law Courts.

#### RE: PETITION TO THE NATIONAL ASSEMBLY ON NON-REFUND OF CASH BAIL AT MARIMANTI LAW COURTS

We the undersigned residents of Tharaka Constituency, Tharaka Nithi County, hereby forward our petition through our Member of Parliament Hon. Beatrice Nkatha for consideration by the National Assembly.

This petition is necessitated by the fact that officers at the Marimanti law courts have refused/failed to refund our cash bails deposited with the court long after the determination of our cases. A majority of the cases in question commenced in 2012 and have since been determined. However, we have not been refund our cash bail amounts ranging from Ksh. 5000 to Ksh. 50,000.

The petitioners herein have been meeting at Marimanti center and have elected officials chaired by Dickson Njeru to champion their interests. The petitioner's representatives have met and sought assistance from various government officers. They include the magistrate and court prosecutor at Marimanti law courts as well as the area CID boss. However, the issue remains unresolved despite all this meetings.

The group has further sought the intervention of human rights group but this endeavor has equally not borne fruit. At one point, the human rights group organized a demonstration for the petitioners but they were dispersed by a team of heavily armed security officers.

The petitioners have only received a good reception at the District Commissioner's (DC's) office. He promised to take up the matter but no feedback was ever received from the office. At one time, the Chair was approached by individuals who offered to bribe him so that he could quit pursuing the matter. The petitioners are poor citizens living in abject poverty and have therefore been affected psychologically by this issue. In fact, a majority of the petitioners took up loan facilities to secure funds for the cash bails.

### PETITION BY RESIDENTS OF THARAKA CONSTITUENCY ON NON-REFUND OF CASH BAIL

We hereby confirm that we have made efforts to have the matter addressed by relevant authorities but our efforts have been unsuccessful. We also confirm that the issues in respect of which the petition is made are not pending before any court of law or constitutional or other legal body.

Therefore, your humble petitioners pray that the National Assembly—

- 1. Investigate this Matter
- 2. Recommend to the Chief Justice that the cash bail be refunded with interest computed from the date of determination in respect of each case; and
- 3. Recommend to the Chief Justice to take the necessary disciplinary action against the officers responsible for the non-refund of the cash bail.

#### THE JUDICIARY

#### STATUS OF DEPOSITS FOR MARIMANTI LAW COURTS

#### 1. INTRODUCTION

Marimanti Law Courts was established in 2007 to serve the community of Tharaka South District who were travelling 70 km and more to seek justice at Chuka Law Courts in Meru South District.

The Station is housed on premises rented from the DC and has two magistrates.

From inception, the Station had never had an accountant until March 2014, when an Accounts Assistant was posted there.

The Deposits of the Station are in two categories:

- 1. Old Deposits with the National Treasury (for period 2007 to August 2012).
- 2. Current Deposits in the Station's Bank Account (from September 2012 to date)
- 2. OLD DEPOSITS WITH THE NATIONAL TREASURY- KSHS.1,127,000
- i. The operation

From the inception of the Court up to August 2012, the legal deposits of the Court used to be managed at the National Treasury at the Tharaka South District Treasury. The Court Station would collect deposits in cash then surrender the cash to the District Treasury which was then being banked in a pool Bank account together with monies for other Government Departments. Refunds of the deposits were being also made through the District Treasury.

In September 2012, the Court Station within the framework of Judicial transformation opened its bank account with the Cooperative Bank of Kenya. Thus, deposits were now in two pockets: one the deposits banked in the District Treasury bank account and two, the deposits banked in the Station's bank account. Consequently, depositors' refunds would be made from the account where the money was banked.

#### ii) Discovery of misappropriation

It was around April 2013 after an experience of difficulties and delays in making refunds, when it was discovered that the legal deposit monies surrendered to the District Treasury for banking had been instead misappropriated by the cashier. The District Treasury informed the Station that their bank account ledgers didn't reflect any money held as legal deposits despite the Station's Deposits Ledger Book reflecting outstanding deposits. The outstanding Deposit Ledger listing with respect to this account amount to Kshs.1,127,000 of which most cases were concluded, but refunds can not be made due to unavailability of the funds. This has caused unrest by the affected parties.

#### Actions taken

- a. 11<sup>th</sup> April 2013, the Station reported the matter to the District Commissioner's office.
- b. 18<sup>th</sup> April 2013, the District Accountant made a formal report to the police.
- c. 24<sup>th</sup> July 2013, the District Accountant forwarded the Official Loss Report Forms to the Principal Secretary, The National Treasury through the Tharaka South District Commissioner.
- d. After the Loss Report, the Principal Secretary interdicted the concerned officer for gross misconduct and DCIO commenced investigations which have not been concluded to date.
- e. 21<sup>st</sup> April 2015, the Station wrote to the District Accountant and DCIO Tharaka South seeking to be updated with the progress on the matter.
- f. 23<sup>rd</sup> April 2015, the District Accountant informs the Station that the matter was still with the DCIO.
- g. 23<sup>rd</sup> April 2015, DCIO responded confirming that the case was still pending under investigations as they were yet to receive an external audit report which they requested to be done at the Treasury.
- h. 20<sup>th</sup> May 2015, The Chief Registrar of the Judiciary requested the Principal Secretary, The National Treasury to avail the lost funds to enable finalization of outstanding deposit refunds for the concluded cases.

 25<sup>th</sup> August 2015, Office of the Principal Secretary, The National Treasury advised the Judiciary to factor the lost funds in its budget, which has been done for the FY 2016/17 budgetary estimates.

#### Way forward on the matter

Having factored the lost funds of Kshs.1,127,000 in the FY 2016/17 budgetary estimates, the outstanding deposit refunds thereof, can only be settled as from July 2016 when the funds are received from The National Treasury.

#### 3. CURRENT DEPOSITS IN THE STATION'S BANK ACCOUNT

The summary of a brief quick reconciliation of the Outstanding Current Deposit listings against the funds available in the Bank Account is as below.

Comprehensive reconciliation needs to be done to ascertain the exact shortage or excess and all the pending reconciling items cleared.

The refund of current deposits whose funds are held at the Station's bank account with the Cooperative Bank, Chuka Branch is being done promptly through cheques as the cases are concluded (see attached notice to the members of the public notifying them of the uncollected cheques).

Cooperative Bank mobile visits. Plans are at an advanced stage to introduce cashless collections with the bank via mobile banking.

#### 4. CONCLUSION

Save for the Kshs.1,127,000 outstanding deposits with respect to the lost funds, the Station has endeavored to comply with the Judicial requirements of making deposits refunds within the shortest time possible.

### RE: MISAPPROPRIATED DEPOSITS;-

Please refer to the above captioned matter in which Judiciary deposits were misappropriated by staff at the District Treasury and have remained unpaid since September 2012 to date.

The matter was initially reported by my predecessor (Hon. P. M. Kiama -PM) vide a letter dated 13<sup>th</sup> April 2013 addressed to the District commissioner and copied to your office. I also raised the issue when I took over as head of station vide my letter dated 30<sup>th</sup> April 2014. (the letters aforesaid have been attached for ease of reference). The then District Accountant made a formal report to the police vide OB No 11 of 18/4/1013 at Marimanti Police Station and extract of which we have attached.

The investigations into the loss of the funds has not been completed and the still remain unpaid. We are under pressure to refund the

deposits for the finalized cases but it has been difficult pushing the other government agencies to act and resolve this case. So far an audit requested by the DCIO Tharaka South Police Division has not been completed to facilitate further action (find a copy of letter from the DCIO Tharaka South Police Division confirming as much).

The purpose of this letter is to request your office to intervene on our behalf and implore the National Treasury to release money for refund of the deposits as they continue to follow up the matter with their staff at the District Treasury where the deposits were misappropriated.

We look forward for your favourable intervention in this matter to facilitate service delivery to the public.


