COMMUNICATION FROM THE CHAIR

COMMISSION OF INQUIRY INTO THE PETITION TO DISSOLVE MAKUENI COUNTY GOVERNMENT

The Speaker (Hon. Ethuro): I have a communication from the Chair on the Commission of inquiry into the Petition to dissolve the Makueni County Government.

Hon. Senators, Article 192 of the Constitution, as read together with Section 122 of the County Governments Act provides for the suspension of a County Government by the President, in an emergency arising out of internal conflict or war, or in any other exceptional circumstances. Section 123 of the County Governments Act states as follows:-

- "(1) Subject to subsection (2), a person may petition the President to suspend a county government in accordance with Article 192(1) (b) of the Constitution if the county government engages in actions that are deemed to be against the common needs and interests of the citizens of a county.
- (2) A Petition under sub-section (1) shall be supported by the signatures of not less than 10 per cent of the registered voters in the county.
- (3) The President shall, within fourteen days after receiving a Petition against a county government under sub-section (1), submit a report on the averments made and grounds giving rise to suspension of a county government before the apex inter-governmental body (hereinafter referred to as the apex body) established under the law governing inter-governmental relations for approval."

Hon. Senators, pursuant to these provisions, I have received correspondence, dated 6th February, 2015, from the presidency informing me that His Excellency the President received a Petition for the suspension of the Makueni County Government. Subsequent to the receipt of the Petition, His Excellency the President requested the Independent Electoral and Boundaries Commission (IEBC) to confirm the veracity of the signatures annexed to the Petition to ensure

that the requirement under Section 123 (2) of the County Governments Act had been satisfied and that those who supported the Petition were indeed registered voters of Makueni County. The IEBC subsequently confirmed that Section 123 (2) of the County Governments Act had been satisfied.

Consequently, in compliance with Section 123 (3) of the County Governments Act, His Excellency the President submitted the Petition and a report of the same to the National and County Government Coordinating Summit established under Section 7 (1) of the Intergovernmental Relations Act, for its approval. Subsequently, the National and County Government Coordinating Summit approved the report on 8th December, 2014.

I will resume my seat to allow the Senators at the Bar to enter.

(Hon. Senators entered the Chamber and assumed their seats)

(Sen. Ong'era stood up in her place)

Order, Sen. Ong'era, it is a privilege to be allowed to enter the Chamber by the Chair and so, the sooner you assume the seat the better for everybody.

(Sen. Wako stood up in his place.)

Order, Sen. Wako, just because I mentioned Sen. Ong'era's name does not mean it applies to you as well.

Hon. Senators, Section 123 of the County Governments Act further provides as follows:-

- "(4) Upon approval by the apex body, the President shall nominate members of a Commission to inquire into and investigate the situation in the county and make recommendations on the suspension of the county government and shall, after approval by Senate, appoint the members of the Commission by notice in the Gazette.
 - (5) The Commission shall comprise—
- (a) a chairperson, who shall be an advocate of the High Court of Kenya with at least fifteen years' experience;
 - (b) the chairperson of the National Police Service;
- (c) two persons resident in the affected county and who have not for the last ten years stood for an elective office in the affected county government, or have been an officer or employee of the affected county government; and
- (d) two other persons not resident in the affected county with experience in conflict management.
- (6) The Commission shall have all or any of the powers vested in a Commission under the Commissions of Inquiry Act (Cap. 102), and at any inquiry directed under this section, the county government in question and any member thereof shall be entitled to be heard.
- (7) The Commission shall inquire into the matters before it expeditiously and report on the facts and make recommendations to the President."

Hon. Senators, pursuant to Article 192 (2) of the Constitution as read together with the above provisions of the County Governments Act, His Excellency the President is required to appoint a Commission of Inquiry to investigate the veracity of the allegations set out in the Petition.

Hon. Senators, by letter Ref: No. OP/CAB.1/40/2A dated 6th February, 2015 and received in the Office of the Speaker of the Senate on 9th February, 2015, the Chief of Staff and Head of the Public Service informed the Speaker that pursuant to section 123 (5) of the County Governments Act, His Excellency the President has nominated the following persons to the Commission of Inquiry to investigate the veracity of the allegations set out in the Petition for the dissolution of Makueni County Government:-

Hon. Senators, I now direct that the names and curriculum vitae of the six nominees be forwarded to the Sessional Committee on Devolved Governments for vetting. The Committee should file its report within 14 days from today for deliberation by the Senate pursuant to Section 123 (4) of the County Governments Act. In carrying out the vetting process, the Committee must adhere to the provisions of the Public Appointments (Parliamentary Approval) Act, 2011.

DEMISE OF HON. GEORGE MUKURU MUCHAI, MEMBER FOR KABETE CONSTITUENCY

The Speaker (Hon. Ethuro): Order Senators! I have one Communication to make on the demise of Hon. George Mukuru Muchai.

Hon. Senators, as you may be already aware, on the morning of Saturday, 7th February, 2015, the Hon. George Mukuru Muchai, Member for Kabete Constituency, together with his two bodyguards and a driver, lost their lives when they were attacked by armed thugs along Kenyatta Avenue, Nairobi.

Records in Parliament indicate that the late Hon. George Muchai was born on 22nd July, 1949. He attended St. Michael Primary School between 1956 and 1963 and Highway Secondary School, Nairobi between 1964 and 1967. He obtained a Certificate in Electrical Installation Trade Test from the Railway Training School in 1974. Later, the late Hon. Muchai attended the Kenya Polytechnic where he was awarded a Certificate in Electrical Installation Technology. He thereafter undertook several courses on labour matters, regionally and internationally.

The late Hon. Muchai was an active and vibrant labour unionist, having been elected as the General Secretary of the Bakery, Confectionery, Food Manufacturing and Allied Workers' Union in 1984, a position he still held until his demise, owing to his passion for and responsiveness to the needs of the people he represented. His empathy and humility largely endeared him to the workers of this nation and saw him overwhelmingly elected as the Deputy Secretary General of the Central Organization of Trade Unions (COTU) in 2001. Indeed, he never lost an opportunity to air the problems that befall the masses, especially workers, whom he continued to represent for the last three decades.

Hon. Senators, the late Hon. George Muchai made his debut in national politics in the run-up to the 2013 General Elections when he successfully vied for the Kabete Constituency seat, Kiambu County. His swift mastery and grasp of parliamentary business ensured that his contributions were keenly followed by all. Particularly, his contributions on legislations related to the labour and education sectors were insightful and tremendously enriching to the matters under debate. He was an active Member of the Departmental Committee on Labour and Social Welfare as well as the Budget and Appropriations Committee of the National Assembly.

On behalf of all Senators and indeed on my own behalf, I wish to take this opportunity to condole with the family of the late Hon. Muchai, the people of Kabete Constituency and all his friends for the loss of this great trade unionist and a people's defender at this trying time. I also condole with the families of the late police constables Samuel Lekakeny Montata and Samuel Kimathi Kairingia who were security officers of the deceased Hon. Member and the late Stephen Ituu Wambugu, the driver of the late Hon. Muchai. As the Senate, we assure the families of our support during this period of great sorrow.

As I conclude, I would like to appeal to the concerned security agencies to move with speed in investigating this heinous crime with a view to bringing the perpetrators to book. It is only through this that the nation, and indeed the families of the departed, will rest knowing that

justice, and indeed the sacredness of every life as enshrined in the Constitution, will have prevailed. May his soul and the souls of his departed staff rest in eternal peace.

As I promised yesterday, I will allow a few minutes for Senators to eulogise our departed colleague.

SCHEDULE FOR THE PROCESSING OF THE BUDGET POLICY STATEMENT 2015 BY THE SENATE

The Speaker (Hon. Ethuro): Hon. Senators, as you are aware, the legislative budget cycle for 2015/2016 Financial Year and the Medium Term has begun with the submission of the following four documents to Parliament, yesterday 16th February, 2014. The four documents are:

- (a) The Medium Term Budget Policy Statement (BPS) 2015, which contains proposals for the 2015/2016 fiscal framework, showing the projected revenues and proposed expenditure ceilings as well as the economic indicators guiding budget formulation;
- (b) The Medium Term Debt Management Strategy, 2015, which shows the total indebtedness of the country, the proposed borrowing to finance the 2015/2016 Budget and strategies of ensuring that the country's debt remains sustainable;
- (c) A legislative proposal on the Division of Revenue, 2015, seeking to anchor in law the amount of national revenue to be divided between the national Government and the devolved level of Government (vertical division of revenue); and,
- (d) A legislative proposal on the County Allocation of Revenue, 2015, proposing the exact amounts due to each county or central division of revenue.

Hon. Senators, Section 25(7) of the Public Finance Management Act, 2012, provides that the BPS should be passed by Parliament within 14 days. This means that both Houses of Parliament should have dispensed with the BPS as well as the Medium Term Debt Management Strategy (MTDMS) by 3rd March, 2015, so as to allow the smooth interface of these documents with the subsequent budget documents, which include the introduction of both the Division of Revenue as well as the County Allocation of Revenue Bills in Parliament. This will also allow sufficient time for the respective county fiscal strategy papers to be aligned with the BPS, as provided in Section 117(2) of the Public Finance Management Act, 2012.

In light of the limited amount of time occasioned by the strict deadlines in the processing of both the BPS as well as the MTDMS, a schedule that will guide the processing of both documents in the Senate has been prepared and is available at the Journals Office. I now direct that it be made available to all Senators. I would like to remind the hon. Senators that we must abide by the Budget cycle.

FORMATION OF JOINT COMMITTEE TO VET THE NOMINEE FOR THE POSITION OF INSPECTOR- GENERAL OF THE NATIONAL POLICE SERVICE

The Speaker (Hon. Ethuro): Hon. Senators, I have the following Communication to make. You recall at the sitting of Wednesday, 18th February, 2015, the Senate Minority Leader, Sen. Wetangula, rose on a point of order seeking the guidance of the Speaker on the matter of the formation of the Joint Committee of the Senate and the National Assembly to vet the nominee for the position of Inspector-General of the National Police Service.

In particular, Sen. Wetangula sought clarification on whether the Senate had passed a resolution for the establishment of the Joint Committee. The Senator further raised concerns on the procedure to be followed by the Joint Committee and whether the Fourth Schedule to the Standing Orders which sets out the rules for Joint Committees of Parliament would apply to the proceedings of the Joint Committee.

Sen. Wetangula took the view that each House, through its respective Committee, ought to have vetted the nominee and the procedure for mediation should thereafter have been applied if the House were to arrive at a different conclusion on the suitability or otherwise of the nominee.

Sen. Murkomen and Sen. Orengo also rose on points of order and made contributions on the matter. In supporting Sen. Wetangula, Sen. Orengo observed that as a matter of constitutional design, the perspectives of the two Houses while vetting the nominee would be different and it would therefore be important that each House separately vets the nominee.

Hon. Senators, as you will recall on Tuesday, 17th February, 2015, I conveyed to the Senate a Message from His Excellency the President on the nomination of Mr. Joseph Kipchichir Boinet for appointment to the position of Inspector–General of the National Police Service. While conveying the Message, I indicated that having consulted with my brother, the Hon. Speaker of the National Assembly, and taking into account the strict 14 day timeline stipulated in the Public Appointments (Parliamentary Approval Act), No. 33 of 2011 and also the prolonged vacancy in the office of the Inspector-General, an important constitutional office holder and a host of activities that required to be undertaken within that short period of time, we agreed that the vetting of the nominee be jointly conducted by the Senate Standing Committee on National Security and Foreign Relations and the National Assembly Departmental Committee on Administration and National Security.

In arriving at this decision, it was observed that Section 9 of the Public Appointments (Parliamentary Approval Act) states that if after the expiry of the 14 day period for consideration of the nomination, Parliament has neither approved nor rejected the nomination of the candidate, the candidate would be deemed to have been approved for appointment.

However, In light of these timelines and the requirement for approval of the nomination by both Houses of Parliament, Parliament runs the real risk of failing to meet the stipulated timelines thereby abdicating its important constitutional function of vetting the Inspector—General of the National Police Service. This would be a great disservice to the people of Kenya

who are anxiously waiting the vetting of the nominee and the eventual appointment of a new Inspector-General.

I must, however, hasten to add that, the establishment of a Joint Committee of the two Houses for vetting of a nominee for appointment should not be an exceptional measure to be taken out of necessity such as the case in this situation. This should not and was not intended to be the general rule or the precedent to be applied for the future processes.

As such, it is of utmost importance that the timelines in the Public Appointment (Parliamentary Approval Act) which are replicated in Section 12 of the National Police Service Act, No.11A of 2011, be scrutinized with a view to ensuring the practicality of the timelines in the context of a bicameral Parliament. It is evident that the timelines set out in these provisions of the law did not take into account the dual vetting processes to be undertaken by the approval of both Houses of Parliament is required.

In this regard, I hereby direct the Standing Committee on Legal Affairs and Human Rights to interrogate this matter further and to Table its Report within 21 days of this Communication.

CONVENING OF SPECIAL SITTING OF PARLIAMENT FOR ANNUAL STATE OF THE NATION ADDRESS BY HIS EXCELLENCY THE PRESIDENT

The Speaker of the National Assembly (Hon. Muturi): Your Excellency, Hon. Uhuru Kenyatta, President of the Republic of Kenya and Commander-in-Chief of the Kenya Defence Forces, the hon. Speaker of the Senate, hon. Ekwe Ethuro, hon. Members of Parliament, Article 132(1)(b) of the Constitution of Kenya requires the President to address a Special Sitting of the Parliament of Kenya once every year and at any other time. Further, Article 132(1)(c) requires the President to, among others:-

"once every year-

- (i) report, in an address to the nation, on all the measures taken and the progress achieved in the realisation of the national values, referred to in Article 10: and.
- (iii) submit a report for debate to the National Assembly on the progress made in fulfilling the international obligations of the Republic."

In addition, Article 240(7) of the Constitution requires the President to report to Parliament annually on the state of the security of the Republic.

In this regard, hon. Members, following a request from His Excellency the President and pursuant to Article 132 (1)(b) and (c) (i) and (iii) of the Constitution and the provisions of Standing Order No.22 (1) and (2) of the National Assembly Standing Orders, by Gazette Notice No.1978, which was published in a Special Issue of the Kenya Gazette on 20th March, 2015, I gave notice of this Special Sitting to the Members of the National Assembly.

Similarly, pursuant to Article 132(1)(b) and (c)(i) and (iii) of the Constitution and the provisions of Standing Order No. 22(1) and (2) of the Senate Standing Orders, by Gazette Notice No.1980, which was published in a Special Issue of the Kenya Gazette on the 24th March, 2015, the Speaker of the Senate gave notice of this Special Sitting to the Senators. Accordingly, hon. Members, this Special Sitting is properly convened.

It is now my singular honour and privilege to invite His Excellency the President of the Republic of Kenya to address this Special Sitting of Parliament.

SUBMISSION OF DRAFT REGULATIONS OF THE PUBLIC FINANCE MANAGEMENT ACT BY THE PS TREASURY

The Speaker (Hon. Ethuro): Hon. Senators, I have a Communication to make on the submission of the Public Finance Management (National Government Regulations 2015), Public Finance Management (County Government Regulations 2015) and Legal Notice for Declaration of the National Government Entities (State Organs).

Hon. Senators, Section 205(1) of the Public Finance Management Act gives the Cabinet Secretary responsible for Finance powers to make regulations to give effect to some provisions of the Act. Section 205(4) of the Public Finance Management Act, further provides that such regulations made by the Cabinet Secretary must be approved by a resolution passed by Parliament.

Hon. Senators, pursuant to the above provisions and by a letter reference number. CONF.1/022/Vol.II/95, dated 13th March, 2015, addressed to the Clerk of the Senate,the Principal Secretary in the National Treasury submitted the following:-

- (i) Draft public finance management (national Government) regulations, 2015.
- (ii) Draft public finance management (county governments) regulations, 2015.
- (iii) Draft Legal Notice for declaration of the National Government Entities (State Organs).

Hon.Senators, I now direct the Chairperson of the Sessional Committee on Delegated Legislation to table the three draft Legal Notices and, further, that the draft Legal Notices be committed to the Sessional Committee on Delegated Legislation for consideration. The Committee should file its Report on or before Thursday 26th March, 2015 and this is significant for deliberation by the Senate pursuant to section 205(4) of the Public Finance Management Act.

Hon. Senators, I also wish to draw the attention of the Senate to the provisions of Section 205(6) of the Public Finance Management Act which states as follows:-

"If a House of Parliament does not make a resolution either by approving or rejecting any regulations within 15 sitting days after submission for its approval, the House shall be deemed to have approved those regulations."

Hon. Senators, I take this opportunity on behalf of the Senate and on my own behalf, to wish the delegation a happy and fruitful visit in the Senate. As you know, the Senate is dedicated to the protection and promotion of county interests.

EXTENDING DISCUSSIONS ON A MATTER BEFORE A COMMITTEE OUTSIDE THE HOUSE

Hon. Senators, on Tuesday 3rd March, 2015, the Senator for Mombasa County, Sen. Hassan drew the attention of the House to an Article appearing in a Sunday newspaper of 1st March, 2015 covering information allegedly divulged by the Chairperson of the Standing Committee on Education, Sen. Karaba. Sen. Hassan claimed that the information given to the media breached Standing Order No.88 of the Senate as it amounted to pre-empting or anticipating debate as the matter was being investigated by a Committee of the Senate, on disturbances facing the University of Eldoret.

Hon. Senators, although the Senator quoted Standing Order No.88 that relates to anticipating debate, the appropriate Standing Order is No.89 which states:-

"No Senator shall refer to the substance of the proceedings of a Select Committee before the Committee has made its report to the Senate."

I wish to note that the above provision applies to debate within the House which gives the principle of application of the rule of extending discussions by Senators outside the House.

The question of Members of the House taking debate or commenting on matters pending before the House or Committees outside the House is not new. Therefore, as you can expect, there is a well developed path in terms of procedure which is codified through rules and practice, which as you are well aware, is uncodified and set by precedence mostly through Communications from the Chair. Let me remind Senators that the Chair comprehensively pronounced itself on the subject in the last Session and that position has not changed.

Hon. Senators, I have looked at the article in the newspaper referred to by Sen. Hassan titled "Senate Team Unearth Rot at Eldoret Varsity." It is a report summarizing alleged problems confronting the institution that led to the unrest from the author's perspective, in the course of their work of reporting Committee activities. It is not quoting or referring to a Statement issued by or attributed to a Member of the Committee or any other Senator, or indeed, including the Chairman himself. Therefore, arising from the foregoing, the Chair is satisfied that the reporters who filed the story were within the parameters provided by the Constitution and our rules of procedure and hence there was no breach of the rules by any Senator, nor by the newspapers.

Hon. Senators, I also applaud and commend Members of the Committee for staying the course and not being carried away and deviating from the task at hand, namely; making proposals that will assist the university back to its feet as the specialized agency of the House in education matters. I, therefore, wish to encourage all Senators, starting with Sen. Hassan, to be reading the stories more carefully before they bring the matter to the House.

CLARIFICATION OF THE WORDS "DEMEANOUR"

AND "MISDEMEANOUR"

The Speaker (Hon. Ethuro): Hon. Members, I want to start by giving the definitions. A "demeanour" is a mien, facial appearance and behaviour. A misdemeanour is a minor offence.

(Loud consultations and laughter)

When the Senate Minority Leader, Sen. Wetangula, rose to seek a clarification from the Chairperson, Sen. (Prof.) Kindiki, he said:-

"Mr. Speaker, Sir, you heard the Chairman tell us and you could see from his demeanour--- That is the word he used; facial appearance; "that he did not even appear---" Indeed, Sen. Wetangula even used the word "appear," which was really being repetitive for purposes of emphasis;

"to believe in what he was saying; that our forest cover is 6.9 per cent. This is a big joke---"

And he continued.

Now, when the Chairperson rose to respond, he said:-

"Before I even proceed, I seek your indulgence. I am very disturbed that an hon. Member can stand and say: 'reading from my misdemeanour---'

(Laughter)

"I take it that the Member hates some inherent trait of my personality and not only for today. I will need your protection because the personal grudge being brought under the table in terms of misdemeanour---"

(Laughter)

I challenged him as the Chair and the Chairman of the Committee responded;

"Mr. Speaker, Sir, I mean misdemeanour."

The Senate Minority Leader retorted:

"It is demeanour and not misdemeanour."

I pointed out to the Chair that he is the one referring to himself in the word "misdemeanour" That is not what the Senate Minority Leader said. He repeated saying that the key word here was "misdemeanour."

So, I, therefore, direct that the key word "misdemeanour" was not part of the words used by the Senate Minority Leader. And that the two words are not related.

(Laughter and applause)

NOTICE OF SPECIAL SITTING OF PARLIAMENT

The Temporary Speaker (Sen. Murkomen): Hon. Senators, as you may be aware, Article 132(1)(b) of the Constitution and the Standing Order 22(1) of the Senate Standing Orders require the President to address a special sitting of Parliament once every year and at any other time. Further, pursuant to Article 247 of the Constitution, His Excellency the President will also report on the state of the security of Kenya.

I, therefore, urge all the hon. Senators to attend the Special Sitting, which is an important occasion in the Calendar of Parliament; that provides the opportunity for His Excellency the President to deliver the State of The Nation Address and address the legislature and people of Kenya on critical matters concerning the country.

Hon. Senators, due to limited sitting space, the Senators and Members of the National Assembly will be at liberty to invite one guest each for the occasion. You are hereby requested to provide the names of such guests at the Senate reception to facilitate the preparation of formal invitation cards.

Hon. Senators, the Special Sitting has necessitated a re-arrangement of parking. Consequently, the current Senators' parking area here at the Main Parliament Building will be unavailable for parking on Thursday 26th March, 2015. Please, do also note that access to Parliament through the parking area, formerly known as the Ministers' Gate, will remain restricted from tomorrow 25th March, 2015, to facilitate the pitching of tents for refreshments on the particular day. Alternative arrangements have been made for parking at the COMESA Grounds of the KICC. I urge the hon. Senators to bear with the situation.

COMMUNICATION FROM THE CHAIR

APPRECIATION TO MPS FOR PARTICIPATING IN THE FIRST LADY'S BEYOND ZERO CAMPAIGN HALF MARATHON

The Speaker (Hon. Ethuro): Hon. Senators, I have a Communication to make.

Hon. Senators, as you may be aware, on Saturday, 8th March, 2015, the First Lady of the Republic of Kenya, Her Excellency, Margaret Kenyatta, led close to 20,000 people to participate in the 2nd Edition of the Beyond Zero Campaign Half Marathon. The goal of the marathon was to raise funds to improve access to healthcare services to the Kenyan people, especially expectant mothers and children.

Hon. Senators, you may recall that the theme of the marathon was "**no woman should** die while giving life."

I recall that the inaugural marathon was held last year, 9th March, 2014 and that this second marathon, coincided with the International Women's Day, 2015 whose theme was: "Make it happen". That coincidence was deliberate in order to underscore the centrality of the important role played by women as integral members of the world's humanity and, hence, the need to recognize and lend them our support.

The noble initiative was undertaken in the greater effort to afford maternal healthcare to all mothers so that their children can enjoy life "Beyond Zero", irrespective of their region or place of birth. This is indeed unprecedented and deserves our commendation and support. It will go a long way towards the realization of Millennium Development Goal (MDGs) 4 and 5 which are:-

- 4. To reduce child mortality
- 5. To improve maternal health by reducing maternal mortality by three quarters and achieving universal access to reproductive health.

Globally, the maternal mortality ratio has declined by 47 per cent over the past two decades, from 400 maternal deaths per 100,000 live births in the year 1990 to 210 in the year 2010. However, in Kenya, maternal mortality ratio remains at an unacceptably high level of 488 deaths per 100,000 live births. This ratio has almost remained constant since 1990.

Further, there are wide regional disparities in maternal mortality within the country, with maternal deaths representing about 15 per cent of all deaths of women aged between 15-49 years, which translates to an estimated 6,000 to 8,000 pregnant women dying every year. The disparities in maternal mortality between counties are considerable, where the county with highest maternal mortality ratio has 20 times the deaths of that with the lowest. The 15 counties with the highest number of maternal deaths and highest maternal mortality ratio contribute over 98 per cent of the national total, and include:-Mandera, Wajir, Garissa, Lamu, Taita-Taveta, Marsabit, Isiolo, Turkana, Nakuru, Migori, Homa Bay, Kisumu, Siaya, Kakamega and Nairobi.

You will undoubtedly agree with me that these statistics are unacceptable. This noble drive initiated by the First Lady, which has received overwhelming support from thousands of people from all walks of life, is not only patriotic but also human centered given the impact witnessed so far.

Health being a fully devolved function, it is noteworthy to mention that the proceeds from the first marathon. Some 21 fully-equipped mobile clinics have so far been procured and distributed to the following counties which were prioritized because they have higher incidences of maternal and infant mortality, they include:- Taita-Taveta, Nyeri, Homa Bay, Samburu, Laikipia, Tharaka Nithi, Baringo, Isiolo, Narok, Turkana, Marsabit, Siaya, Kisii, Kiambu, Kitui, Mombasa, Kilifi, Kwale, Uasin Gishu, Elgeyo Maraket, and Wajir.

Hon. Senators, for your information, which is one of the issues which you have been called upon to partner, the First Lady also officially launched the 9th Stop Cervical, Breast and Prostate Cancer in Africa (SCCA) Conference on Wednesday, 18th March, 2015, here in Nairobi which is an initiative spearheaded by African First Ladies. The actual conference will be held from 19th to 21st July, 2015 and will be hosted by the First Lady. This will be the ninth in Africa. Our Senate has been requested to fully participate and especially extend the invitation to the Speakers of Parliaments in Africa.

Hon. Senators, it is my firm persuasion the First Lady's efforts towards improving health should be commended. I therefore take this opportunity, on your behalf and on my behalf, to commend and applaud the First Lady for her exceptional focus and tireless efforts in promoting the Beyond Zero Initiative which will afford healthcare services to many Kenyans who would otherwise never have accessed such services. I also laud her for being a good role model to our young girls and indeed many others who care about humanity.

Finally, I also want to convey my appreciation and commend all the Senators and Members of the National Assembly in general who participated in this year's event.

CONVENING OF SPECIAL SITTING OF THE SENATE TO CONSIDER THE DIVISION OF REVENUE BILL (NATIONAL ASSEMBLY BILL NO. 11 OF 2015)

The Deputy Speaker (Sen. Kembi-Gitura): Hon. Senators, I have a short Communication to make.

Hon. Senators, I wish to welcome you from the Easter Holiday recess and thank you for finding time to attend this Special Sitting of the Senate. Having just commenced our very short recess during which time I am sure each one of you had scheduled major county events, I know it is because of the value you attach to the business of the Senate, especially the consideration of a key piece of legislation like the Division of Revenue Bill that you have created time to be here today.

Hon. Senators, you may recall that the Division of Revenue Bill (National Assembly Bill No. 11 of 2015) was read the First Time in the Senate on Wednesday, 1st April, 2015, and committed to the Standing Committee on Finance, Commerce and Budget for consideration.

Hon. Senators, for your information, Standing Order No. 160(3) provides that; and I quote:-

"The Senate shall proceed upon and conclude its consideration of the Division of Revenue Bill not later than ten days after the Bill has been introduced with a view to approving it, with or without amendments."

The ten day period lapses tomorrow.

Hon. Senators, by a letter dated 2nd April, 2015, and pursuant to Senate Standing Order No.29(1), the Senate Majority and Minority Leaders, supported by seventeen other Senators, requested the Speaker to appoint a day for a Special Sitting of the Senate to consider the Division of Revenue Bill (National Assembly Bill No.11 of 2015). Following consideration of the request by the two Senators, the Speaker was satisfied that it met the requirements of Standing Order No.29(2) and it is in this respect that the Speaker convened this Special Sitting of the Senate via Gazette Notice No.2323 of 7th April, 2015, which was carried in a special issue of the Gazette on the same day.

Hon. Senators, as required by Standing Order No.29(5), the notice specified that the business to be transacted at that sitting would be the consideration of the Division of Revenue Bill (National Assembly Bill No.11of 2015) as passed by the National Assembly without amendments on 25th March, 2015.

Hon. Senators, as specified in the Gazette Notice and in accordance with Standing Order No.29(5) of the Senate Standing Orders, the business specified in the Notice shall be the only business before the Senate during this Special Sitting following which the Senate shall stand adjourned until Tuesday, 28th April, 2015, at 2.30 p.m. in accordance with the Senate Calendar.

Indeed, hon. Senators will observe that Order Nos.3 and 4 in today's Order Paper, pursuant to these provisions of the Standing Orders and as indicated in the Gazette Notice, the business to be transacted is the consideration of the Division of Revenue Bill (National Assembly Bill No.11 of 2015) at Second Reading and Committee of the Whole stages.

Therefore, it is noteworthy and I wish to emphasize that in accordance with Article 123 of the Constitution and Standing Order No.71 for the Senate to proceed to Standing Order No.4, this Bill must be passed by a majority of delegations at the Second Reading, Order No.3. The same requirement applies for business under Order No.4; Committee of the Whole. I, therefore, urge you all to remain in the Chamber for the transaction of this very important business.

APPROVAL BY THE NATIONAL ASSEMBLY OF SENATE AMENDMENTS TO THE PUBLIC SERVICE VALUES AND PRINCIPLES BILL (NATIONAL ASSEMBLY BILL NO. 29 OF 2014) AND THE PUBLIC PROCUREMENT AND ASSETS DISPOSAL (AMENDMENT) BILL (NATIONAL ASSEMBLY BILL NO. 31 OF 2013)

Senators, after the passage of the Bills by the Senate, and pursuant to Article 110(4) of the Constitution, and the provision of Standing Orders No. 20(2), and 149 of the Senate Standing Orders, I forwarded to the National Assembly, certified copies of the Public Service Values and Principles Bill otherwise referred to as the National Assembly Bill No. 29 of 2014 and the Public Procurement and Asset Disposal (Amendment) Bill, otherwise referred to as the National Assembly Bill No. 31 of 2013, as amended by the Senate together with a Message requesting the concurrence of the National Assembly.

Hon. Senators, I wish to report to the Senate that pursuant to Standing Order No.40(3), the Clerk has delivered to me correspondence from the National Assembly regarding the approval by the National Assembly of all amendments by the Senate to the Public Service Values and Principles Bill and the Public Procurement and Assets Disposal (Amendment) Bill respectively. The Bills with the Senate amendments incorporated will be finalized and forwarded to His Excellency the President for assent.

SERVING OF POLICE SUMMONS TO MPS WITHIN PRECINCTS OF PARLIAMENT

The Speaker (Hon. Ethuro): Hon. Senators, at the sitting of the Senate held on Thursday, 7th May, 2015, Sen. (Prof.) Lonyangapuo rose pursuant to Standing Order No.46 of the Senate Standing Orders, seeking the indulgence of the Senate to make a Personal Statement. He informed the Senate that on that day, he had attended a Kamukunji of the Senate which was held in this Chamber from 11.00 a.m. to 1.30 p.m. He stated that on exiting the Chamber, he met with an officer of the National Police Service (NPS), who identified himself as Corporal Daudi Mutui. He stated that he wished to serve on him "a notice to compel attendance under Section 52(1) of the National Police Act, No.11A of 2011. The notice was issued by Mr. Joseph Ngisa Angasa, a police officer attached to the investigation branch who stated that he was investigating a case of robbery with violence, contrary to Section 295 as read with Section 296(II) – anti-stock theft contrary to Section 278 of the penal code. The notice went further to compel the Senator to appear at the DCI headquarters at Mazingira House, along Kiambu Road on 8th May, 2015.

The Senator stated that the notice was served on him immediately upon exiting from the Chamber at the doors of this Chamber which is stated to be unprocedural. He, therefore, sought the guidance and protection of the Chair, to ensure that what had happened to him does not become the practice in Parliament.

Hon. Senators, without going into the substance of the matters covered in the notice served on the Senator, in his Personal Statement, Sen. (Prof.) Lonyangapuo brought to the attention of this House and of the Speaker the question of service of summons, notices to appear or other related documents on Senators within the precincts of Parliament. The Senator posed this question: While in the course of the discharge of their functions and while within the precincts of Parliament, should Senators be accosted with summons and notices to appear? This was the question, Sen. (Prof.) Lonyangapuo posed.

Hon. Senators, Members of Parliament, including Senators, the world over, by virtue of the offices they hold, and in order to secure the effective discharge of the functions of those offices, enjoy various powers, privileges and immunities – generally referred to as Parliamentary Privilege. Parliamentary Privilege in essence refers to the freedom of a parliament to conduct its proceedings without interference or obstruction from any other bodies, entities or persons. In Erskine May's *Ties on law: Privileges, Proceedings and Usage of Parliament*, Parliamentary Privilege is defined on page 75 as follows:-

"Parliamentary Privilege is the sum of the peculiar rights enjoyed by each House collectively as a constituent part of the High Court of Parliament and by Members of each House individually, without which they could not discharge their functions and which exceed those possessed by other bodies or individuals."

Thus privilege, though part of the law of the land is to a certain extent an exemption from the general law. Certain rights and immunities such as freedom from arrest or freedom of speech belong primarily to individual members of each House and exist because the House cannot perform its functions without unimpeded use of the services of its members. Other such rights

and immunities such as the power to punish for contempt and the power to regulate its own constitution belong primarily to each House as a collective body for the protection of its members and the vindication of its own authority and dignity.

Fundamentally, however, it is only as a means to the effective discharge of the collective functions of the House that the individual privileges are enjoyed by members. For our legislature, the National Assembly Powers and Privileges Act, Cap.6 of the laws of Kenya which by dint of Section 7 of the Sixth Schedule to the Constitution applies to the Senate - It provides for various powers, privileges and immunities available to members of Parliament, including freedom of speech and freedom from arrest for civil debt. In particular Section 5 provides for freedom from arrest for a civil debt during a session such that no Member of Parliament is liable to arrest for any civil debt, except a debt, the contraction of which constitutes a criminal offence whilst going to, attending at or returning from a sitting of the Parliament or a committee of Parliament.

Section 6 further provides that no process issued by any court in Kenya in the exercise of its civil jurisdiction shall be served or executed within the precincts of Parliament while Parliament is sitting and/or shall such process be served or executed through the Speaker or any officer of Parliament unless it relates to a person employed within the precincts of Parliament or to the attachment of the Members' salary.

Hon. Speaker Kaparo in a ruling made on 24th June, 1997, had the occasion to clarify the provisions of Section 6 of the Act by stating as follows:-

"Any person attempting to serve summons on any honourable Member on days on which the House meets, contravenes Section 6 of the Powers and Privileges Act. Any such purported service or summons is annulet *ab initio*.

In addition to the National Assembly Powers and Privileges Act, the Speaker's Rules provide for admission to the precincts of Parliament. In particular Rule 5 restricts the entry of visitors to the precincts of Parliament without the special permission of a Senator, a senior officer of Parliament or the Speaker. Rule 9 further requires an officer seeking the audience of a Senator, to not only obtain the necessary pass before entering the precincts, but also wait in the waiting room until escorted.

It is, therefore, evident from these provisions that in addition to civil process issued under Section 6 of the National Assembly Powers and Privileges Act, notices to appear before investigatory agencies cannot similarly be served on Senators while the Senate or its committees are sitting.

Further, no person purporting to serve such notice on a Senator may do so without the special permission and admission to the precincts required under the Speaker's rules.

Hon. Senators, there is, therefore, no doubt that the manner in which Sen. (Prof.) Lonyangapuo was served with the notice to appear was wanting. The Senator stated in his personal statement that the notice was served on him immediately upon his exit from this Chamber; at the doors of the Chamber. It cannot be surely that a Senator, while in the course of executing his or her functions in this Senate and Committees within the precincts of Parliament, would do so with apprehension and anxiety, not knowing if or when he or she will be accosted with notices to appear.

This is certainly not the intention of the National Assembly Powers and Privileges Act, the Speaker's rules and the practices established on the matter of parliamentary privilege. We cannot have process servers lying in wait for Senators on the corridors of Parliament, waiting to accost them with notices to appear as they enter or leave the Chamber or committee rooms. If

this were to be allowed, the business of the Senate would be adversely affected. All of us are familiar that in 1975, two Members were taken from here to where you know; detention.

In the circumstances, I would not allow such things to happen. I have, therefore, directed that henceforth, no notices to appear such as happened on Sen. (Prof.) Lonyangapuo or other similar documents, should be served on a Senator within the precincts of Parliament while the Senate or the Committees of the Senate are sitting. Further, no such notices should be served without the notification and special permission of the issue by your Speaker. We are investigating the circumstances in which the strangers found their way to the Chamber.

FAILURE BY SENATORS TO VOTE ON MATTERS BEFORE THE HOUSE DESPITE BEING PRESENT

The Speaker (Hon. Ethuro): Hon. Senators, I have a communication to make.

During the sitting of Tuesday, 19th May, 2015, the Senate voted for the following three Bills to be read a Second Time:-

- (1) The Public Audit Bill (National Assembly Bill No.38 of 2014)
- (2) The Fair Administrative Action (National Assembly Bill No.10 of 2015)
- (3)The Public Procurement and Asset Disposal Bill (National Assembly Bill No.40 of 2014)

At the conclusion of the voting, there were variations in the number of Senators voting culminating into a point of order raised regarding Senators who did not vote as it is in violation of the Standing Orders. In particular, I wish to recognise the alacrity of the Senator for Vihiga, Sen. Khaniri, on such matters. I directed that we establish the Senators who did not vote. Subsequently, from the division list print out, Sen. Fatuma Adan Dullo and Sen. Daniel Karaba, did not vote for the Public Procurement and Assent Disposal Bill (National Assembly Bill No.40 of 2014) while Sen. Fatuma Adan Dullo, did not vote for the Fair Administrative Action (National Assembly Bill No.10 of 2015).

As canvassed by Sen. Khaniri, Standing Order No.80 provides for decorum during division and it states:-

- "(1)No Senator shall be obliged to vote in a division, but those present and not voting shall either-
- (a) in the case of electronic vote, press the "abstain" button; or
- (b) in the case of a roll call vote, record the abstention with the Clerk.
 - (2)It shall be disorderly conduct for a Senator to fail to record his or her abstention in a division."

I looked at the Standing Orders and what is provided for is "gross disorderly conduct". This one is not gross.

(Laughter)

But it is still a breach of the Standing Orders. However, it is also worth noting that several Senators have been experiencing challenging with using the electronic system, sometimes without their knowledge. It is therefore necessary to continue reminding Senators of the above provision and to encourage those in doubt on whether they have voted to consult the Clerks-at-the-Table, otherwise sanctions will ensue if this persists. That is a warning for now and we can establish whether you voted or not.

SPEAKER'S COMMENDATION TO SENATORS FOR DILIGENTLY DISCHARGING THEIR MANDATE

The fourth one is The Public Procurement and Asset Disposal Bill (National Assembly No.40 of 2014). The Fair Administrative Action Bill (National Assembly Bill No.10 of 2015); The Potatoe Produce and Marketing Bill (Senate Bill No.22 of 2014); and The Public Fundraising Appeals Bill (Senate Bill No.28 of 2014).

I note with great satisfaction and commend you, hon. Senators, for considering and approving the Report of the Mediation Committee on the Division of Revenue Bill (National Assembly Bill No.11 of 2015) yesterday.

Hon. Senators, this is highly commendable. The onus is now on the National Assembly to expedite the approval of the Mediation Committee Reports. Both Houses were able to agree on the mediation process.

Hon. Senators, let me point out that the debate was also concluded on several other Bills which are now due for the Committee of the Whole. One of which, is listed under Order No.9 for consideration today.

I would like to go on record by saying that the Senate has risen to the call of duty and effectively discharged its legislative mandate, particularly with regard to passage of Bills with Constitutional deadlines despite the very short timelines this House had as a result of the late submission of the said Bills to the Senate.

Consequently, on 19th June, 2015, my office invited the Cabinet Secretary to a consultative meeting to discuss cash transfer programmes for vulnerable groups namely; the elderly, persons with disabilities, Orphaned and Vulnerable Children (OVC).

INVITATION TO A CONFERENCE TO BUILD CONSENSUS ON ON A SUITABLE PENSION SCHEME FOR COUNTY EMPLOYEES

The Speaker (Hon. Ethuro): I would like to make an announcement relating to a conference that has been organized by the Standing Committee on Labour and Social Welfare to deliberate on the County Retirement Scheme Bill, (Senate Bill No.25 of 2014).

As you may recall, the County Retirement Scheme Bill, (Senate Bill No.25 of 2014) was Read the First Time in this House on Wednesday 6^{th} August, 2014 and it was committed to the Standing Committee on Labour and Social Welfare for consideration pursuant to Standing Order No.130 of the Senate Standing Orders.

The Committee identified and invited the following stakeholders to make written or oral submissions on the Bill:-

The Senate Standing Committee on Finance, Commerce and Budget. The National Treasury Pensions Department.

- (1) The Retirement Benefits Authority (RBA).
- (2) The Local Authorities Provident Trust (LAPTRUST).
- (3) The Local Authorities Provident Fund (LAPFUND).
- (4) The Transitional Authority (TA).
- (5) The Salaries and Remuneration Commission (SRC).
- (6) The Council of Governors (CoG).
- (7) The Commission for the Implementation of the Constitution (CIC).
- (8) The County Public Service Boards Forum.
- (9) The Kenya Government Workers Union (KCGWU).

Hon. Senators, at the stakeholders' consultative meetings, it was noted that:-

- (i) County Government employees were concerned that the Senate had delayed in merging the two schemes; LAPTRUST and LAPFUND, leading to concern over the security of the employees' savings.
- (ii) Some county governments had not been remitting the employees' monthly contributions to the schemes as there was no clear direction on where to remit the monies.
- (iii) There will be a large number of county staffers retiring in the year 2016 and unless this matter is resolved, these staffers might end up losing part of their pension.
- (iv)The County Pension Scheme for county staffers had become highly politicized and there is need for objectivity and broad consensus in its consideration.

Arising from the above, the Standing Committee on Labour and Social Welfare has organized to hold a one day conference to build consensus on a suitable pension scheme for all employees of counties. The conference will be held at the Boma Hotel, Nairobi on Friday 17th July, 2015 from 9 a.m.

Hon. Senators, we owe it to all the employees of counties to enact a law that will establish a suitable framework to safeguard their savings and assure them of a dignified retirement. This is, therefore, to request you to find time to attend this important conference.

To facilitate this role, the Senate through my office has established the County Liaison Office, whose function is to facilitate and coordinate effective interaction between the Senate and county governments.

To this effect, the Speaker's Office has established a Legislative Staff Attachment Programme for technical staff in county assemblies. The attachment programme is designed to provide county assembly staff with a unique opportunity to acquaint themselves with parliamentary structures and processes. The programme aims to expose the staff to the best practices and procedure in legislative, legal, procedural and research services for the enhancement and support of the legislative processes in their respective counties.

On behalf of the Senate and on my own behalf, I welcome them to the Senate and hope that they will enjoy a fruitful programme. I wish them well for the remainder of their stay in our House.

COMMUNICATION FROM THE CHAIR

REPORT OF THE COMMISSION OF INQUIRY ON THE PETITION SEEKING THE SUSPENSION OF THE COUNTY GOVERNMENT OF MAKUENI COUNTY

The Speaker (Hon. Ethuro): I have a Communication to make on the Report of the Commission of Inquiry into the Petition seeking the suspension of the County Government of Makueni County.

You will recall that in the sitting of the Senate held on 15th September, 2015, the Senator for Makueni County, Sen. Mutula Kilonzo Jnr., rose on a point of order seeking the directions of the Chair with respect to the tabling of the report of the Commission of Inquiry on the Petition seeking to suspend the County Government of Makueni. The Senator observed that the report of the Commission of Inquiry had been presented to His Excellency the President and that although the report was in the public domain, it had not been forwarded to the Senate for tabling and consideration by the Senate.

The Senator expressed concern that apart from the recommendations of the Commission of Inquiry that the County Government be suspended, there were other recommendations in the report which require legislative intervention by the Senate. The Senator further expressed concern that the report had also raised some audit queries and other discrepancies of financial nature which require the intervention of the Senate in accordance with its oversight mandate provided for under Article 96 of the Constitution.

The Senator stated that the people of Makueni had waited for a year for a solution to the challenges besetting Makueni County and that the decision by His Excellency the President on the matter could not stop the Senate from seeking that the report be tabled in the Senate; not just for the sake of the residents of Makueni County, but also so that the rest of the country would understand the contents of the report. The Senator concluded by requesting the Speaker to give directions and ruling on the tabling of the said report.

In support of the point of order raised by Sen. Mutula Kilonzo Jnr., other Senators, namely; Sen. Billow, Sen. Wangari and Sen. (Dr.) Khalwale underscored that it was in the interest of Makueni County and the entire country that the report be tabled in the Senate so that

the Senate would take appropriate action on the recommendations of the report in terms of Article 96 of the Constitution.

Hon. Senators, it is in the public knowledge that on 3rd September, 2015, the Commission of Inquiry into the petition seeking the suspension of the County Government of Makueni County submitted its report to His Excellency the President. It is also in the public domain that one of the recommendations of the commission of inquiry was that pursuant to Article 192(2) of the Constitution, the County Government of Makueni be suspended. Article 192(1) of the Constitution says:-

"The President may suspend a county Government –

- a) in an emergency arising out of internal conflict or war; or
- b) in any other exceptional circumstances."

Article 192(2) of the Constitution further provides that:-

"A county government shall not be suspended under clause (1)(b) unless an independent commission of inquiry has investigated allegations against the county government, the President is satisfied that the allegations are justified and the Senate has authorized the suspension."

The County Governments Act Section 123 sets out the procedure relating to the suspension of a county government. Of particular interest is Section 123(7) which provides that:-

"The commission shall inquire into the matters before it expeditiously and report on the facts and make recommendations to the President"

Section 123(8) further provides that:-

"Upon receipt of the commission's report and upon finding that justifiable grounds exist for the suspension of a county government; the President shall within seven days forward the report of the recommendations of the commission together with the petition for suspension of the county government to the Speaker of the Senate."

Hon. Senators, it is evident from my reading of this provisions of the law that where, pursuant to Section 123(8) of the County Governments Act, the President is satisfied that justifiable grounds exist for suspension of a county government, the President is required to forward the report and recommendations of the commission of inquiry as well as the petition for suspension of the county government to the Speaker of the Senate.

Thereafter, in accordance with Section 123(9) of the County Governments Act, the Speaker would cause a Motion for the suspension of the county government to be laid before the Senate for consideration by the Senate.

It is noteworthy that while the County Governments Act sets out the process to be followed, where the President is satisfied that justifiable grounds exist for the suspension of a county government, no procedure is provided to govern scenarios where the President is not satisfied that justifiable reasons exist for the suspension of a county government.

The law as it is presently seems to require no further action on the part of the President where, as is the case with the Petition relating to the County Government of Makueni, the President is not satisfied that justifiable reasons exist for the suspension of a county government. There is no obligation under the law for the President to forward the subject report to the Senate.

Hon. Senators, for the reasons that were cited by Sen. Mutula Kilonzo Jnr. in his point of order, as well as the further reasons advanced by the other hon. Senators who spoke to the matter, this is an area that may require legislative review.

As the hon. Senators noted, the recommendations of the Commission of Inquiry, aside from stating whether or not a county government ought to be suspended, would most, probably, also make recommendations requiring legislative or other interventions by the Senate.

The recommendations may specifically relate to the subject county government, but may also apply to other or all county governments. It does not, therefore, appear logical that such recommendations will remain outside the knowledge of the Senate.

I, therefore, direct that the Standing Committee on Legal Affairs and Human Rights considers the procedure set out under Section 123 of the County Governments Act, and propose appropriate amendments that would ensure that the Senate is not fettered in the discharge of its functions under Articles 94 and 96 of the Constitution.

The Senate should, as part of its oversight mandate over the county governments, and as part of its mandate to represent the counties and to protect their interests and those of their governments, consider the report of an Independent Commission of Inquiry established under Article 192(2), whether or not, it recommends a suspension of a county government, and whether or not, the President is satisfied that justifiable grounds exist for suspension of a county government. This being a matter that is critical to the system of devolved governments, I further direct that the Committee tables its report on this matter on or before 29th October 2015.

Hon. Senators, with regard to the report of the commission of inquiry into the petition seeking the suspension of the County Government of Makueni, although in the circumstances, there is no requirement for the forwarding of the report to the Senate, all is not lost. The Speaker has contacted the Presidency and the Presidency has agreed to send the report to the House.

(Applause)

Our Standing Orders also provide various mechanisms through which the Senate could interrogate the issues that require legislative or oversight interventions by the Senate. For example, nothing in our Standing Orders would bar a Senator from requesting a statement from the relevant committee chairperson on this matter in terms of Standing Order No.45(2)(b). Similarly, an interested Senator may give notice of an appropriate motion on this matter for deliberation by the Senate. Standing Order No. 45(2)(a) relating to statements by a Senator on a county issue or an issue of general topical concern, may also provide an avenue by which the matter could be deliberated.

Hon. Senators, this and other options in our Standing Orders, remain available to the interested Senators. I thank you.

ADDRESS TO A JOINT SITTING OF PARLIAMENT BY H.E (Dr.) JAKAYA MRISHO KIKWETE, PRESIDENT OF THE UNITED REPUBLIC OF TANZANIA

The Speaker (Hon. Ethuro): Hon. Senators, I have a communication to make on the Joint Sittings of Parliament on Tuesday 6th October, 2015 at 2.30 p.m. for purposes of address by visiting dignitary. The Speakers of the two Houses of Parliament have received a request from the Office of the President to allow His Excellency (Dr.) Jakaya Mrisho Kikwete, President of the United Republic of Tanzania to address a Joint Sitting of the Houses of Parliament on Tuesday 6th October, 2015. His Excellency President Kikwete will be on a State Visit to Kenya.

Hon. Senators, Standing Order No.25(2) states as follows:-

"The Speaker may, in consultation with the Speaker of the National Assembly, arrange for a Joint Sitting of Parliament for purposes of an address by a visiting Head of State or such other visiting dignitary."

In this respect, I wish to inform the House that the Speaker of the National Assembly and I, have consulted and consented to the request. This is, therefore, to invite all Senators to a Joint Sitting of the Houses of Parliament which will be held on Tuesday 6th October, 2015 in the National Assembly Chamber, Main Parliament Building at 2.30 p.m. for the purpose of an address by His Excellency (Dr.) Jakaya Mrisho Kikwete, President of the United Republic of Tanzania.

This being the first time that a visiting Head of State will be formally addressing our Parliament, I wish to take this earliest opportunity to request all of you Senators to avail yourselves for this auspicious occasion. If what I heard from the Floor is anything to go by, I can assume that it is an affirmation.

Due to the normal legislative agenda before the Senate, particularly on the various Bills, the Senate will continue with its normal sitting shortly after the address by His Excellency the President of Tanzania.

COMMUNICATION FROM THE CHAIR

PROCEDURE FOR DISPOSAL OF PRESIDENTIAL MEMORANDA ON THE PUBLIC AUDIT BILL AND THE PUBLIC PROCUREMENT AND ASSETS DISPOSAL BILL

The Speaker (Hon. Ethuro): Hon. Senators, I wish to make a communication with respect to His Excellency the President's memoranda on the Public Audit Bill (National

Assembly Bill No.38/2014) and the Public Procurement and Asset Disposal Bill (National Assembly Bills No. 40/2014).

This communication is intended to give guidance on the procedure for the disposal of the Presidential Memoranda on the two Bills. As you recall, pursuant to Article 112(1)(b) of the Constitution, the Senate passed both Bills with amendments on 20th May, 2015, and subsequently, forwarded the Bills to the National Assembly for concurrence on 22nd May, 2015.

The National Assembly did not concur with some of the Senate's proposals to the Public Audit Bill (National Assembly Bill No.38 of 2014). Accordingly, the Bill was referred to a Mediation Committee to develop a version of the Bill that would be presented to both Houses for approval. The Mediation Committee on the Public Audit Bill was constituted on 26th May, 2015. Its report was tabled in the Senate on 27th May, 2015. All these culminated in the presentation of both Bills to the President for assent on 27th May, 2015.

In a communication issued on 23rd July, 2015, I informed the Senate that I had received a message from the National Assembly regarding the receipt of a Presidential Memoranda on the Public Procurement and Asset Disposal Bill 2015. The message from the Speaker of the National Assembly stated as follows:

"Pursuant to the provisions of Standing Orders Nos.41 and 142 of the National Assembly Standing Orders, I hereby convey the following message from the National Assembly;

THAT WHEREAS in exercise of powers conferred on him by Article 115 of the Constitution, His Excellency the President refused to assent to the Public Procurement and Asset Disposal Bill 2015 (National Assembly Bill No.40/2014) and referred the Bill to Parliament for reconsideration;

AND WHEREAS the National Assembly on Thursday, June 18, 2015, reconsidered and passed the Bill, fully accommodating the President's reservations and without proposing any amendments to the said reservations;

NOW THEREFORE, in furtherance of the provisions of Article 115(3) and (4), I hereby forward the memoranda of the President containing his reservations to the Bill to the Senate for reconsideration.

In the same communication, I ruled on the procedure for the disposal of the memoranda. In so doing, I specifically observed that the Standing Orders for both Houses provide for the establishment of a Joint Committee to consider the President's reservations on a Bill.

Consequently, I informed the House of the Senate's membership to the Joint Committee and a Message to this effect was forwarded to the National Assembly on 24th June, 2015.

On 14th July, 2015, I reported to this House that I had received a message from the National Assembly informing this House of receipt by the National Assembly of a presidential memorandum on the Public Audit Bill. The message stated as follows:

"PURSUANT to the provisions of Standing Order Nos.41 and 142 of the National Assembly, I hereby convey the following message from the national Assembly:-

THAT WHEREAS in exercise conferred on him by Article 115 of the Constitution, His Excellency the President refused to assent to the Public Audit Bill (National Assembly Bill No.38/2014) and referred the Bill to Parliament for reconsideration;

AND WHEREAS the National Assembly on Tuesday, June 23rd – Thursday 25th, 2015, reconsidered and passed the Bill, fully accommodating the President's reservations and without proposing any amendments to the said reservations;

NOW THEREFORE, in accordance with the provisions under Article 115(3) and (4) of the Constitution, I hereby forward the memorandum of the President containing his reservations to the Bill to the Senate for reconsideration."

I also reported that I received a Message from the Speaker of the National Assembly regarding the appointment of Members of the Joint Committee on the Presidential Memorandum on the Public Audit Bill (National Assembly Bill No.40 of 2014) and the Public Procurement and Asset Disposal Bill (National Assembly Bill No. 40 of 2014).

The Joint Committee held its first sitting on 6th August, 2015. In accordance to Standing Order 158(2) of the Senate Standing Orders, which is replicated in the National Assembly Standing Orders as Standing Order No.155(2). The Senate and the National Assembly were to receive the report of the Committee within 14 days which lapsed on 20th August, 2015 without the Joint Committee tabling a report as contemplated under Standing Order No.158(2) of the Senate Standing Orders. What then is the fate of the Presidential Memoranda in the absence of a report by the Joint Committee?

Hon. Senators, Standing Order No.158(5) provides that, "where the Joint Committee fails to submit a report under paragraph 2 or the report of the Joint Committee is to the effect that the Committee has failed to agree to the President's reservations or where the Joint Committee fails to agree on a version of proposed amendments to the President's reservations, the President's reservations shall be taken to have been approved by Parliament upon laying of the report on the table of the Senate under paragraph 2.

Hon. Senators, you will recall that in the communication issued on 23rd July, 2015, I observed that Standing Order No.158(5), though it may be aimed at ensuring expeditious disposal of a Presidential Memorandum, does not accord with the Constitution. This is because Article 115 of the Constitution requires that each House of Parliament specifically pronounces itself on a Presidential Memorandum. I, therefore, rule that to the extent that the Standing Order No.158(5) provides for a "deeming" of approval by the Senate of the President's reservations upon laying of the report on the table of the Senate without considering by the senate, it does not accord with Article 115 of the Constitution and must, therefore, yield to Article 115.

In the circumstances, I invoke Standing Order No.1 to find that where a Joint Committee fails to submit a report under paragraph 2, or if the report of the Joint Committee is to the effect that the committee has failed to agree to the President's reservations or where the joint committee fails to agree on a version of proposed amendments to the Presidents reservations, the Senate shall consider a motion that, the Senate approves the Bill fully accommodating the President's reservations. This Motion may be moved by a member of the Joint Committee, the Senate Majority Leader, or a Senator designated by the Senate Majority Leader.

In accordance with the Motion, the Senate may:-

- 1. Pursuant to Article 115(2) of the Constitution, amend the Bill in light of the President's reservations or amend the Bill in a manner that fully accommodates the President's reservations. This will require the vote of a majority of the delegation in the Senate which is 24 delegations.
- 2. Pursuant to Article 115(4) of the Constitution, pass the Bill a second time without amendments or with amendments that do not fully accommodate the President's reservations. This would require the vote of two-thirds of the delegations in the Senate which is 31 delegations.

There are, however, two questions that arise from this: First, what would be the fate of the President's reservations where the Senate does not obtain the 24 delegations required to accept the President's reservations?

Secondly, what would be the fate of the President's reservations where the Senate does not obtain the 31 delegations required to reject the President's reservations?

In either case, is it possible to deem an acceptance or a rejection by the Senate by dint of failing to obtain the requisite numbers? The answer is in the negative.

Article 115 of the Constitution would appear to require that the Senate must pronounce itself on the President's reservations by either accepting or rejecting the reservations. There is no room for deeming of either an acceptance or a rejection. A specific resolution must be made by the Senate.

Consequently, the only action that would take the agenda forward is either an acceptance or a rejection of the President's reservations by the requisite numbers. It would appear that any other action that does not result in an outright acceptance or rejection of the President's reservations, would put the Bill in a constitutional purgatory requiring some new action that will reignite and bring the legislative process to a close. In this regard, the following may occur:-

- (1) Since it is evident from the rendition of Article 115 of the Constitution that the legislative process on any Bill only comes to an end when there is an agreement between the legislature and the Executive; having found none, this may provide the occasion for further consultations between the Legislature and the Executive on the President's reservations. Such consultations may result in a resubmission of the Motion at an appropriate time in accordance with the Standing Orders.
- (2) It is also possible that the situation could mark the end of the life of the Bill as published and instead result in the introduction of a new Bill which could either exclude the contested provisions or include the provisions in a negotiated format.
- (3) The failure to accept or reject the President's reservations may be an indicator that Parliament does not intend to enact new legislation on the matters covered in the Bill and that it would rather retain the existing legislative framework. The legislative process would, therefore, come to an end.

The above notwithstanding, it is important that hon. Senators bear in mind that the two Bills in question are subject to the constitutional timelines stipulated in Article 261 of the Constitution as read with the Fifth Schedule to the Constitution. Thus legislation on these matters, whether in the form of the two published Bills or in the form of new Bills requires to be enacted by Parliament on or before 27th August, 2016.

Hon. Senators, having said this, I now direct that the matter of the two Bills be placed on the Order Paper next week for the giving of Notice of Motion in the manner I have explained.

ADMISSIBILITY OF SEN. MURUNGI'S MOTION ON ESTABLISHMENT OF A TASK FORCE TO SURVEY AND FIX BEACONS FOR ALL COUNTY BOUNDARIES

The Speaker (Hon. Ethuro): Hon. Senators, I have a Communication to make on the notice of Motion by Sen. Murungi.

On Tuesday, 22nd September, 2015, the Senator for Meru County, Sen. Kiraitu Murungi gave a Notice of Motion whose main thrust is to request the Office of the President and the Ministry of Lands, Housing and Urban Development to establish a task force to survey, mark and fix beacons for all county boundaries.

Thereafter, several Senators, including Sen.(Dr.) Machage, Sen. Murkomen, Sen. Khaniri and Sen. Mutula Kilonzo Jnr. raised reservations on whether the Notice of Motion was proper in terms of procedure, and whether it was constitutional, given the framework regarding alteration of county boundaries as provided for in Article 188 of the Constitution. In addition, there were assertions that a similar Motion, sponsored by Sen. Mutula Kilonzo Jnr., had been passed by the House and that, indeed, a Bill on county boundaries was on the verge of introduction to the Senate.

Hon. Senators, I will allow the Senators at the Bar to enter the Chamber given that some of them seem to be much appreciated in this Communication.

(Sen. M. Kilonzo Jnr., Sen. (Dr.) Khalwale and Sen. Melly entered the Chamber)

(Sen. (Dr.) Khalwale continued standing in his place)

Order, Sen. (Dr.) Khalwale! If I were you, when courtesies are extended to you, you take the earliest opportunity to appreciate them by sitting.

Hon. Senators, let me begin by giving a chronology of events surrounding this matter. First, a Motion was earlier filed by Sen. Mutula Kilonzo Jnr. urging the Standing Committee on Legal Affairs and Human Rights to initiate and prioritize the drafting of legislation within 90 days to provide for an independent commission to inquire into, examine and identify the boundaries of counties taking into account the criteria set out in Article 188(2) of the Constitution. The Motion was subsequently approved by the House.

Secondly, I am aware that the Standing Committee on Legal Affairs and Human Rights has done a great deal of work to implement the resolution of the House and that a Bill has been drafted in that regard. However, the Bill has not been introduced to the House yet by way of First Reading as required under Standing Order No.129.

Hon. Senators, it is important to note that the Motion by Sen. Mutula Kilonzo Jnr. and the Bill being developed by the Committee aim to establish an independent Commission to consider the boundaries of counties in accordance with Article 188 of the Constitution. Let me repeat for emphasis that the Motion by Sen. Mutula Kilonzo Jnr. and the attendant Bill being developed by

the Committee aim to establish an independent commission to consider the boundaries of counties in accordance with Article 188 of the Constitution.

I, therefore, would like to clarify that what Sen. Murungi's Motion is seeking is to have the boundaries as they now stand clearly surveyed, marked and beacons fixed. For the avoidance of doubt, he is not seeking to have the boundaries altered as doing so without the recommendations of an independent commission would violate the provision of Article 188 of the Constitution. This is, therefore, in my considered opinion, a different matter altogether because, regardless of any disputes and any proposals that may be made for the alteration of county boundaries, counties remain in existence and there are boundaries.

It may be such that the process of survey and marking would be affected and be difficult to undertake while disputes exist. That goes to the merits of the Motion and is a matter for the Senate to determine in the debate and for the Senate to make a decision.

Hon. Senators, arising from the foregoing, therefore, I am satisfied that there is no contradiction in the Motions by Sen. Mutula Kilonzo Jnr. and Sen. Murungi. They can both proceed. Indeed, Sen. Mutula Kilozo Jnr.'s Motion was passed by the House. So, even as you entertain Sen. Murungi's Motion, you will already put into account what you had already decided as a House.

COMMUNICATION FROM THE CHAIR

PROCEDURE FOR DISPOSAL OF PRESIDENTIAL MEMORANDA ON THE PUBLIC AUDIT BILL AND THE PUBLIC PROCUREMENT AND ASSETS DISPOSAL BILL

The Speaker (Hon. Ethuro): Hon. Senators, I also have another communication to make. On 1st October, 201, I issued a communication detailing the procedure to be followed on the disposal of the Presidential Memorandum on the Public Audit Bill, 2014, and the Public Procurement and Asset Disposal Bill, 2014.

In the Communication, I noted that the Joint Committee had failed to agree on the President's reservations and consequently ruled that the two Memoranda be scheduled for consideration on the week starting 6^{th} October, 2015.

After my Communication, several Senators, including Sen. Hassan Omar Hassan, Sen. Moses Wetang'ula, Sen. James Orengo and Sen. (Dr.) Boni Khalwale, canvassed the matter and urged the Speaker to stay the consideration of the Memoranda to allow consideration of the following issues –

- 1. Whether the President, who is not a Member of Parliament (unlike in the repealed Constitution) can participate in law making, by exercising veto power?
- 2. Whether the reservations in the Presidential Memoranda can include introduction of new sections that were not contemplated in the Bill as passed in the first instance?
- 3. Whether the new clauses introduced in the Memorandum need to go through the usual legislative processes of First, Second and Third Readings.

I undertook then to give further guidance on the matter before the Senate could consider the Presidential Memoranda.

Hon. Senators, I have considered the issues raised and I wish to give the following guidance-

i) On whether the President can participate in law making, I wish to state that Article 115 of the Constitution gives the President a legislative mandate of Assent and Referral of Bills. Thus the veto power is rightfully exercised by the President. This has always been the case even in the repealed Constitution.

This answers to the matter raised making reference to the former Constitution in force immediately before the coming into force of the current Constitution. Section 46(4) of the repealed Constitution stated as follows-

"Where the President refuses to assent to a Bill he shall, within fourteen days of the refusal, submit a memorandum to the Speaker indicating the specific provisions of the Bill which in his opinion should be reconsidered by the National Assembly, including his recommendation for amendments."

ii) On whether the President can introduce new clauses in the Memoranda, I wish to state that Article 115(1)(b) provides that the President shall-

"refer the Bill back to Parliament for reconsideration by Parliament, noting any reservations that the President has concerning the Bill".

This means that the President can only object to what is already in the Bill and in proposing how to deal with the reservations, he may propose amendments to the specific clauses, including such other consequential amendments in form of new clauses. Therefore, new clauses in place of those in the Bill can be proposed so long as they are within the scope of the Bill.

iii) On whether the New Clauses have to follow all the legislative stages, I wish to state that at the stage of reservations, a Bill will have been passed by Parliament. By considering the Memorandum, Parliament is not re-opening debate on a Bill, but restricting itself to the "reservations". In my view, the new clauses need not go through the entire legislative process of First, Second and Third Readings.

Arising from this and upon further reflection and given the fact that the Joint Committee appointed to consider the Memoranda failed to submit a report, I now direct that the Memoranda on the two Bills be placed in the Order Paper for Thursday, 29th October, 2015, for consideration in Committee of the Whole.

As has been the practice, at the Committee Stage, each proposal by the President will be considered and voted on independently. It is important to note that Senators may amend the President's proposals, but will require the support of at least two-thirds of the delegations in line with Article 115(4)(b) of the Constitution.

PROPOSED REMOVAL FROM OFFICE, BY IMPEACHMENT, OF THE GOVERNOR OF MURANG'A COUNTY

The Speaker (Hon. Ethuro): Hon. Senators, I have the following Communication to make on the proposed removal from office by impeachment of the Governor of Murang'a County.

Hon. Senators, by a letter received in the Office of the Speaker of the Senate on Wednesday, 21st October, 2015, the Speaker of the County Assembly of Murang'a informed the Speaker of the Senate of the approval of a Motion by the County Assembly of Murang'a for the removal from office, by impeachment, of the Governor of Murang'a County.

In terms of Article 181 of the Constitution, Section 33(3(a) of the County Governments Act, 2012 and Standing Order No.68 (1) (a) of the Senate Standing Orders, the Speaker of the Senate is required, and I quote"-

"Within seven days after receiving notice of a resolution from the Speaker of a county assembly, to convene a meeting of the Senate to hear charges against the Governor."

Hon. Senators, pursuant to Section 33(3)(a) of the County Governments Act, 2012 and Standing Order No.68(1)(a) of the Senate Standing Orders, I convened this sitting of the Senate through Kenya Gazette Notice No.8100, published on 27th October, 2015.

Hon. Senators, pursuant to Section 33(3) of the County Governments Act, 2012 and the same Standing Order of the Senate, I hereby proceed to read the charges against Hon. Mwangi wa Iria, the Governor of Murang'a County.

Ground 1: Gross Violation of the Constitution of Kenya, 2010, the County Governments Act, 2012, the Public Finance Management Act, 2012 and the Public Procurement and Disposal Act, 2005.

Particulars include, and I hope Sen. Hassan Omar Hassan is listening attentively as per yesterday's intervention:-

- (i) Lack of accountability for the management and use of county resources by incurring unsustainable debts to the tune of Kshs2.5 billion which were not disclosed in the Debt Management Paper, 2015 and the County Fiscal Strategy Paper, 2015, thus violating Article 201(e) of the Constitution of Kenya, 2010, Section 123 and Section 107(2) (e) of the Public Finance Management Act, 2012. Further scrutiny of the Debt Owing Report submitted by the County Executive Committee Member for Finance, IT and Planning as at 14th August, 2015 indicated violation of Article 226(5) of the Constitution of Kenya, 2010, since some programmes in the debt report already had an appropriation in the budget for the Financial Year 2014/2015 only to re-appear in the said debts, a clear indication of misappropriation of funds for the projects. For instance, Gakoigo Stadium, under the Department of Youth and Sports, was allocated Kshs30 million in the Financial Year 2014/2015 yet it had incurred a total debt of Kshs59 million and no monies had been paid. This positions the county at a very precarious situation which may lead to the auctioning of county assets.
- (ii) Violation of Article 201(a) and (d) of the Constitution of Kenya, 2010, that stipulates principles of public finance and Section 5 and 130(1)(b)(i) of the Public Finance Management

Act, 2012. The County Governor allowed misappropriation of county funds by spending public funds in private commercial entities. The report of the Auditor-General on the financial operations of Murang'a County Executive for the period 1st July, 2013 to 30th June, 2014, shows that the County Executive contributed a total of Kshs28,489,800 to Murang'a Investment Cooperative Society *Shilingi kwa Shilingi*. The expenditure was incurred in respect of advertisements to promote the co-operative society and invite the general public to purchase shares in the co-operative. Further details of the same are contained in the Report of the County Assembly on the Murang'a Investment Cooperative Society, *Shilingi kwa Shilingi*.

The Society is registered under the Co-operative Societies Act, Cap.490, Section 6(3) of the Laws of Kenya. The Society is an autonomous body independent of the County Executive and according to the Auditor-General's Report, it was not clear, therefore, the circumstances under which the County Executive was funding it. This was in contravention of Section 5(1) of the Public Finance Management Act, 2012 as the Society was not declared a county corporation.

Let me allow the Members to enter.

(Several hon. Senators entered the Chamber)

- (iii) Violation of the Constitution of Kenya, 2010, Articles 201(a), (d), (e), on the principles of public finance and Article 226(5) on audit of public entities, Article 227(1) on procurement of goods and services and the Public Procurement and Disposal Act, 2005 by failing to adhere to the principles of public finance management and procurement of public goods and services. In the Financial Year 2014/2015, as stated in the County Governments Budget Implementation Review Reports of the Controller of Budget, the County Executive, under the stewardship of the County Governor, incurred advertisement expenditure amounting to Kshs247 million against an approved budget of Kshs7 million as at 31st March, 2015 that is, Kshs114 million and Kshs133 million in the half year and third quarter report, respectively thus, further undermining the principles of fiscal prudence as stipulated in Article 201(d) of the Constitution of Kenya, 2010 and Section 107(2) of the Public Finance Management Act of 2012.
- (iv) Violation of Article 183(2) and (3) of the Constitution of Kenya, 2010 and Section 30(3)(b) of the County Governments Act, 2012 through failure to provide leadership to the County Executive Committee on the generation of county policies, plans, legislations and full and regular reports, regarding key programmes such as the Napier Grass, A.I. Crushes, among others.
- (v) Failure to establish the County Budget and Economic Forum as stipulated under Section 137 of the Public Finance Management Act 2012. As a result, the County Governor has failed to consult with the public over the preparation of county plans, budgets, economy and financial management at the county level thereby violating the provisions of Sections 87, 91 and 115 of the County Governments Act, 2012 and more importantly, Articles 10 of and 201(a) of the Constitution that require public participation in decision making.
- (vi) Violation of Articles 176(1) and 185 of the Constitution of Kenya, 2010 by disregarding the County Assembly as an arm of the County Government and undermining its legislative authority, through requisition of monies and not remitting the same, hence crippling the operations of the Assembly and undermining the independence of the latter. This, by extension, violates Articles 6 and 10 of the Constitution of Kenya, 2010 that underpins the spirit of mutual respect, cooperation and consultation on all governance structures. This is evident from requisitions made in the following periods that were never remitted:-

- (a) Kshs44,347,764 in the Financial Year, 2013/2014 (annexed);
- (b) Kshs28,779,000 in the Financial Year 2014/2015 (annexed), and;
- (c) Kshs51, 843,000 in the Financial Year 2015/2016 (annexed).

This misappropriation and misdirecting of funds indicates lack of good intentions towards the Assembly and creating a monarchy system, an endevour to curtail the oversight role of the Assembly, violating Article 73(b) of the Constitution of Kenya, 2010 which requires a state officer to serve the people and not power to rule over them. This further violates Article 174 of the Constitution of Kenya 2010, which requires county governments to provide democratic and accountable exercise of power.

(vii) Violation of Section Four of the County Governments Act, 2012, that requires the County Executive Committee to develop legislation on county symbols, for example, the Murang'a County Symbols Act. After the Murang'a County Symbols Bill was passed in the Assembly and consequently gazetted into an Act, the County Executive so far has failed to implement the approved symbols in all their communication artefacts.

(viii)Violation of Article 227(1) of the Constitution of Kenya 2010. It was done through procurement of goods and services by state organs and public entities and Section 135(1) of the Public Finance Management Act 2012, by disregarding cost effectiveness and over-spending in the departments of Finance, IT and Economic Planning, Transport, Energy, Infrastructure, Public Service and Administration, among others, as indicated in the Third Quarter Budget Review Implementation Report for the FY2014/2015 from the Office of the Controller of Budget. Such expenditure should have been ratified through a supplementary budget or justified by the respective departments

(ix)Violation of Articles 186(1), 189(2) and 226(5) of the Constitution of Kenya 2010 by approving/directing/diverting public funds to non-devolved functions contrary to Schedule 4(2) of the Constitution of Kenya 2010. For example, construction works at Kahuhia Girls High School that were split nine times, amounting to Kshs31 million. Also, conversion of public primary schools into boarding schools, among others.

(x)Violation of Article 227(1) of the Constitution of Kenya 2010 and Section 30 of the Public Procurement and Disposal Act, 2005 through splitting of tenders with different LPO numbers for the same contractor. For instance, the proposed opening of Kahuruko-Ngatho Junction under the Department of Transport and Infrastructure was split 11 times with different LPO numbers according to the debt owing report from the County Executive Committee Member (CEC), Finance, IT and Planning as at 14th August, 2015.

(xi)Violation of Articles 10, 183 and 201 of the Constitution of Kenya 2010 on priorities through public participation, legislative framework and fiscal prudence and accountability, respectively. Also, Section 29 of the Public Procurement and Disposal Act, 2005, through evading of open tender method by purchasing of land along the Kenol-Kabati Road worth Kshs340 million through request for quotations, without stipulated reasons for using alternative procurement procedures in writing by the Tender Committee. Fraudulent procurement procedures of the Artificial Insemination (AI) crushes under the Livestock Development Programme amounting to Kshs61,690,000, among other goods and services.

(Sen. Haji and Sen. (Prof.) Anyang'-Nyong'o bowed to the Bar and entered into the House when the Speaker was on his feet)

(xii)Contravention of Article 201(a) and (e) of the Constitution of Kenya 2010, on principles of public finance in regard to accountability, responsible finance management and clear fiscal reporting and Section 155(5) of the Public Finance Management Act, 2013, by failing to ensure that an Internal Audit Committee is established. This has exposed the County Executive operations to lack of checks and balances in financial controls, especially in the County Treasury and lack of decentralized payment systems, particularly in the departmental level. This is evidenced by irregular practices such as the opening of uunauthorized bank accounts, contrary to the guidelines of the Transition Authority, lack of maintaining of cashbooks for some accounts and surrendered imprests, lack of adherence to the budget implementation, among other irregularities, also highlighted in the report of the Auditor General 2013/2014 and the Controller of Budget Third Quarter Report 2013/2014. This heightened impunity on the part of the County Governor has resulted in continued loss of public funds.
