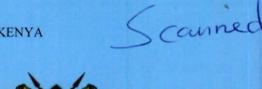

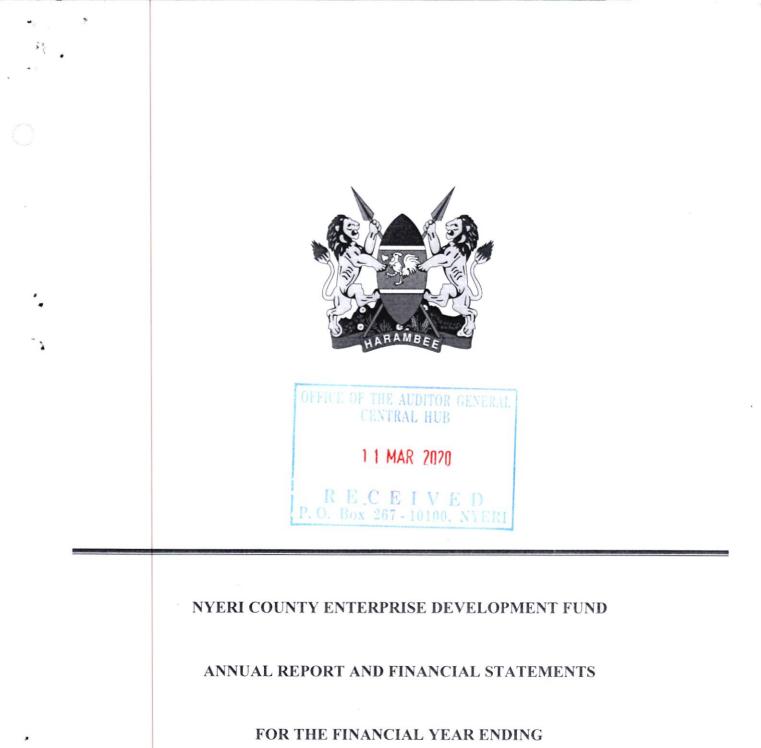

(a) Background information

Nyeri County Enterprises Development Fund is established by and derives its authority and accountability from Nyeri County Enterprises Development Act 2018. The Fund is wholly owned by the County Government of Nyeri and is domiciled in Kenya.

- The fund's objective is to:
 - a) Provide affordable loans to applicants stipulated under section 20 operating in Nyeri county;
 - b) support capacity building of the beneficiaries;
 - c) provide training, mentorship and provision of business development services to beneficiaries;
 - d) promote enterprise development in Nyeri County;
 - e) support micro and small enterprises to develop linkages with large enterprises
 - f) promote marketing of products and services for the enterprises;
 - g) support technology acquisition, adoption and utilization by Micro and small enterprises and Cooperatives Societies; and
 - h) Promote gainful employment through enterprise development.

(b) Principal Activities

The Fund's principal activity is to provide affordable loans to applicants operating in Nyeri County as stipulated under the Nyeri County Enterprise development Fund Act.

CHAIRMAN'S STATEMENT

It is with great pleasure on behalf of the Board Members to present Nyeri County Enterprise Development Fund year 2018/2019 financial statements.

The Fund received Kshs. 30 Million as its seed capital late in the financial year 2017/2018. The Board has received support from the County Government of Nyeri in rolling out the fund and have made significant milestones towards implementation of the fund. We have however faced a few challenges but the successes exceed all the challenges. We have continuously learnt from the challenges and our strategy is well informed.

The first significant achievement in FY 2018/19 the sensitization activity that was conducted at three levels: County Assembly Trade Committee Members on the rollout plan, which received support. The sub county and ward administrators also underwent a training so that they can help the applicants fill in the forms and handle questions. The next level was to the General public which were held in all eight sub-counties and campaigns about the Nyeri County Enterprise Development through notices and in social media. The participants were educated on the ACT, the purpose of the fund and the objectives of the EDF, how to fill the application form and the required documents.

The Board received 143 applications that are currently under review. The Board have advised on procurement of a financial institution to partner for disbursement and management of the fund.

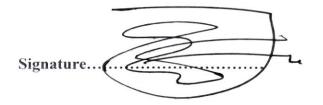
Among the successes the Board invested the Funds in a call deposit account that earned Kshs. 973,000. The fund has also continually improved the loan guidelines which shall be used in appraising the loans and in general administration of the fund.

Key challenge was most applicants did not attend sensitization forums and therefore poorly filled in applications. We are however grateful to the secretariat that have relentlessly called the applicants and it's a great milestone to where we are.

The Board looks forward to disbursing the loans out of the entire kitty of the fund and maintaining a healthy portfolio book. We are positive the fund will grow to compete with tier one financial institutions. This fund will promote the micro and small enterprises in Nyeri County.

During the year, the Cooperative representative was appointed the Chairperson of the Board and Director Trade representative was appointed. The board members are committed to continually serve the citizenry of Nyeri in this Fund.

Our appreciation goes to the Management team and the secretariat for their immense support and selfless service that has seen this fund to where it is now. May the almighty abundantly bless you.

FUND ADMINISTRATOR'S REPORT

I am honoured to present highlights for the financial year 2018/2019. The year presented significant challenges majorly attributed on how to rollout the Fund.

The fund rollout kicked off with sensitization and training for the key stakeholders in the implementation. The county assembly committee for trade tourism and co-operative development was taken through the act, regulations, the workout plan, the process of loan application, loan appraisal and vetting and thereafter approval. The next group to be sensitized were the administrators at the ward and sub-county. They were a key pillar in implementing the fund as they had a role in receiving the loan applications and submit them to the secretariat. The administrators were also sensitized on the processes, the laws and regulations so that they could handle any questions.

The sensitization of the general public was conducted at the sub-county level from 25th July to 3rd August. Call for application followed from 8th August to 9th September 2018. Campaigns through various channels were employed like advertising in the County Government's Website and official social media pages inviting all interested individuals to submit their applications.

A total of 143 applications were received, appraisal, verification and vetting was then carried out by the secretariat. The secretariat consists of technical people with experience and skills in loan analysis, appraisal and monitoring. 81 applications met the minimum requirements and qualified for business visits.

The Business Visits were conducted between 22nd &26th October 2018. The main purpose of the business visit was to verify that the applicants had operational businesses or they were engaging in the activities that they had indicated in their applications. 66 applications were recommended for the final appraisal and documents perfection. At this point the Board made a decision to involve a financial institution to partner with in disbursement and management of the loan. Procurement of a financial institution started in April 2019 and its ongoing thus the delay in disbursement of the loans.

The Board however approved one loan to be a pilot case for the process and a disbursement of Kshs. 500,000 was disbursed in June 2019. The Board also made a decision to approve to put the fund in an interest earning account and we earned Kshs. 973,000. The expenses for the year were Kshs. 370,000. The balance in the fund account as at 30th June 2019 was Kshs. 30,077,155.25

In the coming year, the board is committed to ensuring that the entire amount is disbursed to qualifying enterprises within Nyeri County as it is the purpose of the fund. More products offering will be launched, sensitization and induction exercises will be conducted throughout the county to ensure the target groups are aware of the availability of the fund, requirements, process and procedure of applying for the loans as well as prudent management of the loan upon disbursement.

CORPORATE GOVERNANCE STATEMENT

The Board held three meetings in the financial year and all meetings had a quorum. The secretariat has young technical people to ensure succession. The Board charter has not been developed though the activities undertaken by the secretariat are included in the department's charter.

The nominations procedure was issued by the County Executive Committee Member for Trade as follows:

- a. Representative of the Business Community
 - i. Two groups/associations with major representation of the Business Community
 - ii. Each groups/associations to nominate two people of the opposite gender
 - iii. The nominees should be residents of Nyeri County
 - iv. The nominees should not be from the same Sub-County to ensure regional balance
 - v. One person will then be appointed to represent this particular category.
- b. Youth
 - i. Two groups/associations with major representation of the youth in creative industry
 - ii. Each groups/associations to nominate two people of the opposite gender
 - iii. The nominees should be residents of Nyeri County
 - iv. The nominees should not be from the same Sub-County to ensure regional balance
 - v. One person will then be appointed to represent this particular category
- c. COOPERATIVE
 - i. Two cooperatives with major of membership from Nyeri County
 - ii. Each cooperative to nominate two people of the opposite gender
 - iii. The nominees should be residents of Nyeri County
 - iv. The nominees should not be from the same Sub-County to ensure regional balance
 - v. One person will then be appointed to represent this particular category
- d. Persons living with disability (PLWD)
 - i. National Council for persons living with disability has been identified as the most representative association for PLWD involved in the county.
 - ii. Submit names of two Nominees who should be residents of Nyeri County
 - iii. The nominees should be running a micro and small enterprise development
 - iv. The nominees should not be from the same Sub-County to ensure regional balance
 - v. Only one will then be appointed from the two nominees.

For a person to be eligible for appointment as a member the following criteria should be met -

(a) is a Kenyan citizen;

(b) holds a minimum of a diploma from a recognized institution in Kenya;

(c) has operated a business which is a micro and small enterprise in the County for a period of three years;

(d) Satisfies the requirements of Chapter Six of the Constitution.

The members of the Board may be removed from office for-

(a) gross violation of the Constitution or any other law;

(b) gross misconduct, whether in the performance of the member's functions or otherwise;

(c) Physical or mental incapacity to perform the functions of office; or

(d) Incompetence or neglect of duty.

The Nyeri County Enterprise Development Fund further provides that the County Executive Member responsible for Trade may, upon the recommendation of the Board, revoke the appointment of a member of the Board on any of the above mentioned grounds.

The following reasons may result in the ceasing to be a member of the Board: -

(a) resignation in writing, to the County Executive Member for the time being responsible for Trade;

(b) conviction of a criminal offence resulting in a sentence to a term of imprisonment of not less than six months;

(c) being declared bankrupt;

(d)being unable to perform the functions of his or her office by reason of mental or physical incapacity; or

(e) Dies.

Where a vacancy occurs in the membership of the Board, the County Executive Member for the time being responsible for Trade shall, if the vacancy relates to non-ex- officio members appoint a new member in accordance with the provisions of this Act.

MANAGEMENT DISCUSSION AND ANALYSIS

In June 2018 the Nyeri county Enterprise development fund received Kshs. 30,000,000.00 from the Nyeri Government County treasury. 3% of the amount was meant to be for administrative expenditures. This amounted to Ksh.900, 000.00.

The balance of Ksh. 29,100,000.00 was deposited in a call account in Cooperative bank in the month of August 2018. This earned an interest on deposit of ksh. 973,670.25 as at May 2019. A loan of Ksh. 500,000 was disbursed in June 2019. The current bank balance amounts to Ksh. 30,077,155.25.

The fund has no outstanding debts to any institution or individual. However, one loan worth Kshs. 500,000 was lent out and is set to be recovered in the next two years.

The Fund has observed all statutory provisions and envisions to continue being compliant. The risks likely to face the Fund are default risk which has been mitigated by having all applicants provide security for their loans. Insurance against death and permanent disability will be undertaken for all borrowers.

REPORT OF THE BOARD

The Directors submit their report together with the audited financial statements for the year ended June 30, 2019 which show the state of the *entity*'s affairs.

Principal activities

The principal activities of the entity are to provide affordable loans to applicants stipulated under the Nyeri county Enterprise development Fund Act, operating in Nyeri County.

Results

The results of the entity for the year ended June 30, 2019 are set out on page 2-6.

Directors

The members of the Board of Directors who served during the year are shown on page v. During the year 2018-2019 no director retired/ resigned and one was board member was appointed with effect from 14th April 2019.

Dividends/Surplus remission

In accordance with Section 219 (2) of the Public Financial Management Act regulations, regulatory entities shall remit into Consolidated Fund, ninety per centum of its surplus funds reported in the audited financial statements after the end of each financial year. Or the entity remitted Kshs - (FY 2018 Kshs -. The entity did not make any surplus during the year (FY 2018 Nil) and hence no remittance to the Consolidated Fund. [Entities to edit accordingly]

REPORT OF THE AUDITOR-GENERAL ON NYERI COUNTY ENTERPRISE DEVELOPMENT FUND FOR THE YEAR ENDED 30 JUNE, 2019

REPORT ON THE FINANCIAL STATEMENTS

Opinion

I have audited the accompanying financial statements of Nyeri County Enterprise Development Fund set out on pages 1 to 54, which comprise the statement of financial position as at 30 June, 2019, and the statement of financial performance, statement of changes in net assets, statement of cash flows and statement of comparison of budget and actual amounts for the year then ended, and a summary of significant accounting policies and other explanatory information in accordance with the provisions of Article 229 of the Constitution of Kenya and Section 35 of the Public Audit Act, 2015. I have obtained all the information and explanations which, to the best of my knowledge and belief, were necessary for the purpose of the audit.

In my opinion, the financial statements present fairly, in all material respects, the financial position of Nyeri County Enterprise Development Fund as at 30 June, 2019, and of its financial performance and its cash flows for the year then ended, in accordance with International Public Sector Accounting Standards (Accrual Basis) and comply with the Nyeri County Enterprises Development Act, 2018 and the Public Finance Management Act, 2012.

Basis for Opinion

The audit was conducted in accordance with International Standards of Supreme Audit Institutions (ISSAIs). I am independent of Nyeri County Enterprise Development Fund in accordance with ISSAI 130 on Code of Ethics. I have fulfilled other ethical responsibilities in accordance with the ISSAI and in accordance with other ethical requirements applicable to performing audits of financial statements in Kenya. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Key Audit Matters

Key audit matters are those matters that, in my professional judgment, are of most significance in the audit of the financial statements. There were no key audit matters to report in the year under review.

REPORT ON LAWFULNESS AND EFFECTIVENESS IN USE OF PUBLIC RESOURCES

Conclusion

As required by Article 229(6) of the Constitution, based on the audit procedures performed, except for the matter described in the Basis for Lawfulness and Effectiveness in Use of Public Resources section of my report, I confirm that, nothing else has come to my attention to cause me to believe that public resources have not been applied lawfully and in an effective way.

Basis of Conclusion

Award of a Contract for Disbursement of the Loans

During the year under review, the Fund awarded a contract for disbursing the Enterprise Development Fund Ioans to Kenya Commercial Bank. This was done through tender number CGN/TTC/251/2018-2019. However, a review of the evaluation report revealed that one of the criteria for evaluation was a bank where the Government of Kenya has ownership. Out of the banks that tendered for the disbursement of the Ioans, only one bank had Government shares thereby disadvantaging the other banks who had shown interest in the tender contrary to Section 58(2) of the Public Procurement and Asset Disposal Act, 2015.

Consequently, the Fund was in breach of the law.

The audit was conducted in accordance with ISSAI 4000. The standard requires that I comply with ethical requirements and plan and perform the audit to obtain assurance about whether the activities, financial transactions and information reflected in the financial statements are in compliance, in all material respects, with the authorities that govern them. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my conclusion.

REPORT ON EFFECTIVENESS OF INTERNAL CONTROLS, RISK MANAGEMENT AND GOVERNANCE

Conclusion

As required by Section 7(1)(a) of the Public Audit Act, 2015, based on the audit procedures performed, I confirm that, nothing has come to my attention to cause me to believe that internal controls, risk management and governance were not effective.

Basis for Conclusion

The audit was conducted in accordance with ISSAI 2315 and ISSAI 2330. The standards require that I plan and perform the audit to obtain assurance about whether processes and systems of internal control, risk management and governance were operating effectively, in all material respects. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my conclusion.

Responsibilities of Management and those Charged with Governance

Management is responsible for the preparation and fair presentation of these financial statements in accordance with International Public Sector Accounting Standards (Accrual Basis) and for maintaining effective internal control as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error and for its assessment of the effectiveness of internal control, risk management and governance.

In preparing the financial statements, Management is responsible for assessing the ability of Nyeri County Enterprise Development Fund to sustain services, disclosing, as applicable, matters related to sustainability of services and using the applicable basis of accounting unless Management is aware of the intention to terminate the Fund or to cease operations.

Management is also responsible for the submission of the financial statements to the Auditor-General in accordance with the provisions of Section 47 of the Public Audit Act, 2015.

In addition to the responsibility for the preparation and presentation of the financial statements described above, Management is also responsible for ensuring that the activities, financial transactions and information reflected in the financial statements are in compliance with the authorities which govern them, and that public resources are applied in an effective way.

Those charged with governance are responsible for overseeing the financial reporting process, reviewing the effectiveness of how the entity monitors compliance with relevant legislative and regulatory requirements, ensuring that effective processes and systems are in place to address key roles and responsibilities in relation to governance and risk management, and ensuring the adequacy and effectiveness of the control environment.

Auditor-General's Responsibilities for the Audit

The audit objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion in accordance with the provisions of Section 48 of the Public Audit Act, 2015 and submit the audit report in compliance with Article 229(7) of the Constitution. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISSAIs will always detect a material misstatement and weakness when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

In addition to the audit of the financial statements, a compliance audit is planned and performed to express a conclusion about whether, in all material respects, the activities, financial transactions and information reflected in the financial statements are in compliance with the authorities that govern them and that public resources are applied in

an effective way, in accordance with the provisions of Article 229(6) of the Constitution and submit the audit report in compliance with Article 229(7) of the Constitution.

Further, in planning and performing the audit of the financial statements and audit of compliance, I consider internal control in order to give an assurance on the effectiveness of internal controls, risk management and governance processes and systems in accordance with the provisions of Section 7(1)(a) of the Public Audit Act, 2015 and submit the audit report in compliance with Article 229(7) of the Constitution. My consideration of the internal control would not necessarily disclose all matters in the internal control that might be material weaknesses under the ISSAIs. A material weakness is a condition in which the design or operation of one or more of the internal control components does not reduce to a relatively low level the risk that misstatements caused by error or fraud in amounts that would be material in relation to the financial statements being audited may occur and not be detected within a timely period by employees in the normal course of performing their assigned functions.

Because of its inherent limitations, internal control may not prevent or detect misstatements and instances of non-compliance. Also, projections of any evaluation of effectiveness to future periods are subject to the risk that controls may become inadequate because of changes in conditions, or that the degree of compliance with the Fund's policies and procedures may deteriorate.

As part of an audit conducted in accordance with ISSAIs, I exercise professional judgement and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Management.
- Conclude on the appropriateness of the Management's use of the going concern basis
 of accounting and, based on the audit evidence obtained, whether a material
 uncertainty exists related to events or conditions that may cast significant doubt on
 the ability of Nyeri County Enterprise Development Fund to sustain its services. If I
 conclude that a material uncertainty exists, I am required to draw attention in the
 auditor's report to the related disclosures in the financial statements or, if such
 disclosures are inadequate, to modify my opinion. My conclusions are based on the
 audit evidence obtained up to the date of my audit report. However, future events or
 conditions may cause the Fund to cease sustaining its services.

Deferred tax assets are recognized for all deductible temporary differences, the carry forward of unused tax credits and any unused tax losses. Deferred tax assets are recognized to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carry forward of unused tax credits and unused tax losses can be utilized, except in respect of deductible temporary differences associated with investments in controlled entities, associates and interests in joint ventures, deferred tax assets are recognized only to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilized.

The carrying amount of deferred tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilized. Unrecognized deferred tax assets are re-assessed at each reporting date and are recognized to the extent that it has become probable that future taxable profits will allow the deferred tax asset to be recovered.

d) Investment property

Investment properties are measured initially at cost, including transaction costs. The carrying amount includes the replacement cost of components of an existing investment property at the time that cost is incurred if the recognition criteria are met and excludes the costs of day-to-day maintenance of an investment property.

Investment property acquired through a non-exchange transaction is measured at its fair value at the date of acquisition. Subsequent to initial recognition, investment properties are measured using the cost model and are depreciated over a 30-year period.

Investment properties are derecognized either when they have been disposed of or when the investment property is permanently withdrawn from use and no future economic benefit or service potential is expected from its disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognized in the surplus or deficit in the period of de-recognition.

Transfers are made to or from investment property only when there is a change in use.

e) Property, plant and equipment

All property, plant and equipment are stated at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the items. When significant parts of property, plant and equipment are required to be replaced at intervals, the entity recognizes such parts as individual assets with specific useful lives and depreciates them accordingly. Likewise, when a major inspection is performed, its cost is recognized in the carrying amount of the plant and equipment as a replacement if the recognition criteria are satisfied. All other repair and maintenance costs are recognized in surplus or deficit as incurred. Where an asset is acquired in a non-exchange transaction for nil or nominal consideration the asset is initially measured at its fair value.

f) Leases

Finance leases are leases that transfer substantially all of the risks and benefits incidental to ownership of the leased item to the Entity. Assets held under a finance lease are capitalized at the commencement of the lease at the fair value of the leased property or, if lower, at the present value of the future minimum lease payments. The Entity also recognizes the associated lease liability at the inception of the lease. The liability recognized is measured as the present value of the future minimum lease payments at initial recognition.

Subsequent to initial recognition, lease payments are apportioned between finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognized as finance costs in surplus or deficit.

An asset held under a finance lease is depreciated over the useful life of the asset. However, if there is no reasonable certainty that the Entity will obtain ownership of the asset by the end of the lease term, the asset is depreciated over the shorter of the estimated useful life of the asset and the lease term.

Operating leases are leases that do not transfer substantially all the risks and benefits incidental to ownership of the leased item to the Entity. Operating lease payments are recognized as an operating expense in surplus or deficit on a straight-line basis over the lease term.

g) Intangible assets

Intangible assets acquired separately are initially recognized at cost. The cost of intangible assets acquired in a non-exchange transaction is their fair value at the date of the exchange. Following initial recognition, intangible assets are carried at cost less any accumulated amortization and accumulated impairment losses. Internally generated intangible assets, excluding capitalized development costs, are not capitalized and expenditure is reflected in surplus or deficit in the period in which the expenditure is incurred.

h) Research and development costs

The additional appropriations are added to the original budget by the entity upon receiving the respective approvals in order to conclude the final budget. Accordingly, the entity recorded additional appropriations of - on the 2018-2019 budget following the governing body's approval.

The entity's budget is prepared on a different basis to the actual income and expenditure disclosed in the financial statements. Revenue from the sale of goods is recognized when the significant risks and rewards of ownership have been transferred to the buyer, usually on delivery of the goods and when the amount of revenue can be measured reliably and it is probable that the economic benefits or service potential associated with the transaction will flow to the entity.

Interest income

Interest income is accrued using the effective yield method. The effective yield discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount. The method applies this yield to the principal outstanding to determine interest income each period.

Dividends

Dividends or similar distributions must be recognized when the shareholder's or the entity's right to receive payments is established.

Rental income

Rental income arising from operating leases on investment properties is accounted for on a straight-line basis over the lease terms and included in revenue.

h) Research and development costs (Continued)

Following initial recognition of an asset, the asset is carried at cost less any accumulated amortization and accumulated impairment losses. Amortization of the asset begins when development is complete and the asset is available for use. It is amortized over the period of expected future benefit. During the period of development, the asset is tested for impairment annually with any impairment losses recognized immediately in surplus or deficit.

i) Financial instruments

Financial assets

Initial recognition and measurement

Financial assets within the scope of IPSAS 29 Financial Instruments: Recognition and Measurement are classified as financial assets at fair value through surplus or deficit, loans and receivables, held-to-maturity investments or available-for-sale financial assets, as appropriate. The Entity determines the classification of its financial assets at initial recognition.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial measurement, such financial assets are subsequently measured at amortized cost using the effective interest method, less impairment. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. Losses arising from impairment are recognized in the surplus or deficit.

Held-to-maturity

Non-derivative financial assets with fixed or determinable payments and fixed maturities are classified as held to maturity when the Entity has the positive intention and ability to hold it to maturity. After initial measurement, held-to-maturity investments are measured at amortized cost using the effective interest method, less impairment. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The losses arising from impairment are recognized in surplus or deficit.

Impairment of financial assets

The Entity assesses at each reporting date whether there is objective evidence that a financial asset or an entity of financial assets is impaired. A financial asset or a entity of financial assets is deemed to be impaired if, and only if, there is objective evidence of impairment as a result of one or more events that has occurred after the initial recognition of the asset (an incurred 'loss event') and that loss event has an impact on the estimated future cash flows of the financial asset or the entity of financial assets that can be reliably estimated. Evidence of impairment may include the following indicators:

Financial liabilities

Initial recognition and measurement

Financial liabilities within the scope of IPSAS 29 are classified as financial liabilities at fair value through surplus or deficit or loans and borrowings, as appropriate. The Entity determines the classification of its financial liabilities at initial recognition.

All financial liabilities are recognized initially at fair value and, in the case of loans and borrowings, plus directly attributable transaction costs.

Loans and borrowing

After initial recognition, interest bearing loans and borrowings are subsequently measured at amortized cost using the effective interest method. Gains and losses are recognized in surplus or deficit when the liabilities are derecognized as well as through the effective interest method amortization process.

Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate.

i) Inventories

Inventory is measured at cost upon initial recognition. To the extent that inventory was received through non-exchange transactions (for no cost or for a nominal cost), the cost of the inventory is its fair value at the date of acquisition.

Costs incurred in bringing each product to its present location and conditions are accounted for, as follows:

- Raw materials: purchase cost using the weighted average cost method
- Finished goods and work in progress: cost of direct materials and Labor and a proportion of manufacturing overheads based on the normal operating capacity, but excluding borrowing costs

4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

i) Inventories (Continued)

After initial recognition, inventory is measured at the lower of cost and net realizable value. However, to the extent that a class of inventory is distributed or deployed at no charge or for a nominal charge, that class of inventory is measured at the lower of cost and current replacement cost.

Net realizable value is the estimated selling price in the ordinary course of operations, less the estimated costs of completion and the estimated costs necessary to make the sale, exchange, or distribution.

Inventories are recognized as an expense when deployed for utilization or consumption in the ordinary course of operations of the Entity.

j) Provisions

Provisions are recognized when the Entity has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits or service potential will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

Where the Entity expects some or all of a provision to be reimbursed, for example, under an insurance contract, the reimbursement is recognized as a separate asset only when the reimbursement is virtually certain.

The expense relating to any provision is presented in the statement of financial performance net of any reimbursement.

Contingent liabilities

The Entity does not recognize a contingent liability, but discloses details of any contingencies in the notes to the financial statements, unless the possibility of an outflow of resources embodying economic benefits or service potential is remote.

Contingent assets

The Entity does not recognize a contingent asset, but discloses details of a possible asset whose existence is contingent on the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Entity in the notes to the financial statements. Contingent assets are assessed continually to ensure that developments are appropriately reflected in the financial statements. If it has become virtually certain that an inflow of economic benefits or service potential will arise and the asset's value can be measured reliably, the asset and the related revenue are recognized in the financial statements of the period in which the change occurs.

k) Nature and purpose of reserves

The Entity creates and maintains reserves in terms of specific requirements. Entity to state the reserves maintained and appropriate policies adopted.

1) Changes in accounting policies and estimates

The Entity recognizes the effects of changes in accounting policy retrospectively. The effects of changes in accounting policy are applied prospectively if retrospective application is impractical.

m) Employee benefits

Retirement benefit plans

The Entity provides retirement benefits for its employees and directors. Defined contribution plans are post-employment benefit plans under which an entity pays fixed contributions into a separate entity (a fund), and will have no legal or constructive obligation to pay further contributions if the fund does not hold sufficient assets to pay all employee benefits relating to employee service in the current and prior periods. The contributions to fund obligations for the payment of retirement benefits are charged against income in the year in which they become payable.

Defined benefit plans are post-employment benefit plans other than definedcontribution plans. The defined benefit funds are actuarially valued tri-annually on the projected unit credit method basis. Deficits identified are recovered through lump sum payments or increased future contributions on proportional basis to all participating employers. The contributions and lump sum payments reduce the post-employment benefit obligation.

n) Foreign currency transactions

Transactions in foreign currencies are initially accounted for at the ruling rate of exchange on the date of the transaction. Trade creditors or debtors denominated in foreign currency are reported at the statement of financial position reporting date by applying the exchange rate on that date. Exchange differences arising from the settlement of creditors, or from the reporting of creditors at rates different from those at which they were initially recorded during the period, are recognized as income or expenses in the period in which they arise.

o) Borrowing costs

Borrowing costs are capitalized against qualifying assets as part of property, plant and equipment.

Such borrowing costs are capitalized over the period during which the asset is being acquired or constructed and borrowings have been incurred. Capitalization ceases when construction of the asset is complete. Further borrowing costs are charged to the statement of financial performance.

p) Related parties

The Entity regards a related party as a person or an entity with the ability to exert control individually or jointly, or to exercise significant influence over the Entity, or vice versa. Members of key management are regarded as related parties and comprise the directors, the CEO and senior managers.

q) Service concession arrangements

The Entity analyses all aspects of service concession arrangements that it enters into in determining the appropriate accounting treatment and disclosure requirements. In particular, where a private party contributes an asset to the arrangement, the Entity recognizes that asset when, and only when, it controls or regulates the services the operator must provide together with the asset, to whom it must provide them, and at what price. In the case of assets other than 'whole-of-life' assets, it controls, through ownership, beneficial entitlement or otherwise – any significant residual interest in the asset at the end of the arrangement. Any assets so recognized are measured at their fair value. To the extent that an asset has been recognized, the Entity also recognizes a corresponding liability, adjusted by a cash consideration paid or received.

r) Cash and cash equivalents

Cash and cash equivalents comprise cash on hand and cash at bank, short-term deposits on call and highly liquid investments with an original maturity of three months or less, which are readily convertible to known amounts of cash and are subject to insignificant risk of changes in value. Bank account balances include amounts held at the Central Bank of Kenya and at various commercial banks at the end of the financial year. For the purposes of these financial statements, cash and cash equivalents also include short term cash imprests and advances to authorised public officers and/or institutions which were not surrendered or accounted for at the end of the financial year.

b) Interest rate risk

Interest rate risk is the risk that the entity's financial condition may be adversely affected as a result of changes in interest rate levels. 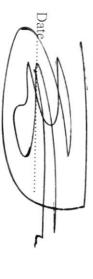
