1.0 PREFACE

On behalf of the Committee on Transport, Public Works and Housing and pursuant to the provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to the House the Report of the Committee on the vetting for appointment of Ms. Aidah Njeri Munano, Prof. Paul Maringa Mwangi, Mr. Wilson Nyakera Irungu and Mrs. Nancy Wakarima Karigithu, nominees for appointment to the positions of Principal Secretaries for State Departments of Housing and Urban Development; Public Works; Transport and Maritime Commerce respectively.

1.1 Committee Mandate

The Departmental Committee on Transport, Public Works and Housing is one of the twelve Departmental Committees of the National Assembly established under *Standing Order 216* whose mandate, pursuant to the *Standing Order 216 (5)* is to, among others;

- a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;
- b) study the programme and policy objectives of ministries and departments and the effectiveness of their implementation;
- c) study and review all the legislation referred to it;
- d) study, access and analyse the relative success of the ministries and departments measured by the results obtained as compared with their stated objective;
- e) investigate and inquire into all matters relating to the assigned ministries and departments as may be deemed necessary, and as may be referred to it by the House or a Cabinet Secretary;
- f) vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No.204 (Committee on appointments); and
- g) make reports and recommendations to the House as often as possible, including recommendations of proposed legislation.

In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider matters of Transport, Roads, Public works, Construction, and Maintenance of roads, rails and buildings, air, seaports and housing and oversees the following Government Ministry and State Department, namely: -

- a) Ministry of Transport and Infrastructure;
- b) State Department for Housing
- c) Directorate of Public Works and Urban Development.

1.3 Message from H. E. the President

Pursuant to Standing Order 42 (1), the Speaker the National Assembly on **Wednesday 2nd December**, 2015 conveyed to the House a message from H.E. the President regarding the nominees to the positions of Principal Secretaries for the State Departments of Housing and Urban Development; Public Works; Transport and Maritime Commerce.



The Speaker further informed the House that H.E. the President was seeking the approval of the National Assembly on the said nominations before appointment.

In accordance with Standing Order 42(3) (c) the Speaker having delivered the Message from the President referred the names of the nominees together with their curricula vitae to the respective Departmental Committees to conduct approval hearings. The Speaker advised the Committees to conduct extensive public participation as provided for under Article 118 of the Constitution as well as the Public Appointment (Parliamentary Approval) Act (No.33 of 2011) and report to the House within fourteen (14) days.

1.4 Nomination and appointment process

The National Assembly having received the names of the nominees is obligated to conduct approval hearings and make a determination of the nominees' suitability or otherwise within fourteen days as provided for in section 8 (1) of the Public Appointments (Parliamentary Approval Act) (No.33 of 2011).

1.5 Committee proceedings

During the approval hearings, the Committee held a total of three Sittings to examine and review the nominees' certificates, testimonial, consider public views and hold vetting meeting with the nominees.

The Committee received no memoranda from the public.

1.6 Committee observations and recommendations

The Committee having held approval hearings of the nominees regarding their suitability, observed that due process was followed on the recruitment process as provided for under the Article 155(3) (b) of the Constitution and the Public Appointments (Parliamentary Approval) Act (No.33 of 2011) and therefore found Ms. Aidah Njeri Munano, Prof. Paul Maringa Mwangi, Mr. Wilson Nyakera Irungu and Mrs. Nancy Wakarima Karigithu suitable and qualified for appointment to the

2.0 BACKGROUND INFORMATION

2.1 Legal framework

In conducting the Approval hearing, the Committee was guided by Article 155 of the Constitution which provides as follows—

155. (1) there is established the office of Principal Secretary, which is an office in the public service.

(2) Each State department shall be under the administration of a Principal Secretary.

(3) The President shall—

(a) <u>nominate a person for appointment as Principal Secretary</u> from among persons recommended by the Public Service Commission; and

(b) with the approval of the National Assembly, appoint Principal Secretaries.

(4) The President may <u>re-assign</u> a Principal Secretary.

(5) A Principal Secretary may resign from office by giving notice, in writing, to the President.

2.2 Qualifications for appointment of Principal Secretaries

- Public Appointments (Parliamentary Approval) Act No. 33 of 2011.
 Section 7 of the Public Appointments (Parliamentary Approval) Act, Chapter 136 (PAPAA), provides for issues which the relevant House of Parliament (in this case, the National Assembly) is supposed to consider in relation to any nomination. These are:
 - a) the procedure used to arrive at the nominee;
 - *b)* any constitutional or statutory requirements relating to the office in question; and
 - c) the suitability of the nominee for the appointment proposed having regard to whether the nominee's abilities, experience and qualities meet the needs of the body to which nomination is being made.

 Article 73(2) of the Constitution provides that: The guiding principles of leadership and integrity include

(a) selection on the basis of personal integrity, competence and suitability, or election in free and fair elections;

(b) objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;

(c) selfless service based solely on the public interest, demonstrated by

(i) honesty in the execution of public duties; and,

(ii) the declaration of any personal interest that may conflict with public duties;

(d) accountability to the public for decisions and actions.

2.3 Message from H.E the President

H. E the President on Wednesday 25th November, 2015 communicated the names of the nominees for the positions of Principal Secretaries for State Department of Housing And Urban Development; Public Works; Transport and Maritime Commerce to the Speaker for approval by the National Assembly pursuant to Article 115 (3) (b) of the Constitution. The Speaker in his Communication from the Chair issued on **Wednesday**, 2nd December, 2015 and pursuant to Standing Order 42 referred the names to the Departmental Committee on Transport, Public Works and Housing to conduct approval hearings and report within 14 days.

2.4 Notification to the nominees and Clearance requirements

The Clerk of the National Assembly vide letters ref. KNA/DC-TPWH/CORR/2015 dated 2nd December, 2015 wrote to the nominees, Ms. Aidah Njeri Munano, Prof. Paul Maringa Mwangi, Mr. Wilson Nyakera Irungu and Mrs. Nancy Karigithu, informing them of their nomination by H.E the President and requested them to appear for vetting by the Departmental Committee on Transport, Public Works and Housing on Friday, 11th December, 2015 in the Committee Room 7 Main Parliament



Buildings at 9:00 am, 10.00 am, 11.00 am and 12.00 pm respectively. The Clerk further requested the nominees to bring with them clearance certificates from the Kenya Revenue Authority (KRA), the Higher Education Loans Board (HELB), Ethics and Anti-Corruption Commission (EACC), Criminal Investigation Department and the Credit Reference Bureau.

The Clerk also wrote to the Kenya Revenue Authority (KRA), the Higher Education Loans Board (HELB), Ethics and Anti - Corruption Commission (EACC), Criminal Investigation Department and the Credit Reference Bureau requesting for tax, loans, integrity and criminal record status of the nominees. The institutions wrote back to the National Assembly confirming clearance of the nominees.

2.5 Request for Memoranda and Notification to the public

Section 6(9) of the Public Appointments (Parliamentary Approval) Act No. 33 of 2011, provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated".

The Clerk of the National Assembly on Thursday, 3rd December, 2015 placed a notification in the print media informing the general public of the intention of the Committee to conduct approval hearings, as provided for by Article 118 (1) (a) (b) and (2) of the Constitution and Section 6(4) of the Public Appointments (Parliamentary Approval) Act, (No.33 of 2011), which allow public participation in Committee proceedings. The notification gave provision for the submission of memoranda, on the suitability or otherwise of the nominees, by Wednesday, 9th December, 2015, at 5.00 pm.





2.6 Submission of memoranda

At the close of business on Wednesday, 9th December, 2015, the Office of the Clerk, had not received any submissions touching on the suitability or otherwise of the nominees.

3.0 APPROVAL HEARINGS

The Committee conducted approval hearings for the nominees to the positions of Principal Secretaries for the State Departments of Housing and Urban Development; Public Works; Transport and Maritime Commerce on Friday, 11th December, 2015. In conducting the vetting exercise, the Committee was guided by, among other documents, the Constitution, the Public Appointments (Parliamentary Approval) Act (No. 33 of 2011) and the Standing Orders.

The Committee examined the nominees using the guidelines provided for in the Public Appointments (Parliamentary Approval) Act No. 33 of 2011. The Committee also considered the following in vetting the nominees:

- a. Academic qualifications
- b. Employment record and work experience
- c. Professional association
- d. Public office, political activities and affiliations
- e. Potential conflict of interest
- f. Suitability to the position
- g. Tax compliance
- h. Vision and leadership
- i. Integrity
- j. Expectations and Key priorities



3.1 MS. AIDAH NJERI MUNANO, HSC - PRINCIPAL SECRETARY NOMINEE FOR THE STATE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

Ms. Aidah Njeri Munano, Hsc; appeared before the Committee for vetting on Friday 11th December, 2015. She was orally interviewed by the Committee and responded to questions during the vetting as follows:-

1. Educational and Professional Qualifications

She took Members through her educational and professional background and stated that: -

- She obtained a Master of Science Degree in Construction Project Management from the Jomo Kenyatta University of Science and Technology in the year 2012.
- ii) She also obtained a Bachelors of Architecture degree from the University of Nairobi in the 1981.
- iii) She has attended several short courses from the Building Centre of Japan in the year 1992 and attained a Certificate in Building Engineering and the University of Lund, Sweden in the year 1996 and attained a Certificate of Architecture and Development
- iv) She is currently the Works Secretary with Ministry of Land, Housing & Urban Development.
- v) Previously she had worked in various positions as follows:
 - a. The Deputy Chief Architect in charge of coordinating the implementation of Building Construction projects for 15 Government Ministries which include office of the President, Health Project, Defense Project and State house amongst others with about 400 projects from 2010 to 2014.
 - b. Acting Chief Architect in charge of the co-ordination of activities in the Architectural Department.



- Principal Superintending Architect, from November 2007 to April 2008, in of charge of planning & coordinating Building Development Projects.
- d. Chief Superintending Architect, from February 2001 to November 2007, wherein she represented the Permanent Secretary in all activities of the Ministry in Nairobi Province.
- e. Provincial Works Officer in Nairobi from February 2001 to March 2003. She was involved in Building and Roads maintenance activities and preparation state function for which she was awarded the Honor of Head of State Commendation.
- f. Senior Superintending Architect, from the year 1996 1997 where she was responsible for the Building Development works for various Ministries which included department of Defense and State House projects and coordinating the input of projects of various building professionals.
- g. Superintending Architect, from the year 1989 to the year 1996. Responsibilities also included coordinating the input of various building professionals in project.
- h. Architect I & II from the year 1982 to 1989 where she was responsible for Brief Preparation of projects, design of projects, coordinating preparation of tender documents, supervision of projects, Project Management, coordinating the input of the various building consultants during the implementation and management of projects.
- vi) She is a member of the Architectural Association of Kenya (AAK) as an Architect and Construction Project Manager and the Institution of the Construction Project Manager and also Registered with the Board of registration of Architects and Quantity Surveyors of Kenya (BORAQS).



2. Measures for ensuring that 30% of all tenders are awarded to youth, women and People with Disabilities;

She informed the meeting that she will ensure strict adherence to all regulations governing public procurements and that she will ensure that the evaluation committee demonstrates sound leadership to avoid discrimination of the less privileged members of the society.

3. The reorganization of the State Departments by establishing a stand-alone State Department of Public works visa-vis services delivery;

She stated that the decision by H.E the President to reorganize the State Departments and create the State department of Housing and Urban Development as well as that one of Public Works was a good idea that will ensure efficient service delivery and attainment of vision 2030. She further informed the meeting that she will work closely with her counterpart in Public works to ensure efficient service delivery.

4. Slum upgrading programme;

She informed the Committee that there is a whole Directorate tasked with slum upgrading projects particularly in Kibra and that there are housing units that are ready and will be handed over to the residents soon.

5. The concept of Private-Public Partnership (PPP) in the context of project financing;

She stated that it is a method of financing projects in which the private sector partners with governments to finance and develop projects. She further informed the meeting that she if appointed to the position she will fast track the implementation of projects funded under the same framework and consider introduction of alternative building material and spearhead the utilization of the industrial building systems which had worked very well in countries such as Brazil. Moreover, she indicated that there is also a need to encourage utilization



of land optimally so as to accommodate more people, as well as exploiting cheap financing models to construct more houses in the country.

6. Measures to be put in place to ensure that the cost of building material comes down;

She informed the meeting that she will review the building code with a view to bring down the cost building materials.

3.2 PROF. PAUL MARINGA MWANGI - PRINCIPAL SECRETARY NOMINEE FOR THE STATE DEPARTMENT OF PUBLIC WORKS

Prof. Paul Maringa Mwangi appeared before the Committee for vetting on Friday 11th December, 2015. He was orally interviewed by the Committee and responded to questions during the vetting as follows:-

1. Educational and Professional Qualifications

He took Members through his educational and professional background and stated that: -

- i) He pursued a doctorate degree in Environmental Planning from the Jomo Kenyatta University of Science and Technology (JKUAT) from 1999 to 2005.
- ii) He also attended the University of Nairobi from 1989 to 1991 and from 1979 to 1986 where he pursued a Master's degree in Planning and a Bachelor's degree in Architecture respectively
- iii) Currently he is the senior expert, Planning and Project Management at Workforce Development Authority (WDA), Kigali Rwanda.
- iv) He previously worked in the following fields and organizations:
 - a. As a Technical Expert & Master Trainer in Building Construction, an



Infrastructural Planning & Development Expert

- b. As an Associate Project Team Leader for the Singapore Corporation Enterprise (SCE) & the Workforce Development Authority (WDA) of Rwanda,
- c. As a Consultant advising DACUM founded Competency-based Demand-driven Curriculum Development, Implementation, Examination & Certification with guidance on the TVET Qualification Framework, Quality Assurance and Accreditation and Training of Trainers; and design support for & coordination of WDA inputs into the World Bank funded Skills Development Project.
- v) He was employed as an Acting Rector (Vice Chancellor) and Acting Vice Rector Academics (Deputy Vice Chancellor Academics), and as an Associate Professor of Architecture & Planning - guiding learning, research & quality assurance, while setting up the Faculty of Architecture and Environmental Design (FAED) at the Kigali Institute of Science and Technology (KIST).
- vi) He was a Head of department, Examinations officer, Convener research & syllabus committee, Year Master and Course Tutor in Theory subjects and portfolio and also as a supervisor and examiner for undergraduate and postgraduates in Jomo Kenyatta University of Agriculture and Technology.
- vii) He has publishing experience as an Editor-in-Chief, Journal of Inquiry in Design Pedagogy (JIDEP), Journal of Environmental Planning and Architecture (JEPA), Built Environmental Research Index (BERI); and as Associate Editor, African Journal of Design & Construction (AJDC); Referee for three international peer reviewed journals.
- vii)He worked as an expatriate Assistant Architect/Planner (Projects Architect) with Ramani Consultants in the Kingdom of Swaziland; Local Assistant Architect with Githunguri & Collins International in Nairobi, Kenya, Local



Assistant Architect with the Ministry of Public Works in Nairobi Provincial Offices, Kenya.

- viii) He has experience in accreditation having worked as a professional resource person with the Commission for Higher Education (CHE) in charge of Architecture and planning standards for Universities & post-secondary institutional accreditation in Kenya in the year 2000 to 2006.
- ix) He is a member of the Architectural Association of Kenya (AAK) as a town planning chapter-Graduate member and also a member of the Kenya Institute of Planners as a Graduate member.
- x) He has numerous published and unpublished reports, thesis and reviews.

2. Curbing the rampant corruption in the public service;

He informed the meeting that most of the workers in the Department are architects who are governed by strict code of ethics and it will be easy to deal with corruption. He will also intervene through the Board of Quantity Surveyors not to renew practicing certificates of corrupt officials.

3. Variation in the cost of construction works in the country;

He stated that he will develop clear communication channels that will enable dissemination of information on costs of construction works to clients. He will further streamline tendering processes and procedures to ensure cost of construction works or projects is not expensive.

4. Making use of architects from Public Works by the Government Departments;

He informed the Committee that he will invoke marketing intervention to ensure that the department of Public works is accessible to all clients. He further informed the Committee that he will initiate audit of all architects in the country to ensure quality of work is not compromised.

3.3 MR. WILSON IRUNGU NYAKERA - PRINCIPAL SECRETARY NOMINEE FOR THE STATE DEPARTMENT OF TRANSPORT

Mr. Wilson Irungu Nyakera appeared before the Committee for vetting on Friday 11th December, 2015. He was orally interviewed by the Committee and responded to questions during the vetting as follows:-

1) Educational and Professional Qualifications;

He took Members through his educational and professional background and stated that: -

- i) He attended Stanford University, CA, USA from the year 2003 to 2007 and attained a Bachelor of Science in Management Science and Engineering (Financial Analysis and Decision Engineering) and was awarded the Deans award for exceptional academic achievement.
- ii) He also attended the Deerfield Academy, MA, USA where he attained a Post Graduate Diploma- Coursework in Computer Science, Physics and French Graduated Cum-Laude.
- iii) He attended Starehe Boys Centre Technical Training Institute, Kenya in 2001 where he pursued his Tertiary College in Management Information Systems from the Kenya Institute of Management and Graduated with Distinction.
- iv) He attended the Starehe Boys Centre and School from 1997 to 2000 for his High School and attained a mean grade of A (Plain).
- v) He is a Certified Public Accountant.
- vi) He is currently the Managing Director for Equity Investment Bank wherein he is responsible for spearheading Equity Group's entry into investment banking.
- vii) Previously he had worked in various positions as follows:-



- a. Regional Director, East and Southern Africa for the Frontier Markets Fund Managers, GuarantCo, from 2013 to 2014. He was involved in spearheading GuarantCo's regional mandate to provide infrastructure funding across the East, Central and South African Countries while ensuring donor logical framework of poverty eradication, gender parity and access to utilities is fully achieved through investments.
- Managing Director for NIC Capital Limited from January 2009 to March 2014, responsible for spearheading NIC Capital operations in Kenya, Uganda and Tanzania.
- c. Financial Analyst for Emerging Markets Investment Banking Team, London, UK July 2007 to January 2009, responsible for complex financial modeling, merger and acquisition structures, deal origination, strategic advisory and management of client relationships.
- 2) The financial demand for key infrastructural projects in the state Department of Transport;

He informed the Committee that many projects cannot be financed by the National Treasury and alternative financing must be sought from other sources such as Public-Private Partnership programme. The nominee alluded to the fact that when appointed to the position of Principal Secretary he will explore the possibility of constructing a bridge at the Likoni Channel through Public Partnership programme to ameliorate the problems facing passengers at the channel.

3) Financial problems facing Kenya Airways Ltd;

He stated that the Airline is technically insolvent and the problems facing it are structural and managerial. He recommended that the structural problems facing it should be addressed first before injecting money to it.

4) Corruption in the State Department of Transport;



He stated that he will introduce robust measures to close all loopholes which will include appointment of new managers or directors and Chief Executive Officers for parastatals whose terms are about to end.

3.4 SUBMISSION BY MR. HALAKHE D. WAQO, CHIEF EXECUTIVE OFFICER, ETHICS AND ANTI- CORRUPTION COMMISSION

On Friday, 11th December, 2015, the Committee met with Mr. Halakhe D. Waqo, Chief Executive Officer, Ethics and Anti- Corruption Commission on the allegations touching on the integrity of Mrs. Nancy Wakarima Karigithu MBS, the Nominee for Principal Secretary for State Department of Maritime Commerce.

He briefed the meeting as follows:-

- Mrs. Nancy Wakarima Karigithu was allegedly involved in mismanagement of recruitment, irregular promotion and allocation of trips to few members of staff at the Kenya Maritime Authority when she was the Director General. The said allegations were reported to the Commission in March, 2015 and based on the allegations the Commission commenced its investigations.
- 2. The EACC regional office in Mombasa has finalized its report and the findings of the investigations indicate that Mrs. Kargithu was not involved in any mismanagement of recruitment and irregular promotion of staff at Kenya Maritime Authority as alleged.
- 3. The matter has been concluded and her file is being prepared for closure by the Commission.

3.5 MRS. NANCY WAKARIMA KARIGITHU, MBS - PRINCIPAL SECRETARY NOMINEE FOR STATE DEPARTMENT OF MARITIME COMMERCE

Mrs. Nancy Wakarima Karigithu, MBS appeared before the Committee for vetting on Friday 11th December, 2015. She was orally interviewed by the Committee and responded to questions during the vetting as follows:-



1) Educational and Professional Qualifications

She took Members through her educational and professional background and stated that: -

- She is a maritime lawyer with a Bachelor's Degree in Law from the University of Nairobi, a Diploma in Law from the Kenya School of Law and Masters in Maritime Law from the International Maritime Law Institute, Malta.
- ii) She has successfully completed numerous other professional courses the most recent being the Advanced Maritime Leaders Program (Singapore Maritime Academy) and the Advanced Management Program (Strathmore Business School).
- iii) Currently she sits as a member of the Governing Council of the World Maritime University, based in Malmo, Sweden.
- iv) She was the founding Director-General of the Kenya Maritime Authority (KMA), from 2006 to May 2015.
- v) She spearheaded the formulation and enactment of the legal framework through the Merchant Shipping Act, 2009, and over 40 sets of subsidiary maritime regulations; providing the legal mechanism for enforcing national standards and requirements related to shipping and maritime transport.
- vi) She represented the country in numerous fora related to the maritime sector and severally led Kenya's delegation to the International Maritime Organization (IMO) and other international fora.

vii)Previous has previously she worked in various positions as follows:-

- a. State Counsel at the Attorney General's Chambers in the year 1985 to 1987;
- b. Kenya Ports Authority (KPA) in 1989 to 1995 as a Senior Legal Officer ;
- c. Maritime Law consultancy where she was engaged by among others, the IMO, UNECA and the African Union to establish maritime legal regimes for several African countries.

 - b. Appreciation award by National Nuclear Security Administration Department of Energy, USA in recognition of efforts to prevent illicit trafficking of nuclear materials at the port of Mombasa through participation in the US Department of Energy's Megaports Initiative 2012
 - c. US Coast Guard Appreciation Award in Recognition of Support & Cooperation in the Fight against International Terrorism.
- x) Appointed by the IMO Secretary General to the Team on the Financial Sustainability of the World Maritime University (WMU).
- xi) She is a member of the following associations
 - a. Law Society of Kenya (LSK)
 - b. Institute of Chartered Public Secretaries of Kenya (ICPSK)
 - c. Founder Member, Women in the Maritime Section in Eastern & Southern African (WOMESA)

2) Kenya achieved the goal of meeting maritime obligations by establishing the Kenya Maritime Authority (KMA);

She informed the Committee that indeed the country had lost its maritime credibility and by establishing KMA the country regained its credibility and it was recognized internationally by International Maritime Organization (IMO). Further, she indicted to the Committee that with the establishment of the agency, more technical personnel in the maritime industry have been trained in countries such as Egypt, Australia and Sweden.

3) The Coast Guard Bill;

She indicated that an integrated Coast Guard was established with a view to share maritime security matters. She underlined the importance of enacting the Bill and the input of the Committee on Transport, Public Works and Housing will be paramount.

4) Available opportunities to Kenyans from the maritime sector since the industry is dominated by foreigners;

She informed the Committee that once appointed she will champion to bring in local people in the Maritime sector by introducing a legal framework to have participation of locals in the maritime sector provided for in the statutes.

5) Increase revenue to the government through the maritime sector;

She stated that there will be need to give incentives to various agencies involved in the maritime sector and need to give concessions at each level.

6) Mismanagement of recruitment and irregular promotion and allocations of trips to few members of the staff at the Kenya Maritime Authority;

She stated that the officers that are alleged to have been promoted irregularly were Messrs. Julius Okindo, Daniel Katana and Ms. Irene Atieno Victor. The said officers joined the organization at lower levels and while in employment they were granted full scholarships to pursue higher studies. Upon Completion the



Advisory Committee undertook a staff rationalization exercise in line with their respective skills and deployed them in other departments. She informed the Committee that the deployment was based on staff Regulations. The same information was forwarded to the Ethics and Anticorruption Commission *vide* a letter referenced KMA/HRM/3/4 dated 30th April, 2015.

4.0 COMMITTEE OBSERVATIONS AND FINDINGS

The Committee having considered the nominees curriculum vitae and heard oral submissions during the vetting exercise made the following observations: -

i) Ms. Aidah Njeri Munano – Principal Secretary Nominee for the State Department for Housing and Urban Development

- a) She was born on 22nd February, 1957 and completed her secondary education in 1975. She joined University of Nairobi in 1976 and graduated in 1981 with a BSC, Architecture. She is also a graduate of Jomo Kenyatta University of Agriculture and Technology with masters in Construction Management.
- b) She has a wealth of professional experience in the department having joined the ministry as Architect II and rose to the position of superintending Architect, senior superintending Architect, chief superintending Architect, principal superintending and finally to Works Secretary. Her responsibilities included coordinating the implementation of building construction projects for government ministries, Chief government advisor on building construction and coordinating the inputs of the building project professionals, Architects, Quantity surveyors, Electrical, Mechanical, Civil and Structural Engineers in the implementation of projects.
- c) She had satisfied the requirements of Chapter 6 of the Constitution of Kenya on leadership and integrity.



- d) She had been cleared by the Ethics and Anti-Corruption Commission (EACC), Criminal Investigation Department (CID), Kenya Revenue Authority on tax compliance, Higher Education Loans Board (HELB) and the Credit Reference Bureau.
- e) She was interviewed by the Public Services Commission for the position of Principal Secretary in May 2015.
- f) She has never been charged in a Court of Law and has no potential conflict of interest.

Vetting of the nominees for the positions of the **Principal Secretaries**

The Chairperson invited the nominees for the State Departments to make their presentations as follows:-

1. Ms. Aidah Njeri Munano, HSC- Nominee for the State Department of Housing and Urban Development

She took Members through her educational and professional background and stated that:

- i) She pursued a Master of Science in Construction Project Management from the Jomo Kenyatta University of Science and Technology from the year 2010 to 2012.
- ii) She also pursued a Bachelors of Architecture degree from the University of Nairobi from the year 1976 to 1981.
- iii) She has attended several short courses from the Building Centre of Japan in the year 1992 and attained a Certificate in Building Engineering and the University of Lund, Sweden in the year 1996 and attained a Certificate of Architecture and Development.
- iv) She is currently the Works Secretary with Ministry of Land, Housing & Urban Development.
- v) Previously she had worked in various positions as follows:
 - a. The Deputy Chief Architect in charge of coordinating the implementation of Building Construction projects for 15 Government Ministries which include office of the President, Health Project, Defense Project and State house amongst others with about 400 projects from 2010 to 2014.
 - b. Acting Chief Architect in charge of the co-ordination of activities in the Architectural Department.
 - c. Principal Superintending Architect, from November 2007 to April 2008, in of charge of planning & coordinating Building Development Projects.
 - d. Chief Superintending Architect, from February 2001 to November 2007, wherein she represented the Permanent Secretary in all activities of the Ministry in Nairobi Province.

- e. Provincial Works Officer from February 2001 to March 2003. She was involved Building and Roads maintenance activities and preparation the state function for which she was awarded the Honor of Head of State Commendation.
- f. Senior Superintending Architect, from the year 1996 1997 where she was responsible for the Building Development works for various Ministries which included department of Defense and State House projects and coordinating the input of projects of various building professionals.
- g. Superintending Architect, from the year 1989 to the year 1996. Responsibilities also included coordinating the input of various building professionals in project.
- h. Architect I & II from the year 1982 to 1989 where she was responsible for Brief Preparation of projects, design of projects, coordinating preparation of tender documents, supervision of projects, Project Management, coordinating the input of the various building consultants during the implement of projects, Management of projects.
- vi) She is a member of the Architectural Association of Kenya (AAK) as an Architect and Construction Project Manager and the Institution of the Construction Project Manager and also Registered with the Board of registration of Architects and Quantity Surveyors of Kenya (BORAQS)

Issues raised by the Committee

The following issues were raised by the members during the meeting:-

- 1. On how her education background will be relevant to the position she has been nominated for; she informed the meeting that she previously worked with the then Permanent Secretaries for the Ministry of Public works (PS)by supporting them technically and she understands the needs and what it takes to be a Principal Secretary. She further informed the meeting that her vast experience in the construction sector accumulated over the years will be an asset in performing her duties as PS.
- 11. In regards to how she will ensure that 30% of all tenders are awarded to youth, women and People with disabilities; she informed the meeting that she will ensure strict adherence to all regulations governing public procurements and that she will

ensure that the evaluation committee demonstrates sound leadership to avoid discriminations of the less privileged members of the society.

- III. On whether the reorganization of the State Departments by establishing a standalone State Department of Public works will enhance services delivery, she informed the meeting that the decision by H.E the President to reorganize the State Departments and create the State department of Housing and Urban Development as well as that one of Public Works was a good idea that will ensure efficient service delivery attainment of vision 2030. She further informed the meeting that she will work closely with her counterpart in Public works to ensure efficient service delivery.
- IV. On slum upgrading programme, she informed the meeting that there is a whole Directorate tasked on slum upgrading projects particularly in Kibra, that there are housing units that are ready and will be handed over to the residents soon.
- V. On the understanding of the concept of Private-Public Partnership (PPP) in the context of project financing; the nominee informed Members that it is a method of financing projects in which the private sector partners with governments to finance and develop projects. She further informed the meeting that she when appointed to the position she will fast track the implementation of projects funded under the same framework and consider introduction of alternative building material and spearhead the utilization of the industrial building systems which had worked very well in countries such as Brazil. ,moreover, she indicated that there is also a need to encourage utilization of land optimally so as to accommodate more people, as well as exploiting cheap financing models to construct more houses in the country.
- VI. On whether she could be trusted with Ksh, 24 billion being the budget of the state Department of Housing and Urban Development and yet her net worth is Ksh. 6.2 million she informed the meeting that in the course of her career she has overseen the implementation of projects worth KShs 73 billion and in this regard she should ensure prudence utilization of the ksh. 24 billion.
- VII. On the measures she will put in place to ensure that the cost of building material comes down, she informed the meeting that she will review the building code with a view to bring down the cost building materials.

VIII. On whether she was interviewed by the Public Services Commission for the position of Principal Secretary, she confirmed that indeed she was interviewed for the position in May, 2015.

II. Dr. Paul Mwangi Maringa- Nominee for the State Department of Public Works

He took Members through his educational and professional background and stated that: -

- i) He pursued a doctorate degree in Environmental Planning from the Jomo Kenyatta University of Science and Technology (JKUAT) from 1999 to 2005.
- ii) He also attended the University of Nairobi from 1989 to 1991 and from 1979 to 1986 where he pursued a Master's degree in Planning and a Bachelor's degree in Architecture respectively.
- iii) Currently he is the senior expert, Planning and Project Management at Workforce Development Authority (WDA) in Kigali, Rwanda.
- iv) He previously worked in the following fields and organizations:
 - a. Technical Expert & Master Trainer in Building Construction
 - Associate Project Team Leader for the Singapore Corporation Enterprise (SCE) & the Workforce Development Authority (WDA) of Rwanda,
 - c. Consultant advising DACUM founded Competency-based Demanddriven Curriculum Development, Implementation, Examination & Certification with guidance on the TVET Qualification Framework, Quality Assurance and Accreditation and Training of Trainers; and design support for & coordination of WDA inputs into the World Bank. funded Skills Development Project.
- v) He was employed as an Acting Rector (Vice Chancellor) and Acting Vice Rector Academics (Deputy Vice Chancellor Academics), and as an Associate Professor of Architecture & Planning - guiding learning, research & quality assurance, while setting up the Faculty of Architecture and Environmental Design (FAED) at the Kigali Institute of Science and Technology (KIST).
- vi) He was a Head of department, Examinations officer, Convener research & syllabus committee, Year Master and Course Tutor in Theory subjects and

portfolio and also as a supervisor and examiner for undergraduate and post-graduates in Jomo Kenyatta University of Agriculture and Technology.

- vii) He has publishing experience as an Editor-in-Chief, Journal of Inquiry in Design Pedagogy (JIDEP), Journal of Environmental Planning and Architecture (JEPA), Built Environmental Research Index (BERI); and as Associate Editor, African Journal of Design & Construction (AJDC); Referee for three international peer reviewed journals.
- vii) He worked as an expatriate Assistant Architect/Planner (Projects Architect) with Ramani Consultants in the Kingdom of Swaziland; Local Assistant Architect with Githunguri & Collins International in Nairobi, Kenya, Local Assistant Architect with the Ministry of Public Works in Nairobi Provincial Offices, Kenya.
- viii) He has experience in accreditation as a having worked as a professional resource person with the Commission for Higher Education (CHE) in charge of Architecture and planning standards for Universities & post-secondary institutional accreditation in Kenya in the year 2000 to 2006.
- ix) He is a member of the Architectural Association of Kenya (AAK) as a town planning chapter-Graduate member) and also a member of the Kenya Institute of Planners as a Graduate member.
- x) He has numerous published and unpublished reports, thesis and reviews.

lssues raised by members

The following issues were raised by the members during the meeting:-

1. On how his vast experiences and education will assist him to discharge the duties associated with the position he had been nominated for; he informed the meeting that he previously worked in the public service and he understands the responsibilities of a Principal Secretary. He further informed the Committee that the position of a principal Secretary requires more of institutional management and since he had previously worked as a Vice Chancellor of a university in Rwanda he has the requisite experience to run the state department of Public Works.

- II. In regards to how he will curb the rampant corruption in the public service, he informed the meeting that most of the workers in the Department are architects who are governed by strict code of ethics and it will be easy to deal with corruption. He will also intervene through the Board of Quantity Surveyors not to renew practicing certificates of corrupt officials.
- III. On the cause of variation in the cost of construction works in the country, he informed the Committee that he will develop clear communication channels that will enable dissemination of information on costs of construction works to clients. He will further streamline tendering processes and procedures to ensure cost of construction works or projects is not expensive.
- IV. On why several government departments no longer make use architects from Public Works; the nominee informed the Committee that he will invoke marketing intervention to ensure that the department of Public works is accessible to all clients. He further informed the Committee that he will initiate audit of all architects in the country to ensure quality of work is not compromised.
- V. On whether he was interviewed by Public Services Commission, he confirmed to the Committee that he was interviewed for the position of Principal Secretary in May, 2015.

III. Mr. Wilson Nyakera Irungu- Nominee for the State Department of Transport

He took Members through his educational and professional background and stated that:

- i) He attended Stanford University, CA, USA from the year 2003 to 2007 and pursued a Bachelor of Science in Management Science and Engineering (Financial Analysis and Decision Engineering) and was awarded the Deans award for exceptional academic achievement.
- ii) He also attended the Deerfield Academy, MA, USA where he pursued a Post Graduate Program- Coursework in Computer Science, Physics and French Graduated Cum-Laude
- iii) He further attended Starehe Boys Centre Technical Training Institute, Kenya in 2001 where he pursued his Tertiary College in Management Information Systems from the Kenya Institute of Management and Graduated with Distinction

- iv) He attended the Starehe Boys Centre and School from 1997 to 2000 for his High School and attained a mean grade of A (Plain)
- v) He is a Certified Public Accountant
- vi) He is currently the Managing Director for Equity Investment Bank wherein he is responsible for spearheading Equity Group's entry into investment banking.
- vii) Previously he had worked in various positions as follows:
 - a. Regional Director, East and Southern Africa for the Frontier Markets Fund Managers, GuarantCo, from 2013 to 2014. He was involved in spearheading GuarantCo's regional mandate to provide infrastructure funding across the East, Central and South African Countries while ensuring donor logical framework of poverty eradication, gender parity and access to utilities is fully achieved through investments.
 - b. Managing Director for NIC Capital Limited from January 2009 to March 2014, responsible for spearheading NIC Capital operations in Kenya, Uganda and Tanzania.
 - c. Financial Analyst for Emerging Markets Investment Banking Team, London, UK July 2007 to January 2009, responsible for complex financial modeling, merger and acquisition structures, deal origination, strategic advisory and management of client relationships

Issues raised by the Committee

The following issues were raised by the members during the meeting:-

- 1. On what it entails in the course he pursued, the Bachelor of Science in Management Science and Engineering (Financial Analysis and Decision Engineering), he informed the meeting that it entails using engineering techniques in the financial decision making.
- 11. On the financial demand for key infrastructural in the state Department of Transport, he informed the Committee that many projects cannot be financed by the National Treasury and alternative financing must be sought from other sources such as Public-Private Partnership programme. The nominee alluded to the fact when appointed to the position of Principal Secretary he will explore the possibility of constructing a bridge at the Likoni Channel through Public

Partnership programme to ameliorate the problems facing passengers at the channel.

- III. In regards to the financial problems facing Kenya Airways, he informed the Committee that the Airline is technically insolvent and the problems facing it are structural and managerial. He recommended that the structural problems facing it should be addressed first before injecting money to it.
- IV. On why he was ready to take a pay cut; he informed the Committee that he recognize service to the society and the fact that he was educated through scholarships he felt obliged to give back to the country.
- V. On how he will deal with corruption in the State Department of Transport, the nominee informed the Committee that he will introduce robust measures to close all loopholes which will include appointment of new managers or directors and Chief Executive Officers for parastatals whose terms are about to end.
- VI. On whether he was interviewed by Public Services Commission, he confirmed to the Committee that he was interviewed for the position of Principal Secretary in May, 2015.

IV. Mrs. Nancy Wakarima Karigithu, MBS-Nominee for the State Department of Maritime Commerce

Before meeting the nominee, the Committee met with Mr. Halakho D. Waqo, Chief Executive Officer, Ethics and Anti- Corruption Commission on the allegations touching on the integrity of Mrs. Nancy Karigithu MBS, the Nominee for Maritime Commerce. He briefed the meeting as follows:-

- 1. Mrs. Nancy Karigithu was involved in mismanagement of recruitment and irregular promotion and allocations of trips to few members of the staff at the Kenya Maritime Authority when she was the Director General. The said allegations were reported to the Commission in March, 2015 and based on the allegations the Commission commenced its investigations.
- 11. The EACC regional office in Mombasa has finalized its report and the findings of the investigations indicate that Ms. Kargithu was not involved in the

mismanagement of recruitment and irregular promotion of staff at Kenya Maritime Authority as alleged.

III. The matter is has been concluded and that her file is prepared for closure by the Commission.

Subsequently, the Committee invited the nominee for the vetting exercise. Thereupon, the nominee took members through her educational and professional background and stated that:

- i) She is a maritime lawyer with a Bachelor's Degree in Law from the University of Nairobi, a Diploma in Law from the Kenya School of Law and Masters Degree in Maritime Law from the International Maritime Law Institute, Malta.
- ii) She has successfully completed numerous other professional courses the most recent being the Advanced Maritime Leaders Program (Singapore Maritime Academy) and the Advanced Management Program (Strathmore Business School).
- iii) Currently she sits as a member of the Governing Council of the World Maritime University, based in Malmo, Sweden.
- iv) She was the founding Director-General of the Kenya Maritime Authority (KMA), from 2006 to May 2015.
- v) She spearheaded the formulation and enactment of the legal framework through the Merchant Shipping Act, 2009, and over 40 sets of subsidiary maritime regulations; providing the legal mechanism for enforcing national standards and requirements related to shipping and maritime transport.
- vi) She represented the country in numerous forums related to the maritime sector and severally led Kenya's delegation to the International Maritime Organization (IMO) and other international fora

vii) Previously she worked with:-

- a. State Counsel at the Attorney General's Chambers in the year 1985 to 1987;
- b. Kenya Ports Authority (KPA) in 1989 to 1995 as a Senior Legal Officer ;
- c. Maritime Law consultancy where she was engaged by among others, the IMO, UNECA and the African Union to establish maritime legal regimes for several African countries.

- viii) In 1999, she was appointed to the Roll of Consultants by the International Maritime Organisation.
- ix) In recognition of her service to the national maritime industry, she was awarded several awards namely:
 - a. The Presidential Award of the Order of the Moran of the Burning Spear (MBS), in December 2007;
 - b. Appreciation award by National Nuclear Security Administration Department of Energy, USA in recognition of efforts to prevent illicit trafficking of nuclear materials at the port of Mombasa through participation in the US Department of Energy's Mega ports Initiative 2012
 - c. US Coast Guard Appreciation Award in Recognition of Support & Cooperation in the Fight against International Terrorism
- x) Appointed by the IMO Secretary General to the Team on the Financial Sustainability of the WMU
- xi) She is a member of the following associations
 - a. Law Society of Kenya (LSK)
 - b. Institute of Chartered Public Secretaries of Kenya (ICPSK)
 - c. Founder Member, Women in the Maritime Section in Eastern & Southern African (WOMESA)
 - d. Institute of Directors (IOD)
 - e. Institute of Chartered Shipbrokers (ICS)
 - f. Chartered Institute of Arbitrators (CIARS)
 - g. Member -- Ethics Institute of East Africa, (EthicEA)
 - h. Member Mentor for Industry, JKUAT
 - i. Mentor for Science, Technology, Engineering and Maths Program (STEM), UNESCO

Issues raised by members

The following issues were raised by the members during the meeting:-

1. On whether the county achieved the goal of meeting maritime obligations by establishing the Kenya Maritime Authority (KMA); the nominee informed the Committee that indeed the country had lost its maritime credibility and by establishing

KMA the country regained its credibility and it was recognized internationally by International Maritime Authority (IMO). Further, she indicted to the Committee that with the establishment of the agency, more technical personnel in the maritime industry have been trained in countries such as Egypt, Australia and Sweden.

- II. On the need to enact the Coast Guard Bill; the nominee indicated that an integrated Coast Guard was established with a view to share maritime security matters. She underlined the importance of enacting the Bill and the input of the Committee on Transport, Public Works and Housing will be paramount.
- III. On the available opportunities to Kenyans from the maritime sector since the industry is dominated by foreigners; the nominee informed the Committee that once appointed she will champion to bring in local people in the Maritime sector by introducing a legal framework to have participation of locals in the maritime sector provided for in the statutes.
- IV. On plans the nominee will put in place to boost revenue to the government through the maritime sector. She informed the Committee that there will be need to give incentives to various agencies involved in the maritime sector and need to give concessions at each level.
- V. On the allegations that she was involved in mismanagement of recruitment and irregular promotion and allocations of trips to few members of the staff at the Kenya Maritime Authority when she was the Director General; she informed the Committee that the officers that are alleged to have been promoted irregularly were Messrs. Julius Okindo, Daniel Katana and Ms. Irene Atieno Victor. The said officers joined the organization at a lower level and while in employment they were granted fully scholarship to pursue higher studies. Upon Completion the Advisory Committee undertook a staff rationalization exercise in line with their respective skills and deployed them in other departments. She informed the Committee that the deployment was based on staff Regulations. The same information was forwarded to the Ethics and Anticorruption Commission vide a letter referenced KMA/HRM/3/4 dated 30th April, 2015.
- VI. On whether he was interviewed by Public Services Commission, he confirmed to the Committee that he was interviewed for the position of Principal Secretary in May, 2015.

Executive Summary

Mrs. Nancy Wakarima Karigithu is the founding Director-General of the Kenya Maritime Authority (KMA), a position she has held since the establishment of KMA in 2006. The principal objects of the Authority are to regulate, co-ordinate and oversee maritime affairs in the country through undertaking various functions aimed at ensuring safety of life at sea; security of persons, property and ships; the protection of the marine environment from pollution and the training and welfare of Kenyan seafarers.

She led the establishment a legal framework through which Kenya meets her obligations under the various International maritime conventions that the country has ratified. The framework also provides the legal mechanism for enforcing national standards and requirements related to shipping and maritime transport.

Her leadership and steering of the country's maritime affairs has earned her respect and recognition among her peers in the maritime and other associated industries. Her role and service to the industry saw her awarded the Order of the Moran of the Burning Spear by President Mwai Kibaki in December 2007. She has represented the country in numerous forums related to the industry and has been an important member of Kenya's delegation to the International Maritime Organization (IMO). Her leadership qualities have shone through in these meetings and representations and she is highly regarded in international shipping in general and at the IMO in particular.

She has managed to raise Kenya's profile and position the country as an emerging and important maritime nation in Africa. She led successful campaigns for election of Kenya to the IMO Governing Council for the 2011-13 biennium and the current 2014-15 biennium. She was personally recognized by being elected as the Chair of IMO's Technical Committee (one of only five committees through which the 174 member state organization conducts its business) for three years to date. She also serves as a member of the Governing Council of the World Maritime University, based in Malmo, Sweden.

Her work in the international maritime forum has enabled the Government of Kenya make key strides in improving maritime security in the Country.

In February 2015 KMA hosted the international maritime community in Kenya for the first ever National Maritime Conference.

Oualifications and Experience

Mrs. Karigithu is a maritime lawyer with vast experience in national, regional and international shipping. She holds a Bachelor's Degree in Law from the University of Nairobi, a Diploma in Law from the Kenya School of Law and Masters in Maritime Law from the International Maritime Law Institute, Malta. She

has successfully completed numerous other professional courses.

Previously, she worked as a State Counsel at the Attorney General's Chambers before entering private legal practice. She was then appointed a Senior Legal Officer at the Kenya Ports Authority (KPA). She left KPA to found a Maritime Law consultancy and was engaged by among others, the IMO and the African Union to establish the maritime legal regime for several African countries.

Current Appointment

As the Director-General of KMA, Mrs. Karigithu has achieved the following:

- 1. Set up the Authority and established a comprehensive legal framework for maritime activities in Kenya including all rules and regulations to the extent necessary in the interests of the maritime sector. Under her leadership and guidance, the Merchant Shipping Act was enacted in 2009 as the principal law under which Kenya's maritime affairs are conducted. Her guidance has seen Kenya takes its role in IMO very seriously and has ratified many of the Conventions emanating from the Organization. Key amongst them is the International Convention on Oil Pollution Response and Coordination (OPRC 90). Her initiative has seen the drafting of an Oil Spill Contingency Plan, the development of an Oil Spill Environmental Sensitivity Mapping for Coastal Areas of Kenya and the conclusion of a National Oil Spill Dispersants Use Policy. Coupled with the enactment of relevant legislation in that regard, Kenya is now well positioned to roll out the National Oil Spill Response Contingency Plan. The Marine Pollution Bill drafted under her tenure for implementing the MARPOL Convention is also at advanced stages of enactment.
- 2. Through her committed stewardship, she has enabled the Government of Kenya make key strides in improving maritime security in the country. Key amongst them is the establishment of a National Maritime Security Committee which the Authority hosts. Initiatives to formalise the Committee are at advanced stages. The Committee has played a key role in drafting proposals for the establishment of a framework for maritime security in Kenya.
- 3. Her focus on maritime security has also led Kenya to maintain a forefront position in suppression and prevention of acts of piracy and armed robbery against ships in implementation of the Djibouti Code of Conduct (DCoC). She operationalized the Regional Maritime Rescue and Coordination Centre (RMRCC) in Mombasa. The functions of the RMRCC have been broadened to include piracy information sharing, thus enhancing Kenya's role in the suppression of piracy and is a useful point of contact where ships regularly request advice or assistance when sailing in waters off the coast off the coast of Somalia. Her guidance has also seen the Centre collaborate with International partners to boost its capacity. The Centre in this regard has continued to host and benefit from the EU Maritime Security (Marsic) Project coordinators whose mandate is to build capacity of the Information Sharing Centres under the DCoC.
- 4. She led and oversaw the country's efforts to attain White listing by IMO in 2010. This means that Kenyan trained seafarers can access jobs in international shipping. She is also leading efforts to ensure creation of a pool of seafarers to cater the local job market and global shipping in line with Vision 2030. Her commitment to the welfare of Kenyan seafarers has resulted in the ratification of the Maritime Labour Convention and guided the drafting of guidelines for recruitment and placement of seafarers on board ships, terms and conditions for recruitment and placement, as well as guidelines for the accreditation of maritime training institutions.
- 5. As Chair of the Port Community she has shown steadfastness in trade facilitation, enabling Kenya maintain focus on implementing the Maritime Traffic Facilitation (FAL) Convention and set pace for further implementing Kenya's obligations under the Trade Facilitation Agreement within the World Trade Organization framework. She has ensured the establishment of a regulatory framework for fair trade and under her guidance in implementing the Merchant

Shipping Act, commercial shipping legal frameworks have been drafted. Under her oversight changes in the way business is conducted at the port of Mombasa have seen a drastic reduction in time taken to clear goods from the port leading to reduced cost of doing business not only for Kenyan businessmen, but also those in other East African countries using the port of Mombasa.

- 6. Led the campaigns and lobbying at the IMO Assembly for election of Kenya as a Member of the Council for 2010-12 biennium and the current 2013-15. The Council is comprised of forty member elected from the IMO's 174 member states.
- 7. Lobbied and campaigned for election of Kenya as the Chair of IMO's Technical Committee.
- 8. She was instrumental in laying the ground work that led to the establishment of the Association for Heads of African Maritime Administration. To set the pace, Kenya hosted the first meeting in Mombasa in 2012. During the period, the Authority has become a respected Government Agency and is one of the three major Maritime Administrations in Africa after South Africa & Nigeria.

The Mission to Zambia involved identification and assessment of short term national requirements in matters pertaining to maritime legislation having special regard to a landlocked state with vast inland waterways navigation and further advising and assisting in the review of all legislation pertinent to the maritime trade and transport sector, in order to modify, consolidate and update the same to meet the present needs and modern technological changes in the international shipping industry.

5. Ethiopia: March - April 2000.

The Mission was undertaken back to back with number three above and the Consultant's duties involved identifying and assessing the short term national requirements of a recently landlocked state owning a national shipping line, on all matters pertaining to maritime legislation. The consultant also reviewed the "Draft Maritime Code of the Federal Republic of Ethiopia" (prepared under an earlier mission by UNCTADA 1), and further reviewed relevant legislative matters relating to inland water transport; the particular circumstances in the country and the national aspirations of the State in regard to maritime trade and transport.

6. Tanzania: November - December 2000.

During this Mission the Consultant provided advice and reviewed the legal and administrative framework for the establishment of an independent Maritime Administration; identified and assessed the short term national requirements on matters pertaining to maritime legislation and the regulatory responsibilities of an independent Maritime Administration. At the end of the mission the Consultant provided the IMO with a draft Merchant Shipping Bill and a Mission Report which detailed the mission findings and recommendations. The Draft Merchant Shipping Bill prepared during this Mission was enacted into law in 2003 and provided the basis upon which Tanzania became one of only 12 countries in Africa to be admitted to the STCW White list.

7. Seychelles: March - April 2003.

The terms of reference for the above mission included advising, preparing and reviewing the legal and administrative framework for the establishment of a Maritime safety Administration; drafting the incorporation bill for the setting up of the Maritime administration: advising the Government of Seychelles on the incorporation into domestic legislation of the conventions ratified and acceded to by the country as a member of the IMO; revising, reviewing and amending the Merchant Shipping Act,1998 to reflect subsequent amendments to major IMO technical conventions, protocols and codes and to make provisions for their incorporation into local legislation. The Mission resulted in the drafting of two Bills, namely The Maritime Administration Bill setting up

an independent maritime Administration and a Merchant Shipping Bill.

8. Improvement of the Safety of Navigation on Lake Victoria Project; 2002 to 2003.

This was a joint project between IMO, IALA, IHO, and the French Government (foreign affairs department), working under the coordination of the East African Community Secretariat. The project had four components namely:

- (i) Maritime Legislation
- (ii) Aids to Navigation
- (iii) Search and Rescue
- (iv) Hydrography, Charting and Mapping

As the lead Consultant in charge of maritime legislation she prepared the legal and administrative framework for a maritime safety regime for inland water transport in East Africa. The exercise translated into a draft East African Inland Water Transport Bill, together with five sets of subsidiary legislation which altogether, incorporated various maritime conventions *inter alia*, SOLAS, MARPOL, OPPRC, SAR, and the IMDG Code. These conventions, although not applicable to inland water navigation provide the basis for ensuring uniform safety standards, having been earlier incorporated into the "Model Legislation for Non-convention Craft and Vessels" in Africa. The drafting process involved close liaison with senior government officials of the three member states of the East African Community, and in the course of the project participated sessions of drafting the "Protocol for the Sustainable Development of Lake Victoria Basin", an institutional framework for harnessing resources and coordinating all development issues in the subject area. The deliverables for this assignment include a draft legislation that has been recently enacted by the East African Legislative Assembly as the Lake Victoria Transport Bill.

9. Republic of The Gambia: January - May 2004

The Mission involved carrying out a marine environmental programme and the setting up of the Gambia Maritime Safety Administration. The consultant therefore undertook drafting of pollution legislation and other pertinent subsidiary legislation, the Draft taking into consideration various conventions, namely, MARPOL, OPPRC, FUND, LDC, CLC and other maritime conventions having a bearing on the marine environment. Further tasks included drafting more than twenty sets of subsidiary legislation necessary to enforce the Gambia Merchant Shipping Bill.
