

## **EXECUTIVE SUMMARY**

The National Flag, Emblems and Names (Amendment) Bill, sponsored by Sen. Mutula Kilonzo Junior, MP., was Read a First Time in the Senate on Wednesday, 29<sup>th</sup> November, 2017. Following the First Reading, the Bill, stood committed to the Standing Committee on National Security, Defence & Foreign Relations pursuant to standing order No. 134 (5) of the Senate Standing Orders.

Subsequently, the Committee subjected the Bill to public hearings pursuant to Article 118 (1) (b) of the Constitution and standing order 134 (5). The Committee invited submissions on the Bill from members of the public via advertisements carried in the Daily Nation and the Standard Newspapers on 4<sup>th</sup> March, 2018.

The Committee held a public hearing on Wednesday 7<sup>th</sup> March, 2018, in Committee Room 5, Main Parliament Buildings, but noted that no public turned up to give oral submissions. The Committee received one written submission on the Bill.

The Committee thereafter considered the submissions and views of the Committee as documented in this Report.

## 1. INTRODUCTION

## 1.1. The National Flag, Emblems and Names Act, Cap. 99

The National Flag, Emblems and Names Act, Cap. 99 commenced on 10<sup>th</sup> December, 1963. It was enacted to prevent the improper use of the National Flag and of certain emblems, names, words and likenesses for professional and commercial purposes, and to prohibit the display of certain flags.

## 1.2. The National Flag, Emblems and Names (Amendment) Bill, 2017

The Bill is sponsored by Sen. Mutula Kilonzo Junior, MP. It introduces a new section 4B to the National Flag, Emblems and Names Act (Cap. 99) to provide that a person may, in expressing their patriotism, display the National Flag at any private residence or any place of work or business during a public holiday. The Bill however only allows such display of the National Flag if it does not undermine the authority or reputation of the State.

The Bill further provides that the Cabinet Secretary may make rules on the display of the National Flag.

The Bill also seeks to bring the National Flag, Emblems and Names Act into conformity with the Constitution by substituting the word "Minister" with the word "Cabinet Secretary" which is now the term used under the current Constitution.

# 1.2 Committal of the Bill to the Standing Committee on National Security, Defence and Foreign Relations

The National Flag, Emblems and Names (Amendment) Bill, 2017 was published 2<sup>nd</sup> November, 2017 and Read a First Time in the Senate on 29<sup>th</sup> November, 2017. The Bill was thereafter committed to the Standing Committee on National Security, Defence and Foreign Relation for consideration and facilitation of public participation.

Pursuant to Article 118 (1) (b) of the Constitution and standing order 134(5) of the Senate Standing Orders, the Committee invited views on the Bill from the public by placing advertisements in the Daily Nation and the Standard Newspapers of 3<sup>rd</sup> March, 2018.

The Committee received a written memorandum from the Council of County Governors, which was delivered through the Office of the Clerk of the Senate.

## 2. SUBMISSIONS

## 2.1 Submissions from the Council of County Governors

In a memorandum submitted to the Committee, the Council of County Governors stated that it is in support of the Bill which seeks to amend the National Flag, Emblems and Names Act so as to allow members of the public to express their patriotism by flying the National flag in their private residence and place of work or business during public holidays provided this does not undermine the authority or reputation of the State. It reiterated that the implementation of the national values and principles under Article 10 of the Constitution is a responsibility of both the National and County Governments. Further, it noted that the promotion of patriotism has a positive effect on governance at the county level and promotes national cohesion.

## 3. COMMITTEE OBSERVATIONS

Having considered the Bill and the submissions received, the Committee observed as follows-

- (1) That Article 9 of the Constitution sets out the national symbols of the Republic, which are the national flag, the national anthem, the coat of arms and the public seal. These are the most sacrosanct symbols for Kenya as a Nation. They reflect Kenya's past, present and aspirations for the future and give a sense of belonging and identity to all Kenyans.
- (2) The National flag in particular, bears colors and symbols which conveys the country's fight for independence, the sacrifice made by Kenyans to achieve independence, the people of Kenya and their desire for peace and prosperity.
- (3) Prior to the promulgation of the Constitution, the law which provided for the national symbols was the National Flag, Emblems and Names Act. The Act came into force on 10<sup>th</sup> December, 1963, two days before *Jamhuri* Day to prevent the improper use of the National Flag and of certain emblems, names, words and likenesses for professional and commercial purposes.
- (4) The Act as currently worded, does not clearly state whether or not Kenyans are allowed to fly the National Flag during public holidays, yet public holidays,

particularly the celebration national days set out under Article 9(3) of the Constitution, provide opportunities for Kenyans to express their patriotism.

- (5) Patriotism being a national value under Article 10 of the Constitution, it is important that National Flag, Emblems and Names Act allows Kenyans to freely express their patriotism by expressly stating that flying the National Flag on public holidays is allowed.
- (6) Comparatively, in other democratic jurisdictions, the flying of national flags at private residences and places of work is allowed.

The Committee Bill therefore noted that the Bill is timely and will foster the very important value of patriotism.

## 4. COMMITTEE RECOMMENDATIONS

The Committee unanimously agreed to support the Bill and recommends that the Senate passes the Bill which, if enacted, will foster patriotism, promote national cohesion and have a positive effect on governance at both levels of government.

## THE NATIONAL FLAG, EMBLEMS AND NAMES (AMENDMENT) BILL, 2017

#### A Bill for

AN ACT of Parliament to amend the National Flag, Emblems and Names Act to allow members of the public to fly the National Flag in their places of residence, work and business; and for connected purposes

ENACTED by the Parliament of Kenya, as follows -

1. This Act may be cited as the National Flag, Emblems and Names (Amendment) Act, 2017.

Short title.

2. The National Flag, Emblems and Names Act, (in this Act referred to as the "principal Act") is amended in section 2 by inserting the following new definition immediately before the definition of the word "motor vehicle"—

Amendment of section 2 Cap. 99.

"Cabinet Secretary" means any Cabinet Secretary responsible for matters relating to the National Flag, Emblems and Names;

3. Section 3 of the principal Act is amended—

Amendment of section 3 Cap. 99.

- (a) in the introductory phrase to subsection (1) by deleting the word "Minister" appearing immediately after the words "permission of the" and substituting therefor the words "Cabinet Secretary"; and
- (b) in subsection (3) by deleting the word "Minister" appearing immediately after the words "conditions as the" and substituting therefor the words "Cabinet Secretary".
- **4.** The principal Act is amended by inserting the following new section immediately after section 4A—

Insertion of new section 4B.

Display of the National Flag in private residences.

**4B.** (1) Despite any other provision of this Act, during a public holiday, a person may, as a sign of patriotism, display the National Flag, at any private residence or

any place of work or business, provided that the display of the National Flag does not undermine the authority or reputation of the State.

- (2) The Cabinet Secretary may make rules on the display of the National Flag under subsection (1).
- 5. Section 8 of the principal Act is amended by deleting the word "Minister" appearing before the words "may, by notice" and substituting therefor the words "Cabinet Secretary".
- **6.** Section 9 of the principal Act is amended in the introductory phrase by deleting the word "Minister" appearing immediately after the word "the" and substituting therefor the words "Cabinet Secretary".

#### MEMORANDUM OF OBJECTS AND REASONS

#### Statement of objects and reasons

Patriotism is a national value and principle of governance under Article 10(2)(a) of the Constitution. In this respect, the Bill seeks to allow members of the public to express their patriotism by flying the National flag in their private residence and place of work or business provided this does not undermine the State.

## Statement on the delegation of legislative powers and limitation of fundamental rights and freedoms

The Bill does not delegate legislative power and does not limit fundamental rights and freedoms.

#### Statement on how the Bill concerns county governments

Implementation of the national values and principles under Article 10 of the Constitution is a responsibility of both the National and County Governments. Further, promotion of patriotism has a positive effect on governance at the county level and promotes national cohesion.

The Bill therefore concerns county governments in terms of Articles 110 (1) (a) of the Constitution in that it contains provisions that affect the functions and powers of the county governments as set out in the Fourth Schedule to the Constitution.

## Statement that the Bill is not a money Bill, within the meaning of Article 114 of the Constitution

This Bill is not a money Bill within the meaning of Article 114 of the Constitution.

Section 2 of Cap. 99 that the Bill proposes to amend—

#### 2. Interpretation

In this Act, unless the context otherwise requires—

"motor vehicle" has the meaning assigned to it in the Traffic Act (Cap. 403);

"the National Anthem" means the national anthem, the words and music of which are set out in the Third Schedule to this Act;

"specified emblem" means any emblem, seal, flag, pennant, insignia, ensign or coat-of-arms of a kind specified in Part I of the First Schedule to this Act;

"specified likeness" means any photograph, drawing or other pictorial representation of the person for the time being holding any of the offices or dignities specified in Part III of the First Schedule to this Act;

"specified name" means any of the names and words specified in Part II of the First Schedule to this Act, and includes any abbreviation of any such name;

Section 3 of Cap. 99 that the Bill proposes to amend—

- 3. Prohibition of improper use of emblems, names and likenesses
- (1) Notwithstanding anything contained in any law for the time being in force, no person shall, except with the written permission of the Minister—
  - (a) use any specified emblem, specified name or specified likeness, or any colourable imitation thereof, in furtherance of, or display the same as an advertisement for, any trade, business, calling or profession; or
  - (b) use any specified emblem, specified name or specified likeness, or any colourable imitation thereof, in the title of any patent, or in any trade mark or design; or
  - (c) manufacture or import any article or goods bearing any specified emblem, specified name or specified likeness, or any article or goods on which any title, trade mark or design is used in contravention of paragraph (b) of this subsection.
- (2) The provisions of subsection (1)(a) of this section relating to the use of a specified likeness shall not apply to the publication of a *bona fide* news item (whether in a newspaper or by any other medium) or to the publication in a newspaper of any article connected with any *bona*

fide news item other than a news item in the furtherance of, or as advertisement for, any trade, business, calling or profession.

- (3) Any permission given under subsection (1) of this section may be given subject to such conditions as the Minister may deem fit.
- (4) Any person who contravenes the provisions of this section shall be guilty of an offence and liable to a fine not exceeding five thousand shillings, or to imprisonment for a term not exceeding six months, or to both such fine and such imprisonment.

Section 8 of Cap. 99 that the Bill proposes to amend—

#### 8. Power to amend First Schedule

The Minister may, by notice in the *Gazette*, amend the First Schedule to this Act.

Section 9 of Cap. 99 that the Bill proposes to amend—

#### 9. Regulations

The Minister may make regulations—

- (a) prescribing the occasions upon which, the persons by whom and the manner in which the National Flag or the Armorial Ensigns may be flown or displayed, as the case may be;
- (b) prohibiting, controlling or restricting the use of any specified emblem, specified likeness or specified name;
- (c) regulating the manner in which application may be made to him for his permission under section 5 of this Act, prescribing the form of any licence by which such permission may be given and fixing any fee for such application and licence;
- (d) generally for carrying this Act into effect.
